THE Department of Environment and Natural Resources (DENR) has welcomed the recognition of the Del Carmen Mangrove Reserve in Siargao Island Protected Landscape and Seascape (SIPLAS) as a Wetland of International Impor-

DENR Asst. Secretary Marcial Amaro Jr. emphasized the importance of wetlands such as mangrove swamp forests in serving as communities' barrier and first line of defense against natural disasters and effects of cli-

mate change. The Del Carmen Mangrove Reserve was cited during the World Wet-lands Day (WWD) 2023 celebration last February

Anchored on the theme, "It's Time for Wet-land Restoration," the national celebration of WWD 2023 was led by the DENR's Biodiversity Management Bureau (BMB) and hosted by the local government unit of Del Carmen, Surigao del Norte.

The celebration showcased the ecological ben-efits of a restored wetland and the restoration efforts

in the Del Carmen man groves, reaping the fruits of wetland conservation protection and restoration work with increased fish ery resources, alternative livelihood from tourism and increased protection from storm surge, espe-cially during the onslaught of typhoon Odette in December 2021.

"The wetlands of Siar gao Island Protected Landscape and Seascape or SIPLAS serve as a testament to these ecological functions during the height of typhoon Odette. If not for these mangrove forests, the damage to the communities of SIPLAS

could have been worse and more people could have suffered. This testament is one of the many reasons we should protect our wetlands from further degradation," Amaro said.

According to the DENR official, the recognition of Del Carmen Mangrove Reserve serves as a precursor to its nomination for inclusion in the global network of significant wetlands known as the Ramsar List of Wetlands of International Importance or Ramsar Sites.

The mangrove reserve has already fulfilled two of the criteria for being a Ramsar Site. Its rich biodiversity and the ecological benefits of 4,800 hectares of mangrove that cover one of the largest contiguous mangrove reserves in the country, and the presence of an assemblage of endemic, native and migratory species, make this part of SIPLAS globally important.

In 2010, the municipal government of Del Carmen worked to restore the mangrove forest and save it from illegal activities, such as mangrove cutting and poaching. The area now covers about 53 percent of Siargao Island's total mangrove forest.

HIS ADVICE: GET INSURED

OF HAZARDS OF LIVING IN **RECLAIMED AREA**

A geology and environmental science expert has warned those planning to purchase reclaimed land, including on any of the multibillion-peso reclamation projects in Manila Bay, to be wary of the dangers that might come with their investment, such as land subsidence, storm surges and tsunamis.

"My last resort is to tell anyone who wants to buy property on reclaimed land: Make sure you can get damage insurance. If you cannot, be forewarned. Don't be a fool," said Kelvin Rodolfo, a professor at University of Illinois in Chicago, who received the Gawad Bayani ng Kalikasan in 2022.

In a message to the Inquirer on Tuesday, he extended his cautionary note to insurance companies, saying: "To protect themselves, insurance companies also must educate themselves of the hazards and risks" concerning any big-ticket reclamation project.

The geologist issued the warning after reviewing the A2

grains of bay-fill materials so buildings on top of sediments could sink or topple over.

"It is therefore very possible that liquefaction during an earthquake would cause the heavy steel pilings to sink deeply into the bay floor, leaving the reclamation without its containment," he said.

'Big One'

Rodolfo also cited a 2004 report by the Japan International Cooperation Agency (Jica) which said Metro Manila was overdue for a magnitude 7.2 earthquake, or the "Big One."

In such a catastrophe, the geologist said the "greatest damage" would likely happen in the shore areas being planned for reclamation.

This is because ground shaking and the likelihood of liquefaction are greater in inconsolidated or partly consolidated sediment present in reclamation sites, he said.

He noted, however, that feclaimed areas in Manila Bay did not need an earthquake to happen to suffer "serious damage."

In 1968, a magnitude 7.3 earthquake in Casiguran, Quezon province, which was 225 kilometers away from Metro Manila, destroyed many structures near the Pasig River, Rodolfo said.

"The six-story Ruby Tower in Binondo collapsed from amplified ground shaking liquefaction, or both, killing 260 people," he said.

The massive magnitude 7.8 earthquake on Feb. 6 that devastated southeastern Turkey and parts of Syria and claimed over 40,000 lives has triggered fresh calls from lawmakers to prepare the country for the next big temblor.

The Jica study, made together with the Metropolitan Manila Development Authority, also noted that many structures in the National Capital Region and nearby provinces would not be able to withstand a magnitude 7.2 earthquake.

Experts believe such a powerful quake may originate from the Marikina Valley Fault System, particularly the West Valley fault line. INQ

proposed P34-billion Manila Waterfront City Reclamation project, a joint venture agreement that involves the reclamation and development of 318 hectares of foreshore and offshore areas of Manila Bay.

Rodolfo expressed alarm over the scale and breadth of the developments in the bay.

"Despite the clear dangers from land subsidence, storm surges, tsunamis and liquefaction during earthquakes, Manila Bay reclamation is proceeding rapidly," he said.

He noted that, along with the revival of the mothballed Bataan Nuclear Power Plant, the massive reclamation projects on Manila Bay were among the "biggest human-made threats to the environment" in the country.

'Very bad idea'

In a peer-reviewed article published in 2014, Rodolfo said land subsidence, or the lowering of the surface closer to sea level, delayed runoff from rains and worsened flooding and tidal occurrences.

This and other reasons were what made near-shore reclaimation a "very bad idea," he said.

Based on his study, coastal areas in Metro Manila were sinking as fast as 9 centimeters every year. "Caloocan, an industrial area that uses large volumes of groundwater, subsided 8 cm/y in 2004 and 2005," he said.

Rodolfo said increased pressure from the weight of new buildings in reclaimed areas could also speed up the compression of the surface, resulting in subsidence.

"Coastal areas, whether underlain by natural deposits like those of the Pasig River delta or artificial reclamations, also experience seismically induced liquefaction," he said, referring to the process that takes place when sediments near bodies of water behave like quicksand.

During earthquakes, the shaking of the ground tends to break the contact between

Marikina eyes dredging expansion

Marikina City Mayor Marcelino Teodoro on Tuesday said they will expand their dredging activities in Marikina River this year as part of the city government's flood control measures.

The city government is also eyeing to complete the construction of sustainable slope protection in the river banks using high resistant materials which serve as protection against river bank erosion that will reduce falling of debris into the water.

"Our river is our ecological heritage, many of our city's history lie on the banks of the river and its surrounding environment," Teodoro said.

The Marikina Riverpark Promenade is a 22-kilometer long linear park along the river from Barangay IVC until Barangay Nangka where the city government will put new jogging and bike lanes, park and water amenities, and facilities like flower gardens, gondola rides, amusement park, picnic groves, commercial hubs, events place, fresh food market and a lot more.

"We will put a big ferris wheel where riders will have an overlooking view of the whole city," Teodoro said.

MWSS turns over P160 M for Kaliwa Dam construction

The Metropolitan Waterworks Sewerage System (MWSS) has remitted P160 million to the Rizal and Quezon Indigenous Peoples Organizations (IPOs) as construction disturbance fees for the construction of Kaliwa Dam.

In a ceremonial turnover yesterday, the MWSS turned over P80 million to the IPOs in Rizal and another P80 million to the IPOs in Quezon.

These will cover the disturbance fees for the duration of the construction of the New Centennial Water Source-Kaliwa Dam Project, which is expected to be completed by end-2026, MWSS administrator Leonor Cleofas said.

These are part of government's commitment to the affected com-munities in the ancestral domains under their memorandum of agreement (MOA) after securing free, prior and informed consent (FPIC) process, which took nearly eight years, she said.

The turnover was made as some 300 Dumagat-Remontado IPs march from Gen. Nakar, Quezon to Malacañang f m Feb. 15-23 to show their opposition to the Kaliwa Dam Proj-

In an interview after the ceremony, National Commission on In-

digenous Peoples (NCIP) regional hearing officer and designated spokesperson for Kaliwa Dam in Region 4A Josefina Agusti said the value turned over by MWSS was determined by the IPOs themselves.

The P80 million is the valuation of the IPs. They did not only compute the material impact but also considering their culture and tradition. They have considerations which is very unique to them," she said.

The Rizal and Quezon IPOs have formed their respective community royalty management and development plans to use the proceeds from MWSS.

"One of the roles of NCIP

is to ascertain that all benefits will be received by the IPs from MWSS. We will also guide the IPs, especially with their community royalty management and development plan. They plan out the projects they need in the community according to the ancestral domain sustainable development plan," Agusti said.

The NCIP will also assist the IPOs NCIP in the trainings needed to uplift their technical skills on management and will also be part of the monitoring team on their spending and ensuring compliances of their rights.

Once the project is complete,

the MWSS will provide annual financial assistance of P1 million per community in both provinces, or P36 million in Quezon and P10 million in Rizal, Cleofas said.

[The P160 million] will be replaced by a financial assistance of P1 million per community recognized by the NCIP. The NCIP recognized community in Rizal is 10 and 36 in Quezon," she said.

The MWSS official said the clear objective is to deliver the Kaliwa

Dam project by end-2026.

THE Metropolitan Waterworks and Sewerage System (MWSS) said on Tuesday that the Kaliwa Dam in Rizal and Quezon provinces is now 22% complete.

"(Including) detailed engineering design... the Kaliwa Dam is now 22% complete," Leonor C. Cleofas, MWSS administrator, told reporters.

Ms. Cleofas said that MWSS hopes to complete the Kaliwa Dam, which will serve as the new source of water for Metro Manila, by the end of 2026, with

operations commencing by 2027.

Last year, the MWSS said a memorandum of agreement was concluded with the indigenous peoples around the Kaliwa river, a waterway in Rizal and Quezon provinces.

The Dumagat-Remontado indigenous peoples who have an ancestral domain claim, received a P160-million "disturbance fee" for the construction of the dam.

"It was a recognition that they are the owners of the ancestral domain; again, there is no transfer of ownership. Their ownership for the land is being recognized through the disturbance fee," Josefina R. Agusti, regional hearing officer of the National Commission on Indigenous Peoples Calabarzon, told reporters.

She said P80 million each was distributed to Tanay Dumagat-Remontado Ancestral Domain Development, Inc. and to Pinagtaanan ne Dumagat-Remontado de General Nakar, the two IP organizations will also receive a share of the revenue, known as the "benefit share,"

once the dam starts operations.

"After the awarding of P80 million, of course we will be expecting their yearly benefit share which is P36 million for General Nakar, Quezon. For Tanay, Rizal, that is another P10 million per year," Ms. Agusti said.

The Kaliwa Dam is a bulk water supply project which is a component of the New Centennial Water Source program of the MWSS. It is expected to supply 600 million liters per day of water. — Ashley Erika O. Jose

MBC backs PBBM's push for creation of WRMO

Marcos Jr.'s decision to issue a new executive order (EO) for the creation of the proposed Water Resources Management Office (WRMO) to boost water supply across the country.

"We believe the WRMO will help address urgent issues, even as we encourage Congress to pass a law creating an even more effective Department of Water," MBC said in a statement issued on Tuesday. The MBC also noted there are as many as 30 agencies with water-related mandates, which, it said, are slowing down upgrades and expansion.

Citing the National Economic and Development Authority (Neda) and the Philippine Water Supply and Sanitation Masterplan (PWSSMP), MBC said 45.2 percent of the population relies on point sources (e.g., springs, rivers, streams, wells, peddlers, and other sources) that are susceptible to contamination.

Of the 54.8 percent who had access to safe water supply, only 15 percent to a piped distribution network, and 11.2 percent relied on communal faucet systems, MBC noted.

Further, according to MBC, Neda said to achieve Sustainable Development Goal 6—clean water and sanitation for all—by 2030, yearly investments of P132 billion are needed. However, MBC said the current rate is in the "single digits."

The business group stressed, "Most water service providers are unable to deliver adequate services to a growing population due to financial, technical, efficiency, and coverage issues."

Further, MBC said the situation is expected to reach "critical levels" by 2040 if the sector remains "stagnant."

"The 1995 Water Crisis Act helped address the situation at that time, including the awarding of Metro Manila concession agreements to private sector players in 1997, leading to vastly improved and expanded services in the capital," MBC said.

With this, MBC said, "We are confident that a WRMO and a Department of Water can do the same for the current crisis."

Likewise, the European Chamber of Commerce of the Philippines (ECCP) said in a statement last week it welcomes the creation of the WRMO as a transitory body pending the creation of a Water Re-

source Department.

The foreign business group said the creation of the WRMO is a "wel-

comed first step in fully realizing this as it aims to strengthen collaboration among various agencies in implementing water management programs in accordance with the Integrated Water Management Plan."

ECCP underscored the need to approach water resource planning using Integrated Water Resource Management (IWFM), which it described as an "internationally recognized" framework that is used to guide countries in their journey to water security.

This is based on the idea that water issues should not be approached in "isolation," but rather in a "more holistic" manner due to the interdependence of the uses of finite water resources, the business chamber explained.

Three weeks ago, the Presidential Communications Office (PCO) said President Marcos ordered the formation of the WRMO during a multi-sectoral meeting in Malacanang to consolidate water management efforts of all concerned government offices.

PCO said the core task of WRMO would be to formulate and ensure the implementation of the Integrated Water Management Plan of the Metropolitan Waterworks and Sewerage System, Local Water Utilities Administration, and the Department of Environment and Natural Resources.

SMCPC seeks clearance for power plant

SAN Miguel Consolidated Power Corp. (SMCPC) is preparing for the development of a 56-megawatt (MW) diesel power plant project in Zamboanga City, documents submitted to the Environmental Management Bureau (EMB) showed.

The project has an indicative estimated cost of P3.2 billion that will include the conduct of feasibility study, preparation of detailed engineering design, acquisition of necessary government permits and licenses, site development, leasing and construction of power plant components, procurement of equipment and materials, environmental management and protection, pollution control facilities, and environmental monitoring

The EMB filing showed initial project cost for the first 28 MW phase is P1.6 billion and the other P1.6 billion is for the 28 MW second phase.

SMCPC said in the filing it initially applied and secured an environmental compliance certificate for a single 28 MW gas turbine power plant project but decided to increase it to 56 MW due to projections of increasing power demand in the entire Zamboanga Peninsula in the coming years.

The company said the project is

seen to help the looming low voltage issue in Zamboanga City as the Zamboanga Peninsula lacks local generators which trigger voltage difficulties and power instability in northwestern Mindanao.

Among potential environmental impacts cited by SMCPC that are being assessed by EMB for the project are soil erosion, vegetation removal and loss of habitat, threat to existence or loss of important local species, pollution of land, ground vibration and possible surface water pollution and water quality deterioration from solid and liquid wastes, among others. -

San Miguel power unit building ₱3.2-b gas turbine power plant in Zamboanga

SAN Miguel Consolidated Power Corp. is building a 56-megawatt gas turbine power plant in Zamboanga City at a cost of P3.2 billion.

SMCPC, a wholly-owned subsidiary of SMC Global Power Holdings Corp., said in a report to the Department of Environment and Natural Resources it received an environmental compliance certificate for the project's first phase involving a 28-MW gas turbine power plant in Sangali, Zamboanga City.

The ECC-approved project is under

construction, but SMCPC decided to increase its power generating capacity to 56 MW because of the projected increase in power demand in the Zamboanga Peninsula.

SMCPC submitted the gas turbine power plant expansion project to the DENR's Environmental Management Bureau for public scoping.

Bureau for public scoping.

SMCPC said the deployment of modular, fast-start, high-speed, quick-response, small-capacity, diesel-fired generating units would alleviate the power supply delivery and voltage stability issues in Zamboanga.

PHL biodiversity to get lion's share in global environment cash pool

HE protection and conservation of the country's rich biodiversity will be getting the proverbial lion's share under the 8th replenishment cycle of the Global Environment Facility (GEF8), an official of the Department of Environment and Natural Resources (DENR) said.

AlO. Orolfo, director of the DENR Foreign Assisted and Special Projects Services, said that with over \$52-million in total allocations the Philippines is expected to "narrow the gap" for biodiversity spending. The allocation is one of the largest in Southeast Asia.

There are a dozen proposed projects for GEF 8 funding and five focal areas in which these projects are categorized. Seven of the proposed projects fall under "climate change," three under "chemicals and wastes

and land degradation" and two projects under "International Waters."

The DENR said the FASPS will be working with the GEF Secretariat and various implementing multilateral financing agencies in overseeing the project's implementation during the 4-year cycle covering the years 2023 to 2026.

Inimplementing the GEF-funded projects, the DENR hopes to advance the country's efforts to address environmental issues. These efforts include: tackling the drivers of ecological degradation; strengthening the country's commitments to multilateral environmental agreements and contributing to global environmental benefits; supporting integrated approaches; and, ensuring that programs are inclusive and prioritizes the most vulnerable.

Private capital

THE projects are also being eyed to

help realign private sector capital to achieve wider scale and impact, empower local communities to harness their contributions, strengthen their capacities, protect their livelihoods, uplift their socio-economic conditions, and enhance resilience.

The GEF is the largest multilateral fund dedicated to addressing environmental threats. Established as a \$1-billion pilot program of the World Bank during the 1992 Rio Earth Summit, the cash pool was created to fund environmental actions by developing countries.

The GEF funding window now serves as a financial mechanism for the UN Convention on Biological Diversity (CBD), Persistent Organic Pollutants (POPs), UN Convention to Combat Desertification (UNCCD) and the Minamata Convention on Mercury.

Now on its eighth replenishment cycle, the GEF grants have reached a

total of 774 million with co-financing reaching over \$5 billion with the support of agencies like the Asian Development Bank and the World Bank, among many others.

Counter-financing

IN presenting an overview of the GEF in the Philippines during a forumlast January 18, Orolfo noted the evolution from the piloting phase during the first to third GEF rounds, the "taking-off period" under the fourth to fifth GEF rounds, Institutionalization under GEF 6, and "Going for Greater Impacts" under the GEF 7.

"Now GEF 8, we have adopted 'Systematic and Transformational Strategies' that will support integrated approaches and ensure programs are inclusive and prioritizes the most vulnerable projects with potential for scalable transformation or impacts," he said.

According to Orolfo, the FASPS

and the GEF Secretariat along with other GEF agencies will integrate the different proposals.

different proposals.

"We are adopting the integrated approach because it is stronger and better in terms of impact," he said.

Orolfo said the 40-percent increase in the allocation for the PHL "is an opportunity to provide some financing gaps to funding different environmental concerns."

He said the government and the GEF actors will adopt metrics to measure the impact of the projects.

"In the end, it should trickle down to the communities but, at the same time, it should also have a global impact," Orolfo said.

"From the project implementors, we expect them to consolidate resources."

He noted the GEF allocation for the Philippines would be buffered by cash and non-cash counter-financing.

Germany extends ₱2-B aid for PH climate actions

ermany has extended around \$\frac{1}{2}\$ billion or 50 million euros assistance to the Philippines for the country's proenvironment initiatives.

This came after German Foreign Minister Annalena Baerbock met her Filipino counterpart, Department of Foreign Affairs (DFA) Secretary Enrique Manalo, who was touring various German cities for a series of activities, including fostering bilateral ties and participating in a security conference.

According to the German Foreign

Office, it is important for Germany to strengthen its cooperation with its partners in the Indo-Pacific region.

"As one of the countries most affected by the climate crisis, the Philippines has embarked on an ambitious course in their transition toward renewables. As a partner country of the German Climate Initiative, we are supporting them with over €50 million," it said, reiterating Baerbock's commitment to Manalo.

Aside from climate support Germany also expressed intention to intensify its cooperation with the Philippines to attract more skilled workers as the latter's "largest trading partner" in the European Union as well as support for the peaceful resolution of conflict in Mindanao.

In his Twitter posts, Manalo said he is "very pleased to have had a comprehensive meeting" with Baerbock in Berlin, when they "exchanged views on regional security issues, including West Philippine Sea and the Ukraine crisis."

"We reaffirmed the importance of a rules-based international order and the peaceful settlement of disputes. We agreed to increase cooperation on climate change, renewable energy, trade and investment, labor and human rights, among others," he added.



Climate action setbacks as countries go back to fossil fuels and nuclear energy

THE world is still struggling with the energy crisis as the global economy continues to slow down and the price of energy remains high. This was exacerbated by the Russia-Haraine conflict which



react, know that this is a drop in the bucket of

overall global greenhouse gas emissions. The EIU Energy Outlook 2023 is forecasting some global setbacks in climate action, namely the UN Sustainable Development Goals. Despite the SDG targets to reduce carbon emissions, including the failed Paris Agreement, we will see a growth in the consumption of coal again to compensate for the need for gas supplies. Extreme weather conditions will also push many countries to rely on fossil fuels, delaying the commitment to transition to clean energy. We may see a surge in renewable energy consumption in Asia, but investment in this sector will weaken as funding countries will have to prioritize dealing with their domestic energy crisis. And interestingly, some governments will reconsider their efforts to phase out nuclear power.

These setbacks in climate action strategies may just be the reality check that Bjorn Lomborg of the Copenhagen Consensus has been alluding to. In many of his reports, articles and interviews, he stated that the panic on the apocalyptic forecasts from climate change has caused many governments to come up with bad and unrealistic climate policies. He is not a climate change denier, far from it. Climate change is real. Temperatures are rising. But Lomborg says more people die from extreme cold than from heat. He has numbers, after all, he runs a think tank. He advocates for smarter and saner policies and investment in research and innovation to mitigate and adapt to climate change. It cannot simply be solved by transitioning to renewable energy. Besides, this quest to switch to all renewables comes at a bigger cost to poor countries, such as the Philippines, which haven't had the benefit of building wealth from the Industrial Revolution.

The EIU forecasts an increase in coal usage due to extreme weather events such as droughts,



heat waves and typhoons. Droughts will affect river systems such as the Yangtze in China, the Danube and the Rhine in Europe, and the Colorado River in the US. This may impact hydropower generation

and force countries to fall back on coal. Heat waves could also lead to more blackouts as this increases power demand for air conditioning use. The EIU forecasts China and India to rely back on coal as hydro power accounts for 10 percent of their electricity generation.

As all countries in the Global North and South deal with their own domestic energy crises, this may set back any gains in pushing for climate finance. Again, it will be the developing countries that will be impacted. The Philippines has been clamoring for climate justice in the form of finance. We have been badly battered by typhoons caused by the La Niña and El Niño cycles, which are now generically referred to as climate change, for more than two decades. This brings me back to what President Ferdinand "Bongbong" Marcos Jr. said in his speech at the UN General Assembly in September 2022. "The effects of climate change are uneven and reflect a historical injustice: Those who are least responsible suffer the most. The Philippines, for example, is a net carbon sink, we absorb more carbon dioxide than we emit. And yet, we are the fourth most vulnerable country to the effects of climate change." The President emphasized the need for nations to correct injustices by accepting their share of responsibilities. We may expect to see a shift in public sentiment in countries that initially committed to funding global climate mitigation solutions, as they deal with their own volatile economic and geopolitical environment domestically.

A very interesting point in the EIU report is the idea that some governments may rethink their plans to phase out nuclear power. Japan, whose Fukushima Daiichi disaster in 2011 prompted not just their own cancellation but many other countries' idling of nuclear plants, now plans to restart seven nuclear reactors by the summer of 2023. Japan has 23 commercially operable but offline nuclear reactors. We may also see Germany, which gradually shut down nuclear power plants since the Fukushima disaster, make a U-turn on its nuclear policy due to the energy crisis.

The Philippines continues its commitment to expand renewable energy sources like hydropower, geothermal, solar and wind, as promised by BBM in his July 2022 SONA. It'll be interesting to navigate through a world where both rich and poor, northern and southern countries are experiencing the energy pinch. We stay the course. After all, resiliency, a word that has been trivialized by the culture wars, is actually not a bad thing in the discussion on climate change policies.
