Sibuyan mining firm suspends operations

CITY OF CALAPAN—Following a weeklong protest against its mining exploration activities on Sibuyan Island in Romblon province, Altai Philippines Mining Corp. (APMC) announced on Monday that it was voluntarily suspending its operations.

In a statement, the company said it had decided to suspend all its exploration and testing activities on the island as it began coordinating with authorities to address the concerns or issues raised by protesters related to its operations.

"[APMC] is committed to maintaining the highest standards of environmental responsibility and community engagement," it said. The company did not say if and when it would reopen.

Earlier, the APMC was cited by the Department of Environment and Natural Resources (DENR) on Feb. 4 for violations, including building a causeway without an environmental clearance and cutting trees without a permit. It was ordered to suspend work on the causeway and to explain within 10 days why it should not be fined for violating the Forestry Code.

No reaction

In its announcement on Monday, the company did not address the issues raised by the DENR.

Instead, it said that its priority was "to maintain peace and order, to ensure the concerns and well-being of the Sibuyanons, and to ensure that no parties are negatively impacted by our operations."

Antimining residents, however, said that they would continue barricading APMC's port in San Fernando town to ensure that the company's trucks would not haul nickel ore from its mining site on the island.

"We will still hold the line even if [APMC] voluntarily suspends [its] operations. We will continue our barricade," Rodne Galicha, leader of the protestors, said in a Facebook post on Monday.

According to the residents, the mining company did not obtain the necessary permits to operate on the island, which covers Romblon's towns of Cajidiocan, Magdiwang and San Fernando.

Antimining advocates expressed concern that the "illegal" mining activities of APMC would destroy the unspoiled ecosystem of the crescent-shaped island.

Since Jan. 29, protesters have formed a human barricade to stop the company's hauling trucks from leaving the port as they called on authorities to suspend mining operations on Sibuyan.

On Feb. 3, two residents were injured when police officers tried to disperse the protesters who were blocking the path of the trucks.

Senate investigation

Sen. Risa Hontiveros called for an investigation of the clashes between local police and residents, as she filed proposed Senate Resolution No. 459, which urged the legislative body to look into the mining activities of APMC on the island.

"The peaceful resistance being put up by residents against the supposed aggression by a mining company need not end in violence, as it seeks to invade their places of abode. Barricading residents only wanted to protect the natural resources of their locality and they are well within their rights to protest," Hontiveros said on Monday. No

Altai defends legality of Sibuyan, Romblon mining operations

A LTAI Philippines Mining Corporation (APMC) on Monday belied allegations that its operation on Sibuyan Island in Romblon province is unlawful, saying the company has secured all necessary permits and licenses to lawfully and peacefully conduct business in the area.

In a statement, APMC said its operation began many years before it even set up camp on-site by undertaking comprehensive environmental and socioeconomic studies and outcome analyses.

The mining company said it has also consulted with government regulators and agencies, and engaged the surrounding communities to ensure that operations will be safe, legitimate, and with minimal environmental effects.

"Given this, we categorically deny all allegations questioning the legality of our Sibuyan operations. Our company has secured all the necessary permits and licenses to lawfully

lines set by the law.

"We would like to assure the public that APMC will continue to strictly and uncompromisingly adhere to all laws pertinent to our activities, for the current exploration and future development, operation, and rehabilitation plans. We pray that those who may have grievances against this will observe the same," the company said.

The company said it remains committed to ensure that its mining operations involve and respect all stakeholders, minimize environmental impact, and prioritize a fair division of socioeconomic benefits.

The Social Action Network and Caritas Philippines, for its part expressed "serious concern over the recent events in Romblon and stand in solidarity with its people who are taking the boldest stance to protect their only home—the beautiful, ecologically rich, and peaceful Sibuyan Island."

In a statement, the group said:

We strongly support the Diocese of Romblon's efforts to protect the environment, by opposing the and peacefully conduct our business in the area," APMC said.

According to APMC, the company's right to operate is "as inviolable as the right to peaceful protest and assembly."

To recall, a series of protests in SanAntonio, Romblonledbyagroup calledSibuyanonAgainstMininghas reportedly resulted in the violent dispersal of protesters last week, injuring two people.

Subsequently, following the protests, the DENR issued a Notice of Violations (NOV) to the company, followed by the call for the government to issue a cease-and-desist order to stop the company's operation on the island.

APMCsaiditis deeply saddened by the recent hostilities that happened near the vicinity of the company's mining exploration operations.

"Based on reports, there were a few incidents involving our employees, law enforcement personnel, and protesters who were purportedly hurt when tensions got out of hand at the site. Our company has exhausted all means to help those

It is for that reason that the APMC said it has repeatedly reached out to the protesters to establish dialogue, and hopefully find common ground.

"We hoped that we could assure them that our activities are lawful and compliant to government requirements, and fully aligned with global best practices. Unfortunately, these efforts did not bear fruit," the company said.

Probe of Sibuyan mining sought

A SENATOR has sought a probe of nickel and metallic mining operations on Sibuyan island in Romblon province south of the Philippines after residents set up a human barricade to block these activities.

"The Senate should hear all stakeholders' and unravel the layers of issues that have plagued Sibuyan island for decades," Senator Ana Theresia "Risa" N. Hontiveros-Baraquel said in a statement on Monday.

"Large-scale mining is already damaging the environment, but if seems that the company is still breaking laws in the conduct of their business." she added in Filipino, referring to Altai Philippines Mining Corp. "There are repeated reports about the violence caused by mining companies and it's time the government really listened to the community's grievances."

In a statement, Altai said it is "committed to maintaining the highest standards of environmental responsibility and community engagement."

"In line with this commitment, we have decided to voluntarily halt all exploration and testing activities in Sibuyan Island and to continue our full cooperation and coordination with the relevant authorities to address any concerns or issues that have been raised," it added.

At least two residents got injured due to police dispersal, she said, citing news reports. "The residents' peaceful resistance to the intrusion of mining companies in their own homes should not turn into violence."

"Residents just want to protect the natural resources in their area," she added. "The residents are well within their rights to protest."

Ms. Hontiveros said Sibuyan residents have been fighting for close to two decades to stop mining exploration in their area. But the island soon became a mining hotspot for its nickel resource.

Escalation of mining activities, she said, increased further in September 2021 after the Environment department lifted its cease-and-desist order against Altai.

By December 2022, a mineral ore export permit had been issued to the company, allowing it to bulk test 50,000 metric tons of ore. But residents said the company had failed to get a village clearance, municipal business permit and foreshore lease contract from the Environment department, as well as a permit to build a private port from the Philippine Ports Authority.

The Department of Trade and Industry has said the Philippines would prioritize nickel exports as a core economic strategy.

"This economic prospect can urge mining companies to aggressively do business that will undermine the rights and welfare of the people of Sibuyan," Ms. Hontiveros said. "With the desire to advance quickly, they don't realize that there are already people being stepped on."

The senator noted Sibuyan's distinction of being "the Galapagos in Asia" for its extraordinary flora and fauna.

"We in the Senate should help champion the conservation of the island's endemic flora and fauna, defend its coastal communities from long-term ecological devastation and protect the residents from violent incursions of mining companies," she said. — Alyssa Nicole O. Tan

Gatchalians behind Sibuyan mining ops?

Militant group Alyansa Tigil Mina on Monday bared that "Plastics King" William Gatchalian is the one behind the questionable mining operations of the Atlai Philippines Mining Corp.

The ATM alleges that the Gatchalians own APMC. They claim that Gatchalian's involvement in the mining company is through his son Kenneth, who is also a director of APMC's parent firm.

The group provided the Daily Tribune some documents showing that Kenneth Gatchalian sits as chairman of Wellex Mining Corp., one of the 23 mining firms ordered closed in February 2017 by the Department of Environment and Natural Resources under then Secretary Regina Lopez.

The ATM also said Kenneth Gatchalian is the direct beneficiary of Dynamo Atlantic Ltd. that acquired Sibuyan Nickel Properties Development Corp., partner of Altai Philippines Mining Corp. whose president is a former official of the Wellex Group.

Kenneth Gatchalian is the brother

of Senator Sherwin Gatchal an who was recently appointed Department of Social Welfare and Development Secretary Rex Gatchalian.

Operations ceased

Over the weekend, the DENR had ordered APMC to cease its operations in Romblon due to lack of permits.

The department issued the order stopping the mining company's operations on Saturday after Sibuyan residents clashed with police to halt APMC's mining activities in their community.

According to a notice of violation issued by the DENR-Mimaropa Environment Bureau, Altai Philippines Mining Corporation had violated the implementing rules and regulations of the Water Code of the Philippines

The DENR alleged that APMC did not have a foreshore lease agreement for a pier, had built a causeway without securing an Environmental Compliance Certificate, and had cut down trees without a permit.

Sibuyan mining activities slammed

THE Catholic Church in the Philippines yesterday denounced the controversial mining activities in Sibuyan Island, saying the project of the Altai Philippines Mining Corporation (APMC) will not serve the interest of Romblon and will only damage the environment.

In a unified statement released by the Caritas Philippines, several dioceses and archdioceses, social action centers, and Caritas organizations called for the halt in the mining operations in Sibuyan Island

operations in Sibuyan Island.

"The Social Action Network and Caritas Philippines express serious concerns over the recent events in Romblon and stand in solidarity with its people, who are taking the boldest stance to protect their only home – the beautiful, ecologically rich, and peaceful Sibuyan Island," said the joint statement.

"We call on Altai Philippines Mining Corporation and other conglomerates to stop destructive mining," it also said, adding that the mining activities will only further escalate the degrading of the island's natural resources.

Worse, they said the project will not bode well for the communities living in the island, especially in the long term.

"We believe that the project would not serve the overall interests of the province and would pose a threat, particularly to the lives and lands of the communities on the island, and the rich biodiversity in the area," they said.

"We feel a moral duty to safeguard and uphold the well-being of our shared environment," they added.

The APMC, in a statement, announced it has "decided to voluntarily halt all exploration and testing activities in Sibuyan Island and to continue our full cooperation and coordination with the relevant authorities to address any concerns or issues that have been raised."

It reiterated that it is "committed to maintaining the highest standards of environmental responsibility and community engagement"

engagement."

"Our priority is to maintain peace and order, to ensure the concerns and well-being of the Sibuyanons, and to ensure that no parties are negatively impacted by our operations. We pride ourselves as stalwarts of sustainable and responsible mining, so we take this as an opportunity to address all recent concerns brought up against our Sibuyan exploration. We look forward to working with all stakeholders to resolve any outstanding concerns," it also said.

Aside from calling on the mining firm to cease its operations, the Church organizations also called on the national government to perform its true mandate.

"We urge the Department of Environment and Natural Resources, as well as all government offices, to prioritize protecting people and nature before vested socio-economic and political interests," they said.

Similarly, the groups appealed to the police authorities to maintain partiality towards justice.

"We bid all law enforcement agencies to rightfully serve justice," said the groups.

Expressing solidarity and agreement with the unified statement are 63 dioceses and archdioceses, 30 social action centers, and 23 Caritas organizations.



N official of Barangay España, San Fernando, Romblon on Monday said that the human barricade of residents will continue despite the suspension order issued by the Department of Environment and Natural Resources (DENR) Mimaropa Regional Office against Altai Philippines Mining Company (APMC).

In a radio interview, Barangay España Councilor Jhay Romero said that residents will continue barricading as the ship, barge and trucks of APMC remain in the area.

"Our barricade will continue as we are still monitoring the ship at the pier, as well as the trucks," Romero said.

Residents of Sibuyan Island in Romblon formed a human block-ade to prevent the mobilization of trucks loaded with ore.

Romero noted that at least seven trucks of APMC are still parked in

"The police are also here watch-ng us," he said. According to Romero, the min-

ing company failed to secure permits from the village and mu-nicipality. At the same time, he criticized

the police for allegedly siding with the APMC after they allowed the entry of three trucks carrying

"The police should side with the residents of Barangay España but the chief of police signaled as caught in the video to allow the entry of the trucks," Romero said.

He claimed that the APMC transported at least 20 trucks to operate on the island.

He noted that he was even hand-cuffed by the police even though the barricade being conducted in

the area remains peaceful.
"We have been barricading the area for 12 days and we even provided the police with snacks like sweet potatoes, coffee and bread because we thought they were on our side," Romero said.

He added that the police did not entertain his complaint against the personnel who handcuffed him.

Manila Water: DENR should accept SC order

MANILA Water Co. on Monday said it would abide by a Supreme Court decision that I no Inc., Manila Water and MWSS for their settled fines imposed against the firm and noncompliance with the Clean Water the Manila Waterworks and Sewerage Act. From the previous P921 million, System (MWSS) for violating the Clean the tribunal reduced the fine to P202

In a disclosure filed with the Securities and Exchange Commission (SEC), Manila Water said it was jointly and severally liable with the MWSS for a total amount of P921,464.184.

The Supreme Court denied a motion for partial reconsideration filed by the Office of the Solicitor General for the respondents, Department of Environment and Natural Resources (DENR), et.al.

It also ruled that no further pleadings or motions would be entertained and that entry of judgment would also be made immediately.

"With this denial by the Supreme Court of the government's Motion for Partial Reconsideration, the DENR will have no basis to continue to refuse to accept the company's payment of fines as computed by the court," Manila Water said.

Aside from the solidary liability to pay the fines as modified by the July 19, 2022 resolution of the Supreme Court, the firm is required to submit a completion plan for the establishment and operation of water, sewerage and sanitation projects covering the period up to 2037, to include periodic five-year completion targets with the end-goal of achieving 100 percent water, sewerage and sanitation coverage.

The high court earlier cut down fines

imposed on Maynilad Water Services

The Supreme Court in 2019 fined Maynilad and MWSS P921,464,184 and separately fined Manila Water and MWSS the same amount.

The water concessionaires were "found liable for violation of Sec. 8 of the Philippine Clean Water Act," which requires the connection of existing sewage lines in all subdivisions, condominiums, commercial centers and other establishments, including households, to an available sewerage system.

In 2009, the DENR imposed a P29.4-million fine against MWSS, Maynilad and Manila Water for having failed to install and maintain wastewater treatment facilities within five years after the Clean Water Act was enacted in 2004. The Court of Appeals (CA) upheld the DENR's decision in 2013.

Both Maynilad and Manila Water filed separate motions for reconsideration, where they called on the Supreme Court in 2019 to reverse the CA decision as it was "impossible" to establish a complete centralized sewage system within five years.

According to Manila Water, it now operates 41 treatment facilities, and is increasing wastewater treatment capacity by 925 percent, from the previous 40 million liters per day (MLD) to 410 MLD at present.

Manila Water readies plan for sanitation projects until 2037

MANILA Water Co., Inc. on Monday said that it would submit its completion plan to build and operate water, sewerage and sanitation projects until 2037.

In a regulatory filing on Monday, Manila Water said it had received on Monday a copy of the Jan. 17, 2023 notice from the Supreme Court (SC) that "denied with finality" a motion for partial reconsideration filed by the Office of the Solicitor General (OSG) for the Department of Environment and Natural Resources (DENR).

"It also stated that no further pleadings or motions will be entertained, and that entry of judgment will be made immediately," the listed company said.

With the denial, the DENR will have no basis to continue to refuse to accept the company's payment of fines as computed by the court, Manila Water said. The fines were imposed on the water concessionaires in their case for non-compliance with Republic Act No. 9275 or the Philippine Clean Water Act of 2004.

Aside from the fines, the company said the SC notice also mandated the east zone water concessionaire to submit as required by its legislative franchise a plan for the establishment and operation of water and sanitation projects until the 2037 period.

This includes a five-year completion target, which will achieve 100% water, sewerage and sanitation coverage by 2037.

In October last year, the SC unanimously affirmed its 2019 ruling that the Metropolitan Water Works and Sewerage System (MWSS), Manila Water, and Maynilad Water Services, Inc., should be held liable for violating Section 8 of the Clean Water Act.

However, the High Court also allowed the lowering of the fines imposed on the two concessionaires to P30,000 per day from P200,000 per day from the day of the violation on May 7, 2009 to Jan. 21, 2022, which amounts to P202.26 million.

in 2009, the DENR filed a complaint against MWSS ar 3 its concessionaires, Maynilad and Manila Water, for their failure to provide, install, operate, and maintain adequate wastewater treatment facilities for the

sewerage system, resulting in the degraded quality and beneficial use of the receiving bodies of water leading to Manila Bay.

Section 8 of the Clean Water Act manclates the connection of existing sewage lines in all subdivisions, condominiums, commercial centers and other establishments, including households, to an available sewerage system within five years from the law's effectivity in 2004.

Manila Water said it made several attempts to pay the fine but the DENR rejected the payment. The OSG then filed a motion for partial reconsideration on Nov. 2, 2022.

In the SC notice denying the motion, the court said that "the issues raised by the OSG have been passed upon and no substantial arguments were presented to warrant the reversal."

Meanwhile, Maynilad is set to spend aroun 1 P3.2 billion for the construction of four modular treatment plants in Cavite, the west zone water concessionaire said on Monday.

"Cavite is the farthest point of our concession area, so there are portions that do not yet receive 24-hour water supply. The new modular treatment plants will draw water from adjacent dams, and serve as a dedicated supply source that can lengthen supply availability for these underserved areas," Maynilad Chief Operating Officer Randolph T. Estrellado, said in a media release on Monday.

The modular treatment plants are expected to be completed between 2023 and 2024, these will be located in the province of Cavite in the cities of Bacoor and Imus, the four modular treatment plants will have a combined water output of 47 millior liters per day (MLD) which can provide water supply to about 200,000 households.

Metro Pacific Investments Corp., which has a majority stake in Maynilad, is one of three Philippine units of Hong Kong-based First Pacific Co. Ltd., the others being Philex Mining Corp. and PLDT Inc. — Ashley Erika O. Jose

Restoring Pasig River

FIRST, the Tullahan River.

This year, San Miguel Corporation (SMC), one of the country's most diversified companies, is poised to accomplish another feat: the rehabilitation of the historic Pasig River.

Approximately 27 kilometers long, Pasig River connects Laguna de Bay and Manila Bay.

The main Pasig River passes through the cities of Taguig, Pasig, Makati, Mandaluyong and Manila, and the municipality of Taytay in Rizal.

The river system has four major tributaries— Marikina, Pateros-Taguig, Napindan and San Juan—and 43 minor tributaries such as creeks and esteros mostly in Manila.

Pasig River, which played an important role in the development of Manila and its neighboring cities and town, was was famous for its pristine waters.

It was not only a source of water, livelihood nor a transport route; it was also a place for recreation.

I came across a speech by the late President

Ferdinand E. Marcos Sr. delivered before the Philippine Jaycees in 1970 where he reminisced about Pasig River.

"I remember when I was young, I used to be a member of an outboard motorboat race's group, and we used to race down the Pasig River. I turned turtle right in front of Malacanang, or rather, just behind Malacanang. But the water was so clear that it was a pleasant swim to the river bank," the late president said.

That was the Pasig River before the onset of rapid urbanization and settlements of informal settlers along its riverbanks.

Apart from pollutants from factories and households that end up in the river, the proliferation of water hyacinth and other seasonal phenomena such as algal bloom, and salt water intrusion have contributed to the river's water quality.

Over the years, several attempts have been made in the hope of rehabilitating and reviving the river to improve its water quality and flood water carrying capacity, and restore its environmental integrity.

The regent pronouncement by SMC

President and CEO Ramon S. Ang that SMC expects its P2-billion Pasig Clean-up project to surpass the one million metric tons threshold in silt and solid waste extracted from the river this month is good news to all of us.

According to SMC, the dredging teams will focus efforts on both ends of the river where water flow restriction is usual.

SMC's clean up teams have removed a total 927,198 metric tons of silt and waste from the Pasig River to date. Monthly, SMC targets to extract more than 70,000 tons.

Being an archipelago, the country is highly vulnerable to water-related hazards. Manila and its neighboring cities and towns along bodies of water are prone to flooding especially during the rainy season and onslaught of typhoons.

The rehabilitation of the Pasig River will mitigate the flooding in these areas as its flood-carrying capacity has vastly improved.

The dredging and de-silting of the river increased the depths to five-six meters from just two-three meters when the project started.

"Hopefully, by the time the rainy season sets in later this year, our cities will feel the benefits of the Pasig River's larger carrying capacity, along with government's other flood mitigation and control programs," RSA said.

With its increased hydraulic capacity, Pasig River as a transport route will also be vastly improved. River ferries will be able to provide better intra-city connectivity and help decongest thoroughfares in the metropolis.

The rehabilitation of the Pasig River is the second initiative of SMC in support of DENR's Adopt-A-River Program after the Tullahan River rehabilitation.

It also contributes to efforts being undertaken in compliance with the continuing Supreme Court mandamus to clean up the Manila Bay.

It is the largest such initiative by a single entity in the country which I hope will inspire other entities from the private sector to emulate.

The Memorandum of Agreement for the implementation of the P2-billion Pasig Dredging Project was signed between DENR and SMC on June 9, 2021.

The rehabilitation of the Tullahan River which was completed in 27 months and the ongoing Pasig River project are just two initiatives of SMC led by RSA that demonstrate the conglome ate's love for the country.

Like SMC and RSA, we too can show our love for cur country by becoming good stewards of the country's resources.

PMA wins case over 28-hectare property

BAGUIO CITY – The Philippine Military Academy (PMA) has won in a land dispute case involving a 28-hectare property located within the military reservation.

In a ruling issued on Jan. 19, the Municipal Trial Court in Cities (MTCC) Branch 1 affirmed the PMA's right over the disputed land and declared the claimants guilty of encroachment.

The ruling came two years after the PMA filed a case against the respondents, who claimed to be the heirs of a certain Gusec Dacdacan.

The court cited a survey report of the Department of Environment and Natural Resources (DENR) confirming the contested land is part of the military reservation, which was established through Proclamation 2405.

through Proclamation 2405.

Although the claimants possessed a survey plan approved by the DENR in 1961, the court ruled that it was not sufficient to prove their ownership over the land.

The court said there were no records showing the legality of the claimants' entry into the disputed property.

It said the claimants have no right over the land due to a pending status of their petition for a Certificate of Ancestral Land Title (CALT) with the National Commission on Indigenous Peoples (NCIP).

Peoples (NCIP).

"The NCIP has no policy directions yet on the processing of CALTs in the city of Baguio," the court said.

It also cited a Supreme Court ruling in 2019, stating that the NCIP does not have any legal power to reclassify lands that were previously included as part of the Baguio Townsite Reservation, as provided under Section 78 of Republic Act 8371 or the Indigenous Peoples' Rights Act of 1997.

The respondents admitted that they along with other claimants have repeatedly entered the property and introduced some improvements despite being told by the PMA that the area is within the military reservation.

The court said such acts violate Presidential Decree 1227, which penalizes unlawful entry into any military base in the country.

The respondents were sentenced to 10 days in prison and ordered to pay a fine of P100 each. — Artemio Dumlao
