DENR-PhilSA creating geospatial database

The Department of Environment and Natural Resources and the Philippine Space Agency this week sealed a partnership to create the national environment and natural resources (ENR) geospatial database.

A memorandum of agreement was signed between Environment Secretary Antonia Loyzaga and PhilSA Director General Dr. Joel Joseph S. Marciano Jr. for a collaborative project of using satellite imagery in creating the national ENR geospatial database, and in other related programs of the DENR.

"A geospatial platform is fundamental for us in terms of establishing the physical basis of our natural resources, and in terms of our wanting to inventory them for strategic and critical development of our country," Loyzaga said

The MoA specifically covers two initiatives: the National Greening Program progress monitoring through the use of current and emerging space science and technology applications capabilities in the country, and the establishment of a comprehensive national geospatial database for the Environmental and Natural Resource Accounting Program, which includes the collection of climate information and conduct analysis.

PhilSA will be responsible in developing and generating maps, systems and tools on a national level that analyzes vulnerabilities and impacts of climate change and disasters, among many others:

DENR urged to revoke MPSA of Altai

AN official of the Sibuyanons Against Mining on Tuesday said that the Department of Environment and Natural Resources (DENR) should revoke the mineral production sharing agreement (MPSA) of Altai Philippines Mining Company (APMC) after the DENR ordered the suspension of its mining operation in Romblon.

In a radio interview, Sibuyanons Against Mining coordinator Elizabeth Ibañez maintained that the actions of the DENR against APMC were not enough.

"Our call is to ensure that APMC will permanently leave the area by revoking the MPSA of Altai. Until the mining company leaves the

area, we will not be at peace as it is possible that they will resume their operation in the mountains," Ibañez said.

DENR Mimaropa regional director Joe Amil Salino has ordered the APMC to suspend its mining operation in Sibuyan Island as he issued notice of violation against APMC for operating a causeway project without an environmental compliance certificate.

Ibañez added that as of Tuesday, ores from the barge were still being unloaded at the pier.

"The ore from the barge that was supposed to be transported to China, was being unloaded at the pier. The problem is the soil

is being dumped at the pier. Once it rains, it will be washed out into the ocean. It will contaminate the water," Ibañez noted.

According to Ibañez, the DENR should ensure that APMC should be held liable amid the various violations it committed.

"The mining company committed a lot of violations. It caused the destruction of the mountain, including the denudation of forest. Many people were also hurt, The activities caused inconvenience to the residents," she added.

At the same time, Ibañez echoed the statement of Councilor Jhay Romero of Barangay España, San Fernando, Romblon that the

human barricade of residents will continue.

The police are still there claiming they are allegedly maintaining the peace and order. Until then, we will maintain our barricade as we are awaiting concrete action from the government. We cannot afford to lower our guard as once the cease and desist order is lifted, the operation of Altai will resume," she said.

Ibañez also welcomed the announcement of Sen. Ana Theresia "Risa" Hontiveros that she will file a resolution calling on the Senate to formally look into the violations of APMC.

Halt to mining in Sibuyan suspicious

For now, the Altai Philippine Mining Corp. (APMC) has ceased its operations to extract nickel ore from Sibuyan Island in the town of San Fernando, Romblon. The human barricade did well in drawing media attention to the serious concerns of island residents and environmentalists.

This halt, though, is not the result of legal action or government sanctioning, so it is non-binding. Altai has only agreed to stop its mining activities until after sorting out three violations pointed out by authorities.

From the APMC's standpoint, this is just a hiccup in its 25-year operation plan to mine the area. Even if protesters were correct in claiming that it had been operating illegally, there seems to be no resolve on the Department of Environment and Natural Resources (DENR) to shut the mining firm down.

If Altai eventually gets its way, what's bothersome is that the government shall have demonstrated how poorly it upholds laws to protect the environment and the community living in resource-rich areas.

Obviously, we haven't learned enough from the Marcopper disaster to demand more than just minimum compliance from today's mining firms.

Back to bullying

China is back to its bullying tactics in the West Philippine Sea. This time it is using two of its coast guard ships and two other maritime militia vessels to test the patience of our very own navy ship BRP Andres Bonifacio (PS-17) near Panganiban Reef.

What happens at sea directly represents President Xi Jinping's two-faced diplomacy toward the Philippines.

Too many, too often, too blatant, too antagonistic, and too oppressive have been the encroachments made by Chinese vessels in the WPS that our fishermen have lost their

livelihood and our sovereign rights over our maritime borders trampled on.

So, here we are now, forced to look at the option of holding joint

coast guard patrols with our defense ally, the United States. Maybe, China doesn't want that to happen; but they sure were asking for it.

'Doctored' by doctors?

The country's leading forensic pathologist, Dr. Raquel Fortun, must be sick to her stomach that her recent review has exposed how doctors certified as "natural causes" the deaths of drug war victims who agents of the law had gunned down.

We can save the planet

Legarda optimistic about ozone recovery: We can win the fight against climate change

enator Loren Legarda recently expressed optimism that humanity could win the fight against climate change if global policies and actions were put in place and implemented to significantly cut down greenhouse gas emissions, similar to the ef-fort against ozone-depleting substances (ODS).

Legarda cited a 2022 report by the World Meteorological Organization (WMO) that the ozone layer-which protects the planet from harmful ultraviolet rays and was thinning in the 1980s due mainly mately 0.5-1°C by mid-century, compared to an extreme scenario with an uncontrolled increase in ODS of 3-3.5 percent per year.

"What we are doing for our ozone, we must now do for our climate. We already have the Paris Agreement as the landmark treaty on climate change, but countries must have the will to deliver on their commitments, most especially in undertaking significant and deep cuts on fossil fuel emissions and mobilizing finance, technologies, and capacity development support (NDCs) of countries are projected to result in a planet with a global warming level of at least 2.5 degrees Celsius, a degree beyond the 1.5°C climate threshold prescribed in the Paris Agreement and by scientists across the globe.
She added that the annual mo-

bilization of \$100 billion of climate finance for developing countries, starting in 2020, remains unmet and that opening more access to climate finance from public and private sources and philanthropies, and for multilateral development banks and financial institu-

to chlorofluorocarbons (CFCs)—is on track to recover to 1980 levels by 2040 in most parts of the world because of positive actions taken under the Montreal Protocol, a treaty adopted in 1987 to regulate and phase down ODS.

She also said that since the treaty entered into force in 1989, the use of CFCs has decreased by 99 percent. Compliance with the treaty has also resulted in a decline in

ODS emissions and avoidance of global warming of approxi-

to countries and communities who need it," Legarda explained. "Global and domestic policies that favor a transition toward a low carbon and climate-resilient development path must also be put in place, particularly in utilizing renewable energy resources, adopting sustainable systems and technologies, and shifting to a circular economy."

The senator said that current commitments contained in the Nationally Determined Contributions

tions to improve their business models to accept risks and leverage finance for developing countries is needed.

"The depleting ozone layer was such a huge environmental concern back then, but we were able to diagnose the problem and unite to address it. The recovery of our ozone layer is a sign that we are capable of healing our climate and gives us more reason to hope for a better planet and future for all," Legarda concluded.


In a video message, MWSS Trustee and NFWC Director Melanie Lambino cited the importance of planting trees and protecting the watersheds for water security.

Why was the Turkey-Sylla earthquake so deadly?

PARIS: A combination of factors made the powerful earthquake that struck Turkey and Syria early Monday par- following year. ticularly deadly, including its timing, location, relatively quiet fault line and the weak construction of the collapsed buildings, experts said.

More than 2,300 people have been killed by the 7.8-magnitude quake near Turkey's Syrian border, with the toll expected to grow as aftershocks reverberate throughout the day.

The earthquake caused such devastation partly because of its power to hit Turkey since 1939 - and because it hit a populated region.

Another reason is that it occurred at 4:17 a.m. (0117 GMT), which meant that sleeping people were "trapped when their houses collapsed," Roger Musson, honorary research associate at the British Geological Survey, told Agence France-Presse.

The construction of buildings was also not "really adequate for an area that's susceptible to large earthquakes," said the author of the book The Million Death Quake.

The epicenter of Monday's earthquake was at a relatively shallow depth of about 17.9 kilometers near the Turkish city of Gaziantep, which is home to around 2 million people.

It was caused by the Arabian tectonic plate moving northward, scraping past Turkey," Musson said.

"Because it cannot move smoothly, it sticks," he said.

"The release of that movement along it is the strongest earthquake the fault is what produces a major earthquake like the one we've had today."

Phivoles: Another magnitude 7.8 quake possible in I

IN the wake of the magnitude 7.8 earthquake that struck Turkey and Syria, the head of the Philippine Institute of Volcanology and Seismology (Phivolcs) yesterday said such a magnitude is also likely to happen in the country.

"There's always this possibility. In fact, it already happened on July 16, 1990. To recall, the 1990 Luzon earthquake is magnitude 7.8." Phivolcs Director Teresito Bacolcol said

Baco col added that the country has many active faults that are capable of generating magnitude 7.8 earthquakes.

Based on instrumental records, the 1990 Luzon earthquake is the strongest to hit the country, he continued.

According to Phivolcs' website, the 1990 Luzon earthquake produced a 125 km-long ground rupture that stretches from Dingalan, Aurora to Kayapa, Nueva Vizcava. The quake was caused by strike-slip movements along the northwest segment of the Philippine Fault Zone and its splay, the Digdig Fault.
