# **POLICY ISSUANCES**

To support the major programs and thrusts of the Department, the Secretary signed 19 policies in CY 2020.

## Manila Bay Clean Up Program

In support of the Manila Bay Clean Up Program which aims to restore the water quality of Manila Bay to class SB in accordance with the Writ of Continuing Mandamus of the Supreme Court, the management of the Pasig River Coordinating and Management Office (PRCMO) was transferred to DENR Central Office. This is provided under **DAO 2020-02** entitled, "Establishment of the Pasig River Coordinating and Management Office (PRCMO) at the DENR Central Office."

#### **Clean Air Program**

In order to further improve and maintain air quality that meets the National Air Quality Guidelines for Criteria Pollutants throughout the Philippines, the **DAO 2020-14** was issued establishing the Breakpoints for Particulate Matter 2.5 (*PM2.5*) Air Quality Index (*AQI*) and Amending Section 5(a) of DAO 2013-13 "Establishing the Provisional National Ambient Air Quality Guideline Values for Particulate Matter 2.5 (*PM2.5*)."

## **Forest Management**

The following policies were issued to further improve the management, protection and conservation of the country's forest land areas:

# **Enhanced Biodiversity Conservation**

Policies dealing with the conservation and protection of wildlife, and/or maintenance, restoration, and enhancement of their habitats were issued, particularly the following:
