Response to Queries/Clarifications:	
QUERIES/CLARIFICATIONS	RESPONSE
May we know your existing brand of network infrastructure for us to take into consideration compatibility of our switches?	The brand is Cisco. Particular Model: Cisco C9200-48P-E. Must support Cisco DNA (Intent based networking/SDN).
Would you allow or consider manufacturer standard for the access switch power supply rating? This is for the reason that power supply is dictated by the manufacturer to what is best for their devices.	Yes. As long as it can handle Poe+ Equipment specifically Wi-Fi 6 (802.11ax) Wireless Access Points and Cisco IP Phones.
May we know some protocols and features that you are currently using with your existing network? This is for the reason that some features and functionalities requires additional licenses.	Cisco Trunking Protocols, STP and VLANs.
We would want to clarify that the required transceivers are to be used or installed with the required Access Switch? In addition, no cables should be provided except for the stacking cable indicated under the switch?	Yes. Transceivers are to be installed specially during testing and only stacking cable in required.
Warranty covers only the supply and delivery of the access switches and transceivers but does not cover the configuration of the switches?	Yes. Warranty is for supply and delivery only.
May we request to allow a similar completed project contract with "Procurement of Network Switches/or Supply, Delivery and Installation of ICT Equipment" be considered?	Similar completed project with ICT equipment deliveries will be allowed as long as the Procurement of Network Switches is indicated in the deliveries and the cost of those switches must be at least 50% of the ABC of the project.

This Supplemental/Bid Bulletin No. 1 shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
