



CONTRACT

*Procurement of Storage Area Network (SAN) for
Geographic Information System (GIS) of the
Department of Environment and Natural Resources (DENR)*

KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT entered into on this 10 FEB 2021 in Quezon City, Philippines, by and between:

DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, a government agency created by virtue of Executive Order (EO) No. 192 dated 10 June 1987, with office address in Visayas Avenue, Diliman, Quezon City, represented herein by its Undersecretary for Legal, Administration, Human Resource and Legislative Affairs, **ATTY. ERNESTO D. ADOBO, JR.**, CESO / hereinafter referred to as “**DENR**”

- and -

TRENDS & TECHNOLOGIES, INC., a private corporation organized and existing under the laws of the Republic of the Philippines, with business address at 6th Floor, Trafalgar Plaza, H.V. Dela Costa St., Salcedo Village, Makati City, represented herein by its Key Account Manager, **GERRY BAQUIRAN**, hereinafter referred to as “**TRENDS**”

WITNESSETH: That

WHEREAS, the DENR conducted a competitive bidding for the project entitled *Procurement of Storage Area Network (SAN) for Geographic Information System (GIS) of the Department of Environment and Natural Resources (DENR)* with an Approved Budget for the Contract (ABC) of ₱ 9,000,000.00 per Bid Reference No. DENR-CO-2020-035 pursuant to Republic Act (RA) No. 9184 otherwise known as the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the bid of TRENDS was declared as the Single Calculated and Responsive Bid (LCRB) by the Bids and Awards Committee (BAC), and was approved by the Head of Procuring Entity, through his duly authorized representative;

WHEREAS, the DENR issued a Notice of Award (NOA) in favor of TRENDS;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties have agreed on the following terms and conditions:

1. The words and expressions in this Contract shall have the same meaning as are respectively assigned to them in the Conditions of Contracts hereinafter referred to.
2. The following documents as required by the 2016 Revised IRR of RA No.9184 shall be declared to form and be read and constructed as part of this Contract, viz.:
 - A. Philippine Bidding Documents (PBD);
 - i. Schedule of Requirements
 - ii. Technical Specifications (TS)
 - iii. General and Special Conditions of the Contract; and
 - iv. Supplemental/Bid Bulletin
 - B. Bid submission of TRENDS
 - i. Eligibility Documents
 - ii. Technical Documents
 - iii. Financial Documents
 - C. Notice of Award (NOA) received on 01 February 2021.
 - D. **Performance Security** in the form of Performance Bond issued by MAA General Assurance Phils., Inc. in the amount of **₱ 2,483,400.00**.
 - E. Other Contract documents that may be required by existing laws and/or the DENR in the PBDs. TRENDS agrees that any additional contract document or information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution, such as Notice to Proceed (NTP), Variation Order, and Warranty Security, shall likewise form part of the Contract.
3. Supply, delivery, installation, configuration and training shall be completed within sixty (60) calendar days from receipt of NTP.
4. The DENR shall pay TRENDS the amount of **EIGHT MILLION TWO HUNDRED SEVENTY EIGHT THOUSAND PESOS (₱8,278,000.00)** for the said project.
5. The DENR and TRENDS shall comply with the terms and conditions under RA No. 9184 and its IRR, and other applicable laws.
6. All other terms and conditions subsequently agreed upon by the parties after signing of this Contract shall constitute an addendum thereto and form an integral part thereof for all intents and purposes.
