DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, a government agency created by virtue of Executive Order (EO) No. 192 dated 10 June 1987, with office address in Visayas Avenue, Diliman, Quezon City, represented herein by its Director for Administrative Service, **ROLANDO R. CASTRO**, hereinafter referred to as "**DENR**"

FIRST DATACORP, a private corporation organized and existing under the laws of the Republic of the Philippines, with business address at 3F Citibank Center, 8741 Paseo de Roxas, Makati, represented herein by its Team Lead-Government Sector Unit, **CHRISTINE JOY O. CHUA**, hereinafter referred to as "**FDC**"

WITNESSETH: That

WHEREAS, the DENR conducted a competitive bidding for the project entitled Supply and Delivery of Microsoft SQL Server Enterprise Core 2 Software License for the Department of Environment and Natural Resources-Central Office (DENR-CO) with an Approved Budget for the Contract (ABC) of P 4,785,880.96 per Bid Reference No. DENR-CO-2021-030 pursuant to Republic Act (RA) No. 9184 otherwise known as the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the bid of FDC was declared as the Single Calculated and Responsive Bid (SCRB) by the Bids and Awards Committee (BAC), and was approved by the Head of Procuring Entity, through his duly authorized representative;

WHEREAS, the DENR issued a Notice of Award (NOA) in favor of FDC;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties have agreed on the following terms and conditions:

- 1. The words and expressions in this Contract shall have the same meaning as are respectively assigned to them in the Conditions of Contracts hereinafter referred to.
- The following documents as required by the 2016 Revised IRR of RA No.9184 shall be declared to form and be read and constructed as part of this Contract:
 - A. Philippine Bidding Documents (PBD);
 - i. Schedule of Requirements
 - ii. Technical Specifications (TS)
 - iii. General and Special Conditions of the Contract; and'
 - iv. Supplemental/Bid Bulletin/s
 - B. Bid submission of FDC
 - i. Eligibility Documents
 - ii. Technical Documents
 - iii. Financial Documents
 - C. Notice of Award (NOA) received on 18 October 2021 by FDC
 - D. Performance Security in the form of Irrevocable Domestic Standby Letter of Credit dated 26 October 2021 with No. ISB7041027421DSL issued by BDO Unibank, Inc. in the amount of ₽ 232,749.09.
 - E. Other Contract documents that may be required by existing laws and/or the DENR in the PBDs. FDC agrees that any additional contract document or information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution, such as Notice to Proceed (NTP), Variation Order, and Warranty Security, shall likewise form part of the Contract.
- 3. Project completion is within thirty (30) calendar days from receipt of Notice to Proceed (NTP) and in accordance with the Revised Schedule of Requirements (Terms of Reference as of 08 September 2021) based on Supplemental/Bid Bulletin No. 1 dated 15 September 2021.
- 4. The DENR shall pay FDC the amount of **FOUR MILLION SIX HUNDRED FIFTY-FOUR THOUSAND NINE HUNDRED EIGHTY-ONE & 76/100 PESOS (P4,654,981.76)** for the said project.
- 5. The DENR and FDC shall comply with the terms and conditions under RA No. 9184 and its IRR, and other applicable laws.
- 6. All other terms and conditions agreed upon by the parties after signing of this Contract shall constitute an addendum thereto and form an integral part thereof for all intents and purposes.
