CONTRACT

Procurement of Subscription for G Suite Cloud-Based Services for the Email, Storage, Collaboration and Office Productivity Suite for the Department of Environment and Natural Resources (DENR)

KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT entered into on this <u>1 7 NOV 2020</u> in Quezon City, Philippines, by and between:

DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, a government agency created by virtue of Executive Order (EO) No. 192 dated 10 June 1987, with office address in Visayas Avenue, Diliman, Quezon City, represented herein by its Director for Administrative Service, **ROLANDO R. CASTRO** hereinafter referred to as "**DENR**"

-and -

KOLLAB GURU GROUP INC., a private corporation organized and existing under the laws of the Republic of the Philippines, with business address at G/F, BSA Twin Towers Bank Drive, Ortigas Center, Mandaluyong City, represented herein by its Director, HAPPY UY DE BARON hereinafter referred to as "KOLLAB"

WITNESSETH: That

WHEREAS, the DENR conducted a competitive bidding for the *Procurement of Subscription* for G Suite Cloud-Based Services for the Email, Storage, Collaboration and Office Productivity Suite for the Department of Environment and Natural Resources (DENR) with an Approved Budget for the Contract (ABC) of P5,400,000.00 per Bid Ref. No. DENR-CO-2020-010 pursuant to Republic Act (RA) No. 9184 otherwise known as the Government Procurement Reform Act (GPRA) and its Revised Implementing Rules and Regulations (IRR);

WHEREAS, the bid of KOLLAB was declared as the Single Calculated and Responsive Bid (SCRB) by the Bids and Awards Committee (BAC), and was approved by the Head of Procuring Entity, through his duly Authorized Representative:

WHEREAS, the DENR issued a Notice of Award (NOA) in favor of KOLLAB;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties have agreed on the following terms and conditions:

- The words and expressions in this Contract shall have the same meaning as stated in the Conditions of the Contracts as provided under Section IV& V of the Philippine Bidding Documents (PBD) for the procurement of Goods.

- 5. Supply and delivery of a cloud-based service is for a period of one (1) year from receipt of Notice to Proceed (NTP).

Total contract amount is **FOUR MILLION FIVE HUNDRED SEVENTY TWO THOUSAND TWO HUNDRED EIGHTY EIGHT PESOS ONLY (P4,572,288.00)** for the Procurement of Subscription for G Suite Cloud-Based Services for the Email, Storage, Collaboration and Office Productivity for the Department of Environment and Natural Resources (DENR) under Bid Ref. No. DENR-CO-2020-010.
- 7. The **DENR** and **KOLLAB** shall comply with the terms and conditions under RA No. 9184 and its IRR, and other applicable laws.
- 8. All other terms and conditions subsequently agreed upon by the parties after signing of this Contract shall constitute an addendum thereto and form an integral part thereof for all intents and purposes.
