KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT entered into on this _______ in Quezon City, Philippines, by and between:

DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, a government agency created by virtue of Executive Order (EO) No. 192 dated 10 June 1987, with office address in Visayas Avenue, Diliman, Quezon City, represented herein by its Assistant Secretary for Administration and Human Resources, **JOAN A. LAGUNDA, D.M.** hereinafter referred to as "**DENR**"

TRENDS & TECHNOLOGIES, INC., a private corporation organized and existing under the laws of the Republic of the Philippines, with business address at 6th Floor, Trafalgar Plaza, H.V. Dela Costa St., Salcedo Village, Makati City, represented herein by its Key Account Manager, GERRY A. BAQUIRAN, hereinafter referred to as "TRENDS"

WITNESSETH: That

WHEREAS, the DENR conducted a competitive bidding for the Supply, Delivery, Installation, Configuration and Testing of One (1) Lot Brand New Cisco Unified Communication System for the Department of Environment and Natural Resources-Central Office (DENR-CO) per Invitation to Bid (IB) No. DENR-CO-2019-016 with an Approved Budget for the Contract (ABC) of P 8,000,000.00 pursuant to Republic Act (RA) No. 9184 otherwise known as the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the bid of TRENDS was declared as the Single Calculated and Responsive Bid (SCRB) by the Bids and Awards Committee (BAC), and was approved by the Head of Procuring Entity, through his duly authorized representative;

NOW, **THEREFORE**, for and in consideration of the foregoing premises, the parties have agreed on the following terms and conditions:

- The words and expressions in this Contract shall have the same meaning as stated in the Conditions of the Contracts as provided under Section IV & V of the Philippine Bidding Documents (PBD) for the procurement of Goods;

- 5. Supply, Delivery, Installation, Configuration and Testing of One (1) Lot Brand New Cisco Unified Communication System, conduct of trainings and submission must be completed within thirty (45) calendar days from receipt of Notice to Proceed (NTP).

The DENR shall pay TRENDS the amount of SEVEN MILLION EIGHT HUNDRED NINETY FIVE THOUSAND PESOS (P7,895,000.00) for the project entitled, the Supply, Delivery, Installation, Configuration and Testing of One (1) Lot Brand New Cisco Unified Communication System for the Department of Environment and Natural Resources-Central Office (DENR-CO, in accordance with the terms of payment as prescribed in the Philippine Bidding Documents (PBD) for Goods and subject to the usual accounting and auditing rules and regulations.

For one-time payment, the document requirement shall include the following:

- Delivery Receipt
- Service report of installation and configuration
- Test Report accepted by DENR
- Warranty Certificate
- Training Certificates or vouchers
- · Billing statement or Sales invoice
- The DENR and TRENDS shall comply with the terms and conditions under Republic Act (RA) No. 9184 otherwise known as the Government Procurement Reform Act and its Revised Implementing Rules and Regulations (IRR), and other applicable laws.
- All other terms and conditions subsequently agreed upon by the parties after signing
 of this Contract shall constitute an addendum thereto and form an integral part thereof
 for all intents and purposes.
