Japan, US to send experts on oil spill removal operations

The Japanese Coast Guard (JCG) has committed assistance to the Philippine government in containing and cleaning the oil spill off the waters of Mindoro Island.

In a statement, the Philippine Coast

Guard said personnel from the JCG are expected to be deployed in the country to assist in the ongoing oil spill response operations, particularly in Naujan Oriental Mindoro.

"According to Ambassador of Japar in the Philippines Kazuhiko Koshikawa, Japan will send a >10

disaster relief expert team on oil removal and control to augment the country's manpower and assets," the statement read.

Aside from Japan, the United States Coast Guard has already informed the Philippine government that it will also assist in the same operation.

The oil spill occurred after the MT Princess Empress sank off the waters of Oriental Mindoro on Feb. 28. It was carrying more than 800,000 liters of industrial fuel oil.

The oil spill has already affected the coastal areas of at least eight towns of Oriental Mindoro, while oil slicks were monitored in nearby areas. The oil spill also threatens to more tourist spots in neighboring areas

Discussions are still ongoing to contain the spread of the oil spill, including mapping out of strategies on what to do with the oil tanker.

In a statement, the Department of Environment and Natural Resources said the location of the vessel was already located through the National Mapping and Resource Information Authority (NAMRIA) BRP Hydrographer Ventura.

Based on the DENR data, the vessel was located about northeast of Pola, Oriental Mindoro but it is "believed to have moved southeast from its last known position where it completely submerged."

The site is about 1,200 feet or approximately 400 meters below

sea level.

Cash-for-work

On Wednesday, March 8, the PCG started meeting with the provincial government of Oriental Mindoro to deploy as many people to help in the oil spill clean-up drive.

During the meeting, it was agreed that the government will hire one person per family in all affected coastal areas under the "cash-forwork" program.

work" program.

"There will also be a massive and simultaneous shoreline clean-up on Friday, March 10," the PCG said in a statement released on Thursday.

For other missions, BRP Bagacay (MRRV-4410) applied 1,200 liters of oil dispersant in the waters off Nauian.

Meanwhile, shoreline clean-up teams, LGU representatives, and volunteers collected several sacks of oiled debris in Pola.

Oil spill impact 'for decades'; US, S. Korea boost aid

THE damage from the oil spill of a sunken tanker in Oriental Mindoro is "extensive" and will be felt for decades,

environmental Oceana Philippines warned Thursday.

This developed as the United States and South Korea offered to send more aid and Japan sent a team of oil removal and control experts that would help in the ongoing cleanup that President Ferdinand

Marcos Jr. said would take the government about four months to clean up.

That timetable, however, is "unrealistic" and about two months short at least, said lawyer Rose-Liza Eisma-Osorio, legal and policy director of Oceana Philippines.

"I think the realistic (timetable) would

be 6 months to a year," Osorio told ANC's "Headstart," adding that mangroves, seagrasses, and corals in the area "will take years to recover" from the tragedy.

Loyzaga added that the DENR has coordinated with the provincial local government units, the sunken vessel's

by the oil spill will be giventemporary jobs under the emergency employment program of the Department of Labor and Employment (DOLE), with over P100 million earmarked for the cash-for-work

"Around 10,000 individuals will be expected as beneficiaries," Labor Secretary Bienvenido Laguesma said in a phone interview on Thursday with the Philippine News Agency, adding DOLE expected to come up with the final list of beneficiaries soon.

Laguesma said ambulant and market stall fish vendors and employees of beach resorts will also be given assistance.

The humanitarian and social action rm of the Catholic Bishops'Conference of the Philippines (CBCP) will also send aid to residents affected by the oil spill in Oriental Mindoro.

Calapan, Oriental Mindoro's Dioce Social Action Center (DSAC) director Fr. Edwin Gariguez said the NASSA/Carita Philippines would extend assistance to 250 families.

The Lipa Archdiocesan Social Action Commission (LASAC) and the Center for Energy, Ecology and Development (CEED) will also provide food items and nergency assistance

Meanwhile, the oil slick has reached as far south as Cuvo Island in Palawan province, a TV Patrol report said last night, apart from affecting beaches in Mindoro and Antique, and threatening to reach tourist gem Boracay Island.

The motor tanker Princess Empress which was carrying 800,000 liters of industrial fuel oil, sank near the Verde Island Passage off Mindoro-one of the most biodiverse marine habitats on the

Sen. Cynthia A. Villar filed Senate Resolution No. 537 on Thursday to investigate the oil spill from the sunken tanker that she said "has been causing massive damage to the marine ecosystem nd biodiversity, and even threatening the world-renowned Boracay Island.

Go urged the authorities to hold those responsible accountable for the incident.

Meanwhile, the Philippine Coast Guard on Thursday said the Japanese Coast Guard was on its way to help contain the oil spill that is devastating the waters off nine municipalities of the province, including some coastal towns of Palawan and Antique.

"Oil control experts from the Japan Coast Guard will help the Philippine Coast Guard and other agencies in the ongoing oil spill response operations in Naujan," the PCG said in a Viber message.

The announcement of the Japanese assistance was made in a social media post by that country's ambassador to the Philippines, Kazuhiko Koshikawa.

According to Koshikawa, "Japan will send an expert disaster team on oil removal and control to augment the Philippines' manpower and assets."

The affected towns of Oriental Mindoro include Naujan, Pola, Pinamalayan, Gloria, Basúd, Bongabong, Roxas, Mansalay, and Bulalacao, according to the Provincial Disaster Risk Reduction and Management Office.

Seventy-six barangays across the municipalities have been placed under a state of calamity due to the damage caused by the oil spill.

On 4 March, the Philippine Coast Guard reported that the oil spill had reached the island town of Caluya in Antique.

The DENR had earlier said over 2,000 hectares of coral reefs, mangroves, and seagrass had been affected, while water samples from several areas in Oriental Mindoro failed the water quality test.

Estimates are that over 36,000 hectares of mangroves, coral reefs, and seagrass will potentially be affected by the oil spill, after reports said the oil has reached the province of Antique, with fears it might go farther west or to Palawan province.

On Thursday, the DSWD said the number of affected families in Oriental Mindoro had reached 25,000.

The DENR said it will seek the help of American soldiers who will participate in joint drills with Filipino soldiers in Balikatan 2023 in containing and mopping up the oil spill.

Environment Secretary Antonia Yulo Loyzaga said her department will ask the United States Embassy "to explore the possibility of deploying the participants of the joint military drills, the Balikatan 2023, to mitigate the effects of the oil spill as the dispersed oil might reach as far as the exclusive posh Amanpulo beach resort in Palawan.

Loyzaga said the local authorities of the island in Palawan had been alerted. Balikatan 2023 is scheduled on 24-27 April. The DENR's move is on top of Japan's and South Korea's intentions to help in containing the oil spill.

Latest data from the provincial government showed an additional 25 oil spill-related health cases — bringing the total to 43.

The government will also start temporary livelihood programs for affected families. Local residents will be hired for the cleanup under a cash-for-work program.

The provincial government and the Coast Guard reported that, so far, around 230 liters of floating oil and 76 drums of oil-contaminated debris that reached the shorelines had been collected.

Class suit eyed vs sunken tanker owner

The municipal government of Pola will create a task force to run after the owner of the sunken motor tanker MT Princess Empress for the oil spill in the waters off Oriental Mindoro, according to the Philippine Coast Gurad (PCG).

The PCG said appropriate legal actions would be pursued against the owner, operator and insurer of the tanker.

Environmental group Oceana said a class suit may be filed against the owner of *Princess*.

"A class suit requires only two conditions – that it has a common or general interest for many persons, and the parties are so numerous that it is impractical to bring them all before the courts. One may sue on behalf or defend for the benefits of all persons," Oceana legal and police director Liza Osorio said.

She said affected residents can seek damages under Republic Act 9483 or the Oil Pollution Law.

Osorio said the owner of *Empress* is also liable under the Fisheries Code and Clean Water Act.

The Oriental Mindoro Provincial Risk Reduction and Management Office (PRRMO) reported that 19,956 families in 65 barangays were affected by the oil spill. In Pola town alone, 11 barangays were affected.

The Department of Health said 18 residents fell ill after being exposed to the oil slick.

The PRRMO said 13 marine protected areas covering 2,7,43 hectares in Naujan town have been affected by the oil spill.

Japan to send experts

The Japanese embassy said it is sending experts to help in oil spill removal and control.

"We are one with you in these trying times," Japanese Ambassador Kazuhiko Koshikawa said in a post on Twitter.

The PCG said oil control experts from the Japan Coast Guard would help concerned agencies in oil spill response operations.

Meanwhile, integrated marine service provider Harbor Star Shipping Services Inc. was tapped to assist in efforts to clean up the oil spill.

"On March 7, Harbor Star secured a contract with the owner of the vessel MT Princess Empress for the deployment of manpower and resources for shoreline cleanup and oily waste disposal as directed and approved by the Philippine Coast Guard, local government units and other concerned agencies," Harbor Star said.

P100-M aid for displaced workers

The Department of Labor and Employment (DOLE) said it allotted P100 million for the temporary employment of those affected by the oil spill.

Labor Secretary Bienvenido Laguesma said about 10,000 residents are expected to benefit from the emergency employment program, among other assistance from the DOLE.

Laguesma said beneficiaries would engage in cleanup activities to ensure that the oil spill can be addressed at the soonest time possible.

caritas Philippines and the archdiocese of Lipa, Batangas said it donated financial assistance and relief goods to affected residents in Oriental Mindoro.

Fr. Edu Gariguez said a "fund transfer" from Caritas Philippines is being processed for the Diocesan Social Action Center in the province.

PCG SAYS POLA LOCAL GOV'T EYEING SUIT DUE TO OIL SPILL

The Philippine Coast Guard (PCG) said the municipal government of Pola in Oriental Mindoro would pursue legal actions against the owner, operator or insurer of the sunken fuel tanker in proper courts or administrative agencies due to the damage from the oil spill.

The PCG said the town would create Task Force Pola to study the appropriate charges.

Pola Mayor Jennifer Cruz said that apart from the temporary suspension of fishing activities in the province, the tourism industry in her town also saw a decline after the oil spill reached some of their beaches.

MT Princess Empress, which carried 800,000 liters of industrial oil, capsized in the waters off Naujan town in Oriental Mindoro on Feb. 28 and sank the following day after experiencing engine trouble.

The spill has affected coastal areas of Oriental Mindoro and Caluya town in Antique province.

In an online press conference on Thursday, Ram Joseph Temeña of the Provincial Disaster Risk Reduction and Management Office in Oriental Mindoro, said Pola was the worst hit as 11 barangays reported sightings of the oil spill in their shoreline.

Temeña told a virtual press conference that nine out of 15 towns in Oriental Mindoro had been affected by the spill while 18 people reportedly got sick due to inhalation of toxic fumes.

The PCG said the shoreline cleanup team in Pola "observed minimal traces and patches of oil along the shorelines with a 3-kilometer length area covered. They also noted patches of oil floating on the surface of the water."

PCG spokesperson Rear Admiral Armando Balilo earlier admitted it would be difficult for responders to conduct salvage operations because the vessel sank 400 meters deep in the sea. The PCG has been installing booms in the waters off Naujan as part of its containment and recovery operations.

work program," the PCG said.

A simultaneous shoreline cleanup will be conducted in different areas in Oriental Mindoro on Friday.

Harbor Star Shipping Services Inc. said it secured a contract with the vessel owner on March 7 for the "deployment of manpower and resources for shoreline cleanup and oily waste disposal."

Deja vu

Danny Ocampo, senior campaign manager of the conservation group Oceana, said the incident was like a "deja vu" of the Guimaras oil spill in 2006.

"I saw people before in Guimaras na tinatabo-tabo yung (using dippers to scoop the) oil with no personal protection equipment and I saw that again in Pola and here we are 10 days since the spill but there's still no clear way to contain it," he said.

"We salute government agencies for doing their part but we think there's not enough information available for preparedness. People in Antique are reaching out to Oceana and maybe other NGOs (nongovermental organizations): 'What should we do in case the oil reaches our shores?'" he said.

Libertad, Antique Mayor Mary Jean Te, in the same press conference, said coastal communities were concerned that the oil spill would reach their area and would impact on local livelihood and marine biodiversity.

The PCG, however, said it found no trace of fresh oil drifting in the waters off Caluya, Antique, where the spill reached three coastal villages earlier.

No "significant landing of oil" had been observed along the shorelines since March 8, said Commander Jansen Benjamin, public information officer of the PCG Western Visayas District.

But Benjamin said the danger remained that MT Princess Empress would release all its cargo unless the sunken tanker was properly assessed.

Environmental groups Oceana, Greenpeace Philippines and the Center for Energy. Ecology and Development called for transparency from the national government on the real extent of the damage caused by the spill.

Cleanup help

In a statement on Thurs-Iday, the PCG said a team from the Japanese Coast Guard was expected to be deployed in the country to assist in the oil spill response operations, particularly in Naujan town.

"According to Ambassador of Japan in the Philippines Kazuhiko Koshikawa, Japan will send a disaster relief expert team on oil removal and control to augment the country's manpower and assets," it said.

On Wednesday, the PCG met with Oriental Mindoro Gov. Humerlito Dolor to discuss updates on the response operations.

"The officials have agreed to hire one person per family in all affected coastal municipalities under the cash-for"More importantly, there must be accountability from the companies involved, especially the owner of the cargo. They must pay for the immediate and long-term damages their business operations have caused, especially in the disruption of livelihoods and access to ecosystem services," said Greenpeace campaigner Jeff Chua.

Fernando Hicap, chair of the fisherfolk group Pamalakaya, said the government must come up with a contingency plan "for any potential ecological disaster" caused by potential fish kills following the massive oil spill.

Oil spill exposes issue of accountability

N February 28, the oil tanker MT Princess Empress began taking in water after sailing into rough seas off the coast of Naujan town, Oriental Mindoro. The ship was on its way to Iloilo from Bataan with 800,000 liters of industrial oil.

Two days later, the Princess Empress finally slipped beneath the waves, triggering what could be the country's worst oil spill since another tanker sank off Guimaras in 2006.

As of Thursday, authorities were still scrambling to locate the Princess Empress, believed to be lying about 1,200 feet below the surface.

Finding the tanker is a race against time; officials need to know how much more oil is leaking from its cargo hold, and if the flow could be contained.

The oil that has seeped out has formed a slick about 25 kilometers long and 500 meters wide. The slick has already fouled up the waters and beaches of at least eight coastal towns in Oriental Mindoro. There are concerns that the winds and tides could bring the slick to as far as northern Palawan. Along the way, it could contaminate the pristine beaches of Boracay Island in Aklan. Patches of oil have also been reported in Antique.

A major environmental disaster appears to be in the making. Thousands of hectares of coral reefs, mangroves and seaweed are under threat.

The oil slick has already impacted hundreds of fishermen and their families in Oriental Mindoro, exposing them to health risks and endangering their livelihood.

Transporting oil from production sources to consumption locations is an essential function in global commerce, but it is a function that carries big risks as well.

Accidental oil spills inflict severe damage on ecosystems, the well-being of communities and local economies. The world first realized that in 1989, when the tanker Exxon Valdez ran aground in Prince William Sound in Alaska, releasing 11 million gallons of oil that blackened 1,300 miles of shoreline. The oil killed thousands of fish and wildlife and polluted their habitats, and affected local industries and communities.

The Exxon Valdez incident stood as the US' largest environmental tragedy, surpassed only in 2010, when an explosion on the Deepwater Horizon oil well drilling platform killed 11 workers and discharged millions of barrels of oil into the Gulf of Mexico.

In response to the Exxon Valdez disaster, the US Congress passed the Oil Pollution Act, which requires that federal and state agencies work with the companies responsible for oil spills to assess the overall damage. Once a report is finalized, the responsible parties must pay for cleanup efforts and compensate the people affected.

In 1992, 74 states, including the Philippines, signed a treaty to set up the International Fund for Compensation for Oil Pollution Damage, which pays victims of oil pollution damage who cannot get compensation from the owner of tankers responsible for oil spills.

In consonance with the treaty, President Gloria Macapagal Arroyo signed in 2007 Republic Act (RA) 9483, or the "Oil Pollution Compensation Act," which establishes a fund for oil pollution management.

Under RA 9483, the Maritime Industry Authority (Marina) administers the fund, and is supposed to collect a 10-centavoper-liter fee on every delivery or transshipment of oil by tanker barges and haulers.

The fund will finance the containment, removal and cleanup operations of the Philippine Coast Guard during oil pollution incidents.

Noble as its intentions are, RA 9483 remains largely unenforced because it lacks the implementing rules and regulations (IRR).

As early as 2014, then-Kabataan party-list representative Terry Ridon sought to correct this oversight by authoring a House resolution calling for the drafting of the IRR to reactivate the dormant law.

Ridon filed the resolution in reaction to the damage caused by oil leaking from a power barge that was beached in Estancia, Iloilo, at the height of Typhoon "Yolanda" in 2013.

He also said Congress must determine if oil tanker owners have been contributing to the oil pollution management fund. RA 9483 needs to be reviewed, especially now that we could be facing another environmental nightmare.

Groups warn of 'long-term impact' of Mindoro oil spill catastrophe

PARTICIPANTS of an online forum organized by international environmental groups Greenpeace and Oceana Philippines on Thursday expressed grave concern over the "long-term environmental, social, economic, and health impact" of the Mindoro oil spill.

Paul Horsman, Greenpeace Strategic Advisor, said oil spills like the Guimaras oil spill in 2006 and elsewhere around the world, have long-term impacts on the environment, including the biodiversity in affected ecosystems.

Oil spills can sometimes be felt even 30 years after the tragedy, causing irreparable damage to corals, seagrass, and mangroves.

Greenpeace responds to oil spills around the world and has witnessed its long-term impacts.

"We are trying to campaign for the phase out of oil, gas and coal," Horsman said in a pre-recorded video message.

"Oil spills are dangerous to marine life and the environment. We are dealing here with highly toxic material that is normally buried underground," he explained.

According to Horsman, the chemical makeup of oil cause cancers, direct poisoning, and physical effects on animals. He said in the past, thousands of thousands of birds die as a result of the impact of oil.

"It has a lasting effect on the environment. What you don't see is the longer effect of an oil spill," he said, adding that even after cleanups, oil remains in the environment and could hardly be really removed.

"The biggest mistake by government, authorities, and corporations in responding to an oil spill is they undermine or understate the potential impact. The fact is, they will have along-term impact. The corporations are trying to undermine the oil spill," Horsman pointed out.

Prevention

WHAT the government and the private sector can do against oil spills is

prevent them from happening, or if they do, contain them from spreading and prevent them from reaching the shores, he said.

Horsman said the one thing that the government and other stakeholders responding to an oil spill can do is by removing the oil safely. "But you can't clean it up. You have oily waste that has to be dealt with," he said.

Where's the boat?

RAM JOSEPH TEMEÑA, Provincial Disaster Risk Reduction Management Office (PDRRMO) chief of Oriental Mindoro, which is severely affected by the sinking of MV Princess Empress off the shores of Naujan, Oriental Mindoro on February 28, said until now, authorities have yet to pinpoint the exact location of the ill-fated vessel.

It was reported to be carrying 800,000 liters of oil that began to ooze out from the sunken vessel and started to spread to coastal towns nearby.

So far, he said out of the 15 municipalities of Oriental Mindoro, nine municipalities are now affected by the oil spill.

"We have 65 barangays affected. The town of Pola is the worse affected. We have sightings of oil spill in the shoreline already. Eleven barangays reported that the oil spill reached the shores already," Temeña said.

Headded that fisher folk from the province's 111 barangays in the affected towns are also affected as they are prevented from fishing activities.

So far, Temèña said, a total of 19,556 families in Oriental Mindoro alone are affected and belong to coastal communities from the towns of Naujan all the way to Bulalakaw.

He added that based on reports received by the PDRRMO, of the total of 29 marine protected areas or MPAs, 13 are already affected, covering a total of 2,743 hectares.

In terms of its health impact, Temeña said 18 persons in the town of Pola have reported suffering from nausea and vomiting, particularly from the Buhay na Tubig, one of the barangays severely affected by the oil spill.

"We have an incident command

post in Pola to help the town manage the disaster situation. Right now, the sea condition is preventing us from reaching affected barangays. Some are barangays not reachable as they are accessible only by small boats and single motorcycles," he said.

Temeña said the sea conditions remain "bad" preventing the PDRRMO, including the Philippine Coast Guard (PCG), Department of Environment and Natural Resources (DENR), and other volunteers from conducting oil cleanup operations.

So far, he said a total of 21.5 drums of oil and oil debris were collected in three barangays in Pola.

"We are really trying to contain this since March 1. Our governor is hands-on and is working with various agencies, particularly the PCG, which is taking the lead in addressing the disaster," he said, adding that the DENR is also helping out and is conducting water sampling to collect data from the shorelines.

PCG response

PCG Commodore Fidelles D. Salidao said in response to the oil spill, offshore and onshore cleanup is being conducted.

He said manual scooping is being done onshore to put the oil in containers and bring them to Calapan, Oriental Mindoro for hauling. "We collected mixture, 580 liters of oily water mixtures were collected. Why only that? It is because of the dispersal operation that we are conducting. We spray the spill [with chemical dispersants] to dilute the oil. It will disperse. Kaya iyon lang ang nakuha natin na oil," he said in narrating PCG's onshore response.

Offshore, he said four teams from the PCG were deployed in Pola.

"Asofreporting, we have collected approximately 16.63 cubic meters of debris. Contaminated absorbent booms and pads are included in the estimated debris. The concentration that is coming out is the target of the operation," he added.

Ivan Andres, Center for Energy, Ecology and Development coastal communities and climate program lead, said based on reports gathered by the group, 18,000 fishermen are not able to fish.

He said the impacts are not only with the fisherfolk. The team deployed on the ground reported that the "no-fishing" order affected the economy, including tourism. Around P11 billion in fisheries livelihood is estimated to be lost.

Andres said revenue loss from tourism is also expected. In 2019, he noted that revenue from tourism in the area was P3.5 billion.

He added that as of Wednesday, March 8, 43 people are already suffering from severe headaches and nausea in various parts of the province, and called on the government tolookintothese health occurrences.

He expressed alarm on key findings from the University of the Philippines-Marine Science institute that around 36,000 hectares of fishing could be affected by the spill.

Help

CASH aid and food packs, he said, are being released but communities are worried as to until when such help will last.

While an extensive effort should be exerted to contain the oil spill, Andres saiditis equally important to address the livelihood, environmental, and health problems brought about by the oil spill, and hold those responsible accountable for the disaster.

Accountability

ATTY Liza Osorio, Legal and Policy Director at Oceana Philippines reiterated that accountability measures are in place, and government only needs to enforce them.

She said there are various laws wherein affected communities can seek legal remedy, and demand accountability from the private companies to the government who are responsible for the oil spill.

The owner of the ill fated vessel MT Princess Empress, which until now remains to be unidentified, should shoulder clean up-expenses and consequential loss for the contamination, including income, or earnings, of persons affected, including human health or loss of lives.

Gov't should be transparent on oil spill extent, impact says Greenpeace Philippines

GREENPEACE Philippines on Thursday urged the government of President Ferdinand R. Marcos, Jr. to ensure transparency on the real extent of the oil spill off the province of Oriental Mindoro south of the Philippine capital and its effect on communities.

"We need the utmost transparency from the government on the real extent of the spill and its impact," Jefferson M. Chua, campaigner at the environmental group, told a virtual news briefing. "We also need transparency in terms of efforts being made, to make these companies involved provide the immediate redress to communities."

Japan has sent a team of experts who will advise the Philippines on the cleanup of an oil spill off the coast of Oriental Mindoro Province that threatens tens of thousands of hectares of coral reefs, mangroves and seagrass, not to mention residents of the area.

The Japan Disaster Relief Expert
Team would be sent "on humanitarian
grounds and for marine environment
conservation," the Japanese Embassy in
Manila said in a statement on Thursday.

"Japan hopes that this assistance contributes to the prevention of further marine contamination and to the restoration of the marine environment, and intends to continue working closely with the Philippines," it said.

Mr. Marcos on Wednesday said the government aims to clean up the 800,000-liter oil spill from a tanker that sank in the waters of Naujan in Oriental Mindoro last week in less than four months.

MT Princess Empress was carrying 800,000 liters of industrial fuel oil when it sank off Oriental Mindoro, one of the five provinces surrounding the Verde Island Passage, one of the world's most diverse marine habitats.

Marine experts estimate that as many as 20,000 hectares of coral reefs, 9,900 hectares of mangroves and 6,000 hectares of seagrass could have been affected by the spill.

Senators and congressmen have called for separate investigations of the incident, which prompted the province to place nearly 80 coastal villages in nine towns under a state of calamity.

Mr. Marcos said the government had tapped local fishermen who were temporarily banned from sailing to help the government in the cleanup drive.

"We are monitoring the situation closely," he said, adding that the government is working with the private sector and Japan to address the issue.

The Bureau of Fisheries and Aquatic Resources has said about 11,000 fisherfolk families were affected by the oil spill.

"The only way to know the size of this oil spill is through sampling and accurate and timely reporting by government authorities and the vigilance of communities," Mr. Chua said.

Mary Jean N. Te, mayor of the town of Libertad in the province of Antique, said they were afraid that the oil spill could reach their shores especially as the harvest season for yellowfin tuna starts. "We have the biggest number of mangroves, and we have a well-managed coastal resource," she told the briefing.

Ram Joseph D. Temeña of the Provincial Disaster Risk Reduction Management Office in Oriental Mindoro said at least 19,556 families from nine of 15 municipalities were affected by the oil slick. — **Sheldeen Joy Talavera**

DOLE provides emergency jobs to 10K Mindoro residents affected by oil spill

ROUND 10,000 residents affected by the oil spill in Oriental Mindoro, are expected to benefit from the emergency employment program of the Department of Labor and Employment (DOLE).

This was based from the initial estimate of the department of qualified beneficiaries of their Tulong Panghanapbuhay sa ating Disadvantaged/Displaced Workers (TU-PAD) program in oil-spill affected areas.

Under TUPAD, beneficiaries are usually given light public works like street sweeping, debris cleaning, and declogging works, which lasts for 10 to 90 days.

"Around 10,000 individuals will be [the] expected beneficiaries. Secondary affected families, such as ambulant and market stall fish vendors and employees of MSMEs [micro, small, and medium] beach resorts will also be provided assistance," Laguesma said.

The TUPAD beneficiaries will help in the clean up of the oil spill caused by the sinking of MT Princess Empress in the waters off Naujan town in Oriental Mindoro province last February 28.

The emergency employment will last for 10 to 30 days and its beneficiaries will be given personal protective equipment to ensure their safety while cleaning the oil spill.

Laguesma said they would also provide livelihood aid in the oil spill-affected communities.

DOLE allocated P100 million for the said interventions.

Laguesma said they are now coordinating with the Department of Social Welfare and Development (DSWD) and Department of Environment and Natural Resources (DENR) to finalize their list of beneficiaries within the week.

DSWD earlier said the oil spill already affected 7,000 families in six municipalities in Oriental Mindoro.

Something in the water

The turn of the season to the hot and humid months brings with it anticipation for summer breaks and island visits.

Unfortunately, the travel sector's big plans for massive oil a full resurgence of the industry are currently darkened by that recent oil spill off Oriental Mindoro province.

Residents' health remains at risk, and tourist irrevocably destinations around the area may also suffer affected from the consequences arising from the engine marine life in trouble that sent an oil tanker to the bottom of the ocean.

The MT Princess Empress, belly full with 800,000 liters of industrial oil, sunk on 28 February in the waters off Oriental Mindoro, "7.5 nautical miles from Balingawan Point, facing Pola Municipality in Oriental Mindoro,' reports said.

Soon after it happened, demands were made for quick action by the agencies concerned to stave off the oil spill's adverse effects.

Affected are "34 locally managed marine protected areas in 10 municipalities and some 36,000 hectares of coral reefs, mangroves, and sea grass," another report stated.



Yet how do we contain a spill that no doubt has immediatelu and possibly several areas?

Environmental impact notwithstanding, the real question is why oil tankers, such as the MT Princess Empress, should be allowed to ply our precious waters when they may be accidents waiting to happen.

How much care is taken by operators of commercial sea vessels to ensure a safe journey for all - not just the crew, or the cargo, but the people who could bear the full brunt of possible negligence or even law-breaking?

Much has been said about the details of the oil spill, and even the fact that the Japanese seavessel's government "is set to send a team of disaster relief experts to assist the Philippines in the ongoing cleanup of the massive oil spill," a recent report shows.

Yet how do we contain a massive oil these affected spill that no doubt has immediately families and and possibly irrevocably affected marine life in several areas?

The oil will spread, certainly, and word has it that it "might likely even reach the world-renowned Boracay Island."

Thousands of families in the coastal areas of Mindoro were immediately advised to relocate or take extra caution with their water usage. These, of course, are not easy to do.

Will the sea vessel's reported \$1 billion insurance offer the lifeline needed by these affected families and businesses? In this instance, one might assume the immediate and far-reaching effects are not just on livelihoods but also health.

To avoid sea disasters like this, our. government must first review the laws governing the sea, ensure that these are implemented properly, and see that those responsible for vastly damaging accidents like this will be held to account.

PRESIDENT Ferdinand R. Marcos Jr. has ordered the Department of Environment and Natural Resources (DENR) to speed up the oil spill cleanup in the affected areas in Oriental Mindoro.

In response to the President's directive, the DENR is looking into the possibility of tapping the participants of this year's Balikatan exercises for the cleanup drives along the shores affected by the oil spill caused by the Feb. 28 sinking of the MT Princess Empress in the waters off Naujan town in Oriental Mindoro province.

During a meeting with Marcos in Malacañang Wednesday, DENR Secretary Antonia Loyzaga said the agency would work together with the United States (US) Embassy to explore the possibility of deploying the participants of the joint military drills, as part of efforts for cleanup, mitigation, and remediation to reduce the impact of the oil spill incident.

The Balikatan is the annual Philippine-led bilateral exercise of the Armed Forces of the Philippines and the United States Armed Forces.

Loyzaga said Japan and South Korea have expressed their willingness to help contain the oil spill.

The DENR, Loyzaga said, is also coordinating with the provincial local government units, the vessel owner, and the Department of Social Welfare and Development (DSWD) as a potential additional source of funds for the cash-for-work program as assistance to the affected residents.

DSWD Secretary Rex Gatchalian said areas to be given the temporary means of livelihood include the towns of Bansud, Bongabong, Bulalacao, Gloria, Naujan, Pinamalayan, Pola, and Roxas in Oriental Mindoro; Caluya in Antique; and Agutaya in Palawan.

Loyzaga, meanwhile, noted that about PHP60 million has been set aside for the cash-for-work program of the Department of Labor and Employment (DOLE) called the Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD).

She said the vessel owner's insurance provider has offered to

She said the vessel owner's insurance provider has offered to bring in a ship from China to plug the leak in the vessel.

The DENR chief cited the latest reports indicating that the oil

spill has reached the Cuyo Island group.

Meanwhile, the oil spill in Antique and Semirara Island is continuing to spread, she said, estimating the rate of discharge of oil from the sunken vessel at 35,000 to 50,000 liters a day.

According to the models of the National Oceanic and Atmospheric Administration (NOAA), Naujan and Pola in Oriental Mindoro would be the hardest hit.

Japan experts to assist in oil spill removal ops

The Japanese Coast Guard (JCG) has committed assistance to the Philippine government in containing and cleaning the oil spill off the waters of Mindoro Island.

In a statement, the Philippine Coast Guard said personnel from the JCG are expected to be deployed in the country to assist in the ongoing oil spill response operations, particularly in Naujan town of Oriental Mindoro.

"According to Ambassador of Japan in the Philippines Kazuhiko Koshikawa, Japan will send a disaster relief expert team on oil removal and control to augment the country's manpower and assets," the statement read.

Aside from Japan, the United States Coast Guard has already informed the Philippine government that it will assist in the same operation.

The oil spill occurred after the MT Princess Empress sank off

the waters of Oriental Mindoro on Feb. 28. It carries more than 800,000 liters of industrial fuel oil.

The oil spill has already affected the coastal areas of at least eight towns of Oriental Mindoro while oil slicks were monitored in nearby areas. The oil spill also threatens to reach tourist spots in the nearby areas.

Discussions are still ongoing to contain the spread of the oil spill, including the mapping out of strategies on what to do with the oil tanker.

In a statement, the Department of Environment and Natural Resources said the location of the vessel was already located through the National Mapping and Resource Information Authority (NAMRIA) BRP Hydrographer Ventura.

Based on the DENR data, the vessel was located about northeast of Pola, Oriental Mindoro but it is "believed to have moved southeast from its last known position where it completely submerged."

The site is about 1,200 feet or approximately 400 meters below sea level.

Cash-for-work

On Wednesday, March 8, the PCG started meeting with the Provincial Government of Oriental Mindoro to deploy as many people to help in the oil spill clean-up drive.

During the meeting, it was agreed that the government will hire one person per family in all affected coastal areas under the "cash-for-work" program.

"There will also be a massive and simultaneous shoreline clean-up on Friday, March 10," the PCG statement read.

For other missions, BRP Bagacay (MRRV-4410) applied 1,200 liters of oil dispersant in the vicinity waters off Naujan, Oriental Mindoro.

Meanwhile, shoreline cleanup teams, LGU representatives, and volunteers collected several sacks of oiled debris in Pola, Oriental Mindoro.

The workshop and relationships developed will provide contacts for future collaboration and cooperation," the embassy's Export Control and Border Security Program Regional Advisor Ransom Avilla said.

Philippine Strategic Trade Management Office officer in charge Director Janice Dimayacyac recognized the initiative's potential contribution in preventing illegal trade activities in the region, especially with Southeast Asia

which is "located in a strategic area prone to various sanctions evasion tactics".

While in Manila, the participants also visited the Philippine National Coast Watch Center for a briefing on the center's functions and its best practices in countering maritime threats.

The EXBS program, under the Export Control Cooperation Office of the US State Department's Bureau of International Security and Nonproliferation, seeks to prevent the proliferation of weapons of mass destruction, destabilizing and irresponsible transfers of conventional arms and illegal exports of strategic goods by building an effective national strategic trade control system worldwide.



Mindoro oil spill might spoil vacation plans



THE recent oil spill inci-dent in Oriental Mindoro might spoil vacation plans including mine in Puerto Galera.

Latest reports indicat-ed the oil spill has already affected several areas of the province and that it might reach Verde Islands, a protected area.

a protected area.

Verde Island is located between Batangas province and Puerto Galera.

The possible impact of the oil spill is bigger than one might think. The University of the Philippines Marine Science Institute Marine Science Institute (UP-MSI) estimated that 20,000 hectares of coral reef, nearly 10,000 hectares of mangroves, and 6,000 hectares of seagrass are at risk in 21 municipalities across Oriental Mindoro, Occidental Mindoro, Palawan, and Antique.

Among these are Calapan, Puerto Galera, and Bulalacao in Oriental Mindoro; San Jose in Occidental Mindoro; and

Coron in Palawan.

In an earlier bulletin, the UP-MSI said the spill might reach the southern tip of Mindoro in a matter of days, given the direc-tion of the wind and

Meanwhile, government agencies are busy addressing the problem. President Marcos earlier appealed for state departments to help ensure that help is ended to victims.

In response, state pension fund Government Service Insurance System (GSIS) has earmarked P315 million in emergency loans for members and tensioners who were afpensioners who were affected by the oil spill that emanated from a motor tanker that capsized off the coast of Naujan, Oriental Mindoro last February 28

The oil spill has affected more than half of Oriental Mindoro. "With our ental Mindoro. "With our emergency loan program, we hope to alleviate the plight of nearly 13,000 GSIS members who are working or residing in the affected areas and pensioners who reside there," President and General Manager Wick Veloso

GSIS has altocated total budget of P6.2 bil-lion for its emergency loan program for the year. The municipalities of Bansud, Bongabong, Bu-lalacao, Gloria, Mansalay,

Naujan, Pinamalayan,

Pola, and Roxas in Oriental Mindoro have been declared under a state of clared under a state of calamity. Upon receipt of the required documents from the Provincial Government of Oriental Mindoro, GSIS will open the emergency loan to affected 11,024 active members, and 1,896 old-age and disability pensioners.

Should the Oriental Mindoro oil spill further spread and affect other towns and provinc-tes, we assure members other towns and provinces, we assure members and pensioners in said areas that GSIS is ready to open the emergency loan program once a state of calamity declaration has been done and required documents have been submitted to GSIS," Veloso added. added.

Qualified to apply are members in active service and not on leave of absence without pay; have at least three months of paid premiums within the last six months prior to application; have no pending administrative or criminal case; have no due and demandable loan; and have a net take-home pay of not lower than P5,000 after all required monthly after all required monthly obligations have been deducted.

Old-age and disability pensioners are also quali-fied to apply if their re-sulting net monthly take-home pension after loan

availment is at least 25% of their basic monthly pen-

Members with existing emergency loans balance may borrow up to P40,000 to pay off their previous emergency loan balance and still receive a maximum net amount of P20,000. Meanwhile, pen-sioners and those without existing emergency loan may apply for a P20,000

The loan is payable in three years or 36 equal monthly installments at an interest rate of 6% per annum.

In a related develop-ment, the government is looking at tapping Japan to help contain the rapidly spreading oil spill in Min-doro.

Transportation Secreransportation Secretary Jaime Bautista revealed the Philippine Coast Guard (PCG) is working with relevant agencies to contain and recover the slick but the spill has already reached another area in the province

Bill seeks **3** prevention of oil spill

Bill seeks prevention of oil spill

A measure that seeks to strengthen regulation of ships to prevent oil spills and discharge of harmful substances into the sea, has been filed in the House of Representatives.

The recent catastrophic oil spill in Oriental Mindoro prompted Negros Occidental Rep. Kiko Benitez to file House Bill 7515 whose main purpose is to provide strict enforcement of the regulations under the 1973 International Convention for the Prevention of Pollution from Ships, and its 1978 Protocol, or MARPOL 73/78, which the country is a signatory in 2001

"We signed MARPOL 73/ 78 in 2001. An implementing legislation is long overdue. We must keep our commitment to international law and perform our responsibility to protect the environment," Benitez said.

"We cannot let another oil spill happen again. Its damage to the marine environment is just too much. It is impossible to express the negative impact to livelihoods and marine ecosystems in monetary terms," he added.

According to Benitez, the bill is crucial in protecting our marine wealth and promoting blue economy to ensure sustainable development of our marine resources for the benefit of present and future generations.

The bill empowers the Maritime Industry Authority (MA-RINA) to strictly enforce shipbuilding standards and ensure that ships are constructed and equipped with materials and apparatus to prevent discharge or emission of oil, sewage, garbage and other harmful substances and pollutants into Philippine seas. It also mandates the Philippine Coast Guard to apprehend and detain ships for violations of these regulations.

The bill also imposes fines of up to ten million pesos on ship owners for violations. Proceeds from penalties will be used for clean-up and containment of spilled or leaked substances. Jester Manalastas

Developing and promoting ecotourism and nature-based tourism

BETTER DAYS

AST March 1, 2023, the Senate Tourism Subcommittee on Select Senate Bills on Ecotourism and on the Proposed Senate Resolution on Nature-Based Tourism held a hearing to discuss various measures and, ultimately, to find solutions and initiatives to advance the domestic tourism industry's recovery while instilling eco-consciousness amid the country's upcoming summer months and in anticipation of the influx of tourists this year owing to "revenge travel."

The following measures were tackled: Senate Bill 238, establishing the Northern Antique Protected Seascape and Landscape Act of 2022 filed by Senate President Pro Tempore Loren Legarda; several bills that I filed, namely, Senate Bill 1166, declaring the Pag-Asa Islandas an ecotourism cluster and protected area; and Proposed Senate Resolution 472, for the creation of policy reforms and budgetary expenditures to develop the Philippines's potential to be the leading country in the world for sustainable Nature-Based Tourism (NBT).

Discussions on Senate Bill 238 centered on Northern Antique's crucial role in the region's development and its surrounding environment. Department of Tourism (DOT) Re-

gion VI Regional Director Crisma Rodriguez emphasized how Northern Antique positively contributed to tourism growth in Antique, with five of its municipalities registering 14,311 tourist arrivals, or equivalent to almost half of all tourist arrivals in the province and with receipts amounting to P103 million owing to the area's wide range of recreation activities like white river rafting, river tubing, diving, among others. Moreover, local chief executives reiterated that Northern Antique is both a tourism destination and a habitat to dugongs, which are classified as vulnerable species by the World Wildlife Fund (WWF). All the concerned stakeholders concurred that the proposed measure will ensure the protection of the flora and fauna of the Northern Antique seascape and landscape for the benefit of the local communities and future Antiqueños.

For Senate Bill 1166, Rep. Johnny Pimentel (Surigao del Sur 2D), being the counterpart measure's author in the House of Representatives, started the discussion by explaining the bill's noble purpose, which is to assert our sovereign rights through economic initiative or soft diplomacy and to pave the way for the Pag-Asa Island's development. Rep. Edgardo Egay Salvame (Palawan 1D) also manifested his support on the measure and said that the declaration of the Pag-Asa Island Cluster as a protected area would help ensure its coastal and marine resources are protected from overfishing, poaching, large-scale ocean filling or reclamation. While Department of Environment and Natural Resources Undersecretary Augusto dela Peña manifested the agency's support to the bill, he flagged the need for supporting infrastructures and resources to guarantee peace and order so that the safety and security of civilians and civilian activities would be unhampered. Pag-Asa Island is the only Philippine-occupied island in the Spratlys that is inhabited by civilians. Wearetalking about pristine waters that are rich in biodiversity, which makes it an ideal destination for tourists.

Proposed Senate Resolution 472 is a result of our meeting with aca-

demics from the University of the Philippines who observed that we are not maximizing the promotion of NBT in spite of the competitive advantage our country has because of its wealth of resources. Masungi Georeserve trustee Billie Dumaliang agreed that nature-based tourism in the country is still underdeveloped and undermarketed. In fact the United Nations Development Program found that the gap on financing for biodiversity in the Philippines is at 80 percent. Biodiversity Conservation Society of the Philippines pressed the need for consultations to identify protected areas and other nature reserves in the country that have the potential to become flagship destinations for NBT.

As Philippine tourism was heavily hit by the Covid-19 pandemic, there is a need to diversify the sector's products and services while being conscious of sustainability. We fervently hope these discussions would form part of the country's rallying cry to further advance and develop our competitive advantages to propel growth and recovery in the tourism sector.

In solidarity with Masungi

t feels like a victory in a series of battles for the control of Masungi Georeserve, when the Bureau of Corrections (Bu-Cor) postponed its plan to build a headquarters and transfer the New Bilibid Prison in that environment-protected area.

Gregorio Catapang Jr., acting director general of BuCor said in a Senate committee hearing that the plan "will no longer push through... taking into consideration the impact on the environment of the construction of BuCor facilities in the area." This was a different situation from months ago, when BuCor insisted on its right as "registered owner of the property" and sent personnel to inspect the area, which alarmed the Masungi Georeserve Foundation.

When I talked to Billie Dumaliang, advocacy officer and trustee of the Masungi Georeserve Foundation, which she co-founded with sister Ann, she was aware of the challenges — political, social, economic - of protecting the Masungi Georeserve. Protecting that area, Billie said, is not only for them but more for us. She related to me that the conservation and geotourism project was awarded with the United Nations Sustainable Development Goals Action Award in 2022, and the Global Water Changemakers Award in 2021, among others.

To stress the importance of Masungi Georeserve, more than four dozen organizations have signed a statement early this month urging the President and the DENR to stop BuCor's plans in Masungi. Some of the organizations, collectively called the Upper Marikina Watershed Coalition, include the Philippine Native Plants Conservation Society, Philippine Biodiversity Conservation Foundation, Greenpeace Southeast Asia – Philippines,

Wild Bird Club of the Philippines, Living Laudato Si' - Philippines, Youth Strike 4 Climate Philippines, Philippine Center for Environmental Protection and Sustainable Development, Sustainability PH, among others.

The statement said, "We fully support the Masungi Georeserve in its efforts to protect and preserve the conservation area from any form of development that may harm its natural resources and biodiversity. We strongly oppose the

plans of the Bureau of Corrections to build its facilities in Masungi, as this would threaten the delicate balance of the ecosystem and compromise the integrity of the entire area."

"We recognize the need for the BuCor to address the overcrowding in the New Bilibid Prison and provide adequate facilities for the rehabilitation and reformation of inmates. However, we express our concern over the plan to take over the Masungi Georeserve, which is an important karst landscape

crucial to the conservation of the Upper Marikina Watershed."

lenges faced by BuCor in finding suitable sites for their facilities, we firmly believe that this should not come at the expense of the environment - the flora and fauna that have come back and flourished after more than 25 years of rehabilitation by Masungi. A critical part of the Upper Marikina Watershed and other protected areas, Masungi Georeserve also plays a crucial role in regulating the water flow in the region and reducing the risk of flooding and landslides. These ecosystem services are essential in maintaining the ecological balance and sustaining the well-being of the surrounding communities.

It was good that the plan of the BuCor was postponed, but is it indefinite? Or BuCor is just buying time? It remains to be seen. But for the meantime, I wish Billie and Ann all the enlightenment, strength of spirit, and wisdom, as they were entrusted with this environmental "treasure."

To reiterate the statement, it concluded with this paragraph: "We stand in solidarity with Masungi and all other environmental defenders who work tirelessly for the conservation and protection of critical ecological areas, recognizing their value in addressing climate change and building sustainable communities." As an environment writer, I stand in solidarity with Masungi.

Albano halts quarrying in portions of Cagayan River

CABATUAN, Isabela—Gov. Rodito T. Albano III has ordered mandatory rehabilitation of portions of the Cagayan River which were turned into quarry sites in Cabatuan town.

Executive Order (EO) No. 01 series of 2023 was recently issued to all stakeholders including Cabatuan Mayor Bernardo A. Garcia Jr., Isabela Police Provincial Office (IPPO), Environment Natural Resources Office (Isabela ENRO) and respective officials on all concerned barangays citing the unregulated quarrying

that has been done since 2014 leading to several drowning incidents.

EO No. 01 also placed the entire municipality in a quarry moratorium.

Section 1 of the EO consists of the declaration of the cease and desist order to all quarry operations by the Provincial Government of Isabela, which would take over any and all existing quarry operations to give way to the immediate rehabilitation and desilting of Cagayan River.

"The suspension of quarry permits is tantamount to no quarry permit, thus, failure to comply with this EO shall be considered

and proceeded as violation and may cause the permanent revocation of the quarry permit," Albano, in a statement, said

Further, the moratorium/suspension shall remain valid and effective pending the outcome of the rehabilitation and desilting activities.

The quarry moratorium stemmed from the letter of Garcia to DENR-MGB Regional Director, Engr. Mario Ancheta expressing the immensely dismal state of the quarry sites within the municipality due to unregulated quarrying activities and the unrehabilitated state of the riverbeds and riverbanks.

Cebu water district bags grant from JICA

THE Philippines signed with the Japan International Cooperation Agency (JICA) a grant aid of approximately 2-billion Japanese yen (P807 million) to fund septage management projects of Metro Cebu Water District.

The project involves the construction of a septage treatment facility, provision of vacuum trucks for septage collection and operating system for sludge treatment of approximately 430 cubic meters of septage per day to ensure uncontaminated sewage water is discharged back to the natural environment.

JICA added the project will benefit six local government units including Cebu, Compostela, Consolacion, Liloan, Mandaue and Talisay.

The grant will help the region overcome its capacity shortage for wastewater management facilities as Metropolitan Cebu's roadmap targets to adequately treat wastewater by 50 percent in 2030 and 90 percent by 2050.

JICA also said even if septic tanks are widely spread in the region, de-sludging is not regularly practiced and collected septage are rarely appropriately treated due to limited available treatment facilities which becomes a possible health risk due to negative impacts such as deteriorating groundwater quality and surface water pollution.

"Climate change has increased extreme weather events like droughts, putting pressure on water resources. The JICA grant for a septage management system is one way of using Japan's advanced technology and systems to promote sanitation and improve water quality while protecting water environments," said Sakamoto Takema, chief representative of JICA Philippines office, in a statement.

JICA said the grant also helps the region to comply with the Clean Water Act of 2004 that requires all local government units operating without piped sewerage systems to implement septage management. -Jed Macapagal

House set to approve gov't rightsizing bill

THE House of Representatives is poised to approve next week on third and final reading House Bill (HB) 7240 or the proposed "National Government Rightsizing Act."

This after the chamber passed the measure on second reading on Wednesday.

The bill focuses on streamlining the operations of different agencies under the Executive branch.

House Committee on Government Reorganization chairman and Bukidnon Rep. Jonathan Keith Flores, as sponsor, explained that the rightsizing program not only seeks to remove or reduce the number of government employees, but to also streamline the processes of government services in order to provide better services to Filipinos.

Under the bill, a Committee on Rightsizing the Executive Branch (CREB) would be created to oversee the implementation of the program. Maricel V. Cruz TITLE

Cite urgent audit of PH infra

THE Senate Committee on Public Works on Wednesday conducted a wednesday conducted a public hearing focusing on the preparedness and structural integrity of the country's infrastructure in the event of catastrophic

the event of catastrophic natural disasters.

The hearing was a continuation of the last, conducted in February, where the Department of Public Works and Highways (DPWH) failed to provide the appropriate data and concrete answers.

the appropriate data and concrete answers.

DPWH Secretary Manuel Bonoan also failed to attend the initial deliberations on the matter.

Senator Ramon "Bong" Revilla, Jr., the committee chair of the said Senate panel, reiterated the importance of assuring the pubtance of assuring the pub-lic's safety in the event a

lic's safety in the event a massive earthquake hits the Philippines.

"Ang nakataya kasi dito ay buhay ng tao, kaya we have to be careful. There are many questions that have to be answered and so many issues that need to be imissues that need to be im-mediately addressed. Yet we are running out of time. Every second we spend on vague answers; is a second wasted. Kaya kumilos na tayo bago pa mahuli ang lahat," the lawmaker said

in opening the discussion.
Revilla probed the
DPWH on the status of the
infrastructure audit he ordered to conduct to ensure that structures would not be a "hazardous risk" to the people during destruc-

tive calamities. However, the public works department was not able to provide complete and timely data as they presented audits only for the National Capital Re-gion (NCR) and only cov-

gion (NCR) and only covered the years 2016-2018.

This prompted the law-maker to ask the Philippine Institute of Volcanology and Seismology (Phivolcs) if it is only the country's capital that will be suffering greatly from an earthquake.

"Can we confirm kung

The chairperson of the Senate Committee on Public Works further asked DPWH to provide a "master list" of structures and establishments sitting above or near the fault line in order to provide necessary. in order to provide neces-sary precautions to those at great risk... In closing, Revilla raised

the importance of amend-ing the National Building Code and the National Structural Code of the Philippines to ensure the integrity of the country's infra-

structure

structure.

The solon said that the committee will convene a technical working group to develop comprehensive and fine-tuned measures.

Sen. Raffy Tulfo, during the hearing, grilled the DPWH officials as well as the MMDA (Metropolitan Manila Development Authority) and Phivolcs about the actions they have taken to mitigate the effect of the so-called "The Big One" or the worst-case scenario for Metro Manila should the West Valley Fault should the West Valley Fault

should the West Valley Fault move and generate a magnitude 7.2 quake.

Tulfo noted that as early as 2004, these agencies were already informed about the scenario.

He added that a joint study with the Japan International Cooperation in 2004 identified the "poorest of the poor areas" among those that will be badly affected by the strong earthquake.

earthquake.
"What have you been doing? Have you been going around inspecting the houses of our kababayan? Are you coordinating with local government units (LGUs)?" Tulfo asked dur-

ing the hearing.
Sen. Christopher Bong
Go said these government
agencies should be "one
step ahead" of disasters
and make sure that communities remain safe and disaster resilient.

During the hearing, Go underscored the need to review and update the National Building Code and keep the country's laws in tune with the times.
