The Department of Environment and Natural Resources (DENR) through the FY 2021 General Appropriations Act (GAA) intends to apply the sum of Pesos: Two Million Two Hundred Fifty Thousand (2,250,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for the PROCUREMENT OF ECHO SOUNDER AND REAL-TIME KINEMATIC/GLOBAL NAVIGATION SATELLITE SYSTEMS (RTK/GNSS) RECEIVER FOR THE DENR-MBCO:

- 2. Bids received in excess of the ABC shall automatically be rejected at Bid opening. Late bids shall not be accepted.
- 3. DENR now invites Bids from eligible bidders for the **PROCUREMENT OF ECHO SOUNDER AND REAL-TIME KINEMATIC/GLOBAL NAVIGATION SATELLITE SYSTEMS (RTK/GNSS) RECEIVER FOR THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES - MANILA BAY COORDINATING OFFICE (DENR-MBCO)** (hereinafter referred to as GOODS)
- 4. Supply and delivery must be completed within **thirty (30) calendar days** from receipt of Notice to Proceed (NTP).
- 5. A prospective Bidder must have completed within the last five (5) years a Single contract of similar nature amounting to at least fifty percent (50%) of the ABC.

Similar in nature shall mean "<u>Procurement of Echo Sounder and Real-Time Kinematic</u> /Global Navigation Satellite Systems (RTK/GNSS) Receiver".

6. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic

Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its Revised IRR.

- 7. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 8. The Invitation to Bid and Bidding Documents may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and DENR website at <u>www.denr.gov.ph</u>.
- 9. The complete set of Bidding Documents may be acquired by interested bidders upon payment of the corresponding fee as indicated above not later than the schedule of submission of bids. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.
