CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT entered into on this ______ in Quezon City, Philippines, by and between:

DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, a government agency created by virtue of Executive Order (EO) No. 192 dated 10 June 1987, with office address in Visayas Avenue, Diliman, Quezon City, represented herein by its Undersecretary for Legal, Administration, Finance, Human Resources and Information Systems, **ATTY. ERNESTO D. ADOBO, JR.**, CESO I, hereinafter referred to as "**DENR**"

-and -

SOLUTIONS PARTNER, INC., a private corporation organized and existing under the laws of the Republic of the Philippines, with business address at Unit 6D, 6th flr., The Valero Tower, 122 Valero St., Salcedo Village, Makati City, represented herein by its Authorized Representative, **EDWIN LIM**, hereinafter referred to as "**SPI**"

WITNESSETH: That

WHEREAS, the DENR conducted a competitive bidding for the Supply, Delivery, Installation and Configuration of Brand New Network Security Appliances for the Department of Environment and Natural Resources Regional Offices (ROs), Provincial Environment and Natural Resources Offices (PENROs), Land Management Bureau (LMB) and Ecosystem Research and Development Bureau (ERDB) with an Approved Budget for the Contract (ABC) of P11,960,000.00 per Bid Ref. No. DENR-CO-2020-005 pursuant to Republic Act (RA) No. 9184 otherwise known as the Government Procurement Reform Act (GPRA) and its Revised Implementing Rules and Regulations (IRR);

WHEREAS, the bid of SPI was declared as the Single Calculated and Responsive Bid (SCRB) by the Bids and Awards Committee (BAC), and was approved by the Head of Procuring Entity, through his duly Authorized Representative;

WHEREAS, the DENR issued a Notice of Award (NOA) in favor of SPI;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties have agreed on the following terms and conditions:

- The words and expressions in this Contract shall have the same meaning as stated in the Conditions of the Contracts as provided under Section IV& V of the Philippine Bidding Documents (PBD) for the procurement of Goods.
- The following documents attached hereto shall be deemed to form an integral part of this Contract:

A. Bidding Documents

- ii. Instructions to Bidders (ITB) under Section II
- iii. Bid Data Sheet (BDS) under Section III

- vii. Technical Specifications under Section VII

- viii. Bidding Forms under Section VIII
- ix. Checklist of Requirements under Section IX
- B. Bid submission by SPI
 - i. Eligibility Documents

 - iii. Financial Documents
- C. Notice of Award (NOA) received on 30 September 2020
- D. Performance Security in the form of Manager's Check issued by BDO, amounting to Php 597,294.00 dated 29 September 2020.
- E. Other documents that may be required by existing laws and/or the DENR such as but not limited to Minutes of the Pre-Bid and Bid Opening Conference and the conditions stipulated in the NOA
- 3. Duly conformed Schedule of Requirements and Technical Specifications attached as Annex "A".
- 4. Duly signed Financial Bid Form attached as Annex "B".
- Project completion (delivery, installation and configuration) is within sixty (60) calendar days from receipt of Notice to Proceed (NTP).
 - After pre-configuration and testing **SPI** shall transport the appliances to the Bureaus and Regional Offices within thirty (30) calendar days from receipt of Notice to Deliver.
- 6. Total contract amount is ELEVEN MILLION NINE HUNDRED FORTY FIVE THOUSAND EIGHT HUNDRED EIGHTY PESOS ONLY (P11,945,880.00) for the Supply, Delivery, Installation and Configuration of Brand New Network Security Appliances for the Department of Environment and Natural Resources Regional Offices (ROs), Provincial Environment and Natural Resources Offices (PENROs), Land Management Bureau (LMB) and Ecosystem Research and Development Bureau (ERDB).
- The DENR and SPI shall comply with the terms and conditions under RA No. 9184 and its IRR, and other applicable laws.
- 8. All other terms and conditions subsequently agreed upon by the parties after signing of this Contract shall constitute an addendum thereto and form an integral part thereof for all intents and purposes.
