## DENR tinuruan ang mga stakeholder na pasiglahin ang pagpapahalaga sa environmental protection

MANILA, Philippines – Upang itaguyod ang pangangalaga sa kapaligiran hinamon ng Department of Environment and Natural Resources (DENR) ang Boy Scout of the Philippines, teachers, maging ang DENR utility personnel na isulong ang pangangalaga sa environment sa kanilang pamamaraan sa ginanap na learning session para sa pagdiriwang ng Month of the Ocean (MOO).

Ipinaliwanag ni DENR Secretary Roy A. Cimatu na ang pagbibigay ng hamon sa mga stakeholders ay magmumulat o “awaken their passion and awareness about the current situation of our oceans and the biodiversity that thrives in it.”

# 1,082 solid waste management plans approved by NSWMC

QUEZON CITY, June 2 -- The National Solid Waste Management Commission (NSWMC) has approved the solid waste management plans (SWMPs) of 22 more local government units (LGUs) last month, bringing the total number of approved plans to 1,082 or 63 percent of its target nationwide.

Of the 22 approved plans, four are in Misamis Oriental; three in Camarines Sur; two each in Misamis Occidental, Ilocos Norte, Benguet, and Lanao del Norte; and one each in Cagayan, Albay, Sorsogon, Leyte, Northern Samar, and Zamboanga del Sur.

Department of Environment and Natural Resources (DENR) Secretary and NSWMC Chair Roy A. Cimatu lauded the "continued upward trend" in the performance of the LGUs to have their plans approved by the Commission.

"Enabling our local executives to strengthen their capacities for effective solid waste management is a priority of the DENR and the NSWMC, especially LGUs facing difficulties with their solid waste management programs," Cimatu said.

"To the provinces whose towns and municipalities are now all with their approved SWMPs, we commend the leadership of your local executives," he added.

Data from the DENR-Environmental Management Bureau showed that 558 SWMPs are currently under evaluation, 332 of which are almost finished pending the submission of additional data mostly involving budgetary requirements and specifics on proper final disposal facilities.

DENR Undersecretary for Solid Waste Management and Local Government Units Concerns and NSWMC Alternate Chair Benny D. Antiporda stressed that the plans are crucial to the efforts of the DENR and the NSWMC in capacitating LGUs to implement their solid waste management programs, particularly those with limited resources.

"As a solution for LGUs that cannot put up their own disposal facilities, the DENR and the NSWMC are looking at the clustering of these LGUs sharing a single sanitary landfill, and the approved plans will serve as a blueprint on how these sanitary landfills will be optimized by these clustered LGUs," Antiporda said.

Antiporda bared the DENR's plan to bring in the private sector through the public-private partnership (PPP) for the establishment of additional 300 sanitary landfills nationwide within the next two years.

"There are only 237 sanitary landfills in operation across the country servicing some 449 LGUs which all have SLF requirements for their cities and municipalities. This number is still regrettably small," he pointed out.

Antiporda reiterated that sanitary landfills remain the primary long-term method of solid waste disposal allowed under Republic Act 9003 or the Ecological Solid Waste Management Act of 2000.



"Moving forward with the additional 300 sanitary landfills within the next two years through the PPP scheme is the best option possible to effectively address the country's management of solid waste," he said. (DENR)

## Mines regulator proposes 3-5% royalties for mining operations outside reservations

THE MINES and Geosciences Bureau (MGB) said it supports a bill that would extract royalties for those mining outside designated mineral reservations.

At a hearing of the House Committee on Natural Resources Wednesday, MGB Director Wilfredo G. Moncano said that only those within mineral reservations currently pay mineral royalties of 5%.

“Those outside mineral reservation areas do not pay this 5%. These operations are about 75% (of the industry). There are more (miners) outside the mineral reservation areas that are not paying mineral royalties,” Mr. Moncano said.

Mr. Moncano said the royalties will be a readily-available source of added to the government.

“We are proposing between 3-5% royalties for those outside the mineral reservation areas,” he added.

Rowena S. Sta. Clara, a representative from the Department of Finance (DoF), said during the hearing that the department also backs such a royalty scheme.

“We are also proposing the imposition of mining royalties both inside and outside mineral reservation areas, applicable to metallic and non-metallic minerals in both small- and large-scale mines,” Ms. Sta. Clara said, noting that the DoF also backs a range of 3-5%, but implemented in phases.

“We propose that the first year be at 3%, the fourth year 4%, and the fifth year 5% for those outside mineral reservations,” Ms. Sta. Clara said.

On April 14, President Rodrigo R. Duterte signed Executive Order No. 130 that lifted the ban on new mineral agreements.

The government has said that 100 mining projects are in the pipeline, estimated to generate P21 billion in revenue which can be used to fund the government’s pandemic response. The MGB estimates that the value of metallic mineral output in the first quarter rose 14.11% to P28.91 billion.

Nickel ore and other nickel-by products accounted for 47.12% or P13.62 billion, followed by gold at 40.49% or P11.71 billion, copper 11.51% or P3.33 billion, and silver, chromite, and iron ore less than 1% or P254.92 million. — **Revin Mikhael D. Ochave**

# Value, bases of dredging activities in bodies of water explained

ILOILO CITY, June 2 (PIA) – The purpose of dredging activities in heavily-silted river, waterways and inland bodies of water is to clear, desilt and de-clog them in order to address flooding and prevent disasters.

This topic was tackled by Mines and Geosciences Bureau-6 OIC-ORD Raul A. Laput in the DENR-6 program “Ikaw Kag Ang Imo Palibot” aired recently over DYLL Radyo Pilipinas.

Dredging activities also redirect and re-channel the flow of water and stabilize embankment and protect existing structures such as bridges and dikes, said Laput

The MGB-6 chief cited major policy issuances governing dredging projects and activities starting with Department Order No. 139, Series of 2014 issued by the Department of Public Works and Highways (DPWH) “to set guidelines on all river dredging activities for flood-control projects and quarrying purposes.”

In 2019, the DPWH, Department of Environment and Natural Resources (DENR), Department of the Interior and Local Government (DILG) and Department of Transportation (DOTr) issued Joint Memorandum Circular (JMC) No. 2019-01 entitled “Guidelines on the Issuance of Clearance and/or Permit for Dredging Within Waterways or Other Inland Bodies of Water.”

This serves as the basis of the subsequent administrative orders on dredging activities, explained Laput.

Pursuant to the joint circular (DPWH-DENR-DILG-DOTr JMC 2019-01), DENR further issued in the same year policies covering dredging projects in specific provinces such as Mindoro and Zambales. For projects covering the province of Negros Occidental, DENR Secretary Roy A. Cimatu issued DAO 2020-01.

The DENR further issued DAO 2020-07 and is the most recent policy governing large-scale dredging activities towards river restoration, and this applies to the rest of the country.

Under DENR Administrative Order (DAO) No. 2020-07, private contractors will undertake the dredging projects on behalf of the local government unit which may lack the financial and technical capability.

“The private contractor will have to shoulder all the expenses of the dredging operation in exchange for the dredged materials and whatever minerals it may recover, provided it pays the required national and local taxes,” said Laput.

Moreover, the private contractor must secure an operations permit dredging clearance or permit after complying with all the requirements which include a dredging clearance permit from the DPWH, among others.

The DAO requires that only duly registered companies with technical and financial capabilities to undertake large-scale flood control dredging and desilting operations may apply for a dredging clearance with the Department of Public Works and Highways (DPWH).



Local government units which opt to engage private contractors in undertaking river restoration through dredging activities within their jurisdiction need to submit a letter of intent to the Office of the DENR Secretary.

DAO 2020-07 further orders the creation of an Inter-Agency Committee composed of the governor as chair, DENR regional executive director as vice-chair, and regional directors of DPWH and the Mines and Geosciences Bureau and Environmental Management Bureau as members. One of the tasks of the Inter-Agency Committee is to define the River Dredging Zone (RDZ) based on the Dredging Master Plan prepared by the DPWH.

Laput said that dredging can clear and restore the waterways to their original depth and condition, thus preventing flooding. This will be possible at no cost to the government while receiving taxes and fees due for the use and commercial disposition of the dredged materials including the minerals that may be present.

MGB-6 is conducting a series of information dissemination on policies governing river restoration through dredging activities. "We will make further announcements on the schedules of IEC on this topic," said Laput. (PIA6/MGB-6/I.O. Laralournie Artajo)

# PH laws allow wildlife smuggling brains to stay untouched

MANILA, Philippines — Months before police officers found a cargo of poached wild animals in two luxury vehicles at a checkpoint in Tandag City, Surigao del Sur province, in 2019, wildlife law enforcers arrested two men in Mati City, Davao Oriental province, also for a similar smuggling activity.

The two illegal traders had in their possession 450 wild animals believed to have originated from Indonesia and Papua New Guinea, like the Tandag shipment, prompting enforcers to believe that both cases were related and involved the same network of traffickers.

The seized animals were valued at P50 million, but the municipal trial court only handed down the minimum fine for possessing critically endangered species: 2 years and a day in jail and P30,000 in fines, on top of a monthlong imprisonment and a P5,000 fine for illegal trade.

Both wildlife law enforcers and conservationists say that the low penalties prescribed in the current wildlife law no longer deter criminals from poaching or illegally trading wildlife in the country.

“There is a disparity, a real gap between the economic incentives that the criminals can get in wildlife trafficking, and the disincentives given by the law,” said lawyer Teodoro Jose Matta, executive director of the Palawan Council for Sustainable Development.

“There’s also a lack of provision in our current laws to penalize accomplices, accessories ... Right now, if you are a mastermind, you delegate your activity to local traders and you’re never going to get caught,” he added.

## No real jail time

Most of the sentences under the 20-year-old Wildlife Resources Conservation and Protection Act, or Republic Act No. 9147, are below six years imprisonment. First-time convicts often apply for probation to skip jail time and avoid paying the fines under certain terms.

In the Mati case, the two men spent only four days behind bars before posting a P40,000 bail. After their conviction, both sought probation.



According to the Davao Oriental Parole and Probation Office, the men, who are cousins, were “very qualified” for probation, after finding no other criminal charges against them.

The two said they were fishermen from General Santos City, South Cotabato province, who were forced to stay on shore after their boat was damaged. They said they were approached by a certain person to look after the birds—claiming they did not know they were smuggled—in exchange for P250 per day and food.

Their bail was paid for by a relative, said senior probation and parole officer Jonaliza Manguiob, whom they sought for help after they were arrested.

But even when their probation application was granted in September 2020, they have not yet begun their service. They have not shown up at the probation office in General Santos, where their application had been transferred.

Manguiob said the men claimed difficulty in traveling because of their fishing activities. Despite their absence, no warrants have been served against them.

The same story persists in many other cases.

In Tagaytay City, three men who smuggled 10 Philippine pangolins, among the most trafficked mammals globally, were sentenced to merely 3 months imprisonment and a fine of P20,000 each. Only three pangolins were repatriated alive back to Palawan province; seven others had died in the smuggling attempt.

### **Hopes on revision**

The Inquirer learned that only two of them were granted probation, with one confirmed to have ended his term last February. The third convict is on the run with an arrest warrant against him, after he failed to appear at the probation office, according to Eduardo Lamorena Jr., Tagaytay probation and parole chief.

These are the realities that wildlife law enforcers and conservationists hope to overturn in amending the wildlife law.

In the House of Representatives, a substitute bill that consolidated five pending legislation seeking to revamp the law hurdled the committee on appropriations in May, after gaining approval from the committee on natural resources in December last year.

In the Senate, two senators separately filed a bill in March, but these remain pending at the Senate committee on environment, natural resources and climate change.

Under the House substitute bill, the penalties for killing a critically endangered animal could now mean 12 to 20 years in prison, on top of a fine of P200,000 up to P2 million.

Illegal traders could face a minimum imprisonment of four years and cough up P50,000 in fines. Those transporting without proper permits could be sentenced to pay P100,000 and spend time in jail for up to two years.

The revisions also aim to check loopholes in the current law. For instance, each wild animal seized will now constitute a separate and distinct count of an illegal act, so that if 10 specimens of even a near threatened species is involved, the maximum penalty will already be imposed on the offender.



For the first time, wildlife trafficking will now be properly defined as a criminal act committed by a syndicate or with wildlife either bound for import or export from the country.

The proposed amendments aim to strengthen wildlife law enforcement by creating plantilla positions and deputizing wildlife enforcement officers.

“This will deter criminal elements, those involved in trafficking of wildlife,” said lawyer Theresa Tenazas, acting head of the wildlife resources division of the Biodiversity Management Bureau. “The Philippines is no longer a haven for them.”

### **No more delays**

Much remains to be done, however, in ensuring actual prosecution and conviction of wildlife criminals. For one, wildlife law enforcers, especially in the provincial offices of the Department of Environment and Natural Resources, should be trained to handle and see wildlife cases through, and not just settle for the minimum punishment, conservationists say.

The government must also exert efforts to wield other legal mechanisms, said lawyer Edward Lorenzo, policy and governance adviser of Conservation International Philippines. Wildlife criminals, especially those using electronic and online means in their transactions and those involved in transboundary trafficking, could be slapped with violations to the cybercrime law and the antimoney laundering law.

“There can be more creative ways of using these other modes to target the upper levels of the syndicates and not just the lower-ranking parts of the network,” Lorenzo said. “They’re more important since they’re the ones providing financing, logistics and connections..”

As wildlife crime persists despite continuous enforcement operations and the coronavirus lockdowns, the harsher penalties could no longer afford more delays.

“The amended law will not end anything, but I believe it can go a long way in helping us minimize our current problems,” said Lorenzo. “What we want is our enforcers to be prepared, so that when the world opens again and the illegal trade comes back, at least they are more ready.” INQ

# EDC to rescue, propagate Palawan-endemic tree species with PCSD

LOPEZ-led geothermal leader Energy Development Corporation (EDC) in collaboration with its newest Binhi partner, the Palawan Council for Sustainable Development (PCSD), aims to rescue and propagate more Philippine native tree species endemic to Palawan island.

With the recent signing of the Memorandum of Agreement (MoA) between the two above-mentioned institutions, more endangered tree species endemic to Palawan island such as the Palawan mangkono (*Xanthostemon speciosus*), Manggis (*Koompassia excelsa*), Narig-laot (*Vatica maritima*) and Palawan narig (*Vatica mangachapoi* ssp. *obtusifolia*) that are on the brink of extinction are targeted to be rescued and propagated through the in-situ conservation project under the Binhi program.

Binhi, EDC's nationwide forest restoration program and the country's largest private sector-led greening initiative, aims to restore denuded forests, preserve and propagate threatened native tree species, and protect biodiversity to leave a legacy of a verdant Philippines for future generations.

In-situ conservation, one of the restoration processes under the Binhi program, is the process of conserving ecosystems and natural habitats and the maintenance and recovery of viable populations of species in their natural surroundings. Through this process, the BINHI team aims to rescue and propagate Palawan Narig, Narig Laot and 12 other Palawan-endemic tree species identified to be critically endangered and near extinction. The team shall also provide technical assistance and expertise to PCSD during the implementation of the project.

## Conservation center in Mindoro aims to protect island's biodiversity

A biodiversity conservation center being constructed in Puerto Galera aims to promote Mindoro's unique flora and fauna and educate people on climate change.

A project of the Mindoro Biodiversity Foundation, Inc. (MBCFI), which undertakes the protection and preservation of Mindoro Island, the Mindoro Biodiversity Conservation Center in Barangay Dulangan, Puerto Galera, is composed of a Mangyan heritage hall, where the Mangyans can showcase their cultural heritage and sell their handicrafts; a greenhouse, where visitors can try their hand at bio-intensive gardening and nursery landscaping; and a research laboratory, where scientists and researchers can process specimens from key biodiversity areas in the island.

"We have constructed 40% of buildings 1 and 2," said Grace C. Diamante, executive director of MBCFI, at a May 27 virtual event. The first phase of construction is expected to finish before the year ends, she added, although there have been delays due to bad weather.

Sponsorship opportunities — including those that fund the non-profit organization's programs on scientific research, community-related activities, and information campaigns — are available, Ms. Diamante added. Individuals or groups that donate P5–15 million will have spaces named after them.

Located in the southwestern coast of Luzon and northeast of Palawan, Mindoro Island is recognized as one of the world's biodiversity conservation priority areas, specifically in terms of the number of endemic (or native) species, diversity of habitats, and degrees of threats.

The MBCFI and the Malampaya Foundation, Inc. (MFI) have been undertaking the protection and preservation of the island, as well as the other key biodiversity areas of north Palawan and the Verde Island Passage.

Among the various flora and fauna found in the island are the tamaraw or dwarf water buffalo, the Philippine warty pig, the golden-crowned fruit bat, as well as various pine and rattan species. In her presentation, Ms. Diamante shared that Mindoro has more bird species than Madagascar (285 versus 258), known as a globally-recognized megadiversity country. It also has more reptile and amphibian species (70 versus 27) than the United Kingdom, a country with a land area 23 times that of the island.

“Central Philippines has the most number of marine species per unit area, with particular emphasis on the Verde Island Passage,” said Karen Agabin, executive director of Malampaya Foundation, the social arm of Malampaya Joint Venture partners. The Verde Island Passage is located between the islands of Mindoro and Luzon, and is recognized as the center of global shore-fish biodiversity.

A February 2013 study by Jonnell C. Sanciangco, et al., however, noted the evidence of exploitation-related biodiversity loss in central Philippines.

There has been a 90% decline in fish-catch rates since the 1950s to the year 2000, said Ms. Agabin. “Marine protected areas (MPAs) are effective solutions. They can accelerate restoration and [promote the] sustainable use of resources — but only if they are effectively managed,” she added.

MPAs are established to help protect marine ecosystems that are threatened by human activity, such as overfishing or petroleum drilling. They also provide living laboratories for oceanographers and marine biologists to conduct research, according to *National Geographic*.

“The prosperity of humans is dependent on biodiversity,” Ms. Agabin said. “Investing in biodiversity means investing in our future.” — **Patricia B. Mirasol**



# MMDA flags trash clogging pumping stations; urges proper waste management

The Metropolitan Manila Development Authority (MMDA) on Wednesday raised alarm over garbage that clogged pumping stations, which may cause flooding in the metropolis amid tropical storm Dante.

According to Mariz Umali's report over "24 Oras," MMDA chairman Benhur Abalos Jr. inspected the Tripa de Gallina pumping station in Pasay, wherein two of eight machines were not working due to clogged items found in the filter.

If the pumping stations are not fixed, flooding may also be experienced in Makati City, Abalos warned.

"These machines need to keep working, if not, there will be flood waters that could reach Makati City," he said, in Filipino.

In the television report, the Pasay government would collect about seven trucks of garbage per day.

The MMDA chairman also urged the public to segregate their waste as thousands of face shields, face masks and personal protective equipment are being collected and could damage pumping stations.—**Consuelo Marquez/LDF, GMA News**

Gloria Ramos, Vice President of Oceana Philippines; and Marian Ledesma, anti-Plastic Campaigner of Greenpeace Philippines-Southeast Asia will join the online conversation conceptualised and hosted by three-term Senator, now House Deputy Speaker and Antique representative Loren Legarda.

This episode will discuss plastic-free alternatives in local enterprises and alternative delivery systems and reuse solutions.

The Philippines is known for its rich marine ecosystems but is also one of the major sources of plastic trash in the world, contributing almost three million metric tonnes of plastic wastes and 500,000 metric tons of plastic waste leakage per year.

Plastic production and incineration use petrochemicals from fossil fuel and thus contribute to global greenhouse gas (GHG) emissions and climate change.

According to the Global Alliance for Incinerator Alternatives (GAIA), Filipinos use 59.7 billion pieces of sachets, 17.5 billion pieces of shopping bags, 16.5 billion pieces of plastic labo bag, and 1.1 billion diapers yearly.



The Covid-19 pandemic has even magnified the problem of single-use plastics as people aim to minimise contamination and further spread of the virus. This has led to utilising easily disposable items, such as those used for food and other deliveries.

The upcoming episode will focus on non-government organisations that have worked across communities to address the problems caused by plastic pollution, and are calling for the immediate passage of the Single-use Plastic Products Regulation bill.

As an online discussion to promote health, environmental consciousness, and climate-adaptive practices, “Stories for a Better Normal” aims to change the mindset of individuals, families, and communities by demonstrating ways in which a ‘better normal’ can be realised within our communities.

This online discussion is organised in partnership between the Office of Deputy Speaker Legarda and the Climate Change Commission, with support from the Institute for Climate and Sustainable Cities, The Climate Reality Project-Philippines and Mother Earth Foundation.

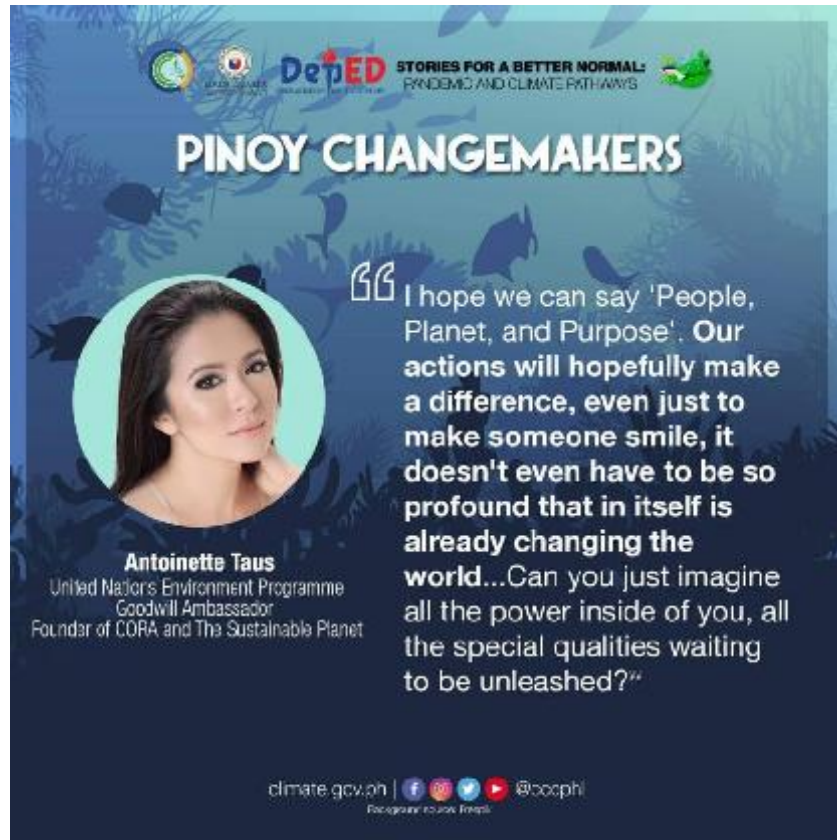

# The lethal argument against climate denialism is reality

THE relationship of climate change denialism to the rest of the world might best be described by a crude analogy: The last bus of the evening arrives at a busy stop, where 100 people are waiting. Ninety-nine people board the bus, reach a consensus that the bus should at least move forward down the street, but as it does so are otherwise engaged in an animated discussion about how fast it should go or what lane it should use.

Meanwhile, the lone person who did not board the bus remains standing at the stop as the vehicle grows smaller in the distance, stridently demanding that someone, anyone debate with him whether buses actually exist, or for that matter, roads.

In his latest screed against the "lie of climate change," the nation's foremost advocate of social atrophy detailed - or more accurately, lifted verbatim from another publication - a summary of a fragment of a scientific debate between three-man teams of climate scientists that took place in January 2014 and was organized by the prestigious American Physical Society (APS).

The excerpt gleaned by the first writer and copy-pasted for the benefit of readers here supposedly presented a "gotcha" moment in the debate: an admission by climate scientists that the climate models they were using to project conditions at the end of the century were inaccurate by as much as 30 percent but were nonetheless still used as the basis of policy formulated by the Intergovernmental Panel on Climate Change (IPCC) and the United Nations.

Our faithful stenographer triumphantly concludes, "To this day, the climate change (CC) movement has not recovered from the devastating debate in New York. CC believers are wary of debating climate change with climate realists, particularly scientists. They won't even present a reasoned brief on their dogma of climate change. They want it to be granted a presumption of proof.

"No wonder, Cal Thomas, the most widely syndicated columnist in America, calls climate change a phony doctrine."

## Reality check

Debating a climate change denier is like getting in a fist fight with a fat kid with asthma. It's not much of a challenge.

Let's clear up the irrelevant non sequitur first: Cal Thomas, whose name or views on the topic appear nowhere else in the latest harangue and is thus a weird choice as a subject of an "appeal to authority" logical fallacy, is not actually the most widely syndicated columnist in America nor apparently as influential as his fans would like to believe. At his peak around 2007, Thomas ranked sixth among American syndicated columnists in terms of total circulation and in a recent (February 2021) survey, ranked 22nd in terms of name recognition.

So much for Cal Thomas; now for the debate itself. According to a more contemporary (April 2015, as opposed to last month's faulty reminiscence used as a source in the latest mewling) analysis of the debate by Scientific American, the reasons it was arranged by the APS were because first of all, many climate scientists were uncomfortable with the "absolute" language used by some of their peers in their conclusions about human-caused climate change - a fundamental principle of any science is uncertainty - and second, they did not wish to exclude, or be accused of excluding, divergent points of view from the broader discussion of climate change.



As Scientific American reports, the attendees at the January 2014 symposium - APS members, all trained physicists - understood the climate skeptics' best argument to be one of dissent with the way the science was being presented to the public, rather than the conclusions of the science itself. "At the end, they understood that the skeptical scientists' 'critique of science itself was extremely weak'," the article quoted Dr. Robert Rosner of the University of Chicago as saying.

Rosner was later part of the committee that drafted the APS' official position on climate change, which responded to the criticism of how the current scientific knowledge was described for public consumption. That statement reads in part, "As summarized in the 2013 report of the Intergovernmental Panel on Climate Change (IPCC), there continues to be significant progress in climate science. In particular, the connection between rising concentrations of atmospheric greenhouse gases and the increased warming of the global climate system is more certain than ever. Nevertheless, as recognized by Working Group 1 of the IPCC, scientific challenges remain to our abilities to observe, interpret, and project climate changes. To better inform societal choices, the APS urges sustained research in climate science."

A debate among those most qualified to engage in it that fundamentally boiled down to a disagreement on semantics can hardly be described as "devastating."

The best evidence that it was not "devastating" is what happened a little less than two years later, in December 2015, when every country in the world except one signed the Paris Agreement on climate action. The lone holdout was the Holy See and only by reason of a technicality: as an observer state of the UN, the Vatican is not a member of the UN Framework Convention on Climate Change, and thus was unable to sign the accord. Pope Francis has since pledged the Church's full cooperation with the pact regardless of its signatory status and committed the Vatican to achieving "net zero" emissions by 2050.

Since the initial signing of the Paris Agreement, only six of the 197 signatories have yet to formally ratify it: Eritrea, Iran, Iraq, Libya, Turkey and Yemen, which together account for less than 3 percent of total global emissions.

An old saying a friend of mine is fond of using occasionally is entirely appropriate here: the dogs may bark, but the caravan rolls on. In the past couple of years, the caravan has been joined by the financial world as well as the political one. Climate impact has now become a standard risk factor in most investments and carries an expensive penalty in almost any project financing or insurance - if financiers or insurers are willing to back environmentally unsustainable investments at all, which they are increasingly refusing to do.

Stubbornly arguing that one is right and the whole of the rest of the world is wrong is the epitome of hubris. When that argument implies - scientific evidence notwithstanding - that it is wrong for humanity to pursue cleaner, more efficient, and more cost-effective technologies and activities, it descends beyond mere hubris into inhumanity.

# World must address oceans crisis – UN

UNITED NATIONS: The world must harness "clear, transformative and actionable solutions" to address the ocean crisis, the president of the UN General Assembly said on Tuesday (Wednesday in Manila) as he opened a meeting to generate momentum toward the 2022 UN Ocean Conference, when public health safety measures allow.

"Simply speaking, our relationship with our planet's ocean must change," Volkan Bozkir told a high-level thematic debate on the ocean and Sustainable Development Goal 14 (SDG14): Life Below Water.

Against the backdrop that human activities have threatened to undo the delicate balance of this ecosystem that supports nutritional, economic and social value to billions the world over, he upheld that there is "simply no scenario" wherein we live on a planet without an ocean.

People do not want to live in "a world of one crisis after the next," said the PGA, preferring instead the "security, sustainability and the peace of mind" that comes with a healthy planet.

"We have seen this in countries and cities that have prioritized coastal and marine areas over tourism... in protected wetlands... in efforts to address illegal, unreported, and unregulated fishing, and regulate shipping and resource extraction," he said.

New governance, policy and market approaches that incentivize both profitability and sustainability - for people and planet - provide an opportunity for a "blue recovery" to build resilience, particularly on small island developing states, upheld by the assembly president.

"Building a sustainable ocean economy is one of the most important tasks and greatest opportunities of our time," he spelled out, urging governments, industries, civil society and others to "join forces developing and implementing ocean solutions."

As the SDG14 targets were among the first to mature, Bozkir encouraged everyone to "think ahead" and arrive at the second Ocean Conference in Lisbon, Portugal with "demonstrable evidence of progress."

Rather than wait until the conference opens to rediscuss these issues, he reminded that the Decade of Ocean Science for Sustainable Development has already begun. "Let us choose to arrive in Portugal with accomplishments and progress that inspire hope and optimism for a better tomorrow," the PGA concluded.

Peter Thomson, UN Secretary General's Special Envoy for the Ocean, emphasized the need to improve our relationship with the sea to one of respect and balance.

He underscored the importance of delivering on SDG14, saying that "ocean acidification cannot continue unabated" while pointing out that greenhouse gas emission reductions are "required to meet 2030 goals."



# US bans drilling in Alaska wildlife site

**ANCHORAGE:** US President Joe Biden's administration announced on Tuesday it was halting petroleum development activity in Alaska's Arctic National Wildlife Refuge (ANWR), reversing a move by former president Donald Trump to allow drilling.

The Interior Department said it was notifying firms of the freeze, pending a comprehensive environmental review that will determine whether leases in the area known as ANWR should be "reaffirmed, voided or subject to additional mitigation measures," the agency said in a statement.

The announcement deals a blow to the long-contested quest of oil companies to drill in the sensitive territory. The push for development picked up momentum after Trump announced the leasing plan last November shortly after losing reelection to Biden.

At a lease sale in January over some 1.6 million acres, US officials auctioned off 11 oil tracts. Major oil companies sat out the bidding and nine of the leases went to the Alaska Industrial Development and Export Authority, a state agency, while two went to small companies.

Biden had promised to protect ANWR during the presidential campaign.

White House climate advisor Gina McCarthy noted Biden's promise and said the move reflected his belief that "national treasures are cultural and economic cornerstones of our country," according to a White House statement.

## COVID-19 cases in NCR rise slightly

MANILA, Philippines — Metro Manila has recorded a slight increase in new COVID-19 cases over the past week, the first time since the peak of the most recent surge in April, the OCTA Research Group said yesterday.

Citing data from the Department of Health, OCTA said the average number of new cases in Metro Manila from May 26 to June 1 was 1,135 per day, up eight percent from the preceding week.

The reproduction number, which indicates the number of persons a positive individual can infect, also increased from 0.57 to 0.68.

Nationwide, the average number of new cases in the past week was 6,699 per day, up 37 percent from the daily average of 4,898 new cases in the preceding week, the lowest since the peak of the surge in April.

OCTA said the cause of the reversal in the downward trend is that the NCR Plus did not see a decrease in cases that would counter the upward trends seen in many local government units outside the bubble.

Several local government units in Metro Manila have also recorded spikes in new cases over the past week.

### Public complacency

In an interview with “The Chiefs” on One News on Tuesday night, OCTA fellow Guido David said public complacency may be seen as a factor in the “disappearance” of the downward trend in Metro Manila.

“It’s not yet at the point that it is very alarming. Right now, the downward trend in the NCR has disappeared. We are seeing an unstable trend right now, which means that we are not certain if it’s going to go up or if it will go down soon,” he said.

“Part of the reason is that we are seeing a lot of these super spreader events happening – private pool parties, social gatherings,” he added. “What we’re getting from reports is that we’re getting community transmission in these private gatherings and if this is the case, then this is more of complacency rather than the overall quarantine restrictions.”



For areas outside NCR Plus, OCTA fellow and molecular biologist Fr. Nicanor Austriaco said the pattern suggests that new COVID variants may have been transported from the capital after the strict lockdown was lifted.

“The NCR surge which we experienced in March and April were driven by variants, and these variants were contained in the NCR for the most part because the bubble went into ECQ (enhanced community quarantine),” he said.

“What you’re seeing all over the Philippines, especially in Mindanao and certain areas in the Visayas, is that regions that had not experienced a surge are now (experiencing it)... This pattern suggests that someone brought the variants from Metro Manila to these regions to set off these outbreaks,” he added.

### **Impact of vaccination**

During the same interview, Austriaco said the country would need to vaccinate more people before its impact on transmission is felt.

“The experience in many other countries suggests that we will not see a significant impact on transmission until the vaccination rate reaches about 30 to 40 percent of the population,” he said.

He pointed out the expected lag in the effect of the vaccination, noting that development of immunity would take six to eight weeks, depending on the type of the vaccine that will be

**MANILA** – President Rodrigo Duterte has renewed his call for universal access to safe and effective Covid-19 vaccines, stressing that vaccine “imbalance” will have consequences.

Duterte made this pitch during the Gavi COVAX Advance Market Commitment (AMC) Summit co-hosted by Japan Prime Minister Suga Yoshihide and GAVI Chair of the Board Jose Manuel Barroso on Wednesday, according to a press statement from the Office of the President.

In his speech, he emphasized the current “glaring imbalance” in vaccine distribution with more than 82 percent of the global supply going to developed countries.

“This imbalance must be corrected – or there will be no real and inclusive global recovery to speak of,” Duterte said.

Duterte also reiterated his earlier pledge to donate USD1 million as a contribution to the World Health Organization (WHO)-led COVAX initiative to aid in accelerating global vaccination coverage.

He first mentioned his desire to contribute USD1 million to the COVAX Facility in a pre-recorded public address on Monday.

“It is our moral responsibility to help each other and face this crisis with greater solidarity and urgency. While modest, our contribution demonstrates our firm commitment to this global fight against Covid-19,” he added.

Duterte said the Philippines, as both donor and recipient country, counts on the COVAX initiative to bring much-needed vaccines to developing countries.

He also thanked the GAVI Alliance and encouraged more countries to also contribute.

The Summit was held with the aim to fill the 1.8 billion gap of the COVAX AMC to provide Covid-19 vaccine doses for lower-income economies.



Securing 1.8 billion doses would enable the AMC to protect nearly 30 percent of the population in all AMC countries or roughly half the entire adult population.

Currently, the AMC has funds in place to protect approximately 20 percent of populations, equivalent to all health and social care workers, the elderly, and those with underlying health conditions. **(PNA)**



# PH to receive more Sinovac, Pfizer COVID-19 vaccines next week—Galvez

**Metro Manila (CNN Philippines, June 2)** — Vaccine czar Carlito Galvez Jr. announced Tuesday the government is expecting the arrival of additional vaccine doses from Sinovac and Pfizer next week.

During a briefing, Galvez said one million Sinovac vaccine shots are seen to arrive on June 6, while another tranche will most likely arrive on June 11.

As for the Pfizer vaccines, he said 2.2 million doses will arrive on June 11. These will be deployed in Metro Manila, Cebu, and Davao, Galvez noted.

Galvez anticipates a steady vaccine supply from the World Health Organization's COVAX facility in the following months. Moreover, he adds that supply from AstraZeneca, Moderna, Sinovac, and Sputnik V will stabilize by July.

Of the more than 8 million doses the country has received, some 5 million COVID-19 shots have been administered. The figure includes 1.2 million Filipinos who are now fully vaccinated.

On the issue of expiring vaccines, the government said 85% of the 1.5 million AstraZeneca doses set to expire end-June have already been given as a first shot, while the remaining 15% will be used up next week.

Latest data show that total number of COVID-19 cases in the country has reached 1,235,467, of which 53,203 are active or currently sick patients.

# PRRD signs AO granting hazard pay to gov't workers

Government workers who rendered service under certain quarantine conditions will receive hazard pay after President Rodrigo Roa Duterte signed Administrative Order (AO) No. 43 on June 1.

The AO grants hazard pay to government workers who were physically present at their jobs in areas where enhanced community quarantine (ECQ) and modified enhanced community quarantine (MECQ) were declared since March 2021.

The estimated hazard pay will be at least 500 per day for all national government agencies including the state universities and colleges, and government-owned and -controlled corporations. The AO also includes workers at local government units.

Moreover, regular, contractual, and casual government workers, as well as holders of contract of service and job order positions are qualified to receive the hazard pay.

**BY THE PRESIDENT OF THE PHILIPPINES**

**ADMINISTRATIVE ORDER NO. 43**

**AUTHORIZING THE GRANT OF HAZARD PAY TO GOVERNMENT PERSONNEL WHO PHYSICALLY REPORT FOR WORK DURING THE PERIOD OF IMPLEMENTATION OF AN ENHANCED COMMUNITY QUARANTINE AND A MODIFIED ENHANCED COMMUNITY QUARANTINE, AMENDING ADMINISTRATIVE ORDER NO. 26 (S. 2020), AND FOR OTHER PURPOSES**

**WHEREAS**, Proclamation No. 922 (s. 2020) declared a State of Public Health Emergency in recognition of the COVID-19 public health event as a threat to national security, and prompted a whole-of-government approach in addressing the COVID-19 outbreak in the country;

**WHEREAS**, Proclamation No. 1021 extended the period of the State of Calamity throughout the Philippines for a period of one year, effective 12 September 2020 to 12 September 2021;

**WHEREAS**, pursuant to the recommendation of the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases under its Resolution No. 106-A (s. 2021), the President imposed an Enhanced Community Quarantine (ECQ) in the National Capital Region and other provinces beginning 27 March 2021 until 04 April 2021, and was subsequently extended until 11 April 2021;

**WHEREAS**, upon the recommendation of the IATF through its Resolution No. 109-A (s. 2021), various areas in the country were placed under a Modified ECQ (MECQ);

**WHEREAS**, government employees occupying regular, contractual or casual positions, or those engaged through contract of service (COS), job order (JO) or other similar schemes, whose services are urgently essential and who physically report for work during the period of an ECQ and MECQ, are inevitably exposed to the risk of COVID-19 infection and other similar health dangers and hazards; and

**WHEREAS**, Joint Resolution No. 4 (s. 2009) authorizes the grant of Hazard Pay to government personnel exposed to hazardous situations, such as, but not limited to, disease-infested places, which pose occupational risks or perils of life;

**NOW, THEREFORE, I, RODRIGO ROA DUTERTE**, President of the Republic of the Philippines, by virtue of the powers vested in me by the Constitution and existing laws, do hereby order:

THE PRESIDENT OF THE PHILIPPINES

**Section 1.** Section 1 of Administrative Order (AO) No. 26 is hereby amended as follows:

**"SECTION 1. Grant of the COVID-19 Hazard Pay.** National government agencies (NGAs) including state universities and colleges (SUCs) and government-owned or -controlled corporations (GOCCs) are authorized to grant COVID-19 Hazard Pay to personnel who physically report for work during the implementation of an Enhanced Community Quarantine and **Modified Enhanced Community Quarantine** in their respective work stations, in an amount not exceeding ₱500 per day per person x x x."

Section 2(b) of AO No. 26 is hereby amended as follows:

**"SECTION 2. Conditions on the Grant of the COVID-19 Hazard Pay.** The heads of government agencies may grant the COVID-19 Hazard Pay to their personnel without the need of further approval of the Department of Budget and Management (DBM), provided the following conditions are met:

x x x

- b. The personnel have been authorized to physically report for work at their respective offices or work stations on the prescribed official working hours by the head of agency or office during the period of implementation of Enhanced Community Quarantine and **Modified Enhanced Community Quarantine** measures in the area of such office or work station; and

x x x."

Section 3 (b) of AO No. 26 is hereby amended as follows:

**"SECTION 3. Funding Sources for COVID-19 Hazard Pay for Employees in the Executive Branch.** The funds needed for the grant of COVID-19 Hazard Pay to employees in the Executive Branch shall be charged against the following sources:

x x x

- b. For GOCCs, the amount required shall be charged against their respective approved corporate operating budgets (COBs) for the **current fiscal year**. Should a GOCC have insufficient funds to fully cover the COVID-19 Hazard Pay at ₱500 per day per person, a lower but uniform rate may be granted for all qualified personnel."

Section 5 of AO No. 26 is hereby amended as follows:

**"SECTION 5. COVID-19 Hazard Pay for Employees in the LGUs.** The grant of the COVID-19 Hazard Pay to employees in LGUs, including those in the barangays, who physically report for work as provided in Section 2(b) of this Order, shall be determined by their respective *Sanggunians* depending on the LGU's financial capability, at rates not exceeding ₱500 per day per person, subject to: (a) the PS limitation in LGU budgets under Republic Act (RA) No. 7160, and (b) the other conditions under Section 2 hereof, chargeable against the **current year's** local government funds. Should an LGU have insufficient funds to fully cover the COVID-19 Hazard Pay at the rate of ₱500 day per person, a lower but uniform rate may be granted for all qualified personnel."

**Section 2.** Except for the foregoing amendments, all other provisions of AO No. 26 shall remain unchanged.

**Section 3.** This Order shall take effect immediately upon its publication in the Official Gazette or in a newspaper of general circulation

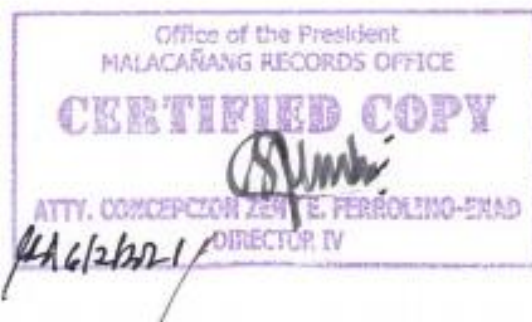

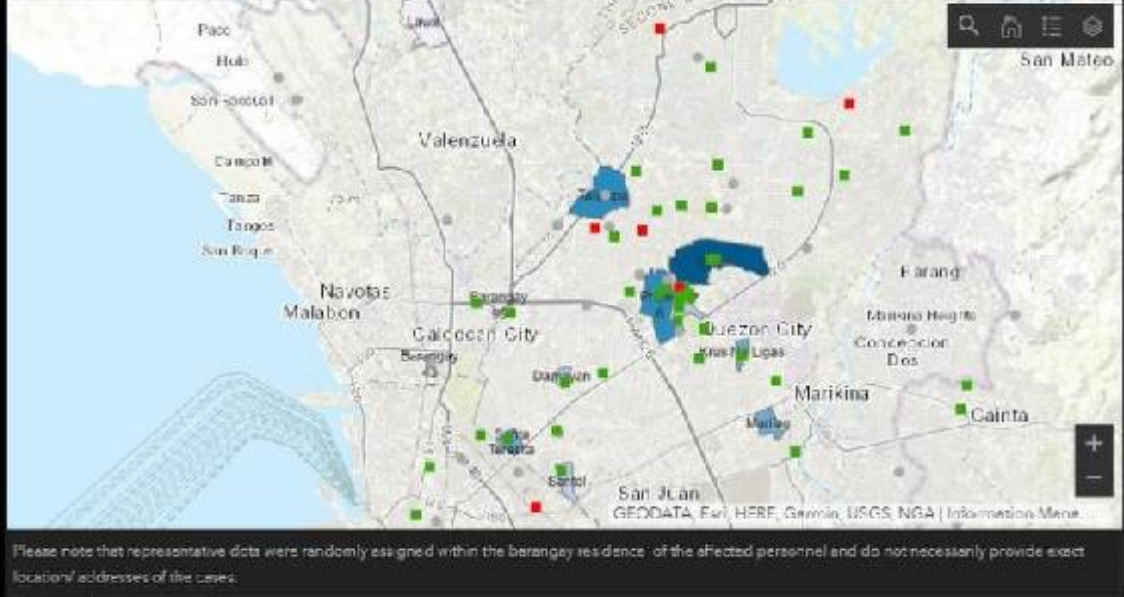
## % COVID-19 Confirmed Cases in DENR-CO



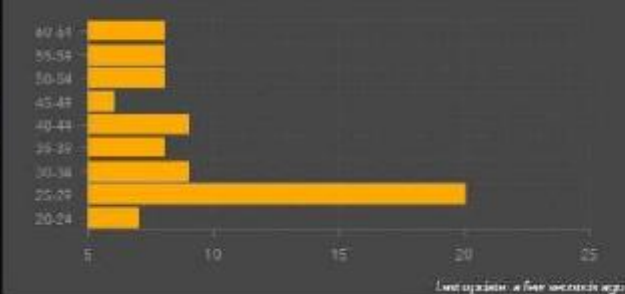

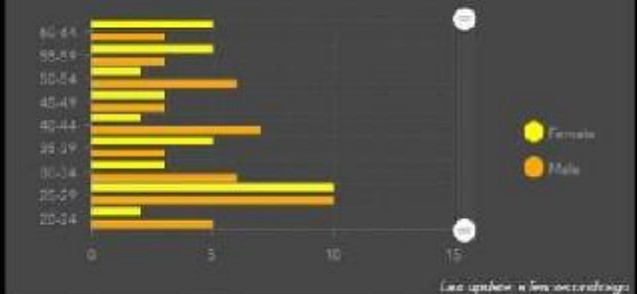
