## **DENR bats for faster mining application process**

The Department of Environment and Natural Resources (DENR) has expressed commitment to improve the efficiency of the application process for priority mining projects, particularly in two areas in Mindanao.

During a consultative meeting on mining concerns in Northern Mindanao and Zamboanga Peninsula last May 5, DENR Acting Secretary Jim O. Sampulna emphasized the importance of expediting the mining approval process in these regions amid the country's continuing economic recovery from the pandemic.

"In our country's quest for economic recovery from the long recession caused by the COVID-19 pandemic, the mining industry may well play a significant role. Our country has around 9 million hectares of land with high mineral potential, out of its total land area of 30 million hectares," Sampulna said in his speech read by Undersecretary for Legal, Administration, Human Resources and Legislative Affairs Ernesto D. Adobo Jr.

The meeting led by the DENR's Mines and Geosciences Bureau (MGB) resulted in the identification of policy gaps and immediate actions from the DENR's Environmental Management Bureau (EMB), Department of Public Works and Highways (DPWH), and National Commission on Indigenous Peoples (NCIP) on several concerns of mining applicants and permit holders in Zamboanga Peninsula and Northern Mindanao.

Among the agenda discussed were the fast-tracking of issuance of environmental compliance certificates through simplified geological study by the EMB and the creation of a one-stop-shop to streamline mining applications by the MGB.

The faster process for issuance of area and dredging clearances by the DPWH and issuance of the Certificate of Non-Overlap and clarificatory meetings with the NCIP were also discussed.

MGB Director Wilfredo O. Moncano said that the aim to address the challenges in filing applications, securing certifications, acquiring permits, and operations of mining projects were mostly considered by the concerned agencies.

"There were some issues that cannot be addressed because these were not under the jurisdiction of the MGB and the other national government agencies that were present. We can bring these issues to the proper agencies. But, for the other issues, I believe we were able to come up with solutions on most of the problems raised in the consultative meeting," Moncano said.

The consultative meeting was also attended by Earth Tools and Development Corporation, identified by the MGB 10 as a mining priority project under Phase 1, which covers companies in the development and construction stage whose commercial operations are expected to become viable within six months.

Holcim Resources and Development Corporation and CEKAS Development Corporation, which are both mining priority projects under Phase 2, also took part in the meeting.

Companies under Phase 2 are those in the process of filing for declaration of mining projects' feasibility, including those in the advanced exploration stage.

Other issues and concerns surrounding TVI Resource Development Philippines Inc.'s Balabag Gold and Silver Project and Canatuan Project and the Industrial Sand and Gravel permit holders in the Zamboanga Peninsula were also discussed.

Moncano said that apart from the prompt approval of permits, the meeting also aimed for the compliance of the Ease of Doing Business Law, improvement in the mines permitting system, faster development of the mineral sector, and increased production capacities of mines.





## Jellyfish bloom seen in Boracay due to Habagat

A jellyfish bloom was reported in the coastal areas of Boracay on Saturday, May 14, due to "habagat," according to the Boracay Inter-Agency Rehabilitation and Management Group (BIARMG).

According to the Bureau of Fisheries and Aquatic Resources (BFAR), the occurrence of jellyfish presence in the shores is dependent on the direction of the wind within the months of May until September.

"Yesterday, the wind direction was southwest or habagat which was towards the White Beach. This caused the jelly fish to accumulate in the beach area," BIARMG General Manager Martin Despi said.

Director Evelyn Abad, BFAR Aklan Provincial Fisheries Office officer-in-charge, said that they are determining the species of the thumb-sized jellyfish that accumulated in the shores.

"We were able to get samples of the jellyfish to determine its species. They were very small and appear to be newborn jellyfish. These will be brought to our laboratory for testing on Monday," Abad said.

Meanwhile, BFAR advised the locals and tourists to avoid swimming in the affected areas. – ag





## EcoWaste: Do away with 'thank you' posters

MANILA, Philippines — After appealing to candidates to take down their campaign posters following the May 9 general elections, an environmental group yesterday asked winners not to hang plastic tarpaulins to thank their supporters.

"In lieu of tarpaulins, politicians can express their gratitude by joining cleanup activities, supporting recycling of campaign paraphernalia and by planting trees," the EcoWaste Coalition said.

"The post-election cleanup has yet to be completed and yet we are seeing 'thank you' posters hanging everywhere. Enough of 'tarpolitics,' we are already drowning in plastics," Aileen Lucero, national coordinator of Ecowaste, said.

Lucero said if all proclaimed winners in the elections would put up "thank you" tarpaulins, people may expect "another garbage overload."

"We need to put a cap on the thoughtless use of tarpaulins, especially for political and other non-essential purposes, as these materials contain hazardous chemicals and are not easily recycled or disposed of," she said.

Tarpaulins, which are often made of polyvinyl chloride or PVC plastic, may contain toxic chemical additives such as cadmium, lead and phthalates.

Laboratory tests commissioned by the EcoWaste Coalition and performed by SGS on six presidential campaign posters found cadmium in all the samples.

"As plastic tarpaulins are neither banned nor regulated, we can only appeal to politicians to control their penchant to 'tarpolize' anything and everything," Lucero said.

According to EcoWaste, the unrestrained use of tarpaulins before, during and after the campaign should prompt authorities to regulate this type of waste.

"In future elections, let us be environmentally responsible and go plastic-free. No more tarpaulins," the group said.

The Department of the Interior and Local Government (DILG) said it is eyeing to issue showcause orders against local government units, which have yet to remove campaign materials in public places.

DILG spokesman Jonathan Malaya said the department continues to receive reports of campaign materials that have not been removed one week after the elections. – Emmanuel Tupas

# Provincial board lifts ban on open pit mining in South Cotabato

KORONADAL CITY — The Sangguniang Panlalawigan (SP) of South Cotabato on Monday approved the proposal to lift the controversial ban on open-pit mining, removing the decadeslong thorn in the throat of the \$5.9 billion (about P295 billion) Tampakan project, Southeast Asia's largest untapped copper-gold minefield.

Without objections from the SP members present, the plenary approved the amendment of the Environment Code on second reading, particularly the removal of the prohibition on open-pit mining.

The session was presided by board member Glycel Mariano-Trabado, in place of Vice Gov. Vicente de Jesus, who was on leave.

Present during the plenary session were board members Hilario De Pedro VI, principal author of the proposal to remove the ban on open-pit mining, Edgar Sambog, Dardanilo Dar, Noel Escobillo, Antonio Fungan, Eamon Gabriel Mati, Henry Ladot, Rolando Malabuyoc, Alyssa Marie Fale, and Rose Grace Achurra.

In a video taken during the recent campaign period and now circulating on Facebook, de Pedro, chair of the committee on environment and natural resources, told a campaign sortie here that he was "against open-pit mining."

De Pedro, the son of the late South Cotabato Gov. Hilario de Pedro III, had sought reelection during the May 9 polls but lost.

"We are doomed," said environmental activist Chinkie Peliño-Golle, a resident of this city, after the provincial board lifted the ban on open-pit mining.

Board member Ester Marin Catorce, who openly stood against the lifting of the open-pit mining ban, was not present during the session. She was designated acting governor as Gov. Reynaldo Tamayo was on leave.

Board members Ellen Grace Subere Albios and Jinky Avance-Samodal were also on leave.

Since 2010, the open-pit mining ban had hounded the giant Tampakan mining project, which had been pursued by Sagittarius Mines, Inc (SMI) since the early 2000s.

SMI earlier revealed in a study that the most viable way to extract the minerals was through open-pit mining. The Tampakan project has been touted as the largest undeveloped coppergold minefield in Southeast Asia and among the biggest of its kind in the world.

It has the potential to yield an average of 375,000 tons of copper and 360,000 ounces of gold in concentrate per annum in the expected 17-year life of the mine. SMI has repeatedly vowed to employ "responsible mining" in the Tampakan project.


The Diocese of Marbel has been staunchly opposing the Tampakan project, which had claimed the lives of dozens of pro- and anti-mining advocates in the past three decades, on concerns over the environment, food security, and human rights.

# More universities join work for Mt. Apo's UNESCO Geoparks listing

FOUR universities and the National Museum of the Philippines are working together for the profiling of flora and fauna at the Mt. Apo National Park, which will be used to support the goal of having the country's highest peak listed as a UNESCO Global Geo-Park (UGGp) as well as update conservation programs.

The data-gathering project is under the Biodiversity in Selected Mountain Ecosystems of Mindanao for Conservation and Sustainable Development program of the Central Mindanao University.

It is funded by the Department of Science and Technology and being undertaken in partnership with the University of the Philippines-Los Baños, Davao Oriental State University, and Davao Del Sur State College.

"The gathering of critical data for the said project will not only aid the generation of knowledge for MANP's (Mt. Apo Natural Park) conservation plans and programs but will also succor its application for recognition as a UNESCO Global Geo-Park (UGGp)," the Environment department's Davao regional office said in a statement.

Indigenous peoples in Mt. Apo, particularly the Bagobo Tagabawa communities, are also collaborating in the research program.

"The partnership shall also act as contribution to the greater body of knowledge for Mountain Ecosystems in Mindanao and the Philippines," the department said.

Mt. Apo's Protected Area Management Board is stepping up efforts this year for the application to the United Nations Education, Scientific and Cultural Organization's (UNESCO) Global Geoparks, a relatively new label ratified by member states in 2015.

Global Geoparks "are single, unified geographical areas where sites and landscapes of international geological significance are managed with a holistic concept of protection, education and sustainable development," according to the UNESCO site.

There are currently 177 UNESCO Global Geoparks in 46 countries.

# 'Kwentong Kalikasan' features stories on forest conservation

TO put a human face on the issues affecting our forests, the <u>Association of Young Environmental Journalists</u> (AYEJ), in collaboration with <u>Forest Foundation Philippines</u>, has launched a new project that aims to highlight ecosystem restoration, preservation, and conservation through visual storytelling and video advocacy.

"Kwentong Kalikasan" is a video advocacy initiative that seeks to feature the stories and works of individuals, scientists, conservationists, champions and emerging advocates of forest landscapes through a video series in the hopes of multiplying, amplifying and creatively documenting the positive impact of forest conservation work.

The first component is a seven-episode TV-magazine show composed of a series of intimate indoor conversations featuring honest stories of Mindanaoans that cover topics like forest conversation, indigenous narratives, biodiversity, science, the environment, and everything in between.

The second component is a seven-part mini-documentary series that feature profiles of emerging advocates and personalities in the Bukidnon-Misamis Oriental area, zooming in on the human dimension of solutions-making in forest landscape issues.

Moreover, the project hopes to immortalize the work being done in forest conservation and the people behind it.

The episodes were launched in April until October twice-a-month on the official Facebook pages of AYEJ and Forest Foundation.

Following the rollout of videos, AYEJ will hold a Traveling Film Festival by the end of the year where it will screen the episodes in and around communities and schools in Bukidnon and Misamis Oriental.

AYEJ is an environmental development communication non-profit based in Cagayan de Oro City committed to enabling communities to be ecologically literate and proactive towards a more livable planet.

They have been doing capacity-building initiatives and knowledge product development with partners such as the <u>Department of Education</u>'s Disaster Risk Reduction and <u>Management Service</u>, Internews, and the <u>US Embassy</u> in the Philippines.

# Zoonotic spillover is the apocalypse you'll be hearing about a lot

THE TERM "zoonotic spillover" might sound either reassuringly geeky or deceptively innocuous — like a sticky mess involving a melted ice cream cone between the monkey cage and the aquarium. It refers, in reality, to one of the greatest dangers to humanity. As such, it is neither more nor less menacing than climate change, but a direct consequence of it.

The word "zoonosis" comes from the Greek for "animal disease." It applies to pathogens that can jump both between critters and from them to us. HIV, the virus that causes AIDS, hopped to humans from chimps, for example. MERS, a respiratory virus, spread to us from dromedary camels. Ebola probably came from apes, monkeys, or bats, or all of them. In similar ways, we've imported hundreds of other ills from the wild kingdom — not least, SARS-CoV-2 (COVID-19), which we also picked up from bats.

What does this have to do with climate change? A lot. The more animals mingle — with other fauna or us — the more opportunities the pathogens they're hosting have to travel, mutate, and spread. And global warming causes exactly such mingling.

As average temperatures rise, they change habitats. Wet areas become arid; cool or lush zones turn into deserts, and so forth. As a result, animals migrate out of their familiar surroundings and come in contact with many other species, most of which they've never encountered.

A team working with Colin Carlson, a biologist at Georgetown University in Washington DC, has now used some very fancy math to model the contacts and cross-species virus transmission we can expect. They've published the results in the journal *Nature*.

It makes for frightening reading. Both the mingling and the transmission are already well underway but will accelerate dramatically in our lifetime. Even in the most conservative warming scenario, for example, we can expect another 15,000 viruses to hop among 3,000 species of mammals in the coming decades. The main melting pots won't be the regions near the polar north or south, as might be expected, but the higher elevations of Asia and Africa.

Mammals play a starring role in this horror movie mainly because they're genetically close enough to us for their bugs to wreak havoc in our bodies. Bats present a particular threat because they can fly and are thus able to migrate farther and faster. Brazilian free-tailed bats, for example, have spread throughout the southeastern US in recent years.

Global warming also abets pathogens in many other ways. For example, it causes a thaw of the permafrost. That frozen ground in northern latitudes is a vast arsenal of ancient viruses, bacteria, and other nasties. The frost has kept them away from wildlife so long, animals and people no longer have any immunity to them. But now they're coming out of their icy vaults. There have been outbreaks of anthrax in Siberia recently, after spores wafted out of ancient reindeer carcasses previously sealed in the ice. We can expect much more of this sort of thing.

Can we do anything about all these threats? Only up to a point. We should certainly clamp down on deforestation — especially in the Amazon rainforest — which also forces species into involuntary contact with one another and us. And we should regulate and monitor wildlife markets, farms, and other places where species jostle up against one another.

Above all, we should prepare for future epidemics and pandemics now. For decades before COVID-19 arrived, various Cassandras told us to have a plan and make it global, but we largely ignored them.

But the most urgent and important effort to which we must <u>recommit</u> is the struggle against climate change itself. In the Paris Agreement of 2015, we collectively declared the ambition to keep global warming to a long-term increase of 1.5 degrees over temperatures in the 19<sup>th</sup> century. No chance. According to <u>new projections by meteorologists</u>, we're likely to breach that threshold by 2026. From here on, every additional uptick on the thermometer also raises our risk of disease.

## MGB eyes probe on illegal Samar mining

Residents in Hinabangan town attested that clandestine mining operations have been ongoing for years now, with trucks seen hauling tons of ores during the night to an unknown destination

TACLOBAN CITY — The Department of Environment and Natural Resources (DENR) and the Mines and Geosciences Bureau (MGB) in Eastern Visayas are set to jointly investigate the alleged illegal mining operation in an old and believed to be an abandoned mining site in Hinabangan, Samar.

MGB-8 information officer Celeste Faith de la Cruz said that the agency is teaming up with DENR's Enforcement Division to look into the extent of the alleged illegal mining in the area and its impact to the environment especially that the site is within the Samar Island National Park, which is a protected area.

De la Cruz added that MGB-8 is waiting for the report from the National Bureau of Investigation (NBI) which conducted an operation which resulted in the arrest of six individuals who were attempting to transport P84-million worth of illegally mined pyrite ores from the area last 2 May, 2022.

The old mining site Bagacay Mine — a copper and pyrite mining area — was operated by Marinduque Mine Industrial Corp. from 1956 to 1985 and by the Philippine Pyrite Corp. from 1986 to 1992 before it was abandoned after the tailing breach spilled tons of heavy metal-laced wastes downstream to Taft River.

While it was believed to be abandoned, residents in Hinabangan town attested that clandestine mining operations have been ongoing for years now, with trucks seen hauling

tons of ores during the night to an unknown destination.

NBI officer-in-charge director Eric Distor said the bureau received intelligence reports of unlawful extraction of high grade mineral, Ore Pyrite, from the mining site without

the required permit from the DENR prompting it to conduct the operation.

The operatives seized an estimated 56,000 kilograms of pyrite ore with an estimated market value of P84 million and arrested the six suspects.

## A noble initiative: the Tullahan rehab project

WITH the looming onset of the rainy season, focus must now be on the dredging of esteros and the rehabilitation of rivers to avert flooding in the metropolis and other urban centers in the Philippines.

Improper garbage disposal and tons of effluents discharged into bodies of water from factories and industrial plants result in water pollution, destroying marine lives, aesthetics and recreational values of the bodies of water.

While it is primarily the government's responsibility to ensure the problem of water pollution is addressed, the sad reality is public funds are not enough. Each of us must be involved in solving the problem of pollution in our country's bodies of water to bring drastic changes to their dismal state.

Filipinos are fortunate that tremendous effort is being exerted by many private companies and organizations to rehabilitate bodies of water. One of these companies is San Miguel Corporation (SMC).

SMC is an active partner of the Department of Environment and Natural Resources (DENR) in the latter's Adopt-an-Estero Program. DENR partners in the program undertake environmental improvement on the waterway they have adopted. Aside from regular clean-up activities and dredging of the waterway, they may also conduct information and education campaigns, community mobilization activities and training for stakeholders.

The program is one of DENR's priority initiatives and strategies relative to the continuing Supreme Court mandamus to clean up Manila Bay. It was on March 14, 2019 when former DENR Secretary Roy A. Cimatu and SMC President and CEO Ramon S. Ang (RSA) signed the memorandum of agreement to formalize the

Spanning 27 kilometers from the La Mesa Water Reservoir in Quezon City to Centennial Park in Navotas City, the Tullahan-Tinajeros River System is a major tributary of Manila Bay. It is considered one of the most polluted waterways in Metro Manila. It traverses the cities of Malabon, Caloocan, Valenzuela and Quezon. It is the beneficiary of SMC's river rehabilitation initiative.

Recently, SMC announced its initiative to rehabilitate the Tullahan River has gained ground. After months of cleaning major segments of the river system, it was reported that a hydrographic survey showed significant improvement in the river depth and carrying capacity. Silt and solid wastes were removed, making the flow of water from upstream unobstructed. This has resulted in less flooding in nearby areas.

This has provided relief to communities affected by flooding as a result of overflowing rivers that are filled up when downpours occur. "Essentially, what we've accomplished is to remove the silt and wastes that have made these rivers shallow and increase their ability to receive water from upstream channels, particularly during heavy rain or typhoon season, which is when severe flooding in many areas in Metro Manila occur," RSA said.

RSA added that the Tullahan River's depths at areas along the 10-kilometer stretch the company's cleanup teams have worked on are now between three to five meters, compared to one to two meters previously.

SMC has removed 876,296 metric tons of silt and solid wastes from the Tullahan River and it hopes to reach one million metric tons by June. It has allotted Php1billion budget for the program that was launched in 2020. The amount will include the cost for equipment acquisition.

SMC's river dredging and clean-up initiative has been lauded by DENR as Acting Secretary Jim O. Sampulna commended the conglomerate for its dedication in protecting and preserving the environment. "We are very grateful for our partnership in securing healthier and cleaner waterways for a better future," he said.

26, 2010, DENR inked a Memorandum of Agreement with San Miguel Foundation. the corporate social responsibility arm of San Miguel Corporation to clean up Metro Manila waterways. One of the focus areas of the Foundation is on the environment that includes river rehabilitation.

The agreement involved the environmental improvement of a 1.7-kilometer portion of the Tullahan River in Valenzuela City starting from MacArthur Highway to the Philippine National Railways bridge. The MOA also stipulated that SMC through SMF will undertake "expanded environmental improvement including including the dredging of portions of the Tullahan River from the MacArthur Highway all the way to Manila Bay.

Then DENR Secretary Ramon Paje called the partnership "a big boost to our adopt-an-estero program" as he emphasized that most of the water bodies in Metro Manila could no longer be restored by feetable books.

### BFAR to determine 'jellyfish' species in Boracay

By 5:00 p.m., the jellyfishes have washed away, and no recurrence was observed on Sunday morning.

the jellyfish is a natural occurrence in the coastal areas of the province from May to September and is dependent on the direction of the wind. Meanwhile, Department of Environment and Natural

said the BIARMG has coordinated with the BFAR Aklan regarding the incident.
"The safety of the public is our primary concern.

BlARMG General Manager Martin Despi said thumb-sized jellyfish were seen in all three stations of the White Beach, particularly in the waters and on the beach area, and in An-

"Yesterday (Saturday), the wind direction was southwest or 'habagat' towards the White Beach. This caused the jellyfish to accumulate in the beach area," said Despi.

As of Sunday morning, May 15, Abad said that the team they sent reported that the White Beach, from stations 1 to 3, is clear of jellyfish and has almost no trace of Saturday's incident.

Despi, on the other hand, added that the lifeguards have advised tourists not to swim in the affected area should there be

# Philippines records 1,118 COVID-19 cases from May 9 to 15

MANILA, Philippines — The Philippines recorded 1,118 new COVID-19 cases and verified 16 deaths from May 9 to 15, the Department of Health said Monday.

The daily case average during that period was 160, which was 0.3% lower than a week earlier. Of the additional cases, 14 or 1.3% had severe and critical illness.

The DOH has recorded more than 3.68 million COVID-19 infections since the pandemic started in 2020.

There are currently 588 severe and critical admissions, which represent 10.6% of total COVID-19 patients in hospitals.

Data from the health department showed that 15.6% of 2,812 intensive care unit beds nationwide have been used, while 17.5% of 23,707 non-ICU beds have been utilized.

Of the 16 deaths verified during the past week, 10 occurred from May 2 to 15. Over 60,000 people have died in the Philippines since the beginning of the public health crisis.

According to the DOH, 68.6 million Filipinos—or 76.29% of the target population for vaccination—have been fully immunized against COVID-19. Of the figure, only 13.6 million have gotten booster shots.

Metro Manila and other parts of the country will stay under Alert Level 1 until end-May. This was announced following the detection of the BA.2.12.1 Omicron subvariant in the capital region and Palawan. DOH said there is no evidence suggesting the subvariant causes more severe disease.

### Philippines logs 588 severe, critical cases

MANILA (UPDATE) - The Philippines' health department said Monday that 588 or 10.6 percent of COVID-19 patients in hospitals were in severe and critical condition.

The figure is lower than the previous week's 611 severe and critical patients who comprised 11.9 percent of COVID-19 hospital admissions at the time.

A total of 438 or 15.6 percent of 2,812 intensive care unit (ICU) beds for COVID-19 patients were occupied as of Sunday, according to the Department of Health's latest bulletin.

From May 9 to 15, the country recorded 1,118 new COVID-19 cases or an average of 160 per day, which is 0.3 percent lower than the cases reported from the previous week.

Of the additional infections during the week, 14 were severe and critical.

The number of new cases is the lowest logged in a single week in more than two years or since March 23-29, 2020 when the country logged 1,032 infections, according to the ABS-CBN Investigative and Research Group citing DOH data.

It is also the sixth straight week that cases logged weekly remained below 2,000, the research group said.

During the past week, the DOH said it verified 16 more COVID-related fatalities, citing late encoding of death information. Twelve of those occurred this month.

It is the lowest weekly death toll in more than two years or since the week of March 16-22, 2020 when the DOH logged 13 deaths, the ABS-CBN IRG said.

Some 68 million or 76.29 percent of the eligible 90 million population in the country have been fully vaccinated against the respiratory disease, of whom 13.6 million have received their booster shots.

The DOH urged the public to get their booster shots as these prevent severe and critical diseases, citing as examples those who contracted the highly transmissible BA.2.12.1.

"We cannot be complacent at this point. Ang ibang bansa pumuputok ang mga kaso because of these sublineages," Health Undersecretary Maria Rosario Vergeire said.

# Metro Manila, 85 other areas under Alert Level 1 until May 31

**MANILA** – Metro Manila and 85 other areas will remain under the lowest Alert Level 1 classification from May 16 to 31, Malacañang announced Sunday night.

Acting presidential spokesperson Martin Andanar said the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) approved the new classification on Saturday.

Also placed under Alert Level 1 during the same period are the following provinces, highly urbanized cities (HUCs) and independent component cities (ICCs):

For Luzon: Abra, Apayao, Kalinga, Mountain Province, and Baguio City in the Cordillera Administrative Region; Ilocos Norte, Ilocos Sur, La Union, Pangasinan, and Dagupan City in Region 1; Batanes, Cagayan, Isabela, Nueva Vizcaya, Quirino, and City of Santiago in Region 2; Aurora, Bataan, Bulacan, Nueva Ecija, Pampanga, Tarlac, Zambales, Angeles City, and Olongapo City in Region 3; Batangas, Cavite, Laguna, Rizal, and Lucena City in Region 4-A; Marinduque, Oriental Mindoro, Romblon, and Puerto Princesa City in Region 4-B; and Region Albay, Catanduanes, and Naga City in Region 5.

For the Visayas: Aklan, Capiz, Guimaras, Iloilo, Bacolod City, and Iloilo City in Region 6; Siquijor, Cebu City, Lapu-Lapu City, and Mandaue City in Region 7; and Biliran, Eastern Samar, Southern Leyte, Ormoc City, and Tacloban City in Region 8.

For Mindanao: Zamboanga City in Region 9; Bukidnon, Camiguin, Misamis Occidental, Misamis Oriental, Cagayan de Oro City, and Iligan City in Region10; Davao City in Region 11; and Surigao del Sur and Butuan City in Caraga.

The following component cities and municipalities will likewise be placed under Alert Level 1 without prejudice to those component cities and municipalities already under Alert Level 1 pursuant to IATF Resolutions No. 165-G, 166-A, 167-A, and 167-C (s. 2022):

For Luzon: Kiangan, Ifugao in Cordillera; and Balud, Masbate and Irosin, Sorsogon in Bicol Region.

For the Visayas: Calape, Bohol; Garcia Hernandez, Bohol; San Isidro, Bohol; San Miguel, Bohol; Alcoy, Cebu; Borbon, Cebu; Oslob, Cebu; Pilar, Cebu; Santander, Cebu; Tudela, Cebu; Bacong, Negros Oriental; Dauin, Negros Oriental; Valencia (Luzarriaga), Negros Oriental; and Zamboanguita, Negros Oriental in Central Visayas; and Tarangnan, Samar and Zumarraga, Samar in Eastern Visayas.

# No case increase seen to warrant change in alert level: OCTA

**MANILA** – The OCTA Research Group said Monday there are no threats of increase in Covid-19 cases so far to warrant a downgrade in the current alert level of Metro Manila and other areas.

In a televised public briefing, OCTA Research fellow Dr. Guido David said the country's positivity rate is 1.1 percent and reproduction rate is 0.6 percent.

"Hindi pa siya tumataas to greater than one, so we're still okay. Pati 'yung hospitalization rate, mababa pa rin naman (It has not gone up to greater than one, so we're still okay. The hospitalization rate remains low as well)," he said. "Wala naman tayong nakitang threat o area na may threat na tumataas ang kaso sa ngayon (We have not seen any threat or area with threat of increasing cases at the moment)".

Metro Manila and 85 other areas are under Alert Level 1 until May 31.

Since the campaign period started in February, the OCTA Research Group has not seen any "sustained increase" in Covid-19 cases. But there were sudden spikes that are considered small and clustering of cases.

David noted that the clustering of cases did not spread "maybe because the country's ball of immunity due to Covid-19 vaccines and natural immunity is still high".

However, these are not definite as cases could increase few weeks after the May 9 elections and with the detection of BA.2.12.1 Omicron subvariant in Metro Manila and Palawan.

In South Africa, the detection of the highly transmissible Omicron subvariants BA.4 and BA.5 caused an increase in the average daily cases – from 1,000 to 8,000 infections per day.

"Kung kukumpara natin sa situation sa bansa, ngayon nasa 200 cases per day pa rin tayo, so, kahit tumaas pa 'yan to 250, hindi 'yan significant. Pero kapag makakita tayo ng pagtaas sa 500, 400, definitely, magiging concerned na tayo at baka nagkakaroon na ng pagtaas ng kaso (If we'll compare the situation to our country, we're still now at 200 cases per day, so, even if it increases to 250, it's not significant. But if we see an increase to 500, 400, definitely, we'll be concerned that there's an increase in cases)," David said. (PNA)

# No local transmission of Omicron BA.2.12.1 yet: DOH

**MANILA** – There is no indication yet of a local transmission of the Omicron subvariant BA.2.12.1 in the country, an infectious disease expert said Monday.

In a televised public briefing, Department of Health (DOH) – Technical Advisory Group member, Dr. Edsel Salvaña, said certain areas were placed under Alert Level 2 because they have not reached the minimum vaccination rate corresponding to their eligible population, not due to the detection of BA.2.12.1 cases.

However, Salvaña did not discount the possibility of local transmission as the subvariant is highly transmissible.

"Para masabi namin na meron talagang local transmission, lalung-lalo na iyong tinatawag na sustained local transmission, tinitingnan natin itong transmission chain niyan at makikita natin kung mati-trace pa natin (For us to say there is really local transmission, especially sustained local transmission, we look at its transmission chain and see if it can be traced)," he said.

Earlier, the DOH detected two local cases of BA.2.12.1 in the National Capital Region. Both had no international travel history.

Twelve other BA.2.12.1 cases were also detected from a tourist cluster in Palawan, 11 of them foreign nationals.

"Halimbawa, iyung sa Palawan, very clear naman [na] isang cluster iyon. Itong sa Metro Manila, iyung dalawa na BA.2.12.1, sinusuri po natin iyong contacts niyan at kung saan man nila nakuha (For example, the one in Palawan, it's very clear that it's one cluster. The two BA.2.12.1 cases in Metro Manila, we're examining their contacts and where they got it). Is it abroad, is it something that was imported o mayroon ba talagang (or was there a) hidden community transmission?" Salvaña said.

The DOH assured the public that Covid-19 vaccines are safe and effective against the BA.2.12.1 subvariant and they help keep the health care utilization low and the economy reopening under Alert Level 1.

The following provinces, highly urbanized cities, and independent component cities are under Alert Level 2 until May 31, without prejudice to their respective component cities and municipalities which may be under a different Alert Level classification: Luzon: Cordillera

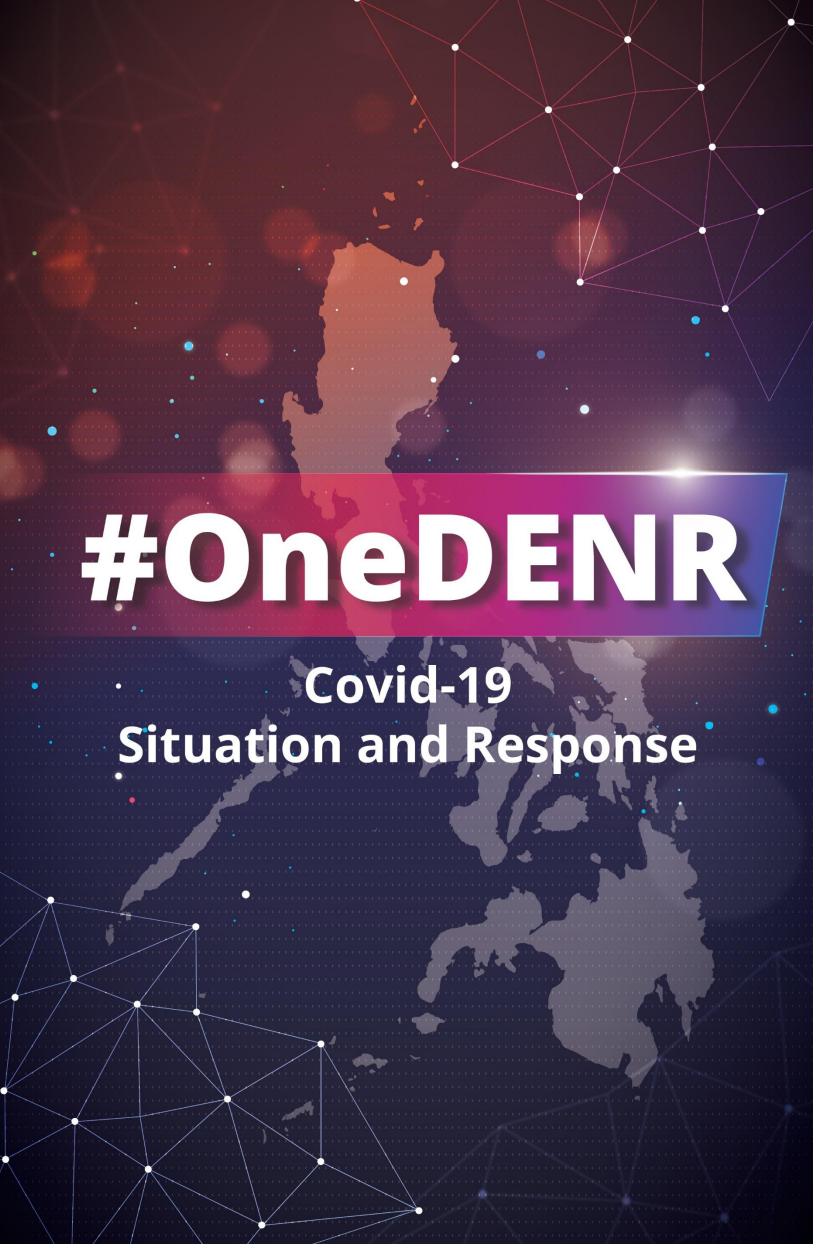


