





In landmark decision, DENR parcels out 2-ha. Lupang Arenda in Taytay



The Department of Environment and Natural Resources (DENR) in a landmark decision said it has distributed a 2.01-hectare land at Lupang Arenda in Taytay, Rizal to the urban poor.

Acting Environment Secretary Jim Sampulna said the land distribution has ended the decades-long wait of the beneficiaries to own the disputed land.

He handed over the land titles to the beneficiary-members of the Samahang Masigasig ng Sitio Tapayan Homeowners Association (SAMATHOA) in Barangay Sta. Ana.

He led the turnover of 41 original certificates of land ownership to the member-beneficiaries of SAMATHOA who have been occupying the 2.01 hectares of land at Lupang Arenda.

He expressed gratitude to President Rodrigo Duterte for his directive to strengthen the land distribution and reform program in the country that benefited the members of SAMATHOA.

He said the government commits to providing the rest of the land parcels which comprise the remaining three hectares of the proposed DENR Center in Rizal through the provision of a temporary ownership document.

"There are still 319 patents supposed to be given to you, however, these are underwater which cannot be titled," he said.

"But in the meantime, I told PENRO (Provincial Environment and Natural Resources Officer) and RED (Regional Executive Director) to issue a certificate of land allocation (CELA). The CELA is already like a land title but you are not yet required to pay tax since we cannot yet have it titled due to its location," he raised.

He urged the Rizal PENRO to expand the titling process in nearby towns.

"I am challenging, the most competent PENRO, PENRO (Ramil) Limpiada that while we are working on distributing lands here in Lupang Arenda, we should also look into other areas in Taytay, in Antipolo, and other areas in the province that needs to be titled," he said.

Go lauds award of land titles to informal settlers



SEN. Christopher Lawrence "Bong" Go lauded the awarding of land titles to 41 informal settlers in Taytay, Rizal, as he urged them to develop their lots to improve their lives.

The senator congratulated the 41 new land title holders during a turnover ceremony led by the Department of Environment and Natural Resources on Friday, March 4.

He said 20 100-square-meter lots in Lupang Arenda, Barangay Santa Ana were distributed to the members of the Samahang Masigasig Tapayan Homeowners Association (Samathoa).

After the ceremony, Go's team distributed meals at the quarantine facility, along C6 Road in Taytay.

In a statement, Go said the move "marked the latest demonstration of the Duterte administration's commitment to solve land ownership issues in the country."

"These lands were granted to you by the government as a result of your negotiation with the government," Go said in a video message in Filipino.

The senator voiced hope that their new lots would inspire them to protect it and develop it.

"Rest assured that I and President Rodrigo Duterte and the help [of the] entire government are always ready to assist you in your desire to have a prosperous life," Go added.

His office said Go had assisted thousands of indigent residents, displaced workers, typhoon and fire victims, and other vulnerable groups in Antipolo City, Angono, Cainta, Rodriguez, San Mateo, Taytay and Teresa in 2021 alone.

The senator's team also assisted 3,352 residents in Rodriguez on February 25 and 26.

Go pushed for the establishment of Malasakit Centers at the Antipolo City Hospital System Annex 4, Bagong Cainta Municipal Hospital, Casimiro A. Ynares Sr. Memorial Hospital in Rodriguez and Margarito A. Duavit Memorial Hospital in Binangonan.

Meanwhile, as vice chairman of the Senate Committee on Finance, he supported the construction of the Taytay Sports Complex and other infrastructure projects to create new jobs and improve the delivery of public services in the province.


He also appealed for cooperation of the public in order to achieve the goal of a flood-free Metropolis.



DENR calls on the next admin to provide more funds on waste management programs

MANILA — The national government must pour in more funds on the country's solid waste management programs, and as the May 2022 national and local elections draw closer, the Department of Environment and Natural Resources (DENR) is hoping that the next administration would include this on their priorities.

The Environment department believes in increasing the funding for local government units (LGUs) and working on the amendment of Republic Act (RA) 6969 or the Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990 to make better of our solid management efforts.


"For those who will be elected into office, my main suggestion is to focus on assisting LGUs by giving appropriate funding to address the garbage problem in their localities," DENR Undersecretary for Policy, Planning, and International Affairs Atty. Jonas R. Leones said.

Based on the data from the DENR's Environmental Management Bureau (EMB), highly-urbanized cities and 5th class municipalities need around P300 million and P1 million to fund their solid waste management programs, respectively.

Leones also emphasized the vital role of private and public sectors in helping the national government address the country's garbage woes.







THE Department of Environment and Natural Resources (DENR) said it hopes the incoming administration would continue the country's solid waste management programs, particularly by increasing funding for local government units (LGUs) and working on the amendment of Republic Act (RA) 6969 or the Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990 as the election draws near on May 9.

"For those who will be elected into office, my main suggestion is to focus on assisting LGUs by giving appropriate funding to address the garbage problem in their localities," DENR Undersecretary for Policy, Planning and International Affairs Atty. Jonas R. Leones said.

Sañez is hoping that a draft bill amending RA 6969 will be given priority to institutionalize circular economy and extended producer's responsibility (EPR) for both municipal and domestic solid wastes and hazardous wastes.

"I hope that the next administration or whoever will be the next president will give priority to the draft bill amending RA 6969. This has already been approved in the House of Representatives but is still awaiting the Senate version of the bill. This has not been given priority for more than two decades already and is constantly being refiled and updated," Sañez said.

The proposed bill will serve as the legal basis to implement the concept of a circular economy and EPR.

Through the EPR, the manufacturer of the product will be given accountability for the treatment, disposal, or recycling of its post-consumer products.

Sañez added that the bill also incorporates provisions on contaminated sites management to address the massive redevelopment nationwide where former industrial sites are being developed into residential, commercial, or combination of both known as commercial business districts.





Sampulna's unyielding determination and commitment to the DENR's mission to protect the environment was seen through the years – from DENR-Soccksargen's Chief Regional Development Specialist in 1988 to Regional Director in 2013.

In 2019, Sampulna became the Undersecretary for Enforcement and Muslim Affairs.

A year later, he undertook the position of Undersecretary for Mining, Muslim Affairs, and Attached Agencies, where his role allowed him to supervise regions, from Regions 11 to 13 in Mindanao, to Region 1 in Luzon and Region 6 in the Visayas.

"As the new acting secretary, I want to promote professionalism and careerism in the DENR," said Sampulna, who has been serving DENR for more than 40 years, and is a member of the career executive service for nearly two decades.

"I encourage DENR regional executive directors, assistant regional executives as well as all employees to strive to become homegrown CESOs (career executive service officers). I hope to motivate and inspire them to become better, yet well-grounded leaders of our country," he said.

From having been conferred with CES Eligibility on February 7, 2000, and appointed to his first CESO rank on November 27, 2001, the new DENR chief has earned the highest CES rank on January 7, 2021.

DENR, USAID to partner for environment, climate change

DENR, USAID to boost partnership on environmental protection and climate change mitigation.

TO PROTECT the environment and prepare the country for a deteriorating climate, the Department of Environment and Natural Resources (DENR) and the United States Agency for International Development (USAID) are exploring ways to further enhance the partnership of the Philippines and the US in environmental protection and climate change mitigation.

US Charge d'Affaires Heather Variava, USAID Mission Director to the Philippines Ryan Washburn, and USAID Philippines Environment Office Chief John Edgar on March 3, paid a courtesy visit on DENR Acting Secretary Jim O. Sampulna in acknowledgement of the longtime partnership between USAID and DENR.

"It is our great pleasure to meet you today and have the opportunity to personally thank the US government for always being supporting in our efforts of meeting our agenda in the environment and natural resources," Sampulna told the US officials.





DENR, USAID to partner for environment, climate change

In a press release the new DENR chief, who had been a regional director from 2009 to 2018, cited that several USAID projects were implemented during his time on the field and hoped to continue doing so under his leadership.

"I came from the field, from the region, and I have implemented many USAID projects. We have the Safe Water project and SIBOL (Sustainable Interventions for Biodiversity, Oceans and Landscapes), which we are implementing right now," Sampulna said.

National Water Resources Board (NWRB) Executive Director Sevillo D. David Jr. said the Safe Water project is currently being implemented by NWRB as DENR's focal agency, among three regional offices in Palawan, Negros Occidental, and Mindanao.

Meanwhile, DENR-Biodiversity Management Bureau (BMB) OIC Director Natividad Y. Bernardino shared that the SIBOL project team has recently worked on the Siargao seascape, which was badly hit by Typhoon Odette in December 2021.

"The work that USAID does to the country's resources is so important to the whole world, and the Philippines is one of our priorities for safe and resilient water," Variava said.

USAID provides technical assistance to the projects, with the Safe Water initiative aiming to improve the sustainable management of the country's water resources, and SIBOL on reducing environmental crimes, and improving water security.

It was former DENR Secretary Roy A. Cimatu who signed the five-year partnership with USAID for SIBOL and Safe Water programs on May 27, 2021.

These projects are under the P_{7.25} billion USAID-Philippines agreement on enhanced and community resilience signed by the National Economic and Development Authority and USAID in February 2021.

Palaui Island reopens to tourists

SANTA ANA, Cagayan: The enchanting island of Palaui in the northeastern tip of Luzon in Cagayan province is now open to tourists after a two-year hiatus due to the Covid-19 pandemic.

A ribbon-cutting ceremony in Barangay San Vicente was held here on Tuesday for the reopening of the Palaui Island Protected Landscape and Seascape (PIPLS) led by officials from the Department of Environment and Natural Resources (DENR), Department of Tourism and the Cagayan Economic Zone Authority (CEZA)

The PIPLS is within the jurisdiction of the community environment and natural resources office of Aparri town headed by forester Joselito Razon.

Members of the Protected Area Management Board (PAMB) also joined the opening ceremony.

PAMB is the decision-making body of the PIPLS, a declared protected landscape and seascape area under Republic Act (RA) 11038 in 1994.

RA11038 defines protected landscapes and seascapes as areas of national significance, which are characterized by the harmonious interaction of man and land and water, while providing opportunities for public enjoyment through recreation, tourism and other economic activities.





Palaui Island reopens to tourists

DENR Region 2 (Cagayan Valley) Executive Director Gwendolyn Bambalan said the reopening of the PIPLS will boost the economy and help the country recover from the effects of the public health emergency.

Also the PAMB chairperson, Bambalan noted that at the height of the Covid-19 pandemic in 2020, the DENR provided a P1-million fund for emergency employment to about 160 families on the island.

"Last year, our department initiated the improvement of facilities in PIPLS with a budget of P4.7 million," she added.

Noting the influx of tourists, Bambalan appealed to local officials for the creation of a municipal environment officer position dedicated to manage the environment and natural resources.

Eliseo Mabasa, DENR Cagayan provincial chief, rolled out the health and safety protocols that must be observed by the visitors, boat operators and service providers.

The PAMB requires vaccination cards to be presented upon registration which it said will ensure the safety of island-goers and the local residents.

It said proper garbage disposal shall be observed while at the protected area, collection of wildlife is prohibited. Vandalism, bonfires and throwing of cigarette butts shall not be allowed.

Palaui is 1.25 kilometers offshore from Santa Ana and is also part of the Cagayan Special Economic Zone and Freeport, managed and operated by CEZA.

Secretary Raul Lambino, CEZA administrator and chief executive officer, said Palaui Island has emerged as a gem for sustainable tourism that "safeguards its socio-economic future."

Palaui won the Association of Southeast Asian Nations Community-Based Tourism Award for 2019 to 2021.

The Palaui Environmental Protectors Association (PEPA), the island's major environmental group, was selected for the award during the Asean Tourism Forum on Jan. 18, 2019 in Halong City, Vietnam.

"This Asean award makes Filipinos proud. This shows us the way forward toward sustainable tourism," Lambino said.

He said tourism on Palaui Island with its untouched beaches, waterfalls, rock formations, extensive forests, mangroves and a 300-hectare marine sanctuary, among others, runs on community-based enterprises that are active in providing various services to visitors.

DENR records also show that the marine protected area has 102-hectare mangrove, coral reef of 1,008 hectares and 472 hectares of seagrass.

According to Lambino, CEZA has established micro-enterprises at the downstream end, creating what is viewed as a business model that steers away from traps of uncontrolled tourism.

Since 2006, PEPA has trained the Aeta residents and other locals in Palaui such as fisherfolk, farmers, women and out-of-school youth in programs that arm them with skills to provide visitors with specific tourism-related services.

PEPA operates a "nature village complex" where visitors can stay overnight in the campsite around the Bayanihan Hall.


The Aetas are among the island residents who were trained in the art of traditional massage, preparation of village cuisine, good hygiene and production of island souvenirs from indigenous materials.



NLEX reduces carbon footprint and plastic wastes, strives for greater sustainability

IN TWO years, the North Luzon Expressway (NLEX) Corporation has been able to reduce about 350,000 pieces of plastic waste, as it continues to implement various waste management initiatives in line with its sustainability program.

The tollway company has also been successful in reducing its carbon footprint through the use of solar power panels and LED lights in its operations. It has so far reduced its carbon emissions by 4,989 tons, saving around 5.9 million kilowatt hours of electricity and 265,000 trees.

These environmental efforts are also in keeping with the entire Metro Pacific Group's commitment to help the Philippines meet the United Nations Sustainable Development Goals (UNSDG), particularly UNSDG 6 (Clean Water and Sanitation), UNSDG 7 (Affordable and Clean Energy), UNSDG 12 (Sustainable Consumption and Production Patterns), UNSDG 13 (Climate Action), and UNSDG 15 (Life on Land).

"As a responsible and ISO-certified organization, we want to ensure that we protect the environment not only for our communities, but for the next generation as well. We'd like to create a positive change by integrating sustainability in all aspects of our operations and making it a way of life," NLEX Corporation President and General Manager J. Luigi L. Bautista said.

Since 2018, NLEX has been harnessing solar power in Meycauayan southbound, Balintawak, Bocaue, Mexico, Angeles, San Fernando southbound, and Karuhatan toll plazas. It also incorporates sustainable energy in its roadway lighting systems, closed circuit television cameras, and variable message signs.

Based on 2021 data, the solar-powered toll plazas have generated carbon emission savings of 202,492 kilograms or the equivalent to 6,041 trees planted. The Bocaue Barrier gained the highest carbon emission savings, followed by Balintawak Toll Plaza and San Fernando Toll Plaza southbound, with carbon emission savings of 70,292 kilograms, 53,948 kilograms, and 36,197 kilograms, respectively.

To help save the environment, the company is boosting its sustainability push by limiting plastic usage and lessening plastic waste. It strictly prohibits single-use plastics in food deliveries, canteen operations, and other food services within its premises including corporate offices in Balintawak, Caloocan City; Guiguinto, Bulacan; and Mabalacat City, Pampanga as well as in corporate events and other activities. Single-use plastics include plastic bags, beverage bottles, and food service utensils such as plates, cups, lids, straws, and stirrers.

Employees are being encouraged to use reusable containers and utensils for their meals, while suppliers and service providers are also being persuaded to reduce plastic usage in their transactions with NLEX.





Gov't eyes use of over 400 testing labs for non-Covid diseases

MANILA – The government mulls to maximize the country's Covid-19 testing laboratories nationwide to test even non-coronavirus diseases, presidential adviser for Covid-19 response, Secretary Vince Dizon, said Wednesday.

Dizon, who is also the country's testing czar, said there are over 400 Covid-19 testing laboratories have been established nationwide—either operated by the private sector or the government.

"When we started this nightmare of Covid-19 in early 2020, we had [only] one laboratory that could test Covid-19," Dizon said.

He recalled the country has to send specimens to Australia for Covid-19 testing with only 1,000 test kits being used per day for the entire country.

"Now we have over 400 [laboratories] nationwide. This is really the effort of the Department of Health," he said. "Talagang napadami natin ang testing labs nationwide (We really increased our testing labs nationwide)."

Despite having many laboratories nationwide, Dizon said the Philippine government's strategy in Covid-19 testing has been "risk-based."

"Ang tinitest lang talaga natin ay yung sa tingin natin kailangan itest. Sino-sino ang mga iyan? Iyan yung may mga symptoms, yung mga close contact and vulnerable (We are just testing those who we think should be tested. Who are they? They are the ones with symptoms and the close contacts)," he added.





Gov't eyes use of over 400 testing labs for non-Covid diseases

Dizon emphasized the government has never advocated for "mass testing".

"Unang-una, kasi ang Covid, hindi mo naman talaga dapat itest yung hindi mataas ang risk na magka-Covid o yung exposure niya ng Covid (First of all, you don't need to test those who are not a high risk to infection or those with low exposure)," he said.

Under Alert Level 1 status, Dizon explained those individuals who are unvaccinated or have higher exposure risk to infection are prioritized in Covid-19 testing, pursuant to the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) Resolution No. 148-B and No. 149, s. 2021.

In addition, testing using reverse transcription-polymerase chain reaction (RT-PCR) is recommended and prioritized for senior citizens, persons with comorbidities, and healthcare workers.

The protocol added that testing "shall be optional for other groups not stated above" and shall not be recommended for asymptomatic close contacts unless symptoms will develop and should immediately isolate regardless of test results. Instead, symptom monitoring is recommended.

Dizon said the Department of Health is planning to maximize the use of these laboratories even for non-Covid diseases.

"We can use them to test for dengue, we use them to test tuberculosis, and we can use that to test for other chronic diseases. And that really gives us now this whole network of laboratories that can best serve our public health system. So that's the plan," he said.

Dizon added: "it's a long response but I think it's important for the public to understand, what will happen to these laboratories." (*PNA*)

In landmark decision, DENR parcels out 2-ha. Lupang Arenda in Taytay

THE Department of Environment and Natural Resources (DENR) in a landmark decision said it has distributed a 2.01-hectare land at Lupang Arenda in Taytay, Rizal to the urban poor.

Acting Environment Secretary Jim Sampulna said the land distribution has ended the decades-long wait of the beneficiaries to own the disputed land.

He handed over the land titles to the beneficiary-members of the Samahang Masigasig ng Sitio Tapayan Homeowners Association (SAMATHOA) in Barangay Sta. Ana.

He led the turnover of 41 original certificates of land

ownership to the member-beneficiaries of SAMATH-OA who have been occupying the 2.01 hectares of land at Lupang Arenda.

He expressed gratitude to President Rodrigo Duterte for his directive to strengthen the land distribution and reform program in the country that benefited the members of SAMATHOA.

He said the government commits to providing the rest of the land parcels which comprise the remaining three hectares of the proposed DENR Center in Rizal through the provision of a temporary ownership document.

""There are still 319 patents supposed to be given to you, however, these are underwater which cannot be titled," he said.

"But in the meantime, I told PENRO (Provincial Environment and Natural Resources Officer) and RED (Regional Executive Director) to issue a certificate of land allocation (CELA). The CELA is already like a land title but you are not yet required to pay tax since we cannot yet have it titled due to its location," he raised.

He urged the Rizal PENRO to expand the titling process in nearby towns.

"I am challenging, the most competent PENRO, PENRO (Ramil) Limpiada that while we are working on distributing lands here in Lupang Arenda, we should also look into other areas in Taytay, in Antipolo, and other areas in the province that needs to be titled," he said.



ANTA ANA, Cagayan: The enchanting island of Palaui in the northeastern tip of Luzon in Cagayan province is now open to tourists after a two-year hiatus due to the Covid-19 pandemic.

A ribbon-cutting ceremony in Barangay San Vicente was held here on Tuesday for the reopening of the Palaui Island Protected Landscape and Seascape (PIPLS) led by officials from the Department of Environment and Natural Resources (DENR), Department of Tourism and the Cagayan Economic Zone Authority (CEZA)

The PIPLS is within the jurisdiction of the community environment and natural resources office of Aparri town headed by forester Joselito Razon.

Members of the Protected Area Management Board (PAMB) also joined the opening ceremony.

PAMB is the decision-making

body of the PIPLS, a declared protected landscape and seascape area under Republic Act (RA) 11038 in 1994.

RA11038 defines protected landscapes and seascapes as areas of national significance, which are characterized by the harmonious interaction of man and land and water, while providing opportunities for public enjoyment through recreation, tourism and other economic activities.

DENR Region 2 (Cagayan Valley) Executive Director Gwendolyn Bambalan said the reopening of the PIPLS will boost the economy and help the country recover from the effects of the public health emergency.

Also the PAMB chairperson, Bambalan noted that at the height of the Covid-19 pandemic in 2020, the DENR provided a P1-million fund for emergency employment to about 160 families on the island.

"Last year, our department initiated the improvement of facilities in PIPLS with a budget of P4.7 million," she added.

Noting the influx of tourists, Bambalan appealed to local officials for the creation of a municipal environment officer position dedicated to manage the environment and natural resources.

Eliseo Mabasa, DENR Cagayan provincial chief, rolled out the health and safety protocols that must be observed by the visitors, boat operators and service

The PAMB requires vaccination cards to be presented upon registration which it said will ensure

the safety of island-goers and the local residents.

It said proper garbage disposal. shall be observed while at the protected area, collection of wildlife is prohibited. Vandalism, bonfires and throwing of cigarette butts shall not be allowed.

Palaui is 1.25 kilometers offshore from Santa Ana and is also part of the Cagayan Special Economic Zone and Freeport, managed and operated by CEZA,

Secretary Raul Lambino, CEZA administrator and chief executive officer, said Palaui Island has emerged as a gem for sustainable tourism that "safeguards its socioeconomic future."

Palaui won the Association of Southeast Asian Nations Community-Based Tourism Award for

The Palaui Environmental Protectors Association (PEPA), the island's major environmental group, was selected for the award during

the Asean Tourism Forum on Jan. 18, 2019 in Halong City, Vietnam.

"This Asean award makes Filipinos proud. This shows us the way forward toward sustainable tourism," Lambino said.

He said tourism on Palaui Island with its untouched beaches, waterfalls, rock formations, extensive forests, mangroves and a 300-hectare marine sanctuary, among others, runs on community-based enterprises that are active in providing various services to visitors.

DENR records also show that the marine protected area has 102-hectare mangrove, coral reef of 1,008 hectares and 472 hectares of seagrass.

According to Lambino, CEZA has established micro-enterprises at the downstream end, creating what is viewed as a business model that steers away from traps of uncontrolled tourism.

Since 2006, PEPA has trained

the Aeta residents and other locals in Palaui such as fisherfolk, farmers, women and out-of-school youth in programs that arm them with skills to provide visitors with specific tourism-related services.

PEPA operates a "nature village complex" where visitors can stay overnight in the campsite around the Bayanihan Hall.

The Aetas are among the island residents who were trained in the art of traditional massage, preparation of village cuisine, good hygiene and production of island souvenirs from indigenous materials

Hiking through three trails that crisscross Palaui and reef experience in five snorkeling areas identified by reef rangers are the major island activities.

Palaui Island also earned a spot among CNN Go's best beaches in the world, and was a two-time location of American television series "Survivor."

THE Department of Science and Technology is hoping more women would take part in all levels of climate change development planning, as well as in disaster risk reduction and management.

Science and Technology Sec. Fortunato de la Peña cited a recent survey on 130 countries that showed that with higher female government representation, there are more international environmental treaties likely to be implemented.

"Studies demonstrate that gender equality and women empowerment are central to economic development as well as environmental sustainability. For example, there is evidence that women play a vital role in dealing with disasters by effectively mobilizing communities in the different phases of the risk-management cycle, thus, their greater involvement would contribute substantively to DRMM," De la Pena said in a virtual forum.

He added that research has shown that globally, women are more likely to be considered about the climate crisis.

However, because only a few world leaders are women, there is a lack of representation in climate decisions. "Although women in power posi-

"Although women in power positions are on the rise, recent studies showed that only seven percent of world leaders and 24 percent of law-makers are female, allowing for male leaders in power to continue to call the shots," he pointed out.

The DoST chief also noted that the continuous stereotyping makes women underrepresented in science, technology, engineering, and mathematics education and in decision-making processes.

The country needs more women at the forefront of climate change, he said, as increasing women's participation would result in more environmental and productivity gains and

greater returns across the sustainable development goals.

The Philippines ranked fourth

The Philippines ranked fourth among countries most affected by extreme weather events in the 2021 long-term Global Climate Risk Index.

"We need to address the deeply rooted inequalities that exist for half of the world's population. We need to ensure that women from all economic, and social standings are included in the conversation on climate change policy and resilience plans," he said.

Floods displace South Cotabato residents

KORONADAL CITY — The Provincial Disaster Risk Reduction and Management Office (PDRRMO) on Wednesday disclosed that at least 300 individuals were temporarily displaced after flash floods hit parts of the municipality of Lake Sebu and the near environs in South Cotabato the past two days.

PDRRMO officer-in-charge Rolly Aquino said that the evacuees were from the villages of Takunel and Poblacion, and two other sub-villages submerged by floodwaters following hours of moderate to heavy rains.

This comes after a low pressure area affected parts of Mindanao and the Visayas on Monday and Tuesday and Aquino noted that the internally displaced persons are now staying at their barangay gymnasium and a local church.

He assured that the PDRRMO has ample stock of packed relief items for the affected families.



Aquino also disclosed that the road connecting Barangay Ned and Sepaka in the town of Surallah remains impassable after it was destroyed by a flash flood and landslide.

He assured that the PDRRMO has ample stock of packed relief items for the affected families.

In T'boli town, at least 30 fishponds were destroyed by flash flood affecting 10 farmers in Barangay New Dumangas.

Dante Tidula Jr., chairperson of New Dumangas, said a house was also washed away by surging floodwaters.

3-day vaccination starts today

MANILA, Philippines — The fourth phase of the National Vaccination Days (NVD) starts today with senior citizens and adolescents aged 12 to 17 as top priorities, the Department of Health (DOH) said yesterday.

According to DOH, a total of 1.8 million peolple have been targeted for inoculation during the NVD-4 from March 10 to 12.

"The targets that were set for NVD-4 are more contextualized, in consideration of areas with low vaccination rates and coverage," Health Undersecretary Maria Rosario Vergeire said.

Vergeire noted the targets are the individuals due for second doses, senior citizens and adolescents.

She added the DOH, Department of Labor and Employment and Civil Service Commission are working to "cover and excuse employees and workers from absences if they are slated to be vaccinated in NVD4."

Under NVD-4, the government is making the rounds of households and workplaces to reach out to those not yet vaccinated.

Vaccination sites are also being set up in pharmacies and private clinics for wider coverage.

"Everyone can get inoculated through the continuous vaccine operations and expansion through more accessible vaccination sites all over the country," she maintained.

However, only 6.47 million have completed their primary series while only 1.86 million received their booster shots as of March 5.

On the other hand, some 1.01 million adolescents aged 12 to 17 years have been targeted for COVID-19 jabs but only 230,384 are fully immunized.




