DENR: Recycle, don't burn used campaign materials

MANILA, Philippines — Candidates in Monday's national and local elections should clean up and dispose of campaign materials in accordance with environmental regulations, the Department of Environment and Natural Resources said.

In a statement Thursday, acting environment chief Jim Sampulna said the disposal of campaign paraphernalia must be in accordance with the Ecological Solid Waste Management Act of 2000.

"Win or lose, these candidates must consider the long-term consequences of their campaign materials in the environment. Therefore, they must encourage their supporters and volunteers to take down these materials, especially those made of plastic, and dispose of these properly," he said.

Sampula urged candidates to assemble teams that will clean up voluntarily "instead of being intimidated by possible violations after the election season."

The DILG ordered local government units and poll candidates to remove and dispose of campaign materials by Friday.

In an advisory to LGUs, the strict enforcement of local ordinances and regulations against illegal dumping, open burning and littering, and utilization of materials recovery facilities to collect and restore reusable items have been recommended.

Local governments were also urged to devise innovative and safe strategies to recycle and upcycle reusable campaign waste materials, and impose the responsibility to the organizers of political activities to ensure the waste will be properly disposed of.

More than 168.84 tons of materials were collected after the midterm elections in 2019.

DENR seeks proper disposal of poll materials

The Department of Environment and Natural Resources (DENR) on Thursday urged candidates to dispose their campaign materials properly.

DENR Secretary Jim Sampulna told the candidates in the 2022 national and local elections to clean up and dispose campaign materials in accordance with Republic Act 9003 or the Ecological Solid Waste Management Act of 2000.

"Win or lose, these candidates must consider the long-term consequences of their campaign materials in the environment. Therefore, they must encourage their supporters and volunteers to take down these materials, especially those made of plastic, and dispose these properly," he said.

The agency, along with the local government units, would be "at the beck and call" of the Commission on Elections to make sure that a resolution would be crafted requiring candidates to remove election materials after every campaign period.

"We will make sure that the existing environmental laws, such as RA 9003, will strengthen the resolution," Sampulna said.

He called on the candidates to assemble their teams to "clean up voluntarily instead of being intimidated by possible violations after the election season."

He recommended the recycling and upcycling campaign materials to lessen the by-products to be disposed of at dumps.

He said the Department of the Interior and Local Government, a member of DENR's National Solid Waste Management Commission, has already disseminated an advisory to all local governments to remind them to strictly enforce the pertinent provisions of RA 9003.

Commission on Elections spokesperson John Rex Laudiangco also urged winning and losing candidates to help them remove their campaign materials.

"We are asking all candidates, please continue cleaning up your campaign materials. Let us be environment friendly and compliant," he said, adding that "if possible, let us recycle these materials. Don't just throw them away anywhere."

During the campaign period — 90 days for running for national positions and 45 days for local — candidates have put up tarpaulins, posters, among others, to promote their candidacy.

DENR chief to pols: Clean up your mess

Both winners and losers in the May 9, 2022, national and local election should clean up their mess, Department of Environment and Natural Resources (DENR) Acting Secretary Jim O. Sampulna said on Thursday.

"Win or lose, these candidates must consider the long-term consequences of their campaign materials in the environment. Therefore, they must encourage their supporters and volunteers to take down these materials, especially those made of plastic, and dispose of these properly," Sampulna said in a news statement.

Together with local government units (LGU), the DENR chief said his agency would push for the passage of a measure that will require candidates to remove election materials after every campaign.

"We will make sure that the existing environmental laws, such as RA 9003, will strengthen the resolution," Sampulna vowed.

Sampulna said candidates should assemble their teams to "clean up voluntarily instead of being intimidated by possible violations after the election season." "Candidates could show how sincere they are in serving the country this way," he added.

The DENR chief suggested to candidates to do recycling and upcycling of their used or even excess campaign materials to lessen the by-products that will be disposed of in dumpsites.

The Department of the Interior and Local Government, a member of the National Solid Waste Management Commission, has already disseminated an advisory to all LGUs to remind them to strictly enforce the pertinent provisions of RA 9003.

Under the advisory, which was disseminated to the regional offices of the Environmental Management Bureau (EMB), several initiatives have been recommended, including strict enforcement of local ordinances and regulations against illegal dumping, open burning and littering, and utilization of materials recovery facilities of LGUs to collect and store reusable materials.

Coming up with innovative and safe strategies to recycle and upcycle reusable campaign waste materials; imposing the responsibility to the organizers of political activities to ensure that the waste generated will be properly disposed of; and encouraging the citizenry to take part in initiatives of LGUs in ensuring a clean and litter-free environment, prior to, during and after elections were also included in the recommended initiatives for post-election activities of the candidates.

In April, the DENR took down over 114,000 campaign materials posted on trees nationwide pursuant to RA 3571.

RA 3571 provides that "cutting, destroying, or injuring of planted or growing trees, flowering plants and shrubs or plants of scenic value along public roads, plazas, parks, school premises, or in any other public pleasure grounds are prohibited."

Clean up poll trash, candidates urged

MANILA, Philippines — With the elections now over, the Commission on Elections (Comelec) yesterday urged candidates to help in the removal of campaign materials.

"We appeal to the candidates, patuloy sana ang paglilinis ng campaign posters. Let us be environment-friendly and compliant with environmental laws," acting Comelec spokesman John Rex Laudiangco said at a press briefing.

"Let us properly dispose of campaign materials and if possible, let's try to recycle these trash. Huwag itapon kung saan saan," he added.

Both winning and losing candidates, Laudiangco said, should coordinate with local government units (LGUs) and the Metropolitan Manila Development Authority (MMDA) in cleaning up campaign paraphernalia.

Laudiangco said the election law should be amended to ban sample ballots during the campaign period.

But he said the Comelec believes that the distribution of sample ballots helps in educating the voters.

Recycle campaign materials

The MMDA said it is looking to recycle election tarpaulins taken down by its personnel under Oplan Baklas.

MMDA Chairman Romando Artes said they are planning to take the campaign posters to Vitas pumping station in Tondo, Manila where there is a solid waste granulator and brick-making facility.

"We will turn these campaign trash into eco bricks or eco bags," he said.

The MMDA has collected 252 tons of campaign materials after the elections.

The Department of Environment and Natural Resources (DENR) also urged the candidates to dispose of campaign materials in accordance with Republic Act 9003 or the Ecological Solid Waste Management Act.

"Win or lose, these candidates must consider the long-term effects of campaign materials on the environment. They must encourage their supporters and volunteers to take down these trash, especially those made of plastic," acting Environment Secretary Jim Sampulna said.

He said the DENR, together with LGUs, would coordinate with the Comelec to make sure that a resolution would be crafted to require candidates to remove election materials after every campaign period.

Sampulna asked the candidates to assemble their teams to clean up campaign paraphernalia.

He recommended the recycling of campaign materials to lessen the by-products that will be created if these trash are disposed of.

Last April, the DENR took down over 114,000 campaign materials posted on trees nationwide.

Manila, Caloocan start cleanup

The Manila city government has started removing campaign posters displayed around the city.

In a Facebook live on Wednesday, outgoing Manila Mayor Isko Moreno said he has ordered the Department of Engineering and Public Works to dismantle campaign posters in the city.

Moreno said the city should get rid of these election paraphernalia, which became an "eyesore" in Manila.

"The election is finished. We need to bring back cleanliness in our electric posts, electric wires and walls," Moreno said in Filipino.

He said the city government could assist private residences in removing the posters of the candidates they supported.

In Caloocan, personnel of the city government's Public Safety and Traffic Management Department hauled 12 truckloads of campaign materials.

Most of the campaign posters were collected along Sangandaan and Rizal Avenue, according to the city public information office.

The Department of the Interior and Local Government had ordered LGUs to clear communities of campaign trash by today. – Rhodina Villanueva, Ghio Ong, Ralph Edwin Villanueva, Marc Jayson Cayabyab

DENR project to protect Samar Protected Landscape

A DEPARTMENT of Environment and Natural Resources (DENR) project to build socioeconomic resilience in the Catubig Watershed will protect the Samar Protected Landscape and Seascape while supporting the livelihood of rice farmers, craftsmen and fishers.

The Small Grants Program (SGP) Phase 7, funded by the Global Environment Facility (GEF), was launched by the DENR last April 8.

It involves livelihood and biodiversity projects in four sites. These are in Aurora province (Sierra Madre), Calamianes Group of Islands in Palawan, and Siargao Protected Landscape and Seascape in Surigao del Norte. Phase 7 sustains the project that was started under GEF-Phase 5.

The DENR-GEF SGP-7's work in Catubig Watershed may have the biggest environmental and socioeconomic growth impact among Samar natives.

While known to have a rich biodiversity profile with mixed dipterocarp forests, Samar Island is also known as the most cyclone-prone region in the country.

The National Economic and Development Authority reported in 2015 that Northern Samar, where the Catubig Watershed is located, had a poverty incidence of 61.6 percent. This makes it one of the country's poorest provinces.

The SGP-7 costs \$13.78 million of which \$4.436 million comes from a GEF grant. The Philippine government co-finances \$9.214 million.

"It is urgent that we strengthen the resilience of our community-based organizations. They are the frontliners in conservation and livelihood interventions. In this period of climate change and biodiversity degradation, a more integrated effort of interventions is essential," DENR Secretary Jim Sampulna said.

Greg Sarmiento, executive director of the Eastern Visayas Partnership for Rural Development, said the launch of SGP-7 is timely due to recent climate hazards experienced in the province.

DENR hopes to extend Boracay gains after June 2022

The Department of Environment and Natural Resources (DENR) conveyed hope that the local government of Malay, Aklan will maintain the Boracay rehabilitation as the Boracay Inter-Agency Task Force (BIATF) expires by June 2022.

In a statement, DENR Acting Secretary Jim O. Sampulna said "the dissolution of the task force does not mean the end of the rehabilitation of the famous resort-island."

"We are all excited to complete the rehabilitation of Boracay. But we cannot allow anyone to undo—immediately or otherwise—what we have accomplished, or to unlawfully stand in the way to the completion of our mission," Sampulna said.

The BIATF was created by President Rodrigo Duterte through Executive Order (EO) 53 on May 8, 2018, chaired by the DENR which works with the Department of the Interior and Local Government as the vice chair, and the Department of Tourism as co vice-chair.

The BIATF's term was extended until June 30, 2022 through EO 147.

Sampulna saud they have done their part in their department to restore the island, hoping that the successor of the next administration will be able to do more.

"Our comfort, by then, is that we have done our part as members of this task force, and that, hopefully, we will be in a position to do more, or that our successors will be able to protect and build on our gains," he said. **-ag**

DENR trains 22 wildlife enforcers for Calabarzon

A total of 22 individuals from various local government units (LGUs), nongovernment organizations (NGOs), and pet shops recently completed a two-day training for wildlife enforcement officers in Region 4A, the Department of Environment and Natural Resources (DENR) said.

After training held in Calamba City recently, these individuals will get the opportunity to become deputized Wildlife Enforcement Officers and help the DENR combat illegal wildlife trade.

The 22 individuals who took the training will also represent the batch of volunteer wildlife enforcement officers (WEO) in the provinces of Cavite, Laguna, Batangas, Rizal, and Quezon.

The DENR-Calabarzon through its Enforcement Division headed the training orientation for the prospective WEOs. Because WEOs do not receive a salary and only work voluntarily, the DENR screens prospective applicants before putting them under training.

During the two-day event, a strong emphasis was placed on the equal importance of both wild flora and fauna and their role in the natural processes in the ecosystem was reminded by Laguna Provincial Environment and Natural Resources Officer (PENRO) Eriberto B. Saños.

Further, Chief Enforcement Division Annabelle M. Barquilla stressed the importance of wildlife law enforcement in ensuring the conservation and sustainable use of wildlife resources.

Meanwhile, the salient features of RA 9147 or the Wildlife Resources Conservation and Protection Act, Cyber Crime Investigation on Illegal Wildlife Trade, Wildlife Law Enforcement Protocol Techniques, Manual Forms, and other documents on Apprehension, Seizure, and Confiscation of Wildlife were discussed during the orientation.

The identification of commonly traded flora and fauna, basic wildlife handling techniques, and actual wildlife handling and restraining were also conducted to further capacitate the prospective WEOs. The actual handling and restraint activity was facilitated by Nielsen Donato, Wildlife Farm Permit Holder and the co-host of the TV Show, Born to be Wild.

The DENR-Calabarzon also called for direct involvement of the citizens through recruitment, training, and deputation as Environment and Natural Resources Officers (ENROs) and WEOs. The conduct of WEO training is one of the requirements in the deputation of WEOs, as stated under section 30 of RA 9147.

MMDA, EcoWaste to turn election trash into ecobricks, ecobags

MANILA – Hundreds of tons of election paraphernalia and other junk left behind during the recent national elections will be collected and recycled by the Metropolitan Manila Development Authority (MMDA) and the EcoWaste Coalition.

In a televised interview on Net 25 on Thursday, MMDA Chair Romando Artes said 'Operation Baklas (tear down) 2022' began on Tuesday, with the cleanup expected to be completed in two weeks.

"Marami po tayong teams na ikinalat para sa pagbaklas po nito at katulong din naman po natin ang ibang sangay ng pamahalaan pati na po yung mga local government units [LGUs] (We have many teams deployed for the teardown and we are assisted by other branches of the government including LGUs)," Artes said.

So far, the MMDA has collected 28 truckloads equaling 98 tons of junk on Tuesday and 43 truckloads equaling 154 tons of junk on Wednesday -- totaling 254 tons of election trash during the first two days of the cleanup drive alone.

Despite the massive amounts of junk to be collected, he said these will not be dumped into sanitary landfills and instead will be recycled into hollow blocks and bricks through an existing brick-making facility at the Vitas Pumping Station.

"Meron naman pong waste granulator kung saan itong mga tarpaulins po na ito at plastic ay gigilingin po natin para maging sangkap po sa ating ecobrick (We have a waste granulator where we will ground these tarpaulins and pieces of plastic to be used in making ecobricks)," Artes said.

He said these ecobricks are used in the rehabilitation of sidewalks and parks in Metro Manila.

The program, he said, was launched in 2021 and funded by the World Bank.

"Yan po nagbabawas ng basura na imbis na itapon sa landfill ay pinapakinabangan po natin sa paggawa ng hollow blocks at bricks (It reduces waste. Instead of being thrown in a landfill, it can be used to make hollow blocks and bricks)," Artes said.

He also said the EcoWaste Coalition, in a meeting requested by the group on Wednesday, will be given tarpaulins collected by the MMDA to be made into ecobags.

"Pinag-usapan po namin yung pagbibigay po sa kanila ng maaayos na tarpaulins para magawa po nilang ecobags (We discussed providing them with tarpaulins that are in good condition which they can turn into ecobags)," Artes said.

To ensure the cleanliness in Metro Manila and the rest of the country, he called on election candidates and their supporters to help take down their election posters and other paraphernalia.

"Kung hindi po ito maaalis pagdating po ng tag-ulan, kalimitan ito ay napupunta sa ating mga kanal, sa estero, na nagdudulot po ng baha (If these are not cleaned up by the rainy season, these usually end up in canals or estuaries, causing floods)," Artes said.

He noted that the MMDA is in close coordination with the Commission on Elections for the continued cleanup of election paraphernalia and other junk. *(PNA)*

Where dismantled campaign posters will go

After several months on display, campaign posters are now being taken down and the Department of Interior and Local Government hopes candidates will take the lead.

But where will dismantled campaign materials go?

According to John Consulta's report on "24 Oras" on Thursday, campaign tarpaulins and paraphernalia can be recycled and used for other purposes.

Lorna Misa, head of Muntinlupa City Environmental and Sanitation Center, said these materials can be converted into chairs, eco bags, tree guards, among others.

"Ito po mga plastics ay dinadala namin sa plastic flamingo para po ihalo sa semento na ginagawa naman mga silya. Yung mga tarpaulins ay ginagawa namin eco bags. Yung mga kahoy at alambre, ginagawa namin tree guards kapag may mga tree planting," Misa said.

(We bring these plastics to the plastic flamingo to be mixed with the cement which can be used to make chairs. For the tarpaulins, we reuse them for eco bags. For the woods and wires, we reuse them as tree guards.)

"Lahat po 'yan ay hindi itatapon. Hindi po pwedeng magsunog kasi masama po 'yan sa kalikasan," she added.

(All those campaign materials will not be thrown away. We can't burn them because it's bad for the environment.)

Meanwhile, the Commission on Elections (Comelec) again appealed to the candidates to implement proper disposal of campaign materials in accordance with the environmental laws.

"Hinihiling po namin ang ating mga pulitiko at mga kababayan patuloy na po tayo sa paglilinis ng ating campaign materials and let's be environmentally friendly and compliant," Rex Laudiangco, acting Comelec spokesperson, said.

(We ask our politicians and countrymen to continue cleaning our campaign materials and let's be environmentally friendly and compliant.)

"Tuloy-tuloy po ang paglilinis at huwag pong itapon kung saan-saan. Makipag-coordinate po tayo dito sa NCR sa ating mga LGUs at sa MMDA," he added.

(Keep cleaning and don't throw it anywhere. Let's coordinate here in NCR with our LGUs and the MMDA.)—Mel Matthew Doctor/LDF, GMA News



Setting a green agenda

The next administration is starting to form its identity, which can be gleaned from the chosen members of the Cabinet. Environment groups and advocates are waiting with bated breath to see who will be placed in various departments that would oversee the protection and sustainable utilization of our natural resources — earth, water, air, caves, mines, deep sea, etc. Like what happened during the 2016 election of then President-elect Duterte, the fact that he chose the late Gina Lopez for the environment portfolio was a signal of a green agenda that highlighted sustainable and community-based eco programs rather than the exploration of more mining sites.

This early, various groups have called on the next administration to "immediately act on climate change." They said that a strong climate leadership is an imperative in this critical decade for climate action — our last window of opportunity to limit global warming to 1.5-degree celsius. One of these groups is Love 52, a youth movement that demands our next leaders for a green and just future through better governance. Joanna Sustento, the co-lead of Love 52, emphasized the need for the government to take action and hold the entities and corporations that are mostly responsible for the climate crisis accountable.

"We will lose our future if the climate crisis is not addressed, if our leaders won't take action," Sustento said. "We are not the ones handing out licenses to companies whose business practices destruct the environment. We're not the ones who invented single-use plastic that is closely related to fossil fuel... There are powerful people and entities who have the greater responsibility because they created and continue to perpetuate the broken system."

Another youth group, called the Youth Advocates for Climate Action Philippines (YACAP), said that the youth is at the receiving end of the repercussions of the current extractive economic system. "It doesn't make sense if your solution to climate change ends up undermining the well-being of the Filipino people. We need leadership that is vocal about the situation of the country and a leader who is willing to hold the industrialized, the Global North, and the Annex 1 countries accountable for their emissions that contribute to the climate crisis," said Jon Bonifacio, national coordinator of YACAP.

"This big problem needs to be solved by genuine leaders who would respond to the root causes of climate change and would bring forth proper changes to this system that is breaking our planet," Jedryc Romero, executive director and founder of youth-led environmental organization KalikaSan Pablo added.

"We need leaders who have the humility to listen to experts, scientists, environmental defenders, and advocates," Romero said, adding that this is the only way to ensure climate actions that are based on evidence and actual truth on the ground.

So, why did I mention all these youth eco groups? It is for the simple reason that they will be the ones who will inherit this planet — and, sad to say, would be the ones who will be most affected if any careless or irresponsible decisions will be made by the next administration.

I'm now, I like to believe, in the "middle" of my life but the youth still have a long, long way to go. And they can't live on a planet marred by climate change — where typhoons are always at categories four or five, where heat breaches 39 degrees, and where microplastics are now contaminating their food.

There are so many environmental issues that must be faced soon. Yes, there are issues on national security, health and pandemic response, foreign affairs, employment and the economy, and so on. But I hope and pray that environment concerns will not be set aside and

Therma Visayas conducts 'Scubasurero' underwater cleanup drive in Toledo

TOLEDO CITY, Cebu — Leading up to the celebration of Earth Day this year, <u>AboitizPower</u> subsidiary Therma Visayas, Inc. (TVI), in partnership with the Aboitiz Foundation, organized an underwater garbage cleanup with its volunteer "*Scubasureros*" in Barangay Bato last April 14, 2022.

"Scubasurero is a term coined from 'scuba diving' and 'basurero' or garbage collector," explained Therma South, Inc. (TSI) Reputation and Stakeholder Management Manager Lou Jason Deligencia. "We have conducted this activity as part of our environmental commitment to help protect marine life, especially in the areas where we operate."

"The idea for this activity came from TVI employees who are also divers," he explained. "They were diving in the beach just across TVI when they discovered trash stuck to the seabed, and so they've decided to tap us and other divers to conduct a wider underwater cleanup."

Among the volunteers who participated in the event were TVI employees, community members, and local government officers. Local surfers from Toledo Local Breakers groups and members of the Young Environmentalists group of Barangay Cabitoonan also provided support to the event. Non-diver volunteers also joined the coastal cleanup in the area.

"I love to dive and I care for the environment—that's a top priority of mine, and TVI's Scubasurero project aligns with my interests and beliefs," said Architect Daryl Carabio of the Toledo LGU City Planning and Development Office.

Along with other volunteers, TVI Procurement Operations Specialist Relyn Lazaro has committed to regularly do underwater cleanups to help decrease the amount of trash in the sea.

"We were able to gather a lot of trash from just a few hours of diving—there was a lot of plastic and even clothes in just two hours, we were able to collect 101 kg of plastic, 21 kg of glass, piles of clothes," said Lazaro. "We are hoping to raise community awareness on proper waste disposal and segregation since most of the trash we've collected underwater are single-use plastics, such as sachets and other plastic packaging, which do not easily biodegrade."

"We have to keep in mind that even the smallest plastic that gets into the sea can be damaging to sea life," said TVI Facilities and Services Administrator Jonneil Culala.

Livelihood in Barangay Bato

Deligencia said the company also takes into consideration its host community members who heavily rely on fishing as their main livelihood.

"Marine life in the area is so rich, but we need to ensure that it continues to thrive so that our local fishermen wouldn't need to go farther out into the sea to catch any fish," he added. "It will be more efficient for them to fish nearer the coast."

"We also intend to put up an initiative in managing Crown of Thorns (COT) starfish infestation in the area. COT feeds on corals and if left unmanaged, will devour an entire reef colony in months. Without corals, the fish will find habitat elsewhere creating lower fish catch for our fisher friends," he added.

This program is a testament to TVI's commitment to the Sustainable Development Goals of the United Nations, particularly on Life Below Water and Decent Work and Economic Growth.

Thai gold mine set to reopen even as locals reel from heavy metal poisoning

Villagers claim their health has suffered as a result of the Chatree mining complex's operations, with mass blood tests confirming that a majority of those tested exhibited elevated levels of arsenic, manganese and cyanide.

Standing in the house where she has lived since she was born 45 years ago, Premsinee Suntornthammathat points to the temple where her grandparents took her to pray as a child.

During festivals, hundreds of people from nearby provinces flocked here. Women gossiped and cooked together in a huge kitchen, while men exchanged stories of farming and boar hunting.

Across the road stood the school where she studied from the age of 3. She loved the big playground, she says. "The grass was so soft that we never hurt falling."

But the village of Premsinee's memories is gone. The temple still stands, but no one visits it. The school building has crumbled to the ground and been swallowed by overgrown trees.

Premsinee stands alone in a ghost town, her neighbours long gone. Khao Mo, the mountain her village is named for, has been hollowed out into an open-pit gold mine, its highest point now standing just 100 meters (330 feet) above her house.

In November 2001, Thailand's first modern gold mine started operations. With a Thai name meaning bravery, the Chatree Mining Complex is owned by Akara Resources Public Company, a subsidiary of Sydney-based Kingsgate Consolidated Ltd.

Chatree, which straddles the provinces of Phichit and Phetchabun in central Thailand, is made up of two ore fields and two processing plants, and has produced more than 1.8 million ounces (51,000 metric tons) of gold and more than 10 million ounces (283,00 metric tons) of silver since it began production.

We will protest at Thailand Stock Market, where Akara has long made efforts to list itself, to notify the public and investors of their hostile actions and ask them to refrain from supporting this hazardous business.

Lertsak Khamkongsak, climate justice activist, Commoners' Party

For now, the mine stands silent. It was shut down in January 2017, following years of complaints and lawsuits from people living nearby, who say mining damaged their health and the environment.

But the silence may not last much longer. In 2017, Akara sued the Thai government for revoking its permit. That case remains pending in an international arbitration tribunal, but in January 2022, the government agreed to allow the mine to reopen.

Decades of disputes

By 2004, three years into rock blasting and mineral processing, residents of Ban Khao Mo and nearby villages started moving out. The mining company bought their land and paid compensation, and hundreds of households relocated. Only a handful of people, like Premsinee, decided to stay.

"There were blasts and dust everywhere," she recalls. "When they blew the mountain away it was dark with dust for days."

During the 15 years the mine operated, multiple lawsuits were launched on both sides. A group of 300 residents filed a class-action suit demanding compensation for health problems. Another group filed cases accusing the company of trespassing on national forest land, resulting in an ongoing investigation by the Justice Ministry's Department of Special Investigation.

Residents also sued Thai state authorities for <u>issuing mining permits without an environmental impact assessment</u> — a complaint that was substantiated. In turn, the company has launched defamation suits against residents, activists and academics.

Nirun Yingmahisaranon, who as director-general of the Department of Primary Industries and Mines was the original grantor of the concession, says complaints starting piling in within a few years of the mine's launch.

At first they centered on the noise and dust, which Nirun says were "manageable." That escalated to reports of heavy metal in water sources, and then to two rounds of mass blood tests of people living near the mine, who complained that chemicals and heavy metal runoff from the mine were making them ill.

In 2014, the country's Central Institute of Forensic Science found that more than half of the 731 adults tested, and more than two-thirds of 67 children tested, had higher-than-normal levels of heavy metals, mostly arsenic and manganese. Akara said the blood test was unacademic, unjust and unfair.

In 2015, another mass blood test was organised by a joint working group including representatives from Akara, residents' groups and government bodies. Of 1,004 adults tested, 420 were found to have manganese levels exceeding safe standards, 196 had unsafe levels of arsenic, and 59 had unsafe cyanide levels.

Tests were also run on 297 children under 15, of whom 165 were found to have unsafe levels of manganese, 53 unsafe arsenic levels and two unsafe levels of cyanide. Though Akara initially participated in the joint working group, it never endorsed the results.

"That started local panic," Nirun says. "Knowing the number of heavy metals in their bodies."

Toxic levels of cyanide

Manit Lampason, 70, is a participant in the class-action suit. Originally from Ban Khao Mo, he sold his land and moved to a new village 2.5 kilometres (1.5 miles) away, only to find his new house sits less than 0.8 km (0.5 mi) from the mine's tailing pond, where waterborne mining waste is stored.

"They told us we will be safe here, but it is not," Manit says. "I have been living with the cyanide pond for years."

In 2011, a lab test from a government hospital found an alarming level of cyanide in his body. The report, viewed by Mongabay, found a cyanide level of 1.04 micrograms per litre (μ g/L), while the lab's reference range said levels exceeding 1 μ g/L amounted to "toxification." A repeat test five month later at the same lab found an even higher level: 1.56 μ g/L.

Cyanide has long been used in gold mines to extract the valuable gold from the ore. But in high concentrations it is toxic, leading to a ban on its use in gold and silver mining in countries including the Czech Republic, Germany, Hungary and Costa Rica, as well as some US states.

Akara, however, maintains that the Chatree mine's safety and environmental regulations are up to international standards, describing the mine as "one of the world's safest and best practice gold mines" with an "impeccable health and safety record."

"We used a 130 ppm [parts per million] solution of Cyanide in the process, then detoxify it to less than 20 ppm — this is a very strict international standard in water control," Cherdsak Uthaaroon, Akara's general manager of external affairs, tells Mongabay. "But the actual solution from our plant has never been higher than 10 ppm, and when it stored in the tailing pond, the concentration will eventually go down to 0.2-0.25 ppm. Generally speaking, this concentration of cyanide is less than what is in our coffee cup."

'I didn't even want to breathe'

When Pisamai Riangpa was four months pregnant in 2015, a blood test taken at a government hospital showed elevated amounts of heavy metals in her body. Her manganese level was recorded at 1.39 µg/L, above the normal reference range of 0.2-1.1 µg/L.

"I felt dizzy and fatigued all the time but first thought it's a pregnancy side effect. It lasted for several years in me," she says.

Her son was also born with high manganese levels, and had to be to hospitalised regularly in his first year. He is 6 years old now, and in good health, says Pisamai, who adds she believes his health has improved because the mine was shut down when he was a year old.

Pranom Chimpalee, who lives 0.5 km (0.3 mi) from the mine pit in Ban Nong Saeng village in Petchabun province, says her family has also suffered. Her neighbours have long since left, and her house stands among torn-down ruins.

Two years ago, her 80-year-old mother died after years of suffering a skin disease whose cause she was never able to determine. "There were burns and purulent wounds over her body," Pronam says. "She always cried in pain. I carried her on my motorcycle to the hospital 16 kilometres [10 mi] away. We could not afford better transportation and my mother was so frail that she could barely straighten herself. I had to bind her with my clothing to reach the hospital."

Akara denies allegations of heavy metal leaks, and says it has worked closely and carefully with the communities to make sure residents around the mine have a better life and are in good health. "Several blood tests showed no harm to anyone," Cherdsak says.

But a tearful Pranom says, "It's unbearable. I didn't want to even breathe. No one ever come to rescue us." She now lives with her 84-year-old uncle, who also has elevated levels of arsenic and manganese, and whose body is occasionally wracked with pain. "Sometimes, it is so much that he has tried walking to the road, hoping to be hit to dead by any passing car," Pranom says.

Nirun, from the mining department, doesn't deny that heavy metal poisoning is a major issue in the region around the mine. However, he says this doesn't amount to proof the mine is responsible: areas rich in precious metals like gold and silver often also have high levels of heavy metals and other minerals occurring naturally in the soil and groundwater.

What's needed, Nirun says, is a concrete plan to ease the problem for the residents. However, nearly two decades after the mine began operations, no such plan exists.

Shut down by the junta

In 2015, after years of complaints, conflicts and legal action, residents brought the case to the prime minister, Prayuth Chan-o-cha, a military general who seized power in a coup in May 2014.

In December 2016, Prayuth exercised his power under the interim charter to order the mine suspend all operations effective Jan. 1, 2017.

Citing the free-trade agreement between Australia and Thailand, Akara's parent company, Kingsgate, announced in November 2017 that it had filed a suit against Thailand at an international arbitration tribunal, claiming the suspension order amounted to "unlawful expropriation." The company said it was seeking to recover "very substantial damages" and vowed to "vigorously prosecute" its claim.

The case is still pending, and the exact sum Kingsgate is seeking has not been made public. If the arbitration tribunal reaches a verdict, it will be legally binding. But the company has the right to revoke the case if negotiations with Thailand are successful.

In January 2022, Thailand granted the company permission to resume and to extend the concession to end in 2031. Another survey concession, covering nearly 61,000 hectares (150,000 acres), was also awarded to Akara.

Prayuth has dismissed allegations made by opposition politicians that the permission was granted in exchange for Kingsgate Consolidated dropping its case against the country.

Bringing political and market pressure to bear

The news that mining operations will resume brought renewed outcry among dismayed residents.

In March, two months after Kingsgate announced plans to relaunch operations, Premsinee was among a group of residents who rushed to parliament to meet with opposition politicians and ask for help.

Opposition MP Jiraporn Sindhuprai, from the Pheu Thai Party, and for years a prominent antimine voice, told Mongabay she plans to highlight the issue during a no-confidence debate scheduled for May, which will be televised nationwide.

In the meantime, the villagers have vowed to take any action necessary to prevent the mine from reopening.

Lertsak Khamkongsak, an environmentalist and leader of the Commoners' Party, which was founded years ago by anti-gold-mining protesters, says residents will take legal action against anyone who allows the Chatree mine to reopen while the case is still under the international arbitration. This list, Lertsak says, includes "the director general of the Department of Primary Industries and Mines, and the permanent secretary of the Ministry of Industry, to name a few."

And while Kingsgate says it needs hefty funding to restart the mine and has asked Thai government for support in raising the money, Lertsak has a different idea.

"We will protest at Thailand Stock Market, where Akara has long made efforts to list itself, to notify the public and investors of their hostile [actions] and ask them to refrain from supporting this hazardous business," he says.

Manit, who still lives a half-mile from the mine tailing storage facility, tells Mongabay he dreads the resumption of mining activities. "I will now have to sleep with the cyanide pond, breathing it in every single day like I used to."

The height of the tailings dam concerns him too. Such dams <u>can and have</u> <u>collapsed</u> with <u>devastating human and environmental consequences</u>.

Reopening, but not any time soon

Kingsgate says it expects to open more mine pits in the area, which could extend its operations for well over three decades.

Bur company representative Cherdsak tells Mongabay it will be months before operations can resume. "The earliest may be before the end of this year," he says. "Covid-19 made everything more difficult and much slower. Machine and repair pieces required a longer time to deliver. Everything will start not early like we expect. There have been over five years of halting, we have lots of brushing up to do."

Though he dismisses all the allegations regarding environmental contamination, Cherdsak says it will take hard work to get the locals understand and accept the mine.

Nirun Yingmahisaranon, of the mining department, also says the mine has caused long and deep conflicts in nearby communities.

While many have joined protests and lawsuits, not all local people are unhappy the mine will reopen. In its heyday, the Chatree gold mine employed more than 800 workers on the ground.

Wisoot Kaefoi, 54, says he is eagerly waiting to go back to work as a truck driver in the mine, a job he held for 13 years. He says he is concerned that after five years' absence he will be seen as too old for the job by his boss. The health risks don't concern him, he says.

Wisoot dismisses the claims against the mine as greedy, and says the long-running protests are driven only by people seeking money. "Those who claimed to have health issues live miles away when I have sat with the ore every single day," he says. "If there must be someone who is sick, it should be me." Wisoot says he will support the reopening of the mine, which he says will benefit local workers and their families.

New requirements for mining operations

Amid the ongoing debate over Akara's mine, the Thai government has introduced a new National Gold Policy. New regulations include a requirement that mining firms undertake extensive studies to establish baseline environmental and human health indicators to serve as benchmarks for ongoing testing and monitoring. The act also calls creates a community protection mechanism, and stipulates that gold should also be refined within the country instead of being exported raw.

In addition, Thailand's newly amended Mineral Act now requires community consent for any new concessions. The act creates local committees, including representatives from the community, government agencies and the company, empowered to allow or suspend concessions.

It also calls for taxes and royalties to be paid at the local level rather than going exclusively to the central government. The act will also mandate that developers establish a relief fund in case of any negative impacts, and provides stiffer fines and penalties, including jail time, for violations.

Nirun, who is now under fire as the person who originally granted the permission for the Chatree gold mine, says he is optimistic. "Under new laws and regulations, the investor

could operate with confidence and it will ease the public concern over the safety of their health and their environment."

Now that is has been reinstated, the Chatree mine complex will stand as the only gold mine in Thailand.

A second, much smaller mine located five hours' drive away, which was shuttered under the same order in 2016, will not be reopening. Protests, including months of road blockades, hampered operations and led to the bankruptcy of the mine company. Lertsak was the leader of that movement. He says he is bracing to launch a similar movement against Chatree, too.

"I do hope we would not be forced to reach that day."

IA TRINIDAD. BENGUET—Dean Cuanso, a resident of this vegetable trading town, was upset when he saw piles of

discarded campaign tarpaulins after the midterm elections in 2019.

Worried that it would be the same situation again after Monday's national and local elections. Cuanso, who has been engaged in the manufacture and sale of home items made from recycled materials, decided to launch the "Eco-tarp Recycling Challenge" on social media, for residents to collect and reuse discarded campaign materials.

In just days, his call generated huge interest from environmental advocates and small business owners who saw potential in recycled products.

Cuanso and his wife, Libay, own and operate Accents and Petals, an upcycling company they formed in 2007, which has produced items like recycled bouquets made of denim, jute sacks and corn husk that have graced events like weddings and birthday parties.

According to Cuanso, his family used to live in nearby Baguio City, where he would visit construction sites in search of metal parts and broken tiles so he and his friends could build robots and action figures.

Part of life

He said recycling had always been part of his life, and Libay, the company's chief designer, grew up repurposing trash into usable items in grade school.

Cuanso said he and his wife lived for a while in Metro Manila, and their first successful items at the time were tin cans turned into découpage home decorations. "This is the art of JR. AND NESTLE SEMILLA INQ

P84-M illegally-mined 'fool's gold' seized in Samar

AGENTS of the National Bureau of Investigation seized illegally-mined gemstone pyrite or "fool's gold" with an estimated value of P84 million and

arrested six persons in Hinabangan, Samar.

NBI Officer-In-Charge Eric Distor said the operation stemmed from an intelligence report regarding unlawful extraction of high grade mineral pyrite from a closed mining site in Hinabangan town without the required permit from the Department of Environment and Natural Resources.

Series of surveillance operations by the NBI-Samar District Office have confirmed the illegal mining active.

The operatives also discovered that trucks have been transporting theore pyrite to Bgy. Pequit, Paranas, Samar for temporary stockpiling.

On May 2, the NBI and DENR flagged down three cargo wing-van trucks moving out of the stockyard. For failure to present the necessary Ore Transport Permit (OTP) from the DENR, operatives seized the ore pyrite, with an approximate volume of 56,000 kilograms and an estimated value of P84 million.

The NBI said those arrested last May 2 were Marcelo O. Villa Jr, Jason Roy Tenedero, Mia M. Laudes, Roger M. Nueva, Cleo Dorado, and a certain "Albert.".

They were caught by agents of the NBI's Samar District Office (NBI-SAMDO) in the act of transporting ore pyrite in three cargo wing-van trucks out of a stockyard in Barangay Pequit in Paranas, Samar.

"For their failure to present the necessary Ore Transport Permit (OTP) from the DENR (Department of Environment and Natural Resources) when

asked by NBI-SAMDO, operatives of the NBI in the presence of Barangay Kagawads with PENRO (Provincial Environment and Natural Resources Office), CENRO (City Environment and Natural Resources Office) and PNP (Philippine National Police) Paranas Municipal Police Station, seized the Ore Pyrite with an approximate volume of 56,000 kilograms with an estimated value of \$\P\$4,000,000 and arrested the Subjects," the NBI said.

"On May 4, 2022, the six arrested individuals were presented for inquest proceedings before the Office of Prosecutor of Samar for violation of Section 103 (theft of high-grade minerals) of

Republic Act No. 7942 (Mining Act of 1995)," it also said.

Google says "Pyrite is called 'fool's gold' because it resembles gold to the untrained eye. While pyrite has a brass-yellow color and metallic luster similar to gold, pyrite is brittle and will break rather than bend as gold does. Gold leaves a yellow streak, while pyrite's streak is brownish black.

The NBI said that prior to the operation, it received "an intelligence report regarding unlawful extraction of high grade mineral, Ore Pyrite, from an old and closed mining site in Hinabangan, Samar and transported to an unknown destination without the required permit from the DENR."

Rody creates transition committees

President Duterte has created a committee to ensure a

proper and orderly transition to the next administration.

Administrative Order No.

47 signed by Duterte last May 10 formed the presidential transition committee (PTC) and

internal transition committees in departments and agencies in the executive branch. The PTC will be led by Executive Secretary Salvador Medialdea and will be composed of Socioeconomic Planning Secretary Karl Chua, budget department officer-in-charge Tina Rose Canda, Finance Secretary Carlos Dominguez III and Foreign Affairs Secretary Teodoro Locsin Jr.

The Office of the Cabinet Secretariat and the Presidential Management Staff will provide technical and secretariat support to the committee.

"The duly elected president and his incoming cabinet members should be given full support and cooperation by the outgoing cabinet to facilitate their assumption into office." Duterte said in the order

fice," Duterte said in the order.
"There is a need to create a
transition committee that will
work closely with the representatives of the presidentelect to ensure a proper and orderly transition of government
into the next administration,"
he added.

Latest partial and unofficial poll results show former senator and presumptive president, Ferdinand Marcos Jr. and his running mate, Davao City Mayor and presumptive vice president, Sara Duterte-Carpio, holding commanding leads over their

opponents.

The PTC will serve as the overall and central coordination committee of all entities under the executive department with regard to the transition to the new administration. It will also oversee the preparation and implementation of the transition activities of all state agencies to ensure continuity and maintain the efficiency of government services.

The order also directed all departments, agencies, bureaus, offices and other government instrumentalities to constitute their respective internal transition committees within five days from the effectivity of the order.

The internal transition committees were tasked to oversee the crafting and implementation of systems and procedures for transition to ensure continued operations of their respective departments.

"We will work closely with the representatives of the incoming administration to ensure a peaceful and orderly transfer of power. Since we still have no proclaimed winner, official talks need to be put on hold for the moment," Medialdea said during a meeting with Duterte and some Cabinet members last Wednesday.

Medialdea assured the public that the executive branch is ready to turn over the government to the next president, but would continue to perform its duties in the coming weeks.

Duterte said he wanted to meet with members of the transition committee to discuss the impact of the conflict in Ukraine, which was driven by Russia's invasion.

He previously predicted that the next president would face difficulties if the conflict between Ukraine and Russia drags on and pushes up fuel prices even further.

"But it would be good for us to meet this – well, not all, but select members of the committee or maybe all of them. We still have about one or two meetings because of the fallout in Ukraine," the President said.

"Oil is a very dynamic thing from the time it is... sucked from the bowels of the Earth until it reaches end users... It's a very dynamic thing and so many problems to solve. The war in Ukraine might be an attrition one... And it could last long or it could be over if (Russian President Vladimir) Putin backs out," he added.



PH logs 109 new Covid-19 cases on May 11: OCTA

MANILA – The country logged 109 new cases of Covid-19 on May 11, bringing the total tally to 3,687,428, the OCTA Research Group said Thursday.

In a tweet, OCTA Research Group fellow Dr. Guido David said the figure is lower but close to the forecast of 120 cases.

Citing data from the Department of Health, David said there were 3,328 active cases and no new deaths were recorded.

The death toll stood at 60,439.

About 418 new recoveries bringing the total number of recovered cases to 3,623,661.

Earlier, Dr. Rontgene Solante, Vaccine Experts Panel member, said an uptick in cases is expected a week or two weeks after the national election.

Solante added there had been super spreader events prior to the election day such as political sorties where minimum public health standards were violated.

As of May 11, a total of 68,526,134 Filipinos are now fully-vaccinated against Covid-19.

A total of 13,519,545 eligible individuals have received their booster shots. (PNA)






