Armed men 'invade' Masungi conservation site

More than 30 armed men have encamped at the Masungi conservation site in Rizal allegedly planning to "take over huge tracts of land in the protected area."

The group of men reportedly belongs to Sinagtala

security agency.
In a Facebook post on Saturday, the Masungi Georeserve described the move as an "invasion."

"They are planning to take over vast tracts of land in the protected area to sell them to third parties," the management said.


The management called on the Departments of the Interior and Local Government and Environment and Natural Resources as well as the Philippine National Police to take immediate action.

"The area is part of Masungi's conservation site, the Kaliwa Watershed protected area, and has been legally titled to the Philippine government since the 1950s," Masungi Georeserve said.

Lt. Col. Eunice de Guzman, spokesperson for the Provincial Police Office 4, said they deployed some personnel yesterday to look into the report.

Armed men seen encamped in Masungi Georeserve

Security personnel plan to take over big tracts of land in protected area, according to foundation tasked to oversee and reforest the critical habitat in Rizal province. But police claim seeing no one at the site.

More than 30 armed men have been encamped since last week on the roadside of the Marikina-Infanta Highway within the vicinity of the protected Masungi conservation site, according to its administrators.

The Masungi Georeserve Foundation, which on Sunday described their presence as an "invasion," said in a statement that the men reportedly associated with Sinagtala Security Agency Services had arrived with the intention of taking over huge tracts of land in the protected area.

The security personnel's camps are along the road between the Kaliwa Watershed and the Marikina Watershed, which are protected and reforested by the Masungi Georeserve Foundation under an agreement with the government.

According foundation cofounder Ann Adeline Dumaliang, the group was flagrantly violating the National Integrated Protected Areas System Act 1992 as well as committing trespassing and forcible entry in broad daylight along a national highway.

While filing a complaint is an option for the foundation, Dumaliang said quick action by the government agencies was crucial to prevent degradation in the area.

'Shady business'

The security men refused to disclose their names and contact details. "If this is not shady business, there is no need to obstruct the verification process by withholding even basic information and avoiding accountability," the foundation said.

Masungi's conservation site has been legally titled to the Philippines since the 1950s.

"It is being conserved and reforested by our team under an agreement with the government. This is a critical area for the wildlife sanctu-

ary and the consequences of losing this area once again will set back forest protection and [will] be a huge injustice to Filipinos," Masungi Georeserve said.

The foundation urged the Department of Environment and Natural Resources (DENR) and the Department of the Interior and Local Government (DILG) as well as the Philippine National Police "to take immediate action... and to stop this

ongoing invasion, and remove the invaders."

Billie Dumaliang, the site management's advocacy officer and trustee, said the DENR had told them a report has been forwarded to "appropriate offices for immediate action."

Lt. Col. Eunice de Guzman, PNP-Calabarzon spokesperson, told the Inquirer that police and Army soldiers were deployed on Sunday morning but they saw nothing.

"We've received reports that there were armed men there but the troops did not see anything during the patrol," she said.

But Ann Dumaliang, who is also Masungi Georeserve project manager, insisted that the armed men were still in the area as of 4:22 p.m. on Sunday.

"Did they search for them? Naturally, sometimes and especially after the postings [on social media], the firearms would not be immediately visible," she told the Inquirer.

Sinagtala's hired men supposedly claimed to hold a survey plan named after a certain Beatriz Sonquipal, and signed by a director of the DENR regional office in 2003.

"Obviously, a mere survey plan is not a proof of ownership," Masungi Georeserve said.

Records showed that Sonquipal was already issued an eviction notice by the DENR in 2016.

Security agencies must provide proof of ownership over the property to be secured in any security service. agreements, as required under the implementing rules of Republic Act No. 5487, the Private Security Agency Law, and the rules of the Supervisory Office for Security and Investigation Agencies.

A certain "Major Laino/Layno," a supposed retired military official from Cagayan and Mindanao, also claimed that he had a title to the land and had long been in the area, but failed to show it when asked, Masungi Georeserve said.

'Critical area'

"He also denies knowing any of the 30 people on the illegal encampment despite some of them saying that they are working for him," it add-

Asked to comment, a Sinagtala official said he was too busy to answer the Inquirer's questions, adding that he could talk only tomorrow (Monday) morning.

Masungi Georeserve is an award-winning conservation initiative and tourist destination located in Baras town, Rizal province.

The conservation area—a 400-hectare land home to endangered flora and fauna as well as the 60-million-yearold limestone pinnacle karst and other rock formationshad seen several land grabbing attempts due to its resources for mining and other money-making ventures.

The site has since been expanded to include the restoration of about 3,000 ha of degraded forests in partnership with the national government.

Conflicts, threats

It was declared a protected area in 2011. However, private settlements and establishments had already been set up there, which led to several conflicts within the watershed.

Just last year, two stationed forest rangers were shot by unidentified assailants, just over a week after the DILG recommended the filing of criminal and administrative charges against a government official and private entities for violation of environmental laws.

Prior to the assault, Masungi's forest rangers had received threats for reporting illegal activities in the watershed.

Last February, seven forest rangers were eating at a food stall when around 30 people ganged up on them, causing two rangers to be hospitalized.

The suspects were be-lieved to be working for owners of allegedly illegal resorts in that area. -with a REPORT FROM INQUIRER RESEARCH INO

Masungi seeks gov't protection amid land-grabbing mess

THE management of the Masungi Georeserve in Baras, Rizal has sought the assistance of government agencies amid the alleged harassment and land-grabbing attempts of a private company.

In its Facebook page on Saturday night, the Masungi Georeserve urged the Department of Environment and Natural Resources, the Department of Interior and Local Government and the PNP "to take immediate action to enforce the laws and mandates they are sworn to uphold, stop this ongoing invasion, and remove the invaders."

"This is a critical area for the wildlife sanctuary and the consequences of losing this area once again will set back forest protection and be a huge injustice to Filipmos. Sinagrala and their dubious associates should leave the premises once and for all," it added.

The management was referring to the Sinagtala security agency, which it said had dispatched security guards to gather and camp outside of the reserved area since last week.

"They reportedly plan to take over huge tracts of land in the protected area and are selling them to third-parties. Let's be clear: This is an invasion," Masungi said.

The social media post alleged that some 30 security guards have encamped outside the Masungi Georeserve in Baras, Rizal.

But Calabarzon regional police office spokeswoman Lt. Col. Eunice de Guzman said the reported security guards were no longer in the area as of yesterday afternoon.

Masungi said Sinagtala claims it has a survey plan under the name of one Beatriz Sonquipal that was reportedly signed by DENR regional office in the early 2000s.

It såid that, "obviously, a mere survey plan is not a proof of ownership."

Masungi said a certain Major Laino or Major Layno from Mindanao, who was supposedly with the group of security guards, had said that he has a title for the property and has been in the area since 2010.

"When asked to show this title, he failed to show anything. He also denies knowing any of the 30 people on the illegal encampment despite some of them saying that they are working for him. He claims to be a retired military official," Masungi said.

"For the record, the hired security men all also refuse to disclose any details such as their names and contact details so that we might check the legitimacy of their claims and arrangements," added Masungi.

Masungi said the security guards would not obstruct the verification process and withhold basic information "if this is not a shady business." It insisted that the area is "legally titled" to the government since the 1950s, "It is being conserved and reforested by our team under an agreement with government," it said.

De Guzman said the PNP regional police office received information about the Masungi complaint yesterday morning, with the number of security men encamping outside the gates allegely even reaching 70.

De Guzman said the Rizal provincial official sent men to the area after initially receiving the information at around 10:30 a.m. yesterday and saw no security guards in the area. Another team was dispatched to check the vicinity at 12:30 p.m. and 1:30 p.m.

"They (Rizal provincial police office) reported there are no security guards (in that area). They already checked the area, both Army and PNP. They didn't see any (security guard)," she said.

Cimatu tapped to lead rehab of Cebu City waterways

CEBU CITY — Former environment secretary Roy Cimatu will lead efforts to rehabilitate rivers in this city.

Cimatu said he is hoping he will be able to replicate in Cebu what he did in Boracay, Marikina River, and Cagayan River when he was environment secretary.

"Cebu City is much bigger. It will be very difficult," Cimatu said in a press briefing on Sept. 15.

He was appointed by Mayor Michael Rama as the city's "DENR-like secretary."

ways have been blamed for the heavy flooding here recently.

Cimatu said part of the task force's goals is to dredge and clear the rivers from illegal structures which include commercial establishments and dwellings of informal settlers.

"If there are illegal structures there, then they are violating the law. We are going to look into that. We will clear it," Cimatu said.

Cimatu urged owners of illegal structures to "self-demolish."

"I know that they know that there is a law on easement. I suggest na (that) they have to self-demolish already," Cimatu added.

He said the problem on flooding will not be solved overnight but at least the city has started to address the problem.

"Maybe we can do it in several years.
It is a challenge really, but with your cooperation we will probably be able to do it," said Cimatu.

Anti-plastic pollution warrior chosen as Magsaysay awardee

A French environmental activist was chosen as one of the youngest laureates at the Ramon Magsaysay Awards, Asia's version of the Nobel Peace Prize, for his "crazy idea" to clean up rivers and expose plastic pollution through creative social media content.

Calling himself "one guy with a dream," 'Gary Bencheghib said he started coming up with creative content to spread awareness about plastic pollution.

He was chosen by the foundation as an "Award-

ee for Emergent Leader-

"There's no limit to age.
You can be as young and old as you want, Our work has shown everybody can make a change. It just needs some thinking crazy," Bencheghib said. "The more we think crazy, the more change will happen. Sometimes, it's believing in yourself enough."

Amoring the "crazy" videcs he made was one documenting his brother Sam running across the American continent wear-

ing recycled plastic shoes, and filming Rob Greenfield wearing every piece of trash he disposed of for 30 days.

Bencheghib also filmed himself in 2017 canceing on the trash-choked Citarum River using a kayak made of plastic bottles.

His gimmick earned him a meeting with Indonesian President Joko Widodo, who launched a seven-year rehabilitation program for the river, which is known as one of the world's most polluted.

A big win for Asia's 'zero waste' advocates

N 2015, the Science international journal published the article "Marine Pollution. Plastic waste inputs from land into the ocean. The paper ranked 192 coastal countries according to estimates of how much plastic waste they each leaked into the sea. The five top contributors were identified as China, Indonesia, the Philippines, Thailand and Vietnam. The USbased Ocean Conservancy picked up from where the research paper left and published a report titled "Stemming the Tide." This report was to become highly influential, setting the agenda for dealing with plastic waste. It focused on the five countries and recommended incineration, waste-to-energy and other technologies to prevent plastic from ending up in the ocean.

Hundreds of NGOs, community-based organizations and prominent individuals wrote an open letter to the Ocean Conservancy, protesting the premise, findings and recommendations of "Stemming the Tide." They were appalled by the report's failure to notice the communities and people who were working on the ground, failure to acknowledge their contributions to solving the plastic waste problem, and fatal failure to see that the real problem is not that plastic becomes marine litter but that there is simply too much of it and it is mostly being pushed by big corporations based in rich countries. "The authors of this report are seemingly resigned to the rapid expansion of global plastics production," the open letter stated. "This mindset will certainly allow for more creation of waste, but we simply refuse to buy into this kind of thinking."

Seven years later the Ocean Conservancy took the unprecedented step of retracting "Stemming the Tide" and issuing a public apology. The organization recognized

not only that it had been wrong, but that its erroneous assumptions and recommendations had caused harm to communities, organizations and to the environment. I'm talking about real harm, not simply hurt feelings — because governments used the report's endorsement of incineration and waste-to-energy to approve and fund such facilities, at the expense of waste minimization, segregation and recycling systems.

Aside from retracting the report and apologizing, Ocean Conservancy reached out to the groups and individuals that had signed the open letter. The Global Alliance for Incinerator Alternatives (GAIA) Asia Pacific on September 14 announced that the "first step of a restorative justice process" with Ocean Conservancy has been concluded, after months of consultations and dialogue.

For now, Ocean Conservancy and the wide network of NGOs and community-based organizations that GAIA represents have agreed to prioritize "plastic reduction policies," move "resources to zero waste solutions" and denounce incineration, waste-to-energy, chemical recycling and other models that usually entail investment in expensive foreign technology and equipment.

GAIA sees the development as a "historic leap in the fight against waste colonialism." The humility shown by Ocean Conservancy is commendable. One can only guess how difficult, painful likely, the retraction process must have been.

This, of course, is just the beginning of the Ocean Conservancy's and the zero waste movement's

working together towards a cleaner and safer world. It inspires hope that a meaningful Global Plastic Treaty will indeed be possible. Governments that embarked on the path laid out by the "Stemming the Tide" report should take note of these developments, the retraction of conclusions and recommendations, and the new focus on reducing production of plastic. Plastic, single-use plastic in particular, has become a liability.

Poland the safe haven

I was fortunate to be invited to the launch of the 25th Cine Europa at SM Seaside City Cebu. Thinty movies from 15 European Union member countries are showing for free at the mall until October 30.

Among the important personages present at the launch were Jaroslaw Roman Szczepankiewicz and Anna Krzak-Danel, chargé d'affaires and deputy head of mission, respectively, of Poland's embassy in the Philippines. It was an opportunity for me to express my admiration for Poland's — its government and people — for welcoming millions of Ukrainian

refugees since February when Russian President Vlidimir Putin launched his military assault on Ukraine. Some 6 million refugees have entered Poland since then with about 2 million currently staying in the country. Considering that Poland's population is 38 million, the relative volume of refugees passing through or staying is considerable. For now, refugee camps have been avoided as the Ukrainians who cannot afford to rent have been welcomed by local families. Children have access to free education, and adults are helped to find jobs. Of course, at this point, after more than six months of war, local host communities and families feel that their own resources are running out. As a result of the war, Poland is suffering from one of the highest inflation rates in Europe affecting people's disposable incomes.

The Ukrainians' determination to fight for their country should serve as an inspiration to other smaller nations that are being bullied by larger ones, Mr. Szczepankiewicz pointed out — the Philippines included. Korek ka diyan, Mr. Chargé d'Affaires.

₱15-B investments seen from zero waste roadmap

Successful implementation of the strategies and roadmap towards the achievement of Zero Waste To Nature (ZWTN) 2030 could generate ₱15.1 billion infrastructure investments, creation of 4,000 new green jobs and ₱5.2 billion income for the informal sector.

This was estimated by the Philippine Alliance for Recycling and Materials Sustainability (PARMS) together with the Fast-Moving Consumer Goods (FMCG) sector members in their "Rigid and Flexible Packaging Applications" its Strategy and Roadmap

The groups are preparing for the implementation of the recently passed Republic Act 11898 or the Extended Producer Responsibility (EPR) Act of 2022 in the country, which underlines the important role of EPR systems as a practical approach to waste management, focusing on waste reduction, recovery and diversion, and the development of environment-friendly products.

Compared to proposed plastic taxes, the groups said that EPR fees are meant to be spent precisely for diversion and circularity. Whereas taxes go to the central budgets and are spent in line with general government considerations like paying public servants, building infrastructure, and the like.

The Roadmap presented a model showing that with the successful implementation of identified strategies; the ZWTN 2030 is feasible for all plastic packaging structures. The model showed benefits to investment, labor and employment.

But to meet the targets for diversion capacity by 2030 in the packaging applications, the roadmap showed an estimated ₱15.1 billion infrastructure investment for new recycling and waste diversion facilities.

The operation of these facilities will directly create 4,000 new "green jobs" while EPR fees to support waste recovery will generate approximately ₱5.2 billion of annual additional income for the informal waste sector and Barangay Material Recovery Facilities.

A diversion rate of 20 percent can be achieved in 2022 or upon operationalization of the EPR scheme and other enabling policies. The diversion rate can be progressively increased by 10 percent each year to reach 100 percent by 2030 ds the other strategies are phased in, driving waste recovery and diversion across the country. NPC bares rehab plan for Agus power plants

NATIONAL Power Corp. (NPC) will pursue the rehabilitation of the Agus hydropower plants in Mindanao at a cost of P12.5 billion and set the notice of a public hearing on the project's environmental impact next month.

The project will upgrade and modernize the hydro plants to restore their rated capacities, extend their operating lives, enhance the dam's structural integrity and ensure the overall safety of the power complex.

NPC said in documents submitted to the Department of Environment and Natural Resources it plans to rehabilitate the 746.1-megawatt Agus plants to increase Mindanao's reliance on renewable and affordable energy and provide ancillary services to enhance the system reliability.

"Currently, the HPPs are operating below their installed capacity and require upgrading, and the Agus HPPs have been in operation for more than three decades and are already experiencing operational problems due to outmoded equipment and parts, and deterioration of their structures," said NPC.

The proposed rehabilitation project supports the government's Build, Build, Build Program, which lists the Agus HPP rehabilitation as part of the state's priority Infrastructure Flagship Projects.

Mayor revokes mining firm's permit over 'fraud'

THE mayor's permit of Sagittarius Mines Inc. (SMI), developer of Southeast Asia's largest untapped gold reserve, was revoked by the local government unit (LGU) of Tampakan town, South Cotabato, for alleged fraud and misrepresentation of its business status.

Mayor Leonard Escobillo canceled the mayor's permit, which he had issued to SMI that serves as a business permit to operate in the locality.

The SMI has been pursuing the controversial \$5.9-billion Tampakan project, launching a near-the-surface minefield in January 2003.

Last Friday, Escobillo said he was implementing the Municipal Tax Code of 2012, which allows the local chief executive to revoke or deny business permits if the applicant deliberately makes false statements in its application.

"There's nothing personal in this case. We are just doing our obligation, which is to implement our tax ordinance (to increase local revenues)," the mayor also said.

He added that the mining company was served the notice of revocation of the mayor's permit at the firm's offices in Tampakan and to the adjacent town of Polomolok, South Cotabato.

Escobillo also stated SMI's core farm in Libertad village, Tampakan was padlocked as a result of the cancellation of the firm's business permit.

The revocation came after a petition filed by SMI against the Tampakan LGU before a local court asking for a review and issuance of a temporary restraining order against the collection of P397 million worth of accumulated taxes and surcharges demanded by the local government from the company.

Escobillo said all business establishments have been subjected to a tax audit in a bid to its crease local revenue generation pointing out that the LGU is not zeroing in on the SMI.

Last month, according to the Tampakan mayor, some business establishments with deficiencies already settled their tax obligations with the local government.

Nena Santos, legal counsel of the Tampakan LGU, said the revocation of the SMI's mayor's permit is not related to the case filed by the firm against the local government.

Santos said the mining firm made a false statement in its application for mayor's permit, the reason why they canceled it, adding that the tax case is a

different matter

"The company falsely claimed that they are already into manufacturing," she said, noting that the firm has not yet gone into commercial mining operations.

Santos added that the company's gross receipts it declared with the LGU were based on the sales of unserviceable assets such as tables, computers, vehicles and other equipment, which can be considered as other income but not coming from the company's mining operation.

She said the SMI classified itself as a general engineering contractor from 2004 to 2011 but changed its status to a manufacturer in 2012.

According to Escobillo's revocation notice, the assessment of the Municipal Treasurer's Office classified the firm as still a general engineering contractor, not a mineral exploration manufacturer as claimed by the company.

The mayor said there are available remedies for the SMI under the law and the local ordinance for the lifting of its canceled mayor's permit.

Meanwhile, Santos said the LGU has 30 days from September 8 to answer the petition lodged by the SMI in court.

The mining firm is yet to make a statement on the issue.

A local Tampakan organization and personalities lauded the decision of the LGU revoking SMI's mayor's permit. "We commend the local government of Tampakan for applying the law and holding the mining company accountable for its false statements in its mayor's permit documents," Jaybee Garganera, national coordinator of Alyansa Tigil Mina (ATM), said.

Rene Pamplona, ATM chairman, said the revocation of the permit is a welcome development especially among residents of Tampakan, who have been opposing mining in the area.

Fr. Frome Milla, director of the Social Action Center of the Diocese of Marbel, also commended the LGU, saying the revocation can be considered as another victory toward stopping the SMI from operating in the area.

"As mandated by the Local Government Code, the LGU of Tampakan made good on its duty to ensure benefit for its constituents. We hope Tampakan's leadership continues to stand firm and further protect Tampakan's environment, this is ultimately its wealth," lawyer Ryan Roset, Legal Rights and Natural Resources Center official, said

A slightly lower congestion rate of 303 percent is reported in BUCOR's six operating prisons and penal farms. One can only imagine the deplorable conditions suffered by four PDLs being packed in an ill-ventilated, smelly jail space designed for one.

Thus, the proposed regular and timely release of PDLs is a welcome move. PDLs should not be made to suffer in prison one day longer than necessary. Check your water supply

friend referred me to a useful online tool for farmers and non-farmers alike.

This is the online farmers' guide prepared by the Philippine Department of Agriculture (http://farmersguidemap.da.gov.ph/). This website features various types of data on agriculture, from crop suitability maps to road networks and groundwater availability.

A vital information from this website is that the groundwater availability maps show that many areas have poor groundwater availability. This is a concern because groundwater is water that is most readily available for our use, and cheapest to tap. Being stored underground makes it less likely to be contaminated with surface contaminants such as natural debris consisting of decaying plants and even household refuse.

Generally speaking therefore, the cost to treat or prepare groundwater for human consumption, or to meet the Philippine National Standards for Drinking Water (PNSDW) is lower compared to surface water such as those from rivers or lakes, which must go through several stages of treatment.

Having sufficient, affordable water is essential to life. Having less water means lower agricultural productivity especially during dry periods. This threatens local food supply, and will cause shortages and raise prices, leading to inflationary spikes. Moreover, in this age of health consciousness due to infectious diseases, sanitation provided by the availability of water is crucial to maintain the health of people in a given locality. Frequent handwashing requires clean water.

The need to ensure that clean ground and surface water is available is why Republic Act 9275 or the Clean Water Act was enacted in 2004. This law was groundbreaking since it views our water resources from a more holistic standpoint. It not only mandates protection of ground and surface water bodies such as rivers, seas and streams from pollution by regulating wastewater from establishments and homes, it does it through the stringent application of standards that can be set at the local level through a multisectoral water quality management area board that oversees the health of water bodies in a given area or basin. This ensures the continuous, sustainable use of the resource over time through programs that can even improve the quality of the water from the rivers, lakes and streams within its jurisdiction, increasing the volume of clean water to be made available to the local population.

With the farmers guide, you can find out which wa-

you can find JOHNTRA out which water basin you fall under, and you can check the DENR website to determine which water quality management area covers your area and ask about programs to strengthen water availability.

With the challenge of changing climate patterns, rainfall may not be as evenly distributed throughout the year. This affects the volume of groundwater since rain is needed for groundwater to be recharged.

Given the importance of water as a resource, the Department of Environment and Natural Resources, along with the National Water Resources Board (NWRB) must lead in monitoring how much water is available for our use in each region.

Regional Development Councils must take note of such availability estimates, as a lack of water hampers development efforts especially food production. It can endorse water development and management programs.

This will also guide water districts to plan for possible shortages by increasing reservoir capacity, for instance, to collect as much water when it is abundant to prepare for the dry months. As citizens, we can ask our water districts about these initiatives.

Sustainable development means a rational and orderly balance for a healthy environment that enables us to survive and thrive. Without abundant, and affordable water, this will be difficult.

People will rebel against green policies

he disconnect between the global elite and the real world is growing by the day. Most people are worn down by the pandemic, food and energy price hikes and general inflation, and worried about recession. Yet, the chattering classes are jetting into conferences at Davos or Aspen to declare that our biggest, immediate threats are climate change, environmental disasters, and biodiversity loss.

This ignores most of our urgent crises. Almost a billion people are at risk of starvation this year, exacerbated by climate-concerned opposition to fertilizers made with fossil fuels. More than a billion schoolchildren have missed out on an average of nine months of learning because of lockdowns, which will cost their generation \$1.6 trillion every year by 2040. Millions among the rich will unnecessarily die from undiagnosed cancer and heart disease ignored during the pandemic, while millions more among the poor will die unnecessarily from malaria and tuberculosis, just like they always do.

If you're a wealthy, climate-concerned jet-setter with private health insurance and a recession-safe job, you don't need to worry about malaria, recession, waiting in line for cancer tests, or about your children falling behind when schools close again. Nor are these issues that will get you attention or airtime.

Solving the real world's big problems is messy, and progress is slow and unspectacular. It is far more exhilarating to make grand promises to save the entire world by going net zero or abandoning synthetic fertilizers.

Climate change is a real, man-made problem that deserves attention. It is also wildly overblown in the media, with every weather "event" turned into a telegenic catastrophe. Last year, newspapers overflowed with stories of devastating hurricanes though satellites showed that 2021 had the fewest hurricanes globally. Hundreds of deaths from

heat waves top the news, when data shows that many more people—4.5 million globally—die from the cold because of a lack of heating worsened by high energy prices.

For decades, we have been told that ending fossil fuels is cost-free or even beneficial. Now, we are starting to see the immense economic and security costs of such untethered promises.

Early pushback came in France with the "yellow vest" protests. The Netherlands has also been roiled by protests since the government introduced policies that would decimate the agricultural industry in the name of the environment. Such policies threaten the food production right when global hunger is rising, yet the government is unable to change course because environmentalists use legal action to lock in the lopsided policies.

It is even worse in Sri Lanka. Egged on by elite campaigners and the World Economic Forum to go organic, the government banned synthetic fertilizers in April 2021. Predictably, food production collapsed, and the currency defaulted.

Solving many of these problems is not rocket science. The rich should stop making food more expensive by insisting on organics. They should stop making energy more expensive by dictating intermittent renewables. Instead, we should increase research and development into better seeds to deliver more food with a lower carbon footprint. We should drive green energy breakthroughs that could make drastic CO2 reductions cheap and feasible. And we should include the many other urgent crises that have simple and effective solutions—for instance tuberculosis

and securing learning in school with computer-assisted teaching at the right level.

Unfortunately, the elite chooses to double down on climate and environment, despite the case of the Netherlands and Sri Lanka being warnings of what will come. Net zero will be the costliest policy that the world has embarked upon, with the price tag for paying for renewable assets and infrastructure costing more than \$5 trillion every year for the next three decades, according to McKinsey. Every year the Eropean Union (EU) has to pay 69 billion euros in subsidies to support its renewables.

As in the Netherlands, governments are going to find themselves increasingly caught between environmentalists, who push costly virtue-signaling initiatives, and working families who cannot cope with rising prices.

The wild increases in energy prices in Europe, although partly caused by poorly designed climate policies, are mostly due to Russia's indefensible war. But the cost of energy could increase even more, every year, and for everyone across the globe, if politicians double down on net zero.

Even under today's policies, EU vice president and long-time climate action advocate Frans Timmermans admits that many millions of Europeans might not be able to heat their homes this winter, leading to "very, very strong conflict and strife."

He's right. When people are cold, hungry, and broke, they rebel. If the elite continues pushing incredibly expensive policies disconnected from the urgent challenges facing most people, we need to brace for more global chaos.

Climate disasters, conflict take toll on children

UNITED NATIONS: From Pakistan to Ukraine to Venezuela to vast stretches of sub-Saharan Africa, rising crises and climate disasters are taking an added toll on the most vulnerable—children deprived of school.

"It is horrendous, and it's hard to imagine," said Yasmine Sherif, head of Education Cannot Wait, a UN fund that focuses on education in crisis zones.

"They've lost everything, and on top of it, they have lost their access to a quality education," she said in a recent interview. Sherif spoke to Agence France-Presse (AFP) ahead of a UN summit on the education crisis to take place on Monday, a day before the annual General Assembly.

The UN fund estimates that 222 million children around the world have seen their education disrupted by conflict or climate-related disasters, including nearly 80 million who never set foot in school.

Since 2016, Education Cannot Wait has raised more than \$1 billion to build schools and buy educational ma-

terials, as well as provide daily meals, and offer psychological services. The aid helps nearly 7 million children in 32 countries.

Sherif said that the urgency of the situation required much bigger efforts.

"If we are going to meet the needs, we have to think in completely different terms today," she said. "We are speaking billions and billions here, not millions" of dollars.

Following the UN summit, Sherif is organizing a conference in Geneva

in February where the fund will seek a further \$1.5 billion with a goal of reaching an additional 20 million children.

Some Western nations spend \$10,000 per year on educating a child. If children in conflict zones receive \$150 each, "you can see the extreme divide," said Sherif, who is Swedish.

In some conflict zones, schools have been destroyed, in what Sherif denounced as war crimes, while others, in violation of international law, have

been turned into weapons depots.

Elsewhere, physical danger or the gradual unraveling of infrastructure and public services have shut down education, which Sherif said should be a lifeline for the world's young.

"What we offer is a tool, a hope, an empowerment to resist those forces in a conflict and, through their own means, be able to rise out of those ashes," she said.

The lack of education has real and immediate consequences. Children sometimes end up on the streets,

facing threats of violence, human trafficking, recruitment by armed groups or, for girls, forced marriage.

"They've seen their villages burned down, they've seen their parents be executed, they have been subjected to violence. The only thing left for them is, 'If I can get an education, I can rise up out of this and make a difference in my life," Sherif said.

"We're taking away that very last piece of hope, unless we provide them with an education."

External environment may improve immune systen

As more kids return to school after two years of remote learning due to COVID-19, a nutrition expert said parents should not be afraid to expose their children to the external environment as this may help in improving their immune system.

Amid the pandemic, Dr. Jun Dimaano, medical director of Abbott Nutrition Philippines, said parents were "normally protective of their children [and] they don't want to expose [them] to the playground or their pets."

But you can actually be helpful because if you expose them to these external stimuli, you also

prime the immune system so that they can react appropriately once they are exposed to pathogenic organisms," he said at a recent roundtable discussion.

"Let's not be afraid to let them explore, go to the playground and interact with friends and classmates but of course with the necessary precaution: masks, washing of hands and social distancing in schools," Dimaano said, adding that ensuring proper nutrition was also equally important.

Dr. Rachael Buck, Abbott's senior research fellow and pioneer in child nutrition, pioneered research on human milk oligosaccharides (HMOs), which are special prebiotics that help strengthen the immunity of chil-

"If you give HMOs, these are consumed by the beneficial bacteria and the beneficial bacteria give the gift of health back to children because [it] stimulates the immune system," she said at the same forum.

'Beneficial bacteria' in gut

Buck pointed out that the gastrointestinal tract, or gut, is essential in the early digestion and brain development since "beneficial bacteria" live and reside in it.

"There are trillions of organisms that live in the gut. And they need to be fed. And what's really important about beneficial bacteria is if you give them the gift

of certain food, they give you the gift of health," she said.

Together with her group from Abbott, Buck made a milk formula consisting of five HMOs whose molecules are abundant in nature, particularly in the Asian populations.

"This blend is catered to Asian populations to help children's immunity and brain development as well," she said.

The milk formulation, Buck said, was a "great way to have that insurance and support for the children's health.'

"Immunity now is just so more important than ever before. We need to keep nourishing the immune system in every way we can," she added. INQ



Try forest bathing to reduce

stress and prevent illness

t's back to Mother Nature for, many people seeking a way to lower stress levels, and thus prevent illness and disease.

It starts with a ritual called forest bathing or forest therapy which is supported by a growing body of scientific research which has measured its many benefits. One significant effect is the lowering of blood pressure (for those with high blood pressure) 15 minutes after engaging in ferest bathing.

There are many groups around the world practicing forest bathing, or "shinrin-yoku," a term coined in 1982 by Tomohide Akiyama, director of the Japanese Forestry Agency. The concept focuses on walking slowly through the forest and bathing "in the environment of the forest, using all your senses to experience nature

Yoshifumi Miyazaki, a university professor, researcher and the deputy director of Chiba University's Centre for Environment, Health and Field Sciences, has published many books on the effects and benefits of forest therapy. In his book "Shinrin-yoku: The Japanese way of Forest Bathing for Health and Relaxation," Mr. Miyazaki discussed how his research studies have measured the benefits of taking a long slow walk in the

Calling the practice "nature therapy" or "forest therapy," Mr. Miyazaki traces its effects to man's connection to nature. "Humans have spent over 99.99 percent of their time throughout history in a natural

That is why when we come into contact with nature, we feel relaxed.

"That is because our bodies (including our genes) were made to be adapted to nature."

His studies have shown that when people are in a natural environment, they reported feeling relaxed. Stress is reduced. "This simple act helps to regulate the nervous system, promoting a healthier balance between activation and relaxation. In this way, illness can be prevented and a healthy way of living is maintained."

Nature therapy, he emphasized many times in the book, is a "preventive approach to lower stress levels, improve quality of life and potentially reduce the cost and strain on health services that stress-related

illnesses cause."

His research has shown that through the simple act of walking in a forest, people experience many benefits during and after a session of forest therapy.

Here are the benefits of forest therapy which his studies have measured:

- Improvement of weakened immunity, with an increase in the count of natural killer (NK) cells, which are known to fight tumors and infection.
- Increased relaxation of the body due to increased activity in the parasympathetic nervous system.
- Reduced stress of the body due to a reduction in sympathetic nervous system activity.
- Reduction in blood pressure after only 15 minutes of forest therapy.
- Reduced feelings of stress and a general sense of wellbeing.
- Reduction of blood pressure after one day of forest therapy,

which lasts up to five days after therapy.

An interesting study on the restorative power of nature is also mentioned in the book. It studied the effect of the view from a window of patients who went through gall bladder removal. Scientists in Pennsylvania studied the patients who were recovering in the hospital. Some of the patients were in rooms with a view of nature, while the rest had windows that faced a brick wall.

They found that "patients with a view of a nature left the hospital sooner and requested for less painkillers during their stay."

The study on the benefits of nature therapy also included the effect of plants in the house, the smell of wood and essential oils, and gardening. Many elements of nature have the same beneficial effects as shinrin-yoku, and he recommended ideas "to bring the forest closer to home," and reduce stress.

If you are interested in pursuing forest bathing, there are many books and articles about that online. A book I picked up years ago - "The Healing Magic of Forest Bathing" by Julia Plevin - is a guide on the rituals one can follow to find "calm, creativity and connection in the natural world."

To Ms. Plevin, forest bathing is

"the practice of intentionally connecting to nature as a way to heal. Part mindfulness, part child's play, it's a portal into true understanding of yourself and the world around you.

I've been practicing forest bathing for a long time now, although I only became aware that my attachment to the forest had a name after reading about it. As a mountaineer, I've hiked through many forests and reached the summits. In the forest, I am a cheerful person and I do not complain, even if I am tired and wet from the rain. I just feel happy. Shinrin-yoku explained that to me.

In the first two years of the pandemie, I did forest bathing in our small courtyard which a neighbor had filled with plants. As soon as the border restrictions were lifted, I went to the forest, trekked through two dense trails in one day - and felt happy, energized, and extremely relaxed. (I am a senior citizen.)

In Camp John Hay in Baguio City, there's a trail specifically marked "forest bathing trail." It winds through a lovely pine forest which a slow walker can complete in about two hours.

But if that's too far for you now, remember what Mr. Miyazaki said in his book: "Any space where there are plants growing can offer relaxation effects to those who are prepared to seek them out and spend time there."

Sometimes, the problem is not finding the green spaces but our busy minds which we cannot set aside to allow our bodies to relax, he pointed out.
