House OKs bill granting Duterte 'necessary' powers due to COVID-19 crisis

MANILA, Philippines — The House of Representatives on Monday approved a bill declaring a national emergency due to the coronavirus pandemic and authorizing President Rodrigo Duterte "for a limited period and subject to restrictions, to exercise powers necessary and proper to carry out the declared national policy."

During a special session, the lower chamber approved the Bayanihan Act of 2020 (House Bill No. 6616) in response to the threat of the coronavirus disease (COVID-19), which has infected 380 people in the country.

The House voted 284 for and 9 against the measure with no abstentions.

"In view of the continuing rise of confirmed cases of COVID-19, the serious threat to the health, safety, security, and lives of our countrymen, the long-term adverse effects on their means of livelihood, and the severe disruption of economic activities, a state of national emergency is hereby declared over the entire country," the bill states.

"In order to optimize the efforts of the President to carry out the tasks needed to implement the aforementioned policy, it is imperative to grant him emergency powers subject to such limitations as hereinafter provided," it added.

The bill allows the President to "issue such rules, regulations, and directives as may be necessary to carry out" his powers, which include implementation of measures to curb the transmission of the disease, hastening medical testing of persons under investigation (PUI) and persons under monitoring (PUM) and "immediate treatment" of COVID-19 patients.

Likewise, the President will also ensure that local government units (LGUs) are following directives from the national government in line with the pandemic response.

The President can also "reprogram, reallocate, and realign any appropriation" in the 2020 national budget "for whatever purpose the President may deem necessary and desirable to fund measures to address and respond to the COVID-19 emergency."

Among other powers authorized for the President to perform include the following:

- When the public interest so requires, direct the operation of any privately-owned hospitals and medical and health facilities, hotels, and other similar establishments to house health workers, serve as quarantine areas, quarantine centers, medical relief and aid distribution locations, or other temporary medical facilities; and public transportation to ferry health, emergency, and frontline personnel and other persons
- Adopt measures to protect the people from hoarding, profiteering, injurious speculations, manipulation of prices, product deceptions, and cartels, monopolies or other combinations in restraint of trade, or other pernicious practices affecting the supply, distribution and movement of food, clothing, medicine and medical supplies, fuel, fertilizers, chemicals, building materials, implements, machinery equipment and spare parts required in agriculture, industry and other essential services, and other articles of prime necessity, whether imported or locally produced or manufactured
- If needed, undertake the procurement of goods and services as "in the most expeditious manner" in relation to COVID-19 response

- Ensure the availability of credit to the productive sectors of the economy especially in the countryside through measures such as, but not limited to, lowering the effective lending rates of interest and reserve requirements of lending institutions
- Liberalize the grant of incentives for the manufacture or importation of critical or needed equipment or supplies for the carrying-out of the policy declared herein, including healthcare equipment and supplies
- Require businesses to prioritize and accept contracts, subject to fair and reasonable terms, for materials and services necessary to promote the herein declared national policy
- Regulate and limit the operation of all sectors of transportation through land, sea or air, whether private or public
- Regulate traffic on all roads, streets, and bridges, and access thereto; prohibit putting up of
 encroachments or obstacles; authorize the removal of encroachments and illegal constructions
 in public places; and perform all other related acts
- Continue to authorize alternative working arrangements for employees and workers in the Executive Branch, and whenever it becomes necessary, in other independent branches of government and constitutional bodies, and the private sector
- Conserve and regulate the distribution and use of power, fuel, energy, and water, and ensure an adequate supply of the same
- Move statutory deadlines and timelines for the filing and submission of any document, the
 payment of taxes, fees, and other charges required by law, and the grant of any benefit, in
 order to ease the burden on individuals under community quarantine
 The measure requires the President to submit a monthly report to Congress within the first 10
 days of the month. The report shall contain acts performed in accordance with the bill.

Violations


Those violating the regulations and directives of the national government will be meted a penalty of not less than P10,000 but not more than P1 million and/or imprisonment of two months. If the offender is a public official, he/she will be meted the same punishment on top of perpetual or temporary absolute disqualification from office.

"Provided, however, that if the offender is a corporation, association, partnership or any other juridical person, the penalty shall be imposed upon the president, directors, managers, managing partners, as the case may be, who participated in the commission of the offense or who shall have knowingly permitted or failed to prevent the commission of the same," the bill states.

"If the offender is an alien, he shall, in addition to the penalties herein prescribed, be deported without further proceedings," the bill further notes.

The House of Representatives, in a historic virtual special session, on Monday night (March 23) approved on second reading a bill seeking to declare the existence of a national emergency and to authorize President Duterte for "only three months", unless extended by Congress, to exercise "necessary" powers to deal with the COVID-19 pandemic crisis.

Among these are the powers to realign as much as P275 billion in government funds and direct the operation of any privately-owned hospitals, medical and health facilities, and other similar establishments to serve as quarantine areas, and medical relief and distribution locations.

Voting 284 against nine with no abstention, the Lower Chamber approved substitute House Bill (HB) No. 6616 or the Bayanihan to Heal as One Act of 2020, giving in to President Duterte's request to immediately grant him the special authority to deal with the COVID-19 crisis.

It took 14 hours for the chamber to pass the measure.

It was Deputy Majority Leader and Pampanga 2nd district Rep. Juan Miguel Arroyo, acting Floor Leader, who moved for the approval of the bill.

At past 10 p.m., the House opened the period of individual amendments to the substitute bill HB 6616.

It was Bulacan Rep. Jonathan Sy-Alvarado who introduced the first and sole amendment to Section 6 of the bill. He proposed that the violators of "directives issued strictly in accordance with provisions" shall be slapped with a penalty of imprisonment for two months and a fine ranging from P10,000 to P1 million.

Last week, President Duterte called for a special session for Congress to pass a supplemental budget to strengthen the government's capacity to contain the spread of COVID-19.

Funding power

HB 6616 authorizes President Duterte to "reprogram, reallocate, and realign from savings on other items of appropriations in the fiscal Year 2020 GAA (General Appropriations Act) in the Executive Department, as may be necessary and beneficial to fund measures to address and respond to the COVID-19 emergency, including social amelioration for affected communities, and the recovery and the recovery of areas, sectors, and industries severely affected."

"All amounts so reprogrammed, reallocated or realigned shall be deemed automatically appropriated for such measures to address the COVID-19 situation," the bill also provides.

Duration of law

The proposed Act "shall be in full force and effect only for three months, unless extended by Congress."

It also provides that the powers granted under this Act may be withdrawn sooner by means of a concurrent resolution of Congress or ended by Presidential proclamation.

Direction of operations of private facilities

HB 6616 specifically provides that "when the public interest so requires," the President is authorized "to direct the operation of any privately-owned hospitals, medical and health facilities, including passenger vessels, and other establishments, to house health workers, serve as quarantine areas and centers, medical relief and aid distribution locations, or other temporary medical facilities; and public transportation to ferry health, emergency, and frontline personnel and other persons."

However, the management and operation of such enterprises shall be retained by the owners of the public service or enterprise, who shall render full accounting to the President or his duly authorized representative of the operations of the utility or business as basis for appropriate compensation, the bill provides.

The measure provides that after the situation has stabilized or at the soonest time practicable, reasonable compensation for any additional damage or costs incurred by the owner of the subject property solely on account of complying with the directive shall be given.

"Finally, that if the foregoing enterprises unjustifiably refuse or signified that they are no longer capable of operating their enterprises for the purpose stated herein, the President may take over their operations subject to the limits and safeguards enshrined in the Constitution," Section 4 of HB 6616 provides.

Unutilized or unreleased balance

HB 6616 also provides that any unutilized or unreleased balance in a special purpose fund, as of the date of declaration of a state of emergency, shall be considered to have their purpose abandoned for the duration of the state of emergency.

"All such unspent, unutilized, or unreleased money or funds sourced from collections or receipts, including future collections and receipts, shall be utilized and are hereby appropriated for such measures to address the COVID-19 situation and accomplish the declared national policy herein," it said.

Under the bill, the President is also authorized to allocate cash, funds, investments, including unutilized or unreleased subsidies and transfers, held by any government-owned or -controlled corporation (GOCC) or any national government agency in order to address the COVID-19 emergency.

Discontinuance of programs, projects, activities

HB 6616 also empowers President Duterte to direct the discontinuance of appropriated programs, projects, or activities (P/A/P) of any agency of the Executive Department, including GOCCs in the FYs 2019 and 2020 General Appropriations Act (GAA), whether released or unreleased the allotments for which remain obligated.

It provides that the savings generated therefrom will be used to "augment the allocation for any item for support operations, response measures, which are necessary, or beneficial in order to address the COVID-19 emergency."

Priorities for augmentation

The following items in the budget shall be prioritized for augmentation:

Under the Department of Health (DOH) — operational budgets of government hospitals, primarily those identified for treatment of COVID-19; prevention and control of other infectious diseases; emergency preparedness and response;

Under the University of the Philippines — the operational budget of the Philippine General Hospital (PGH);

The National Disaster Risk Reduction Fund or Calamity Fund;

Programs of the Department of Labor and Employment, such as but not limited to Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD) and COVID-19 Adjustment Measures Program (CAMP);

Under the Department of Trade and Industry — Livelihood Seeding Program and Negosyo Serbisyo sa Barangay;

Under the Department of Agriculture — Rice Farmers Financial Assistance Program;

Under various programs of the Department of Social Welfare and Development (DSWD), such as, but not limited to, assistance to Individuals in Crisis Situations (AICS), distribution of food and non-food items, and livelihood assistance grants;

Under Allocations to the Local Government Units; and Quick Response Funds lodged in the various relevant departments, such as, but not limited to, the DOH and DSWD.

The discontinued program activity or project may be revived at any time after the national emergency has ceased, HB 6616 provides.

Local government units

HB 6616 also authorizes President Duterte "to ensure all Local Government Units (LGUs) are acting in line with the rules, regulations, and directives issued by the national government, and are implementing standards of community quarantine that are neither more nor less restrictive than what the national government has laid down for the subject area."

Testing kits

The bill also empowers the Chief Executive to expedite and streamline the accreditation of testing kits and facilitate prompt testing by public and designated private institutions of persons under investigation (PUIs) and persons under monitoring (PUMs), and the compulsory isolation and treatment of patients.

Procurement of goods

Under HB 6616, President Duterte is also authorized to undertake the procurement of the following goods—which may include personal protective equipment such as gloves, gowns, masks, goggles, face shields; surgical equipment and supplies; laboratory equipment; medical supplies; common medicines; and testing kits "as the need arises, in the most expeditious manner, as exemptions from the provisions of Republic Act No. 9184 or the "Government Procurement Reform Act" and other relevant laws."

Other exemptions from procurement laws

Also exempt from the procurement laws are the goods and services for social amelioration measures in favor of affected communities; the lease of real property or venue for use to house health workers or serve as quarantine centers, medical relief and aid distribution locations, or temporary medical facilities; the establishment, construction, and operation of temporary medical facilities; utilities, telecommunications, and other critical services in relation to operation of quarantine centers, medical relief and aid distribution centers, and temporary medical facilities; and ancillary services.

Importation of critical supplies

HB 6616 also seeks to liberalize the grant of incentives for the manufacture or importation of critical or needed equipment or supplies, including healthcare equipment and supplies.

Under the bill, the importation of these equipment and supplies shall be exempt from import duties, taxes, and other fees.

Private businesses

The bill also authorizes the President to require businesses to prioritize and accept contracts for materials and services necessary to promote the declared national policy.

Hoarding, profiteering

HB 6616 also empowers the President to continue to adopt measures to protect the people from hoarding, profiteering, injurious speculations, manipulation of prices, product deceptions, and cartels, monopolies, or other combinations in restraint of trade, or other pernicious practices affecting the supply, distribution, and movement of food, clothing, medicine and medical supplies, fuel, fertilizers, chemicals, building materials, implements, machinery equipment and spare parts required in agriculture, industry and other essential services, and other articles of prime necessity, whether imported or locally produced or manufactured.

Philippine Red Cross

Under the bill, the President may engage the services of the Philippine Red Cross as the primary humanitarian agency that is auxiliary to the government in giving aid to the people, subject to reimbursement, in the distribution of goods and services incidental in the fight against COVID-19.

Credit availability

The President shall also ensure the availability of credit to the productive sectors of the economy, especially in the countryside, through measures such as, but not limited to, lowering the effective lending rates of interest and reserve requirements of lending institutions, under the proposed Act.

Moving deadlines

Under HB 6616, the President can move statutory deadlines and timelines for the filing and submission of any document, the payment of taxes, fees, and other charges required by law, and the grant of any benefit, in order to ease the burden on individuals under community quarantine.

Grace period for loan, credit card payments

The bill also empowers the Chief Executive to direct all banks, quasi-banks, financing and lending companies, and other financial institutions, public or private, including the Government Service Insurance System (GSIS), Social Security System (SSS), and Pag-Ibig Fund, to implement a minimum of a 30-day grace period for the payment of all loans. These include, but are not limited to, salary, personal, housing, and motor vehicle loans, as well as credit card payments falling due within the period from March 16 to April 15, 2020, without incurring interest, penalties, fees, or other charges.

Grace period for rent payments

The measure also authorizes the President to provide a 30-day grace period on residential rents falling due within the period from March 16 to April 15, 2020, without incurring interest, penalties, fees, and other charges.

Transportation, power, fuel

Other "authorized" powers of the Chief Executive under the bill are: regulate and limit the operation of all sectors of transportation through land, sea, or air, whether private or public; regulate traffic on all roads, streets, and bridges, and access thereto; prohibit putting up of encroachments or obstacles; authorize the removal of encroachments and illegal constructions in public places; and perform all other related acts; and conserve and regulate the distribution and use of power, fuel, energy, and water, and ensure adequate supply of the same.

Alternative working arrangements

The bill also provides that President Duterte shall continue to authorize alternative working arrangements for employees and workers in the Executive Branch, and whenever it becomes necessary, in other independent branches of government and constitutional bodies, and the private sector.

President's report

HB 6616 mandates the President, during Monday of every week, to submit a monthly report to Congress of all acts performed pursuant to this Act during the preceding week. The report shall include the amount and corresponding utilization of the funds used, augmented, reprogrammed, reallocated, and realigned pursuant to the proposed Act.

Oversight committee

The bill calls for the establishment of a eight-man Joint Congressional Oversight Committee to determine whether such acts, orders, rules, and regulations are within the restrictions provided under the proposed Act.

Important legislation

At the start of the session on Monday, Speaker Alan Peter Cayetano assured the public that the Lower Chamber would pass an important legislation that would address the national health emergency.

"Today, we want to show the world that there will be unprecedented cooperation between the executive and the legislative, that there will be unprecedented cooperation internationally, that today you will see congressmen, governors and mayors working hand in hand, this is our part, we will do our part, we will help the mayors, we will help the LGUs (local government units) deliver these resources into the hands of each and every households," he said in his speech.

He declared the presence of a quorum after a total of 299 House members were in attendance during the special session, 20 of whom were physically present at the Plenary Hall.

The 279 other House members were declared on official business and joined the deliberations through teleconferencing.

It was Majority Leader and Leyte 1st district Rep. Martin Romualdez who moved for the adoption of the motion allowing "members to participate via live streaming, to register their attendance and vote on any matter presented to the body by voice chat, text message, Viber, or other electronic channels using their contact numbers pre-registered by the members and verified by the Secretary General."

Executive Secretary Salvador Medialdea had asked lawmakers to favorably act on the President's request for emergency powers, even as he assured them that there is no intent to overstep the 1987 Constitution and to "abuse" the proposed special powers.

"We assure Congress and our countrymen that this administration has no intent to abuse the powers we are asking of you today," he told the lawmakers.

Joining Medialdea were Department of the Interior and Local Government Secretary (DILG) Eduardo Año and Budget Secretary Wendel Avisado.

Approval

HB 6616 was first approved by the Committee of the Whole, led by Majority Leader and Leyte 1st district Rep. Martin Romualdez. The committee recommended the plenary approval of the bill, which seeks to declare a state of national emergency over the entire country and grant special authority to President Duterte to address the crisis spawned by the novel coronavirus.

"Such authority is needed not only to control the COVID-19 pandemic now gripping the country, but also to immediately mobilize resources for the provision of basic necessities to families and individuals affected by the imposition of community quarantine, especially indigents and their families," Romualdez said in his sponsorship speech.

He said that once approved, the measure "will immediately and amply provide healthcare, including medical tests and treatments, to COVID-19 patients, persons under investigation, and persons under monitoring."

Recovery and rehabilitation

HB 6616 also mandates formulation of a program for recovery and rehabilitation, including a social amelioration program and provision of safety nets to all affected sectors, he said.

Powers

"Specifically, the bill seeks to empower the President to order the purchase of goods like testing kits, to lease properties and to construct temporary medical facilities without going through the rules on procurement, as well as require businesses to prioritize and accept contracts for materials and services in connection with the fight against COVID-19," Romualdez said.

Funding

During the plenary deliberation, Deputy Speaker and Camarines Sur 2nd district Rep. Luis Raymund "LRay" Villafuerte Jr. cited the need for Congress to realign P275 billion in government funds to respond to the pandemic crisis.

He said of the P275 billion "off budget available," P200 billion will be allocated for the implementation of emergency subsidy program to benefit 18 million poor households for a period of two months, and P75 billion to "fund health requirements and other services."

"This measure will also authorize the transfer of funds intended for non-essential expenditures to essential ones, particularly the emergency subsidies for the marginalized and vulnerable, as well as relief and recovery programs for affected workers and small- and medium-sized businesses," he said.

"This bill will also allow the government to adequately equip and protect our countless health practitioners who are at the frontlines of our battle against COVID-19," he added.

20 solons physically present

The chamber allowed only 20 House members, aside from the Speaker, to be physically present at the Batasan Complex in order to strictly adhere to the social distancing protocols issued by the government as part of the safety measures against the spread of COVID-19.

Maynilad, MWC defer meter reading

Metropolitan Waterworks and Sewerage System's (MWSS) Regulatory Office (RO) has allowed Manila Water Company Inc. and Maynilad Water Services Inc. to delay their meter reading until April 14 and to instead charge their customers based on their average water consumption during the past three months.

MWSS-RO said that in light of the implementation of the lockdown or the so-called enhanced community quarantine over Luzon, it has authorized its concessionaires to suspend their meter reading operations and implement average billing, based on the customer's average water consumption during the past three months.

However, the agency noted that upon resumption of regular operations, Maynilad and Manila Water will also be allowed to adjust charges on subsequent water bills based on the customer's actual meter registration.

"The next Maynilad water bills that will be issued to affected customers will be computed based on their average consumption for the past three months. Corrections will just be applied to subsequent bills once Maynilad is able to resume the actual reading of meters," Maynilad said.

As for Manila Water customers, the company said that "any difference versus actual consumption will be reflected and charges will be adjusted on the customers' next bill when Manila Water resumes read-and-bill operations".

"Normal billing process will be observed when the government authorities officially confirm the end of the enhanced community quarantine," the company said.

Maynilad and Manila Water are now both encouraging their customers to pay their bills via online banks or mobile fund transfer channels.

Meanwhile, Manila Water assured its customers in the East Zone that water supply is sufficient even amid the threat of coronavirus disease 2019 (COVID-19).

This is due mainly to the augmentation sources the company has started putting in place beginning last year, such as the Cardona Water Treatment Plant in Rizal and deep wells, as well as non-revenue-water recovery.

Skeleton workforces are also on duty at every water supply and wastewater facility to ensure that service delivery remains unhampered, Manila Water said.

Filipinos' ingenuity produces improvised face masks for health workers in the regions

If necessity is the mother of invention, ingenuity is surely its father. In these times of the coronavirus crisis, when front line health workers are running out of masks and personal protective equipment (PPE) to use, items like garbage bags and tissue papers commonly used to dispose dirt

are shielding them against the virus in the most innovative way they can. Erica Jane De Leon, a doctor to the barrio assigned to the Rural Health Unit (RHU) in Virac, Catanduanes, made an appeal online in hopes to help her fellow front liners in Bicol Region.

If others were improvising surgical or N95 masks from cloth, their situation is different – masks were instead made from pieces of tissue papers assembled using push pins and rubber bands.

Obviously, the materials used were not durable, especially in sustaining long hours of duty, but difficult times require "resourceful" solutions to partly resolve the problem.

We hope to serve our constituents very well, but we also need to protect ourselves because we have families waiting for us at home," she said in a post.

The same ordeal was observed at St. Jude Hospital in Los Baños Laguna, where the post of hospital worker Maria Theresa Depano gained mixed reactions, most of which were urging the government, as well as the private sector, to intervene immediately.

With the scarcity of PPEs, the health workers and other essential personnel at the said hospital improvised their suit using plastics and trash bags.

"We are calling the attention of DOH or any agency that could provide us with personal protective equipment. We ran out of PPEs and we couldn't purchase the item anywhere that's why we improvised to protect our staff, Depano said..

While it gathered most sympathies, the message from social media users was clear – "act now to save them."

While those who wish to drop their donations at St. Jude Hospital, may contact the landline number (049) 536-1982. Since Sunday, hundreds of medical front line workers have been placed under quarantine due to their exposure to coronavirus disease (COVID-19) patients, according to reports.

'Retaso' for face masks Meanwhile, popular swimsuit designer Domz Ramos has turned small pieces of cloth (retaso) into face masks which his team has distributed to barangays and frontliners for the fight against COVID-19.

"So far, we have given some 2,000 face masks. Gumagawa pa rin kami (We are making more)," said Ramos, who is the official swimsuit designer for the Bb. Pilipinas beauty pageant, in an online interview Monday.

Made of cotton fabric, some of these face masks have been distributed to the Philippine General Hospital, National Kidney and Transplant Institute, Children's Hospital, and Qualimed Hospital.

Ramos said his staff members at DR Styles Fashion, relatives, and neighbors helped him make the face masks in Taguig City. "While producing these face masks, we also practiced social distancing. We sanitized, that's why these face masks are clean," he said.

Ramos also donated face masks to frontliners during Taal Volcano eruption in January.

Ramos has been active in charity missions. He is behind the popular Christmas gift-giving activity for children dubbed "MaBarbie Doll ang Pasko Caravan" which is on its fourth year now.

His team and sponsors give away toys, dolls, and food to street children in Metro Manila and nearby areas during the holidays.



Heed Mother Nature

Among the many theories popping up in an unprecedented sequestered world as a result of the virus invasion, the most fascinating was that the situation humanity is now in was dealt by nature.

For years, nations have debated and fought over measures to free the world of an impending disaster as a result of air pollution that had progressively raised global temperatures resulting in weather catastrophes, such as typhoon "Yolanda" that swept away an estimated 10,000 lives in a matter of a few hours.

Environment experts now say that air pollutants and warming gases over some cities and regions have dropped significantly as the coronavirus impacts on commerce and travel.

Researchers in New York bared early results showing carbon monoxide mainly from cars had been reduced by nearly 50 percent compared with last year.

The study was done when most developed countries had yet to impose restrictions on travel.

Emissions of the planet-heating gas carbon dioxide (CO2) have also fallen sharply. The problem, according to experts, is that pollution levels could rise rapidly after the pandemic as nations try to cover lost ground.

Scientists said that by May, when CO2 emissions are at their peak due to the decomposition of leaves, the levels recorded might be the lowest since the financial crisis over a decade ago.

Traffic levels in the Big Apple were estimated to be down 35 percent compared with a year ago. Emissions of carbon monoxide, mainly due to cars and trucks, have fallen by around 50 percent for a couple of days, according to researchers at Columbia University.

There was a five to 10 percent drop in CO2 over New York and a solid drop in methane as well.

"New York has had exceptionally high carbon monoxide numbers for the last year and a half," said Columbia University Prof. Róisín Commane, who carried out the New York air monitoring work.

"And this is the cleanest I have ever seen it. It's is less than half of what we normally see in March."

Those brave souls who go out in the morning in Manila bare the same experience of breathing in an unusually clean air and at night, a brighter sky with stars unseen for some time.

An analysis carried out for the climate website Carbon Brief suggested there had been a 25 percent drop in energy use and emissions in China over a two-week period. This is likely to lead to an overall fall of about one percent in China's carbon emissions this year, according experts.

Both China and Northern Italy, which are the regions hardest hit by the virus, have also recorded significant falls in nitrogen dioxide, which is related to reduced car journeys and industrial activity. The gas is both a serious air pollutant and a powerful warming chemical.

Experts said with aviation grinding to a halt and millions of people working from home, a range of emissions across many countries are also in the downtrend.

"If the pandemic lasts another three of four months, certainly we could see some reduction," according to an expert.

Such length of isolation as a result of the pandemic would prove disastrous to the human species.

A possible takeaway from the global crisis is that the price of the failure of humanity to come together to address problems facing its existence may have to be Mother Nature providing the harsh but needed solution.

We need our national government to stand up for its people.
