# 3 wildlife traders convicted

Three men have been sent to prison for transporting critically endangered Philippine pangolins.

Simforoso Salazar, Jorlan Torrequimada and Victor Equisa were sentenced to up to three months in prison after pleading guilty to violating Republic Act 9147 or the Wildlife Resources Conservation and Protection Act, Tagaytay City Municipal Trial Court Branch 1 Judge Liezl Rosario Mendoza said in her recent ruling. They were also ordered to pay a fine of P20,000 each.

Environment Secretary Roy Cimatu lauded the arrest and conviction of the three, saying it shows the resolve of authorities to crack down on poachers, wildlife traffickers and traders.

"We welcome this victory not only for wildlife species that were rescued but also for the future generation who will benefit from the recuperation and proliferation of its kind," Cimatu said.

Ten heads of the Philippine pangolin were recovered at a checkpoint in Tagaytay City last June.

The Palawan Council for Sustainable Development said only three of the rescued pangolins survived.

Locally known as balintong, the Philippine pangolin is in demand among Chinese for its scales and meat, which supposedly have medicinal properties.

# Traffickers of 10 Palawan pangolins receive

# 'slap on the wrist' from Tagaytay City court

HREE men caught transporting 10 Palawan pangolins in Tagaytay City last June were sentenced to jail terms of up to three months and a fine of P20,000 each after pleading guilty to the crime of illegal trade in wildlife.

The two-page order dated July 18 was handed down by Judge Liezl Rosa-

rio S. Mendoza of the Municipal Trial Court (MTC) in Tagaytay City against Simfroso Salazar, Jorlan Torregquimada and Victor Equisa.

The three pleaded guilty to violating Republic Act 8147 or the Wildlife Resources Conservation and Protection Act of 2001. The law prohibits

the killing, injuring, collection, selling and transport of threatened and endangered wildlife species.

In a statement, Environment Secretary Roy A. Cimatulauded the arrest and conviction of the three convicts.

Cimatu said such "swift justice" is a sign of just how hard the authorities

were trying to clamp down on poachers and wildlife traffickers and traders in the Philippines.

He added that the verdict provides hope and inspiration for the Department of Environment and Natural Resources (DENR) and law-enforcement agencies that go after wild life of fenders. "We welcome this recent victory not only for the wildlife species that were rescued, but also for the future generations who will benefit from the recuperation and proliferation of its kind," Cimatu said.

The court ruling came 20 days after the three accused were caught at a

checkpoint in Tagaytay City on June 28. Ten heads of the Philippine pangolin were recovered from the three.

The pangolins, found in a cramped cage in a van compartment, were initially taken to a DENR rescue center, where they were fed and treated for bruises. Jonathan L. Mayuga

# Angat Dam water level improves

The water level at Angat Dam in Bulacan continues to increase due to monsoon rains over the country in the past few days.

Based on the Philippine Atmospheric, Geophysical, and Astronomical Services Administration's (PAGASA) monitoring as of Monday, Angat Dam's water level has increased by almost a meter from 174.13 meters Sunday to 175.10 meters Monday.

Angat Dam's water level is inching closer back to its 180-meter minimum operating level. It has fallen below the 180-meter mark last April, prompting the National Water Resources Board (NWRB) to suspend water allocation for irrigation of farmlands in Bulacan and Pampanga.

Once water level in the dam reaches its 180-meter minimum operating level, the National Water Resources Board (NWRB) may consider increasing the water allocated for Metro Manila's domestic requirements.

The current water allocation of 36 cubic meters per second (cms) is split 60-40 to water concessionaires Maynilad and Manila Water, respectively. It has been decreased from 40 cms to 36 cms after the dam breached the 160-meter critical level in June.

The normal water allocation for the domestic requirements of consumers in Metro Manila and nearby provinces is 48 cms.

Today, the southwest monsoon (habagat) will still be the dominant weather system throughout the country.

PAGASA weather specialist Ariel Rojas said the weather bureau does not expect the formation or entry of a low pressure area or tropical cyclone inside the country's area of responsibility in the next three to five days.

Monsoon rains will prevail over Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Abra, Benguet, Zambales and Bataan.

Meanwhile, Metro Manila and the rest of the country will experience partly cloudy to cloudy skies with isolated rain showers due to localized thunderstorms.

### For Mother Earth

THE decision of the Supreme Court to penalize concessionaires Maynilad and Manila Water as well as the Metropolitan Waterworks and Sewerage System (MWSS) for their violations of Republic Act No. 9275 or the Clean Water Act is a big triumph for Mother Earth.

The violations stemmed from the failure of the parties to put up sewage lines and sewage treatment facilities which are specifically provided for in the Clean Water Act.

The penalties that the Supreme Court imposed – ₱921.5 million each for Maynilad and Manila Water (with the MWSS jointly and severally liable with each water concessionaire) and ₱322,102 daily fine until they fully comply with the subject provisions of the law, clearly illustrate the extent of the victory for Mother Earth. This is so even

if the concerned parties are expected to exercise their right to file a motion for reconsideration.

The finality of the victory of Mother Earth, in this case, is expected particularly because the Supreme Court's decision was from a vote of 12-0 (with two justices abstaining from the voting and not from a vote of 14-0 as earlier reported).

Such victory, however, is not enough. It has been reported that 20 percent of the bills paid by the customers of the two water concessionaires was specifically for sewage services. Since such services were not substantially provided, the concessionaires should be held accountable for the money paid by their customers.

This should not be a simple question of returning the collected money to the customers. The concessionaires

should account their actions in handling the same.

The concessionaires should not be allowed to gain from money that they collected at the guise of doing actions required not only to serve their customers but also protect the environment.

If the concessionaires increased their shareholders' wealth not only by failing to do what the law requires (which was the matter decided on by the courts) but also by generating profit from what is, at the very least, unethical collection of fees, they should be held liable.

Another interesting angle of this issue is the liability of the MWSS. To what extent will it shoulder the joint and several liability of the two concessionaires? Who will eventually "pay for" the liability of the MWSS considering the public nature of the organization?

The victory of and for Mother Earth can only be complete if other than having the concerned parties pay the imposed penalties and fines, those responsible will be made to repair the environmental damages they caused.

# Settlers want to turn forest protectors

# Land claimants, squatters offer to guard and preserve Baguio watershed

BAGUIO CITY-Facing eviction, Ibaloy land claimants and settlers have offered to secure and preserve the 336-hectare Busol watershed, the city's key source of potable water that has been threatened by encroachment for decades.

The offer was made last week during a meeting called by city officials, who were poised to demolish eight new structures built within the Busol forest reserve, which Baguio shares with neighboring La Trinidad town in Benguet province.


The city intends to resolve squatting on 112 ha of the watershed within its territory as it begins a conservation and rehabilitation program for its remaining 2.5 million trees, Mayor Benjamin Magalong told 200 Busol residents who attended the meeting.

Busol was segregated for the conservation and protection of Baguio water and timber resources in April 1922 through a proclamation.

### Water rationing

It remains vital because potable water in the city has been rationed since the late 1980s. The Baguio Water District (BWD) taps Busol for water that is supplied to 30 percent of the city's about 350,000 residents.

But Magalong suspended the demolition after dwellers

agreed to organize, police their ranks and put together plans for protecting the forest.

The city did not give the number of Busol dwellers, although foresters and the BWD in 2007 listed 695. An inventory conducted in 2006 by a Busol task force, composed of local and national forest regulators, said 643 houses were built in the Baguio part of the watershed at the time while 532 houses were constructed in La Trinidad.

Many dwellers were granted approved land surveys and were issued tax declarations, so the government and the environmental group Baguio Regreening Movement (BRM) launched

a public campaign to fence off the watershed.

### Legal conflict

But the fencing project was blocked in 2009 when Busol became the center of a legal conflict between Ibaloy land claimants and the city government.

Ibaloy families asserted their ancestral land rights and claims, prompting the National Commission on Indigenous Peoples (NCIP) to stop all fencing activities.

Families belonging to the Molintas and Gumangan clans said their ancestors' names were identified as claimants.

The city government cited a provision in the Indigenous Peoples' Rights Act of 1997 (Ipra, or Republic Act No. 8371), which exempted Baguio from the law's coverage.

In an Aug. 30, 2012, letter to the NCIP, the city government opposed ancestral land applications filed in Baguio, except those recognized by the government before Ipra was enforced.

In 2018, the Supreme Court ruled against the claimants.

Magalong, during the meeting with settlers, said that while Ibaloy families could continue to pursue their claims, the high court had clearly established that the watershed could not be inhabited.

# DILG CHIEF BACKS BAN ON NEW BUILDINGS, TREE CUTTING IN BAGUIO

Interior Secretary Eduardo Año on Monday backed a proposed yearlong moratorium on the construction of high-rise buildings in Baguio City to afford the summer capital "a breather from overdevelopment."

Año, in a statement, agreed with Baguio City Mayor Benjamin Magalong's proposed construction ban, saying the city "is now heavily congested and it's taking so much toll on the environment."

He said the city's environmental condition was now a priority concern of the interagency task force headed by Environment Secretary Roy Cimatu, noting that a draft executive order (EO) on the building ban and cutting of trees had been submitted to the Office of the President.

Año said the draft included

a funding component to implement priority projects, such as the upgrading and expansion of the city's sewage treatment system.

"The city needs to pause, breathe, and be healed because of overdevelopment. Let us save Baguio City while we still can. The proposed EO will pave the way for a reevaluation of the city's urban development

planning in order to consider the impact to the environment," said the secretary of the Department of the Interior and Local Government (DILG).

Año said he was confident that with Magalong, a retired police general, at the city's helm, Baguio could also address problems on watershed depletion and traffic congestion.—JEANNETTELANDRADE INQ

# EO on 1-year ban on Baguio skyscrapers, tree-cutting pushed

he Department of the Interior and Local Government (DILG) is pushing for the approval of a proposal of the Baguio City government to impose at least a one-year moratorium on the construction of high-rise buildings in the city "to give the country's summer capital a much-needed breather from overdevelopment."

"I strongly agree with Mayor Benjie Magalong on the moratorium in the construction of high-rise buildings in Baguio City. The city is now heavily congested and it's taking so much toll on the environment. 



# WATCH BIRDS OF PREY FLY, HUNT IN DAVAO'S

# PH EAGLE CENTER

DAVAO CITY—Visitors to the Philippine Eagle Center in Malagos here are in for a treat as they can witness the behavior of birds of prey while in flight or hunting.

"Raptors in Flight," the Philippine Eagle Foundation's (PEF) latest initiative to educate the public about raptors, will be a weekly event at the center in Calinan District starting Aug. 17 in time for the Kadayawan Festival activities.

"This is the first and only demonstration in the world to show a Philippine eagle flying on cue," Dennis Salvador, PEF executive director, said in 'a statement.

### **Conservation mission**

"It truly is a sight to see. We hope that through this educational experience, more people would come to appreciate our feathered friends and in turn, be inspired to contribute to the

conservation mission to make a difference," he said.

Nine raptor species, including the giant scops owl, Mindanao lowland owl, Pinsker's hawk-eagle, Philippine serpent eagle, brahminy kite, greyheaded fishing eagle, whitebellied sea eagle and the Philippine eagle "Sinag," saw action during the launching on Saturday, doing the flight demonstration.

Sinag, a juvenile male

Philippine eagle adopted by the Philippine Airlines, will turn 4 years old in December this year.

Lohwana Halaq, a primatologist and Sinag's handler, has been training the eagles for about two years.

### Training

"For our Philippine eagle and all the other birds of prey here, it does take time [to train them]," she said. "That was the main thing—training in terms for falconry. All the techniques come from falconry ... like training birds of prey to hunt, basically. But instead of hunting here, we're training them on the cue of our glove and they get the reward of a piece of meat," Halaq told reporters after the performance.

She said the training was a way of "conditioning the animals' response to cues on time and to be safe while doing it."

"Our birds are safe and we are safe; [we start] off with getting to know the birds," she said.

Ticket prices for "Raptors in Flight" are P300 for adults and P250 for children, inclusive of entrance fee, film viewing and tour of the Philippine Eagle Center. PEF also arranges private viewing of raptors through reservations@philippineeaglefoundation.org or through mobile number 0917-7089084.—JOSELLE R. BADILLA INO

# Sink holes pose danger to Albay town residents

POLANGUI, Albay – Three sink holes, one and at the back of a school, are a threat to students and residents of Bgy. Pinagdapugan in this town.

The sink holes were discovered in the upland part of the village after rains covered Bicol over the week.

According to Socorro Sambitan, head of the Municipal Disaster Risk Reduction Management Council (MDRRMC), the biggest among the three sink holes was discovered at the backyard of the Pinagdapugan Elementary School, with a diameter of about 1.5meters.

The hole had caved-in over three meters deep.

Sambitan said two other sink holes, with over ameter deep, were also discovered at a residential area at the back of the school

She said the holes continue to cave-in every time there is a heavy downpour in the locality.

Soil samples from the softening ground portion were sent to the Department of Environment and Natural Resources-Mines and Geosciences Bureau (DENRMGB).

The MDRRMC requested the MGB to inspect the sites of the sink holes.

Last week, classes at the Pinagdapugan Elementary School were suspended as the sink hole posed danger to elementary school pupils because of heavy rains.

# 3 sinkholes pose danger resident Polangui

POLANGUI, Alabay--Three sinkholes were discovered in the upland village of Barangay Pi-nagdapugan here, after rains from a recent typhoon ravaged Bicol over the week.

According to Socorro Sambitan, head of the Municipal Disaster Risk Reduction Management Council (MDRRMC) Po-Management langui town, the biggest among the three sink holes was found inside the back-yard of the Pinagdapugan Elementary School with a diameter of about 1.5meter, and a hole over 3-

meters-deep.

Sambitan said two other sinkholes over a meter deep were also discovered at a residential area at the back of the Pinagdapugan Elementary School. It was observed that the holes on the ground have continued to cave in every time there is a heavy down pour in the locality.

Soil samples from the ground have been sent to the DENR-Mines and Geosciences Bureau, while the local MDRRMC had requested the MGB to inspect the sites of the sink holes.

Sambitan said, earlier classes were suspended at the Pinagdapugan Elementary School, to protect students during heavy rains.

# Group wants Napindan floodgate open amid water hyacinth spread

MID the proliferation of the water hyacinth in Laguna de Bay, a national federation of small fisherfolk on Monday reiterated its call to permanently open the Napindan Hydraulic Control Structure (NHCS) in Taguig City.

The NHCS is a flood-control system closed by authorities for a very long time. It prevents the free flow of water passing through the Pasig River which connects the Laguna de Bay and Manila Bay.

Constructed in 1983, the NHCS prevents the saltwater coming from Manila Bay via Pasig River to enter the 90-hectare lake to prevent flooding. It also protects the business of raising tilapia and bangus in the country's largest aquaculture hub because some fish species cannot tolerate salty water.

Also, the Laguna de Bay is now a source of raw water for Metro Manila residents.

Both the Maynilad and Manila Water, the two private water concessionaires of the Metropolitan Waterworks and Sewerage System (MWSS), extract water from Laguna de Bay to augment the limited supply coming from Angat Dam.

Water treatment would entail a higher cost through the process called desalination if the water is too salty.

In a statement, the Pambansang Lakas ng Kilusang Mamamalakaya ng Pilipinas (Pamalakaya)-Rizal Provincial Coordinator Ronnel Arambulo, reported that towns of Binangonan and Cardona in Rizal are now "heavily surrounded" by water hyacinth, blocking the waterways of small fisherfolk.

The group also sent photographs as proof of the massive proliferation of water hyacinth in some portions of Laguna de Bay.

Considered an invasive alien species in the Philippines, water hyacinth, more commonly called water lilies, are known to occur naturally in South America.

This green, leafy free-floating aquatic plant species can rise over a meter in height above the water surface. It competes with other aquatic plants and fish species. It also blocks the sunlight from reaching the water, hence, preventing the process of photosynthesis. Water hyacinth also competes with fish for muchneeded oxygen, hence, resulting in massive fish kills. Jonathan L. Mayuga

# Rio Tuba mine adopts DOST waste converter

RIO TUBA Nickel (RTN) became the first company in the local mining industry to use the Department of Science and Technology's bioreactor that converts biodegradable wastes into organic fertilizers and soil conditioners

RTN, a subsidiary of Nickel Asia Corp. (NAC), adopted this innovative soil conditioning technology through DOST's technology

According to DOST project supervisor Dr. Myra L. Tansengco, the principle behind the bioreactor developed by the department's Industrial Technology Development Institute is to promote efficient solid waste management practices in the communities to comply with Republic Act 9003, the Ecological Solid Waste Man-

agement Act.

"RTN is the first mining company to use the fertilizer and soil conditioner from this bioreactor for their rehabilitation programs and for use in the communities," said Tansengco.

Engr. Cynthia Rosero, RTN Resident Mine Manager, said: "RTN

intends to extend the use of these organic fertilizers for the ongoing vegetable production projects in the IP communities in Rio Tuba that aims to cater to the growing demands for organic vegetables

RA 9003 was signed into law in 2001. It is the legal framework for a systematic, comprehensive, and ecological solid waste man-

agement program in the Philippines.

Almost 20 years after RA 9003 became a law, the challenge con-

tinues with enforcing proper waste segregation in the communities.
Engr. David L. Herrera, Senior Science Specialist at the DOST, explains that the challenge is mainly for the barangay-level folks to be able to visualize how solid waste can be useful, for the individual and for the community as a whole, for them to be really serious about waste segregation.



The specially curated show, dubbed "Alon!," shows photographs of surfers from the country's six leading surfing communities—Siargao, La Union, Baler, Mati in Davao, Gubat in Sorsogon, and Sabang Daguitan in Leyte—each holding plastic trash they picked up from the beach in a five-minute period.

The photos intend to show the extensive presence of trash from plastic-packaged commodities in the country, may it be in Luzon, Visayas, or Mindanao.

In addition to these alarming photos on display, the exhibition, which aims to create awareness of plastic waste and eventually initiate change, also features the the eponymous *Alon* documentary, written and directed by award-winning filmmaker Gabby Fernandez. The docu will premiere on August 28, a day before the opening night of the exhibition organized by Benilde's Center for Campus Art.

The short film, also produced by the CCA, will feature interviews with 40 local surfers as they try to answer the question: Why is the Philippines the third worst plastic polluter in the world?

While the trash gathered by the surfers only represent what's within sight, a mini photography exhibit featuring pictures by award-winning photographer Noel Guevara for Greenpeace Philippines will highlight the amount of non-biodegradable waste in the depths of the seas.

The photos were taken during a threeday dive and exploration at the Verde Island Passage, known as the "center of the center" of global marine biodiversity, located in Batangas.

Also on view will be the dead baby whale sculpture by artist Biboy Royong, first seen as part of the famous 78-by-10-foot whale-like statue "Cry of the Dead Whale" recently installed in front of the Cultural Center of the Philippines.

Made from plastic bags, bottles, and various waste products found in the bodies of water, the dead baby whale, now separated from its mother, depicts the horrifying effects of plastic trash to sea creatures.

"Alon!" will also bring back a series of Benilde projects that illustrated both cause and effect of the issue: the 2016 TrashLation project in partnership with the Spanish Embassy Manila and RM de Leon's 2018 class project Mga Plastik Kayo, a series of charcoal and pastel sketches of sea creatures trapped in various plastic packaging.

"Alon,' the surfers' call when the waves come also pertains to the waves of plastic trash that threaten to engulf our oceans. This is not the first time, nor the last that Benilde will be raising this issue. We are here to remind people that this is a continuous battle,"

said CCA director and curator Architect Gerry Torres.

Torres added, "The exhibit hopes to promote the reduction of singleuse plastics, press multinationals to rethink their plastic packaging, ask the government to implement existing laws on waste management such as the RA 9003, or approve new ones specific to plastic like Senator Francis Pangilinan's Senate Bill 40 or the Single-Use Plastics Regulation and Management Act of 2019."

"Alon!" will likewise showcase solutions by social and community leaders who try to start the change. Young student-designers from Benilde also contributed their promising works, in-

cluding the innovative end-product of accumulated plastic trash transformed into plastic tiles by Architecture Program student Prince Koo, as well as a number of stylish and sustainable ensembles made from unconventional and upcycled materials, including plastic, by the College's Fashion Design and Merchandising students Kimble Adrienne

Quinto, Allana Nicolas, and Pamela Marie Casambros.

The exhibition will be on view from August 30 to December 14 at the 12th floor Main Gallery, School of Design and Arts Campus, De La Salle-College of Saint Benilde, Pablo Ocampo Street, Malate, Manila.

# Legarda wants her green airport when she turns 60

Former senator and now Antique Rep. Loren Legarda wants a new green airport in her bailiwick completed by next year when the former broadcaster hits 60.

According to the Transportation Undersecretary for aviation and airports Manuel Antonio Tamayo, Legarda specifically "recommended" the installation of solar panels, a vertical garden, rain catchment system, and non-corrosive materials for the new Antique terminal that is being rushed for completion by June 30, six months ahead of original target.

June 30 incidentally also marks the first year of Legarda as

congresswoman.

According to a Department of Transportation news release, Legarda's son, Leandro Leviste, whose Solar Philippines company has just been granted a controversial franchise to operate renewable energy plants in underserved areas, has committed to provide the solar panels "free of charge."

In return, Legarda pledged to secure an additional P150 million to fund the extension of the airport's runway from 1,430 meters to 1,800 meters in order

to accommodate jet operations. Legarda has asked the contractor, Verzontal Construction, to submit the airport's masterplan, including the architectural

details of the proposed terminal, apparently to see how the green improvements could be worked in.

Opened only last December, the Antique airport is currently being served by PAL Express with three turboprop flights a week from Clark.

"We have requested the contractor to fast track the development of the Antique Airport," Tamayo said. "To do this, we need the augmentation of workers and equipment, and extend the working hours from eight to 12 hours."

The project involves the construction of a passenger terminal to replace the current one, an admin building, powerhouse, parking area, staff house, perimeter and security fence, and new apron and taxiway, with an original budget of P343 million.

## Delta to stop flying to the Philippines

Delta is ending its daily Manila-Tokyo service by end-March, a busy post-war route that it had inherited from Northwest when it acquired the fellow US airline in 2008.

According to a Delta Airlines announcement over the weekend, the Atlanta-based carrier would still serve the Philippines via its joint-venture partner, Korean Air.

This means that from April 1, 2020, US-bound passengers taking Delta will be routed through Seoul, with the Manila-

Seoul leg actually being operated by Korean Air.

Delta's joint venture with Korean Air also allows Philippine-bound customers to make seamless connections in Seoul between Delta flights from the United States.

At its peak in the '90s, the pre-merger Northwest Airlines was flying three times a day to Japan and onward to US destinations from the Philippines.

With Delta's decision to drop Manila, only United remains the lone US carrier still flying to the Philippines, linking the former US colony daily to the US territories of Guam and Saipan.

Incidentally, Delta's withdrawal from the Manila-Tokyo route should also strengthen the dominance of Philippine Airlines and partner All Nippon Airways for that busy corridor.



he did not deprive them of their livelihood.

# EcoWaste warns vs secondhand toys from thrift stores

SECOND hand toys sold for a cheaper price in thrift stores or "ukayukay" may not be exactly safe for children, EcoWaste Coalition warned Monday.

In a statement, the environmental group said some products in ukay-ukay stores or "UK stores" are laden with chemicals dangerous to human health, especially to a child's developing brain and central nervous system.

Some of the toys the group has tested have high bromine content ranging from 723 to 4,190 parts per million (ppm), with some exceeding the 1,000 ppm limit.

"The bromine found on the black plastic component of these toys, which may come from recycled plastic electronic casings, may indicate the presence of brominated flame retardant chemicals or BFRs," EcoWaste Coalition's Chemical Safety Campaigner Thony Dizon said.

BFRs such as polybrominated diphenyl ethers (PBDEs) are known to interfere with the endocrine or hormone system, the group explained.

EcoWaste said hepatotoxicity or chemical-driven liver damage and neurotoxicity or damage to the central or peripheral nervous system are other potential effects of exposure to BFRs.

Furthermore, the

group also discovered there are toys in ukayukay stores being sold without the required labeling information.

"None of the items we bought from UK stores are labeled, which goes against the mandatory labeling requirements for all toys sold in the country as per Republic Act 10620, or the Toy and Game Safety Labeling Act of 2013," Dizon said.

The group is hoping that their findings will

prompt authorities to investigate the sale of toys to protect consumers, especially children, against health hazards.

"We hope that our findings will prompt the authorities to initiate further investigation on the sale of used toys and other children's products in ukay-ukay stores to protect young consumers against potential hazards to their health and safety," Dizon said.

# lic warned vs buying 'ukay-ukay' toys

Environmental group EcoWaste Coalition has warned the public that imported toys and other children's products sold in thrift stores commonly known as "ukay-ukay" (UK) "may be cheap but not necessarily safe for kids, especially if played without adult supervision."

Quezon City based EcoWaste Coalition urged bargain hunters to take safety precautions when buying second hand children's products such as toys, which are sold in UK stores sans the required labeling information.

The group released its latest toy safety reminder following the examination of 105 assorted children's products that it bought from August 6-10 for ₱10 to ₱180 each from UK stores in Manila and Quezon Cities.

"None of the items we bought from UK stores are labeled, which goes against the mandatory labeling requirements for all toys sold in the country as per Republic Act 10620, or the Toy and Game Safety Labeling Act of 2013," said Thony Dizon, Chemical Safety Campaigner, EcoWaste Coalition.

"Further examination of the samples revealed that as many as 78 items contain small parts that may be separated from the toy. A child may put the detached toy component in the mouth and choke, so a cautionary warning is definitely necessary," he added.

Aside from choking hazard, the group found some ukay-ukay products laden with chemicals that are dangerous to human health, especially to a child's developing brain and central nervous system.

With the help of a handheld X-Ray Fluorescence (XRF) analytical device, the group detected lead, a cumulative toxicant that can affect mental and physical development, in 13 items, including toy cars, toy figurines, toy xylophone, a mug with a football design and a drinking glass with an image of Peko-chan.

"For example, the yellow, orange, green and bars of a used toy xylophone had lead content measuring 27, 200; 11,900; 9,673; and 506 parts per million (ppm), respectively, exceeding the maximum 90 ppm limit for lead in paint," Dizon

The group also found 13 toys, mostly toy cars, with high bromine content ranging from 723 to 4,190 ppm. (Chito Chavez)

# 41 Senate committee

# chairmanships distributed

The Senate has completed distribution of 41 committee chairmanships for the 18th Congress with four senators heading three committees each.

Senate President Vicente Sotto III earlier said the chamber adopted resolutions that created the committee on overseas Filipino workers (OFW) and committee on sustainable development goals and innovation.

The senators who head three committees each are Sherwin Gatchalian, Richard Gordon, Cynthia Villar and Imee Marcos.

Gatchalian chairs the commit-

tees on basic education, arts and culture; energy, and science and technology.

Gordon heads the powerful Blue Ribbon committee or the accountability of public officers and investigations; government corporations and public enterprises, and justice and human rights.

Willar remains chairman of the committee on agrarian reform; agriculture and food, and environment and natural resources. She headed the same committees in the 17th Congress.

Marcos, a neophyte senator, heads the committees on cultural communities; economic affairs and electoral reforms, and people's participation.

The Senate website indicated that 11 senators, mostly from the majority, are heading committees.

They are Nancy Binay, Ronald dela Rosa, Christopher Go, Panfilo Lacson, Manny Pacquiao, Aquilino Pimentel III, Grace Poe, Ramon Bong Revilla, Francis Tolentino, Joel Villanueva and Juan Miguel Zubiri.

Binay heads the committees on climate change and tourism, Dela Rosa the committees on peace, unification and reconciliation, and public order and dangerous drugs.

Go chairs the committees on health and demography, and

sports, while Lacson the committees on accounts, and national defense and security.

Pimentel now heads the committees on foreign relations, and trade, commerce and entrepreneurship.

Poe keeps the committees on banks, financial institutions and currencies, and public services, which she also headed in the 17th Congress.

Pacquiao chairs the committees on ethics and privileges, and public works.

Revilla chairs the committees on civil service, government reorganization and professional regulation, and public information and mass media.

Tolentino heads the committees on local government and urban planning, and housing and resettlement.

Villanueva is chairman of the committees on higher, technical and vocational education, and labor, employment and human resources development.

Zubiri, the majority leader, heads the committees on cooperatives and rules.

Six other senators – Sonny Angara, Pia Cayetano, Leila de Lima, Risa Hontiveros, Lito Lapid and Francisco Pangilinan – have one committee each.

Angara chairs the committee on finance; Cayetano the ways and means; De Lima the social justice, welfare and rural development, and Hontiveros the committee on women, children, family relations and gender equality.

Lapid heads the committee on games and amusement, and Pangilinan the committee on constitutional amendments and revision of codes.

Earlier, Senate Minority Leader Franklin Drilon proposed a review of the referral system as well as the jurisdiction of the committees on various legislation and issues to determine which of them are no longer relevant and could be collapsed.

Drilon said there could be some committees that have few bills referred to them, which may indicate that they may no longer be needed.
