## Tieza-funded sewerage plant to boost Puerto Galera rehabilitation and tourism, DENR says

FFICIALS of the Department of Environment and Natural Resources (DENR) on Thursday announced that a second and bigger sewerage treatment plant (STP) that will soon be constructed near the famous White Beach in Puerto Galera.

The STP plan came following a donation of a prime property that will house the facility that will also ensure proper treatment of wastewater from business establishments and households near the famous beach resorts in Puerto Galera town, Province of Oriental Mindoro, before being released to the environment.

The 1.14-hectare property located at Barangay San Isidro was donated to the DENR by the heirs of the late National Artist for Architecture Leandro Locsin.

Around 2,000 square meters of the donated property will be used for the STP while a suboffice of the DENR Provincial Environment and Natural Resources (PENRO) will be built in the remaining 9,444 sq m.

With the donation, the government could start next month the construction of the P194-million project. It is expected to be operational by the last quarter of 2020.

To legalize the donation, Locsin signed the deed of donation last week.

Puerto Galera's second STP has a capacity of 3,000 cubic meters, and will service residents and business establishments in Barangay San Isidro.

DENRMimaropa Regional Executive Director Henry Adornado said the construction of a second STP in Puerto Galera, a famous beach resort and tourist magnet, will boost the government's effort to protect and conserve the coastal and marine environment in the island paradise.

He told the BUSINESSMIRROR that the project is funded by the Tourism Infrastructure and Enterprise Zone Authority (Tieza), and will be implemented by the Department of Public Works and Highways (DPWH). Upon construction, the facility will be ran and managed by the local government of Puerto Galera.

"All water wastes in the locality shall pass through the STP before discharging. It must pass the water quality standard. In that case, the pollution of water bodies there can be avoided," Adornado said.

He added that the facility will not only cater to business establishments but households in the area, as well.

Meanwhile, in a news statement, the DENR chief said having a second STP and a DENR satellite office within Puerto Galera's White Beach area would enhance efforts to preserve it and help avoid another Boracay, or the temporary closure of a tourist destination because of environmental problems.

"Puerto Galera was ahead of Boracay in terms of gaining international attention as a major tourist destination, and I commend its local executives and stakeholders for taking a proactive stance to prevent a Boracay-like scenario in Puerto Galera," Cimatu said.

Cimatu commended in particular the Locsin family and Puerto Galera Mayor Rocky Ilagan, who has exhibited serious commitment to protect and conserve Mindoro's prime ecotourism destination.

Since embarking on a program to preserve the country's top tourist destinations two years ago, Cimatu said it was his first time to witness "such a partnership between a mayor and a landowner coming together for a common environmental cause."

Cimatu even told Ilagan that he would always set him as "an example for other mayors" due to his efforts to install STPs in his town.

Callingit "adream come true," Ilagan said the donated land was "at a very strategic place for an STP" with around 70 percent of Puerto Galera's annual tourist arrivals going to the White Beach area.

Puerto Galera's first STP, a P100-million facility located in Barangay Sabang, became fully operational last December. It has since been treating 1,750 cubic meters of uncontrolled wastewater per day.

### **DENR** to construct second sewage treatment facility in Puerto Galera

PUERTO Galera will have its second and bigger wastewater treatment facility soon.

According to Environment Secre-tary Roy Cimatu, the heirs of the late National Artist for Architecture Leandro Locsin donated a prime property to the Department of Environment and Natural Resources.

Cimatu said the 1.14-hectare located in Bgy. San Isidro, Puerto Galera, Oriental Mindoro will be a major boost in the efforts to preserve the water and marine resources in the famous White Beach.

He said that the construction of the P194-million Sewage Treatment Plant

(STP) will immediately start next month and expected to be operational by the last quarter of 2020.

## **Huawei helps protect** Palawan rainforest

ENVIRONMENTAL advocates and forests rangers in the Philippines have partnered to protect Philippine rainforest.

"Huawei Rainforest Connection Phase 1" was recently launched by Huawei Technologies Philippines Institute (HTPI) as a pilot project in cooperation with the Department of Environment and Natural Resources (DENR) and Smart Communications.

Phase 2 will be in Bukidnon in partnership with Globe Telecom.

"The Huawei Rainforest Connection hopes to help curb the rate of deforestation in the country, which is the largest contributor to green gas emissions, and cause of major calamities like flooding and landslides. This is one of the projects wherein industry telco players and Government join hands to protect our environment." said Daniel Guo Zhi, Huawei Philippines vice president and chief operating officer

The project was formally presented to DENR Secretary Roy Cimatu last January 21 during a meeting with Topher White, Rainforest Connection (RFCx) chief executive officer and founder; Darwin Flores, vice president of Smart Communications; Nilo Tamoria, DENR executive director; Jim Sampulina, DENR undersecretary; and Karrie Buenafe and Sally Zhou from Huawei Public

Through Huawei's collaboration with Rainforest Connection, a US-Based non-profit organization, used Huawei cellphones are upcycled to help protect the rainforest from illegal logging by repurposing them as "Rainforest Guardians."

Technically known as bio-acoustic monitoring devices, sounds from the forests are recorded, uploaded to Huawei Cloud via data connection, analyzed by Huawei AI and alerts are sent to forest rangers in real time.

DENR and the forest rangers in Palawan now use Huawei's mobile phones as their "listening posts" in the forest areas and are quickly alerted when sounds of threats like chainsaws are identified.

By using Huawei Cloud, Internet of Things and AI-assisted servers, Palawan and the Philippines will be better protected from illegal logging.

Since the project was launched, three alerts of illegal logging in the area were verified and foiled by the Forest rangers.

Rainforest Connection is one of the key programs under Huawei Tech4all that applies technology, applications and skills to help conserve nature and mitigate the effects of climate change and protect our planet more efficiently.





## **Remaining SoKor** garbage shipped back this month

At least 100 shipping containers of plastic waste illegally shipped to Northern Mindanao in 2018 will finally be returned to South Korea.

Quoting John Simon of the Bureau of Customs-Northern Mindanao, EcoWaste Coalition said 50 shipping containers would be shipped back on Sunday and the other 50 on Feb. 23.

Simon said 50 shipping containers were re-exported on Jan. 19 and 51 others

on Jan. 13.
"The re-exportation of the remaining wastes from South Korea... signifies our nation's steadfastness to protect public health and the environment from the deceptive trade in hazardous waste disguised as plastic waste for recycling,"

Simon told EcoWaste in a text message.

Cargo ships Vivaldi and Nordmarsh will bring the plastic waste to its point of

EcoWaste national coordinator Aileen Lucero welcomed Simon's announcement, saying it would "help bring the dumping controversy to a close."

"To deter illegal traffic of

waste in the future, all those responsible for this mess should be fully held accountable in accordance with the rule of law," Lucero said.

Verde Soko Philippines Industrial Corp. imported the shipments that were misdeclared as synthetic plastic flakes.

The shipments arrived at the Mindanao International Container Port on July 21 and Oct. 20 in 2018.

## Air pollution, daming pinapatay

## **COVID-19 to further slow** ocessing of China Ol

The coronavirus disease-2019 (COVID-19) outbreak may further slow down the processing of official development assistance (ODA) from China as there will be fewer meetings due to travel restrictions, the National Economic and Development Authority (NEDA) said.

Socioeconomic Planning Secretary and NEDA chief Ernesto Pernia said there is recognition on both sides that more meetings must be held about projects proposed for financing, but current travel limitations in relation to the spread of the virus may prevent these from pushing through.

"We admitted that we need to meet, to have regular meetings, but it would be difficult right now because we cannot go to China," he told reporters in a recent interview.

He also noted that China's dollar shortage may contribute to the lag in the processing of ODA for infrastructure projects in the Philippines.

Last month, Pernia commented on the slowness of the provision of ODA from China compared with Japan, which is currently the country's top ODA provider.

Pernia attributed this to the lack of regular meetings with their Chinese counterparts as well as the languid pace in the screening process for Chinese companies on the Philippine

So far, only two projects under the government's Build Build Build program have obtained funding from China: the Chico River Dam irrigation project and the Kaliwa Dam project.

The Philippines is stepping up negotiations for ODA to fund its ambitious infrastructure program within the grace period allotted for countries graduating to upper middle income status.

The country is currently classified as a lower middle income economy having a gross national income (GNI) per capita of \$3,830 as of 2018. This year, it is expected to become an upper middle income country with a GNI per capita income range of \$3,996 to \$12,375.

A three-year grace period will be in effect before the country becomes ineligible for concessional loans or borrowings with interest rates that fall below market rates.

Alongside this are efforts to attain an "A" credit rating so commercial funding sources can be tapped in the absence of concessional financing.
