House panel OKs 14 new protected areas

The House committee on natural resources has approved measures declaring 14 sites in eight provinces as protected areas that are closed to commercial and

large-scale exploitation.

Panel chair and Dasmariñas City, Cavite Rep. Elpidio Barzaga Jr. said the areas identified in the six bills would be added to a long list of watersheds, hills, mountains, parks, forest lands and natural landscapes declared protected under Republic Act No. 11038 (Expanded National Integrated Areas System Act or ENIPAS)

Barzaga said most of these areas have been subjected to commercial use for decades and are now overexploited.

"We have to protect, regrow and preserve them for the benefit, enjoyment and appreciation of future generations of Filipinos. For instance, watersheds, hills and mountains are among our primary sources of water," he stressed at the hearing earlier this week.

The veteran lawmaker added that the new protected sites cover a combined area

of 332,456 hectares.

The new areas proposed to be added to the ENIPAS list include Mt. Arayat in

Arayat, Pampanga.

Deputy speaker and Pampanga Rep. Aurelio Gonzales Jr. cited the importance of the measures protecting mountains like

Arayat in his province which "is currently facing environmental challenges like il-

legal logging."
"If no action is taken, it is only a matter of time before Arayat degrades into an unrecoverable husk of landmass devoid of life. It could also become a natural hazard to people living within its periphery," he warned.

The 13 other areas to be added to the list are nine watersheds in Mindoro Occidental and Mindoro Oriental; a group of small islands in the town of Carles in Iloilo; the Tugbo watershed in the city of Masbate and town of Mobo in Masbate; the Hinakpan mystical hills in Guihulngan, Negros Oriental; and the Tirad Pass landscape in Gregorio del Pilar town, Quirino and the towns of Sigay, Cervantes and Suyo in Ilocos Sur.

The six bills have common provisions. If declared protected, the areas will be under the supervision of the Department of Environment and Natural Resources (DENR).

A protected area management office headed by a protected area superintendent would be created to see to it that the sites are no longer subjected to destructive human practices.

Funding for the management and protection of these areas would be included in the annual DENR budget.

Senate panel prefers regulating single-use plastics

THE Senate committee on environment, natural resources and climate change is inclined to regulate rather than issue an outright ban on single-use plastics.

"Baka impossible na i-ban kasi wala naman akong naririnig na replacement for single-use plastic (A ban might be impossible because alternatives are not available)," Senator Cynthia A. Villar, who chairs the committee, said in a briefing Tuesday.

"What we want is for them to recycle."

Ms. Villar said the Committee will be drafting a consolidated bill and hold one more hearing before it passes the measure out to the plenary.

The panel tackled measures regulating single-use plastic or prohibiting the use of certain plastic products.

Ms. Villar said at this point the bill will provide for the inclusion of waste management as part of the criteria being considered for recognizing local government units with the Seal of Good Local Governance. The measure will also contain a chapter that will focus on hospital waste, which she noted should be handled differently than other waste products.

The provisions include incentives to plastic producers that exert effort to collecting waste plastic in the environment and establish information and education campaigns.

"It's just fair that if there are entities who are doing their fair share in trying to recover their plastic from the environment, there must be some proper incentives," Kristoffer Rada of the European Chamber of Commerce of the Philippines (ECCP) said at the hearing. He chairs ECCP's environment and water committee.

The ECCP also supported a provision to hold an information drive to educate the public on recycling.

"We realized even if all member companies try to make their packaging recyclable, if as individuals, we do not do our share, then all of this will go to waste."

CEBU, MANDAUE TO START RIVER CLEANUP TO STOP POLIO

CEBU CITY—At least 800 families in the cities of Cebu and Mandaue would be relocated as part of government efforts to clean up the Butuanon River after its water tested positive for the poliovirus.

In separate statements, Mandaue City Mayor Jonas Cortes and Cebu City Mayor Edgardo Labella said their respective local governments would clear identified "danger zones" along the river as a preventive measure against the disease, which resurfaced last year after the Philippines was declared polio-free in 2000.

Mandaue and Cebu officials said they were preparing relocation protocols and identifying possible resettlement sites. They were also planning to intensify vaccination campaigns, especially in villages close to the river, and help health officers from the Department of Health (DOH) in documenting residents suspected to have contracted the virus.

"Sanitation is very important. Second, we continue with the profiling [of residents living along the Butuanon River], and third, we give vaccination. It's going to be a citywide vaccination but we will first focus on the area within the 5-kilometer radius of the river," Labella said.

The 23-km Butuanon River cuts across Cebu and Mandaue cities.

According to the World Health Organization, the poliovirus can be transmitted person-to-person through the fecal-oral route either directly or with a contaminated vehicle, such as food or water.

Patients often show symptoms, such as fever, fatigue, headache, vomiting, stiffness of the neck and pain in the limbs as the virus attacks the nervous system. Worse cases lead to paralysis.

Children below 5 years old are at risk of contracting polio, health officials said. Complete vaccination is the best preventive measure against the disease.

Dr. Jaime Bernadas, the DOH regional director in Central Visayas, said improper waste disposal might have caused the reemergence of the virus.

In 2018, the City Environment and Natural Resources Office of Mandaue recorded 62 establishments dumping untreated waste in the Butuanon River. Households lacking toilets also dispose of their waste into the same waterway. INQ

'Test rivers in Cebu City for poliovirus'

Cebu City Mayor Edgardo Labella has ordered the Cebu City Health Department (CHD) to conduct water testing in its rivers after Butuanon River in Mandaue City tested

positive for poliovirus.

"It's good that the Department of Health through its" regional office will help us," Labella said.

He gave assurance that a relocation plan is in place for those living near Butuanon River.

The river traverses Barangays Pitos, Talamban, Bacayan and San Jose in Cebu City.

Labella said the CHD conducted profiling of residents within the five-kilometer radius of Butuanon River after the Research Institute for Tropical Medicine confirmed that environmental samples from the river tested positive for poliovirus.

He said health workers conducted a survey to determine if there are residents with health concerns and if children completed their vaccination against polio.

"We will continue with our efforts with the city of Mandaue to clear and clean our waterways... At this point, we will not conduct a massive cleanup of the river... It is off-limits because of the report on the presence of poliovirus," Labella said. - Mary Ruth Malinao/The

ICTSI promotes cooperation in biodiversity

lin (Manis culionensis), Philippine cockatoo (Cacatua haematuropygia) and the vulnerable Palawan porcupine, (Hystrix pumila), along with 12 other ground-dwelling birds and mammals.

In the first year of their partnership, Katala and the ICTSI Foundation would be seeking Prior Informed consent documents from indigenous people-stakeholders, along with installing a camera trap data base within the targeted areas, conducting of awareness campaigns on threatened wildlife and starting activities to develop wildlife warden and patrolling schemes, among others.

Once completed, the project aims to facilitate formal protection of priority areas and help guide policy development for threatened wildlife in Palawan and the rest of the Philippines.

Joel G. Jimenez, President of the Katala Foundation said, "KFI is fortunate to partner with a Philippine-based private enterprise [that] shares the same vision. This initiative is exciting for us as we expand our ongoing work in the area and with the lowland communities, especially indigenous peoples. We implement projects that ensure opportunities for their socioeconomic improvement."

A long-term goal of the project is to come up with approaches and strategies to sustainably manage and conserve the forests of the Victoria-Anepa'an Mountain Range for the benefit of local communities and biodiversity.

The VAMR forms the central

cordillera of the main island of Palawan, covering roughly 165,000 hectares and has a highly significant level of biodiversity with 41 percent endemism in terms of flora and fauna. About 31 percent of the species are of high global conservation significance.

Considered by many as "open access" for resource exploitation, the mountain range has seen high levels of illegal logging and wildlife poaching, particularly on the accessible southern fringes of the area facing the Sulu Sea due to easy access. The third most important population of the Philippine Cockatoo in the wild, a critically endangered endemic species, is holding on in the area for its survival.

Also very vulnerable to habitat loss, poaching and exploitation, the Palawan endemics Philippine Pangolin and Palawan Porcupine need to be assessed and monitored in order to effect protection and conservation measures.

Maynilad allots P10B for Muntinlupa plant

AYNILAD Water Services Inc. has earmarked P10 billion for the development of its third treatment plant in Muntinlupa City that will tap Laguna Lake as a source of raw water, as it scrambles to meet the increasing water demand of its customers.

In a statement on Tuesday, Maynilad said the planned treatment facility, to be constructed in Brgy. Poblacion, will be producing 150 million liters per day (MLD) of potable water.

"We are doing everything we can to meet our service obligations to our customers. So although we have to recast our five-year investment program, we still have to pursue projects essential for meeting the water supply requirements of a growing population," Maynilad President and Chief Executive Officer Ramoncito Fernandez said. "It is a huge risk to rely on just Angat Dam as major source of raw water for Metro Manila, so we are working closely with the Metropolitan Waterworks and Sewerage System so that the development of another source can be facilitated," he added.

Angat Dam is the primary source of water in Metro Manila and adjacent areas.

Maynilad aims to complete the plant by the last quarter of 2022, benefiting about 150,000

households. Once completed, this would bring the company's total yield from Laguna Lake to 450 MLD.

The Poblacion treatment plant will be equipped with several treatment technologies that effectively convert water from the lake into potable water, including dissolved air flotation, biological activated filtration, ultrafiltration, reverse osmosis, and chlorination.

The West Zone concessionaire began tapping Laguna Lake in 2010 as an alternative raw water source to reduce dependence on Angat Dam.

Currently, Maynilad has two treatment facilities in Muntinlupa treating water from the lake that have a combined output of 300 MLD.

Once the Poblacion facility is completed, Maynilad will have a total of five water treatment plants with a combined capacity of about 2,850 MLD for its over 9.7 million customers in its coverage area.



HE Permanent International Association of Navigational Congresses (Pianc) said climate change poses a serious threat that could affect waterborne transport infrastructure.

Pianc said climate change represents a significant risk to business, operations, safety and infrastructure that could create impact on local, national and global economies. The waterborne transport infrastructure would be adversely affected, and so, there is urgent need for port and waterway operators to

take urgent action to strengthen resilience.

"Ports and waterways around the world were experiencing air and water temperature increases, rising sea levels and changes in parameters such as seasonal precipitation, wind and wave conditions. Many were also seeing more frequent and severe extreme events including storms, heat waves and droughts," Pianc said.

Hailed as the world association for waterborne transport Infrastructure, Pianc released its report on "Climate Change Adaptation Planning for Ports and Inland Waterways." The Pianc report was produced by an international working group convened by the Environmental Commission (EnviCom)

It said there is a four-stage merhodological framework that would help port and waterway owners and operators to plan for improved resilience.

They must facilitate the under-

standing of how assets, operations and systems could be impacted and who should be involved in identifying climate change adaptation requirements. They should identify the type of climate-related information needed to prepare an adaptation strategy, and explain how — in reference to climate change "scenarios," they can assist in understanding the range of possible future changes.

They should also describe how the vulnerability of waterborne transport infrastructure assets, operations and systems can be assessed and a risk analysis must be undertaken. Lastly, they should present a "portfolio" of potential measures such as structural, operational and institutional in developing an adaptation pathway.

Meanwhile, the Philippine Potts Authority (PPA) is now holding preparatory meetings with its Foreign Organizing Committee (FOC) in preparation for the hosting of the 10th Permanent International Association of Navigational Congresses - Conference on Coastal and Port Engineering in Developing Countries (Pianc-Copedec) in November.

The Pianc-Copedec Paper Selection Committee is now delib-

erating as to which among the 210 submitted port development proposals from the 37 member countries would be presented to the conference with the theme "Enhancing Waterborne Transport and Sustainable Coasta! Development."

Selected proposals would be classed according to port engineering, port planning and management, coastal engineering, coastal zone and coastal risk management, short sea shipping, coastal and inland navigation, port and coastal environmental issues and climate change, and dredging and disposal management issues.

Davao de Oro orders remaining small-scale miners in Mt. Diwalwal to relocate

THE DAVAO de Oro Provincial Task Force Naboc River aims to complete the relocation of small-scale gold processing operators in Mt. Diwalwal, also known as Mt. Diwata, this month to pave the way for the full implementation

of the river's rehabilitation plan. The Department of Environment and Natural Resources (DENR) issued a cease and desist order (CDO) on the mineral processing plants in Mt. Diwalwal in Monkayo effective March 15 last year. "The Provincial Naboc River Rehabilitation Masterplan serves as our framework in reviving the river. We need to execute first the CDO as we cannot implement the plan if there is still mercury and cyanide that will flow in the river," Provincial Environment and Natural Resources Officer Chamberlain J. Babiera said in a statement last week.

TOXIC

The processing plants, which use carbon-in-pulp and ball/rod mills, discharge toxic wastes directly into the river. "It is not only the miners and residents of Mt. Diwata that are at risk, but also farmers downstream who source water for irrigation of the rice fields... in Compostela," said Monkayo Mayor Ramil L. Gentugaya. The government has a designated processing zone in Mabatas, which has a tailings containment facility. It was built in 2003 when then President Gloria Macapagal-Arroyo issued an executive order for the transfer of the processing plants. Data from the Mines and Geosciences Bureau (MGB) show there were about 300 ball mills in the area. Davao de Oro Governor Jayvee Tyron L. Uy, in his State of the Province Address last month, reiterated his commitment to the Naboc River rehabilitation, which DENR Secretary Roy A. Cimatu declared as one of his priority programs last year. Davao de Oro has one of the biggest gold deposits in the world at 36,328,699 metric tons based on a 1998 report by the Mines and Geosciences Bureau. - Mindanao Bureau


