DENR chief bares protection efforts on PH bodies of water

ENVIRONMENT Secretary Roy Cimatu has assured that the country's bodies of water are protected pursuant to the provisions of the law or the Philippine Clean Water Act of 2004.

One of the important provisions of the law is the designation of Water Quality Management Areas (WQMAs) using appropriate physiographic units such as watersheds and river basins to effectively unforce the law and improve the curling of units. enforce the law and improve the quality of water

"If we can rehabilitate Boracay and Manila Bay, we can give the same protection to all water bodies in the country by strictly adhering to our annual target and even going beyond it," Cimatu explained.

As of October this year, Cimatu said the DENR was able to monitor 45 priority water bodies and 30 priority.

able to monitor 45 priority water bodies and 39 priority recreational water bodies, both representing 100 percent

of the annual targets.

This year, the DENR formulated, updated and monitored 36 action plans related to the operation of WQMAs.

"We hope that through these action plans, we will be able to come up with new WQMAs in the future for the greater protection and regulation on the development of river systems nationwide," Cimatu said.

In line with the implementation of RA 8749 or the Philippine Clean Air Act of 1999, Cimatu said a total of 101 air quality monitoring stations (AQMS) are already operational nationwide.

These stations measure pollutants such as total suspended particulates, sulfur dioxide, nitrogen dioxide and carbon monoxide.

Cimatu said the DENR also monitored the emissions of 14,538 firms out of the annual target of 15,989. The agency also achieved its 2019 target of updating and implementing 22 Airshed Action Plans nationwide, he

Boracay's stakeholders hope to boost '20 bookings

TAKEHOLDERS in Boracay Island will be preparing a marketing plan, with the help of the Department of Tourism (DOT), to help promote the island to key markets abroad.

Their pitch could get some boost from this latest development: Condé Nast Traveler has just included Boracay in its list of "30 Best Winter Vacations to Take This Season." The prestigious travel publication noted: "[This] ittybitty speck [just under 4 square miles] in the Western Philippines

is as close to a tropical idyll as you'll find in Southeast Asia, with gentle coastlines and Instagram-worthy sunsets. Fold in a thriving nightlife scene, and you have one of the top tourist spots in the region."

This developed as hotels and resorts on the island have reported lower guest bookings even toward New Year's Eve, which is considered a "super peak" season, said Tourism Congress of the Philippines (TCP) Jose C. Clemente III. "The resorts were saying that they have lower arrivals for Christmas and even for New Year, for December 31, they are down from previous years," he told the BUSINESSMIRROR, after meeting with stakeholders from the island on December 10.

The resorts failed to submit, however, data and figures to back up their claim of decreased bookings.

Clemente said many factors are behind the lower arrivals on Boracay toward the Christmas-New Year period. Among these are "less flights [to Kalibo and Caticlan], airfares have gone up...like there were cancellations of charters earlier this year, so the Chinese tourists were put off by this." (See, "C.A.B. changes mind, allows charter flights anew to Boracay gateways," in the BUSINESS-MIRROR, July 17, 2019.)

Data from the DOT-Region 6 (Western Visayas) showed total tourist arrivals reached 1.6 million, of which 729,415 were foreigners, in the nine months to September 2019. Total arrivals were 4.6 percent higher than the 1.53 million in the same period in 2017, of which 730,511 were foreigners.

Total tourism receipts (from foreign and domestic travelers) reached some P46 billion from January to September 2019, up 8.223 percent over the P42.5-billion receipts in the same period in 2017. No data was made available for just inbound receipts.

Meanwhile, on Clemente's prodding,

the stakeholders agreed in a meeting on December 16, this time with DOT officials, togoona "destination-specific road show," to push just Boracay Island, starting next year. If the DOT

agrees to support such a road show, "The stakeholders said they were willing to kick in some funding to match whatever DOT is contributing."

He said the stakeholders hope to finish gathering the inputs and suggestions, which TCP will consolidate for submission to Tourism Secretary Bernadette Romulo Puyat. "We hope we can submit this [proposed marketing plan] by January," he asserted.

Clemente also said the stakeholders are now considering expanding the markets to be tapped instead of focusing on the Chinese market, which has driven the arrival numbers on the island.

"They can tap Japan again; the Philippines just received the Excellent Partner Award from the Japanese. We can leverage on that," he noted. The award was given to the DOT during the Japan Tourism Expo in October, in recognition of the agency's role in rehabilitating Boracay Island.

Clemente, who is also president of Rajah Tours Philippines, said Europe is still a viable market. "Europeans were the first to discover Boracay in the 1980s, but look where they are now? The Germans are ranked 10th among Boracay's source markets."

He added, "We never took Boracay off our offerings"—tour operators always sell the island when they join travel fairs abroad. But he noted the resorts have not adjusted their prices, and except for a handful, no longer join the travel fairs.

For one, Boracay resorts still impose surcharges during the so-called peak and super peak seasons. "They were saying they received cancellations also from the Chinese market for the Chinese New Year. So why are they still imposing a surcharge?" he asked.

"Hopefully they've seen what happens when they put all their eggs in one basket," Clemente pointed out, referring to Boracay's reliance on the Chinese market. Published reports noted that mainland Chinese tourists are traveling less to Southeast Asian countries, with China Travel News saying trips to Thailand fell by 4.31 percent, and to Vietnam by 0.82 percent in the first five months of 2019. It was a complete reversal from the strong growths of 27.38 percent and 37 percent in the same period last year, respectively.

In the Philippines, arrivals from China remain strong, having jumped 41.5 percent to 1.5 million from January to October 2019, accelerating from the 30.7-percent increase to 1.06 million in the same period in 2018.

Du30 wants to revisit 1997 water agreement

PRESIDENT Rodrigo Duterte would not step out from the presidency without resolving the onerous provisions in the 1997 water concession agreement, Malacañang said Thursday.

Presidential Spokesman Salvador Panelo said the President, during their discussion Wednesday night, renewed his desire to talk with those who were involved in the crafting of the deal.

"Last night, he repeated that he still wants to talk with lawyers of the government, private lawyers. 'I still want to hear why they allowed this kind of treason," Panelo told reporters.

The President would make an announcement on Jan. 6 next year on the matter, according to Panelo.

Sought for details, Panelo said he would not want to preempt the President.

"You can be assured that the stand of the President remains unchanged; I will not preempt the President," he said.

President Duterte has repeatedly lambasted the two water firms over "onerous provisions" in the 1997 water concession agreement which he said were unfair to the government and Filipino consumers.

The contract carries a provision that says the government should pay the water concessionaires for their losses that result from the actions of the state regulator during the effectivity of contract.

The government also cannot interfere with water rates, as stated in the agreement.

These provisions allowed the two companies to take the Philippine government to a Singapore-based arbitral tribunal which ruled that the state had to pay Maynilad P3.4 billion and Manila Water P7.4 billion for their respective losses.

On Dec. 10, the two firms sent a letter to Duterte, stating that they agreed to revisit and amend the provisions which earned the ire of the Chief Executive.

The letters were signed by business tycoons Manuel Pangilinan and Fernando Zobel de Ayala.

Firm seeks gov't nod for 2 reclamation projects

400 hectares off Manila Bay, 335 ha for Sangley airport project

Integrated property and infrastructure developer DM Wenceslao & Associates Inc. (DMW) has proposed two massive reclamation projects, including a 400-hectare reclamation off Manila Bay fronting its flagship estate Aseana City and the neighboring Philippine

Amusement & Gaming Corp. (Pagcor) Entertainment City.

The other proposal is for the reclamation of 335 ha of offshore island in Sangley in preparation for the development of the Sangley International Airport.

This 400-ha reclamation project is in line with our thrust to contribute to nation-building. Today, DMW's completed reclamation project in Parañaque City houses nu-

The proposed project in Sangley, Cavite, is undergoing review by the Office of the President, the departments of Transportation and of Finance, the disclosure said.

Stop whale shark feeding in Bohol, gov't urged

Environmental groups say tourist activity in Lila town disrupts sea creatures' hunting behavior, puts them in harm's way


LILA, BOHOL—Environmental groups appealed to the Department of Tourism, the Bureau of Fisheries and Aquatic Resources, and the provincial and local governments in Bohol province to prohibit whale shark feeding in Lila town, and instead promote sustainable tourism practices in the area.

Save Sharks Network Philippines (SSNP) said photos and videos of whale shark feeding circulated online last month. The activity was reportedly part of a joint project of a private investor and the local government.

In a separate online signature campaign launched by Bohol Eco Alliance, it identified the new tourism attraction as the "Taug Whale Shark Watching and Snorkeling" in Barangay Taug, which reportedly started soft operations in November.

The campaign, which called on the Bohol government to issue an executive order prohibiting ecological trapping of marine wildlife by the act of feeding and luring, gathered nearly 3,500 signatures as of Thursday.

Free the Whale Sharks Coalition-Bohol (FWSCB) said the practice would not only dimin-

ish the whale sharks' ability to hunt, but would also put the "gentle giants," known here as "balilan, " at risk of getting hurt.

SSNP said conditioning whale sharks to approach boats might make them susceptible to injuries and poaching.

No feeding

But Philip Quiño, one of the tour operators, denied that the activity involved feeding.

"What is going on here is just whale shark watching and snorkeling. The whales are free to go and to hunt for food," he said.

The presence of six to 13 whale sharks in the waters off Lila has enticed tourists to vis-

it the coastal village of Taug to interact with the sea creatures.

Foreign tourists pay P1,000 per person while locals shell out P500. Local paddlers accompany at least 10 tourists on a boat and they swim around a designated interaction area, which is about 30 meters from the shoreline. The activity is open from 6 a.m. to 11 a.m.

At least 130 tourists have "encountered" the whales in Lila since the activity started two weeks ago, reports said.

But lawyer Alma Aparece, convener of FWSCB, however, said their reports indicated that tourists were still feeding the whale sharks.

"There are many things and contentions that they would really like us to believe. But we would still would like to appeal to authorities to stop the feeding at all costs," Aparece said.

Exploitation

In its open letter to government agencies, FWSCB said the practice of feeding whale sharks should not be encouraged and replicated.

"In a country where rules and regulations are difficult to implement, we do not want Bohol to be another example of what not to do and what not to be," the group said.

Marine conservationists warned against the tourism attraction, citing a similar controversy in Oslob town, Cebu province. Experts said that as the whale shark tourism industry grew, researchers observed changes in the sharks' behavior and physiology, as well as the practice's adverse impact on the local environment.

"Feeding of whale sharks for economic purposes is a clear form of exploitation and harms ecological balance in Bohol or anywhere it is practiced," SSNP said in its statement.

The largest of all fish species, whale sharks (*Rhincodon typus*) are classified as endangered by the International Union for Conservation of Nature. INO

Metal production nears P100 B in 9 months

The value of metallic minerals produced in the country increased by seven percent to almost P100 billion as the Philippines continues to benefit from the ore export ban in Indonesia.

Latest data from the Mines and Geosciences Bureau (MGB) showed that aggregate value of metal production rose 6.5 percent to P99.58 billion.

According to the MGB, the nickel ore export ban in Indonesia is expected to boost prices which will be a welcome development for the country's nickel producers.

"This will naturally increase the

demand for our nickel ore. Due to China's limited nickel resource, most of their nickel ore requirement comes from the Philippines and Indonesia," the MGB said.

Indonesia earlier announced an export ban of nickel ore with nickel content below 1.7 percent. Indonesia is currently the world's largest nickel-producing country with 560,000 metric tons followed by the Philippines with 340,000 MT.

Direct shipping nickel ore and mixed nickel-cobalt sulfides took the spotlight, accounting for P47.36 billion or an increase of 12 percent year-on-year despite the price of nickel declining to \$6.05 per pound from \$6.13 per pound.

Gold production accounted for 37 percent of the total production value with aggregate earnings rising seven percent to P36.9 billion as output increased to 16,328 kilograms.

Gold metal price accelerated to \$1,362.99 per troy ounce from \$1,283.27 per troy.

Revenues from copper production, which comprises 14 percent of total metal production value, fell eight percent to P14.4 billion despite a 10 percent hike in output to 234,982 dry MT.

The decline was attributed to lower price of copper.

The production value of silver,

meanwhile, increased by eight percent to P644 million amid higher production at three percent to 24,849 kilos.

The remaining one percent of total metallic production or P900 million came from the combined value of other metals such as iron ore and chromite.

The Philippine Gold Processing and Refining Corp. was the country's major gold producer during the ninemonth period.

For nickel direct shipping ore, Taganito Mining Corp. in Surigao del Norte reported the highest output with 65,694 MT.

MGB said mine output was generally sluggish during the period as

most nickel mines reported production shortfall, while some mining operations are still under care and maintenance program and suspended status.

Meanwhile, Toledo Copper operations in Cebu dominated the copper production with a 65 percent share of the total output.

To date, the country hosts 50 operating metallic mines consisting of 31 nickel, 10 gold with silver as co-product, three copper with gold and silver as co-products, three chromite, three iron, and two nickel plant and two gold plants.

These are in addition to the numerous small-scale gold mining operations across the country.

Govt expedites small-scale mining regulation

The government is intensifying the regulation of small-scale mining operations in the country, particularly in monitoring undisposed residual stockpiles outside mining sites as it continues to revamp the extractive industry.

The Department of Environment and Natural Resources, through attached agency Mines and Geosciences Bureau (MGB), recently issued an administrative order that will speed up the environmental restoration both during and after mining operations by a Minahang Bayan.

A Minahang Bayan is a government-regulated cooperative of small-scale miners organized in a certain area or region.

Under the new DĂO, smallscale mining operations will now have to meet stricter conditions in the disposal of residual stockpiles, or ores previously extracted but not yet disposed during the mining contract.

The disposal will be implemented under a required environmental management plan which miners must submit to report their environmental management objectives and their commitment to protect and rehabilitate the disturbed environment during disposition of residual stockpiles.

The latest move of MGB follows a multi-step campaign to increase the regulation of small-scale mining, in addition to stricter policing of the entire industry.

"We understand the negative view of mining, but we want the public to know that mining is not the same as it was before the Mining Act of 1995," MGB director Wilfredo Moncano said.

"The MGB is working to improve the regulations on mining, to safeguard environmental protection, and protect the community," he said.

Among the steps taken to increase the regulation of small-scale mining were the provision of incentives in legalizing small-scale mining operations and the fast tracking of application processes for various licenses.

The excise and income taxes for small-scale mining operations were also waived to encourage illegal operators to become legal and adhere to environment and safety standards.

The MGB also facilitated a Global Environment Facilityfunded project valued over \$11.7 million to eradicate the usage of mercury in small-scale gold mining operations early this year.

"The approach really has to be inclusive. Outright prohibition and taxation only pushes small-scale miners into the black market," Moncano said.

He said this was part of a long initiative to improve the mining industry overall under the present administration.

Alongside all these steps, the MGB recently kicked off an information and education campaign to promote responsible mining.

Dubbed #MineResponsibility, the campaign aims to educate the public on the regulation of mining to promote responsible mining practices, and to show that the government is committed to the priority of upholding the safety of people and the environment in the mining industry.

Nickel demand boosts mineral output

The country's metallic mineral production registered sustained growth during the first three quarters of 2019, according to the Mines and Geosciences Bureau (MGB).

The agency has attributed this to increased international demand for nickel ore and a decreased source of the commodity as the result of an export ban imposed by Indonesia.

Presently, Indonesia remains the world's largest nickel-producing country recording an output of 560,000 tons in 2018, This was followed by the Philippines, which posted production of 340,000 tons during the same year

Gold retained the second spot with 37 percent or P36.90 billion, while copper took the third position with 14 percent or P14.40 billion. MGB also said the country's metallic production value posted a 6.5 percent or P6.09 billion growth from P93.48 billion during the first three-quarters last year. It also attributed the growth to the country's continuous nickel ore export to China, which has limited nickel resources.

"Despite the 1.24 percent slip in the average nickel price, nickel direct shipping ore with the aid of its other products (mixed nickel-cobalt sulfide and scandium oxalate) again took the spotlight, accounting for 48 percent or P47.36 billion of the total value during the period," the report said.

Gold retained the second spot with 37 percent or P36.90 billion, while copper took the third position with 14 percent or P14.40 billion.

MGB said the remaining 1 percent was cornered by silver and chromite with P900 million.

Metal prices of nickel, copper and silver all went down. Prices of copper declined from \$3.00 per pound to \$2.72 per pound year-on-year. Nickel, likewise, slipped from \$6.13 per pound to \$6.05 per pound year-on-year.

"It is important to note, however, that the price of nickel has been going up from July to September 2019. In September alone, the price was at \$8.01 per pound," MGB said.

In contrast, prices of yellow metal rose by as much as \$79.72 from \$1,283.27 per troy ounce in 2018 to \$1,362.99 per troy ounce in 2019.

Metal mines output up 6.5% by value

THE value of production generated by metal mines rose 6.5% year-on-year in the first nine months to P99.58 billion, the Mines and Geosciences Bureau (MGR) said

The MGB said in a statement that nickel accounted for 48% or P47.36 billion of the total for the period, due to larger volumes shipped which offset a decline in nickel prices.

Gold accounted for 37% or P36.9 billion; copper 14% or P14.4 billion; and silver and chromite 1% or P900 million.

Prices of nickel, copper, and silver fell during the period. Gold prices rose by an average of 6% year-on-year to \$1,362.99.

"The nine-month average of copper and nickel declined 9.45% and 1.31%, respectively. Copper price dropped from \$3 per pound to \$2.72 per pound, year-on-year," the MGB said. However, it noted that nickel prices have been rising in the third quarter.

"The nickel ore export ban in Indonesia is expected to boost prices, which will be a welcome devélopment for the country's nickel producers. This will naturally increase the demand for our nickel ore," MGB said.

In 2018, Indonesia was the world's top nickel producer at 560,000 tons, followed by the Philippine with 340,000 tons. Both countries' top market is China. Top gold producers were
Masbate Gold Project of the
Philippine Gold Processing and
Refining Corp., controlled by the
Filiminera Mining Corp., which
accounted for 32% or 5,182 kilograms (kg) worth P11.78 billion.
This was followed by the Didipio
Copper-Gold Project of OceanaGold Philippines, Inc. and the
Mindanao Mineral Processing and
Refining Corp. of Philsaga Mining
Corp. with 2,637 kg and 2,596 kg,
respectively.

For silver production, the Apex Maco Operation of Apex Mining Company, Inc. had a 34% share or 8,518kg worth P227.29 million. OceanaGold's Didipio produced 4,093kg worth P107.2 billion.

Carmen Copper Corp.'s Toledo Copper Operation topped copper production with a 65% share or 36,986 metric tons (MT) worth P8.34 billion. OceanaGold's Didipio followed with 10,186 MT, Philex Mining Corp.'s Padcal Copper-Gold operation produced 8,555 MT, and Lepanto Consolidated Mining Co. produced 951 MT.

Taganito Mining Corp. was the top nickel producer with 65,659 MT worth P5.87 billion, followed by Rio Tuba Nickel Mining Corp. with 35,684 MT worth P2.81 billion. Both are units of Nickel Asia Corp. — Vincent Mariel P. Galang

HOW do you reward industrial excellence?

By granting perks and other preferential treatment to players who embrace best practices and adhere to, exceed even global standards of performance, including corporate citizenship.

The idea is to shame other laggards or efeb rogues who give industry a bad name.

Consider the star performers in the mining industry whose corporate initiatives go unnoticed at home but are internation-

ally recognized and celebrated.

For instance, three members of the Chamber of Mines of the Philippines were adjudged winners at the recently concluded 2nd ASEAN Mineral Awards held in Bangkok, a biennial event that recognizes mineral resource companies for achieving best practices in environmentally and socially sustainable operations.

Coral Bay Nickel Corp., which operates a nickel processing plant in Rio Tuba, Bataraza, Palawan, emerged with the Best Practices award for the Philippines in the Metallic Mineral Processing category.

Rio Tuba Nickel Mining Corp, also in Bataraza, was named runner-up in the Metallic Mineral Mining category, while Agata Mining Ventures was also named runner-up in the Metallic Mineral Distribution category.

In the non-metallic category, LaFarge Holcim bagged runnerup awards in both the mining and processing categories.

The AMA is an initiative of the Asean mining ministers to recognize best practices in sustainable mineral mining, processing, and distribution among its various member countries.

The Awards, launched in 2017 in Myanmar, saw the Philippines garnering two of the three awards handed out, with Rio Tuba Nickel recognized for best mining practices and Oceana Gold Philippines, Inc. for the best plant.

Since then, the AMA has been expanded to six categories with non-metallic minerals separate from metallic minerals.

"We are extremely pleased that again, Philippine minerals resource companies were recognized for best practices in the various categories," CoMP chairman Gerard Brimo said.

"We hope this recognition will demonstrate that we have world-class mineral operations in our country even as we in COMP strive to raise the bar by subscribing to new global mining standards of excellence, such as the Towards Sustainable Mining initiative. We thank Environment and Natural Resources Secretary Roy Cimatu and Mines and Geosciences director Wilfredo Moncano for encouraging us to aspire to higher standards and better ways of doing things, which has undoubtedly raised the performance of the mineral resource development sector in our country," Brimo added.

The prestigious award held December 11-13 in Thailand is given to a mining company of an ASEAN member country, recognizing its best practices and being an exemplary model of environmentally and socially-sustainable mining.
