DENR bullish on meeting biodiversity goals

THE Department of Environment and Natural Resources (DENR) said it is optimistic in hitting all its 2019 targets of protecting the country's rich biological diversity, despite being preoccupied with the rehabilitation works in Manila Bay and Boracav.

In a statement on Thursday, Environment Secretary Roy Cimatu said that the DENR's Biodiversity Management Bureau (BMB) is expected to surpass its 2019 targets in the areas of cave assessment and issuance of wildlife permits as early as last October.

"This is palpable evidence that the DENR is not only focused in the rehabilitation of Manila Bay and Boracay, but also in the conservation of the country's flora and fauna," Cimatu said.

He said the DENR never missed out in fully enforcing Republic Act 9147 or the "Wildlife Resources Conservation and Protection Act of 2001," which aims to conserve and protect wildlife species and their habitats to promote ecological balance and enhance biological diversity, and regulate the collection and trade of wildlife species.

As of October this year, the BMB has assessed 52 caves or equivalent to 137 percent of the annual target of 38.

The BMB, through the Philippine Operations Group on Ivory and Illegal Wildlife or Task Force POGI, also confiscated a total of 72 heads of different wildlife species, and 15.6 kilograms of agarwood (Aquilaria spp.) in different operations in the country.

Task Force POGI is a composite team of wildlife enforcers from various agencies including the BMB, the National Bureau of Investigation, and the Philippine National Police.

The bureau has issued a total of 7,926 wildlife permits, greatly surpassing the target of 4,026 by 197 percent. Examples of the permits issued are gratuitous, wildlife farm, wildlife local transport, wildlife collector, import, export and re-export permits, as well as certificates of wildlife registration.

The high accomplishment was due to the fact that the issuance of permits was demand-driven, the BMB explained.

In 2019, the BMB maintained 42 wildlife rescue centers and 384 ecotourism facilities nationwide, accomplishing 89 percent and 98 percent, respectively, of the targets.

DENR meets biodiversity targets

THE Department of Environment and Natural Resources (DENR) said it has surpassed its 2019 targets for biodiversity preservation.

Environment Secretary Roy A. Cimatu said the Biodiversity Management Bureau (BMB) exceeded its targets for cave assessment and the issuance of wildlife permits as early as October.

"This is palpable evidence that the DENR is not only focused on the rehabilitation of Manila Bay and Boracay, but also in the conservation of the country's flora and fauna," he said in a statement.

The DENR noted that the BMB assessed 52 caves, compared to its annual target of 38. It has also issued 7,926 various permits for handling, collecting, exporting and farming wildlife, against the target of 4,026.

The bureau's Philippine Operations Group on Ivory and Illegal

Wildlife (Task Force POGI) also confiscated 72 animals and 15.6 kilograms of agarwood. This task force includes personnel from the BMB, the National Bureau of Investigation (NBI), and the Philippine National Police (PNP).

It also maintained 42 wildlife rescue centers, 89% more than the target, and 384 ecotourism facilities, 98% more than the target, across the country.

Republic Act No. 9147, or the Wildlife Resources Conservation and Preservation Act, charges the department with conserving and protecting "the country's wildlife resources and their habitats for sustainability," as well as to promote ecological balance and improve biological diversity, and to regulate the collection and trade of wildlife. - Vincent Mariel P.

THIS a rejoinder to "Practice candy wrappers, paper and plastic bags, plastic forks and spoons, barbecue sticks, used tissue paper, food containers and boxes, etc. Obviously, these were thrown or left behind by the park's visitors that day. The mere sight was disheartening, diminishing whatever holiday cheer I was feeling at that time.

I suggest to local government units and park managers that they set up public address systems in public parks and places (like Luneta, the Quezon Memorial Circle, etc.) to blare out a brief but clear recorded announcement every 15 or 20 minutes urging everyone to pick up after themselves. Hestressed that the Rizal Parkwasapicture of dumping place with plastic bags, bottles, cups and cutlery,

paper and Styrofoam food containers, and picnic were all over the place after the

Christmas revelry.
"Litter is not only unsightly, but also unhygienic and polluting. Litter attracts flies and rats and causes the spread of diseases, while creating rotting smell from food waste. Litter, especially single-use plastic bags, can be blown or washed into waterways and the oceans, harming aquatic life," he said.

He cited RA 9003 or the Ecological Solid Waste

Management Act that bans littering and violators can be fined from P300 to P1,000 or asked to render one to 15-day community service or be required to pay the fine. Manila City Ordinance

7866 prohibits and penalizes illegal disposal of gar-bage with a fine of P3,000 and/or imprisonment of 30 days or both upon the order of the court.

The EcoWaste Coalition is hopeful Filipinos who will go to Rizal Park to celebrate the New Year

or participate in the overnight vigil for the Black Nazarene, will be more considerate and responsible and in leaving the park

with trash.

"Let's all cooperate in protecting Rizal Park and other green spaces from turning into virtual dumps by sticking with the ecomantra 'take nothing but pictures, leave nothing but memories, kill nothing but time' and by just simply being respectful to fellow visitors and to Mother Earth," Benosa said.



Breaking bad habits

During Christmas, one of the most popular venues for family

outings is Rizal Park in Manila. And a common aftermath of such gatherings is the mountain of garbage left in the park.

So this year before Christmas, environmental groups together with the Manila city government and the National Parks Development Committee reminded people to take their garbage with them and dispose of the trash properly.

Typhoon Ursula dumped heavy rains in Metro Manila on Christmas Day, and by afternoon, the crowds had disappeared from Rizal Park. And yet Manila city officials reported that from Christmas Eve until yesterday morning, at least 60 metric tons of garbage were hauled from the park, with the bulk of 51 tons piling up from noon of Dec. 25.

City officials said this was way above the volume of garbage collected last year from the park during the same period. And the city is expecting more trash during the New Year's revelry.

This highlights one of the biggest factors behind the garbage problem in the country: bad habits. Public awareness of the importance of proper waste disposal is abysmal.

Filipinos generally keep their homes clean, but think nothing of

discarding trash everywhere else. This not-in-my-backyard

mindset is often compounded by the lack of garbage receptacles in public places as well as inefficient garbage collection systems.

Garbage is dumped anywhere, including in waterways, with the litterbugs thinking the trash would be washed away, never mind where, as long as it is far from their homes. The filthy habits cover all types of solid garbage – not just plastic but also metal, glass, paper, wood and pathological waste.

Those tasked to clean up Manila Bay have lamented that despite all their earnest efforts in recent months, tons of garbage continue to turn up in the water. Solid waste also continues to clutter street drains, aggravating flooding.

Can filthy habits be broken? New Year's resolutions won't be enough. The importance of proper garbage disposal must be inculcated in Filipinos at a young age, in schools and perhaps in community-based programs. This must be complemented by efficient waste management by the government as well as proper enforcement of laws against littering and improper waste disposal. With sustained effort on multiple fronts, it is possible to break bad habits.

Sa Quezon Memorial Circle naman, bagama't, naisilid na sa mga garbage bag ang mga basura, may ilan pa ring tila tinamad nang magbitbit ng kanilang kalat kaya iniwan na lang ang mga ito sa daanan.

Paliwanag ng grupong EcoWaste Coalition, hindi kailangang palalain ng selebrasyon ang problema sa basura.

Kung magkukusa sa pagse-segregate, pagre-reuse, pagre-recycle at composting, magiging bahagi tayo ng solusyon at hindi ng problema.

Halimbawa, ang hindi na pagbalot sa mga regalo, pagtatabi ng mga balot ng regalo na natanggap upang makabawas sa mga packaging material na itinatapon lang, bukod pa sa iginigiit nilang bawasan na ang paggamit ng single-use plastics.



RAINS FROM 'URSULA' UP Angat dam water level

CITY OF MALOLOS—The water level at Angat Dam in Bulacan province has risen to almost a meter due to rains dumped by Typhoon "Ursula" (international name: Phanfone) in the area.

But the record of 199.72 meters above sea level at 8 a.m. on Thursday was still short of the 212-masl target that would ensure sufficient water supply to Metro Manila residents and Central Luzon farmers.

Thursday's mark was slightly higher than the 198.90-masl level at 5 p.m. on Wednesday, data from the provincial disaster risk reduction and management office (PDRRMO) showed.

Liz Mungcal, head of the Bulacan PDRRMO, said they expected the dam's stock to rise due to intermittent light rains spread out over the reservoir.

Continuous rains within three to four days usually increase the dam level by a meter, she said.

The dam's elevation had risen to more than 10 meters since Nov. 29 when it was at 188.82 masl, which was near the operating norm of 180 masl.

On Dec. 2, the elevation rose to 189.05 masl but it dropped to 188.97 masl at 8 a.m. on Dec. 3, before rising to 189.35 masl at 5 p.m. on the same day.

Rains dumped by Typhoon "Tisoy" (international name: Kammuri) on Dec. 4 increased the dam's elevation by more than 3 m at 194.14 masl.

Earlier, Bulacan Gov. Daniel Fernando had asked Bulakenyos to implore divine intervention so that rains would fill the dam reservoir and reach its normal elevation at 210 masl.

The National Water Resources Board usually cuts the water supply to the National Irrigation Authority for the irrigation requirements of farmers in Bulacan and Pampanga when the dam level goes below 180 masl.

More than 90 percent of Metro Manila's water needs are sourced from Angat Dam while some 25,000 farmers depend on its water for their irrigation.

Finally, Angat water level rises

MALOLOS – The rains spawned by Typhoon Ursula in the past three days have raised the water level of Angat Dam by more than a meter.

Records of the provincial disaster risk reduction and management office of Bulacan showed that water elevation at Angat Dam on Tuesday morning was at 198.71 meters. It rose to 198.80 on Wednesday and to 199.72 meters yesterday for a total of 1.01 meters.

The water elevation of the dam as of yesterday morning was 19.72 meters above its minimum operating level of 180 meters, but still 12.28 meters below its ideal 212-meter

end-of-year water level.

David Sevillo Jr., executive director of the National Water Resources Board (NWRB), told **The STAR** that for January, the board approved a 40-cubic meter per second (cms) allocation – from its normal 46 cms water allocation – for the Metropolitan Waterworks and Sewerage System (MWSS).

It also allocated 10 cms for the irrigation supply to Bulacan and some parts of Pampanga's farmlands. The normal allocation to these areas is 30 cms.

The NWRB is closely monitoring the end-of-year elevation of Angat Dam and will modify its water allocations if water elevation improves, Sevillo added.

The water coming from Angat Dam supplies more than 90 percent of Metro Manila's

domestic water use and irrigates more than 17,000 hectares of farmlands in Bulacan and more than 9,000 hectares in Pampanga.

Early this year, the dam's water level went below its critical level of 160 meters, forcing the NWRB to cut the water allocation for Metro Manila's domestic use to only 36 cms from its normal 46 cms water allocation.

The cut in water allocation for Metro Manila's domestic water use forced MWSS's two water concessionaires to enforce rotational water service interruptions to its customers.

The NWRB also suspended the irrigation allocation for Bulacan and some parts of Pampanga's farmlands when its water elevation dived down below minimum operation level of 180 meters.

Cost recovery and the water contracts

Over the holidays, I have been exchanging notes with a former official in government who had intimate knowledge of how the water contracts took form. Being retired, he prefers to live in simple anonymity. But I want

to share some important points he made.

First of all, there are two basic ingredients to pricing PPP projects: "Cost recovery" and "reasonable returns". While it is possible these ingredients (the cost and the returns) may be prone to abuse by unscrupulous businesses, government is expected to put in the necessary

safeguards and preventive measures to minimize abuse.

Operating on the assumption that we have those "guardrails" in place, these basic ingredients must be clearly defined in a "Terms of Reference" (TOR), which will be the basis for the businesses to price the service.

As an aside, to give some clarification to a controversial issue in the water concessionaire contracts, the TOR stipulated that the taxes will be shouldered by government

so the bidders did not include them in their pricing. Not to favor anybody but probably because in the end, cost recovery requires that that cost be included in the price which will result in higher and "unpopular" water rates

which government probably wanted to avoid.

Another important element of the TOR is "risk allocation" which also has a significant bearing on the cost. There is a tendency of government contract administrators with strong protective legal background to assign all the risks of the contract to the contractor or service provider. This has resulted in many serious bidders to avoid bidding for such government contracts.

Risk assessment and proper assignment of risks seems to be challenging to government contract administrators. For example, the recent inclination to eliminate the usual clauses related to the disposition of MAGA conditions.

This bureaucratic tendency is contrary to the proven WB formula for risk assignment – "The various risks in a contract should be assigned to the party who can best manage a particular risk and for those risks which are not clear-cut, there should be a mechanism for the two parties to arrive at a mutually advantageous win-win solution to address the problem."

Probably because of a reasonably well-designed TOR, recall that the eventual bids for the two concessions were initial water rates that were significantly lower than the

MWSS basic rate of P8/cum at the time.

To address changes in the business environment and to respond to future investment requirements and water rates setting, a five year "rate rebasing" scheme was put in place. This is the responsibility of an internal regulatory body within MWSS, but subject to the final decision of the MWSS Board.

Admittedly, there may have been some issues, not with the underlying principle of the process, but possible manipulation of the data and results which escaped proper supervision, sometimes referred to as "regulatory

capture"
Note that, as designed in the TOR, the concessionaires were just "operators" of MWSS who was still the "public utility" company subject to the review of the NWRB which assumed the powers of the defunct Public Service Commission.

Most basic of the requirement was the limitation on the "returns" of the public utility against its assets, of MWSS's total assets, not the assets of the concessionaires. And because of the large assets of MWSS, the limitation on the "percent return" was never exceeded.

It was not all roses for the concessionaires (and maybe proof that the awards were not "lutong macao" or a "giveaway"). While Manila Water was very successful, over seven years Maynilad was in financial distress as the

Asian financial crisis set in.

Yes, there were some mismanagement on the part of Maynilad, but my source believes that part of their error was their failure to realize that the TOR was also defec-

tive on the matter concerning CERA.

Raffy Alunan mentioned that Maynilad was made responsible for paying about \$700 million of MWSS's \$800 million loans, Manila Water assumed only about \$100 million. Soon after the bidding and award in 1997 from a bid reference value of about P27:\$1 exchange rate, in about four years the exchange rate quickly moved up and ballooned eventually to about P52:\$1. You can imagine the impact on their cost.

Unfortunately, the Currency Exchange Rate Adjustment (CERA) formula in place in the contract, as recommended by IFC the financial consultant of MWSS, did not properly address those cost increase implications. Maynilad was losing P3 to P4 per cum of water sold, while Manila Water was actually still GAINING about

P0.10 per cum from the CERA formula.

Under those conditions, former Manila Water executives looked like geniuses compared to the "bumbling" of the Maynilad executives. It is to the credit of Manila Water that those cost advantages were translated to significant improvements in their water distribution management resulting in NRW (non-revenue water) much less than 10 percent, beating even world class levels and translating into lower eventual water cost to the customers.

Eventually everybody realized that disparity and by the end of 2004, MWSS granted an increase in the Maynilad water rates so that by the end of 2005, Maynilad had a partial recovery of the total of about P7 billion lost from 1997-2004. Maynilad made a profit of P 2 billion.

That helped facilitate that "recovery and turn-around" of Maynilad from a company in the Rehabilitation Court. It made Maynilad an attractive viable business again.

The Lopez Group stepped out as agreed. The new Group led by DMCI and Metro Pacific won the bid to take over with a commitment to inject \$500 million into the business.

Today it looks like the principles of "cost recovery and reasonable returns" are under attack again and the financial sector and business are reacti-ng with some panic! Hopefully they will not ban "cost recovery and reasonable returns" like they wanted to do with "typhoons" in the early days.

ENVIRONMENT PROTECTION GROUPS LAUD MOVE

FOR NOW, WHALE WATCHING, FEEDING STOPPED IN BOHOL TOWN

TAGBILARAN CITY—The provincial government has stopped all whale watching activities in Lila town, Bohol province, pending the passage of an ordinance that would regulate them.

The drafting of the ordinance would be done in coordination with the concerned government agencies such as the Department of Tourism, the Bureau of Fisheries and Aquatic Resources and the Department of Environment and Natural Resources to ensure that marine species were protected and the laws followed.

"We are not after the total ban of whale shark interaction but only on the ecological trapping of marine wildlife by provisioning and/or feeding and luring and other activities which will harm these marine mammals and which are in violation of the law," said the executive order (EQ) issued on Dec. 23 and directed to Lila Mayor Arturo Piollo II.

Move welcomed

The move of the provincial government was lauded by environmental groups that opposed the whale shark feeding and watching as tourism attraction.

"This is an initial victory for us and the 'balilan' (whale sharks) in Bohol. We will continue monitoring as we await the EO's enforcement by the Lila government," said Liza Macalandag of the Free the Whale Sharks Coalition-Bohol.

Jesse Vera Acebes of nonprofit group Balyena at Lumba sa Pilipinas said they hoped that the Lila town government would be open to adopt a better ecotourism activity.

According to Nilo Ahat, provincial legal officer, the Lila government has not passed an ordinance that would have laid, down the guidelines and rules

on whale shark interaction.

Ahat said the private operator of the whale shark activities in Lila did not even have a business permit but owned several boats that were used to ferry tourists who wished to interact with the mammals.

Gentle giants

Bohol has been recognized as one of the places in the world that is rich in marine resources. The presence of whale sharks in the waters off Lila has enticed tourists to visit the town to interact with the whale sharks, also known as the "gentle giants."

But the town's whale shark feeding was met with protests from environmental groups that called it "an ecological trap" and "fake ecotourism."

They said conditioning or feeding the whale sharks created negative effects on the mammals especially on their migration pattern. INQ



INDUSTRY SEES STRONGER DEMAND FOR NICKEL IN 2020

Despite the decline in world prices, the value of the country's metallic production in the first nine months of the year rose by 6.5 percent to P99.58 billion from P93.48 billion a year ago.

The Mines and Geosciences Bureau (MGB) said they were expecting sustained growth next year given Indonesia's ban on nickel ore export.

The robust performance of mixed nickel-cobalt sulfide

(MNCS) drove the positive industry-wide results, with yield of P47.36 billion during the period or 48 percent of the total value registered by the sector.

This despite the 1.24-percent slip in the average nickel price and the continuous nonproduction of a number of nickel mines in Zambales, Dinagat Island and Agusan del Norte.

Gold retained the second spot with P39.60 billion in revenue, while copper contributed 14 percent or P14.40 billion. The remaining 1 percent was accounted for by silver and chromite.

Except for the precious yellow metal, prices of nickel, copper and silver all went down during the period. The ninemonth average of copper and nickel declined by 9.45 percent and 1.31 percent, respectively.

However, things began to look up for nickel in the third quarter when nickel prices started to go up.

MGB said the nickel ore export ban in Indonesia, which was expected to take effect in January next year, was seen boosting prices.

The new policy would naturally increase the demand for Philippine nickel ore, given that the country is the second largest nickel-producing country in the world right after Indonesia.

Both countries rely heavily on China, since it is the world's largest consumer of nickel, accounting for more than half of global consumption.

The Philippines alone exports 90 percent of its nickel ore to the Asian economic powerhouse. INQ

The controversial pork barrel funds issue continues to haunt the House of Representatives.

Six years after the Supreme Court (SC) declared the Priority Development Assistance Fund (PDAF) illegal, the House is still hounded by allegations of pork barrel in the national budget.

Just as in previous years, 2019 again saw Congress in a defensive stance vhile performing its "power of the purse" mandate or its

constitutional duty to decide how the government will spend its budget for the

succeeding year.

After the House recently ratified the P4-trillion budget for 2020, which reflected the amount proposed by the executive department in the National Expenditure Program, with several realignments by both houses and in the bicameral conference committee, Speaker Alan Peter Cayetano and other House leaders said the outlay does not have any pork

barrel or "parked" funds.

But Sen. Panfilo Lacson claimed otherwise, insisting there are pork barrel funds in the ratified version of the budget.

Lacson has alleged that House members realigned P16 billion to fund their pet projects under the proposed 2020 budget.

The senator claimed that the P16 billion was part of the P95.3 billion in appropriations under the 2019 budget of the Department

of Public Works and Highways (DPWH), which was vetoed by President Duterte when he signed the 2019 budget law in April.

The P95.3 billion worth of projects were "not within the programmed priorities," he

insinuated.

The House denied this. "There is no pork barrel in this budget as defined by the Supreme Court," Cayetano declared at a press conference last Monday.

"Anything can be used for corruption but Congress made sure that there will be no projects that are prone to corruption like lump sums at the discretion of lawmakers," he said.

Davao City Rep. Isidro Ungab, chairman of the committee on appropriations, expressed support for the Speaker's position.

"The 2020 budget is porkfree... Attempts to label it pork-ridden by constantly redefining pork is unfair and

misleading," he said. Ungab also rebutted Lacson's claim, saying the process and the product observed utmost transparency" and that senators also realigned funds "based on national priorities and recommendations of government agencies.

Deputy Speaker and Mandaluyong City Rep. Neptali Gonzales II also denied Lacson's allegation.

"We strictly followed the decision of the Supreme Court declaring the PDAF as illegal and prohibiting post-budget enactment identification of projects," he pointed out.

Gonzales explained that they have also been complying with the prohibition on post-enactment insertions in the budget.

Another House leader, Deputy Speaker and Cavite 3rd district Rep. Jesus Crispin Remulla, also scoffed at Lacson's insinuations.

He said the 2020 budget does not have any pork barrel as defined in the SC ruling.

He stressed that lawmakers no longer have discretionary funds in their legislative districts - unlike in the previous congresses when the pork barrel system was still allowed and the

to use funds in lump sums.

"There is no violation of the 2013 Supreme Court ruling because the funds are now with the implementing agencies. We followed the law, the Constitution and jurisprudence," Remulla pointed out.

Lacson earlier claimed that the House version of the 2020 budget included P20 billion in parked funds that were actually lump-sum allocations, which the high court had also declared a violation of the 1987 Constitution.

He specifically cited P10.4 billion worth of questionable projects stashed in the DPWH and another P4 billion hidden under the "Other Financial Assistance to LGUs (local government units)" in the budget of the Department of the Interior and Local Government

It was later clarified, however, that such allocations were not lump sums after the agencies gave detailed items and projects for such appropriations.

Lacson had also accused House leaders in the 18th Congress of planning to allocate P1.5 billion each for their districts - an allegation he later took back after failing to prove it. Cayetano also slammed the senator for "rumor mongering."

900 bills processed

Meanwhile, Majority Leader and Leyte Rep. Martin Romualdez said the House processed a total of 900 measures since the 18th Congress convened on July 22, churning out an average of 28 bills per day during the entire 32 session days

"In just 32 session days, we were able to steer the approval of 175 legislative measures," Romualdez said, noting that the chamber received a total of 6,562 measures and 186 committee reports.

Bills approved on third and final reading were those amending the Foreign Investment Act of 1991, the Passive Income and Financial Intermediary Taxation Act and the Corporate Income Tax and Incentive Rationalization Act.

These bills are important parcels of the Comprehensive Tax Reform Program aimed at helping the Duterte administration reach the 'A' credit rating goal.

The administration is em-

It was such achievement, lawmakers believe, that boosted the approval and trust ratings of the House and Cayetano, based on the latest Pulse Asia survey.

Deputy Speaker and Camarines Sur 2nd district Rep. LRay Villafuerte said the very high approval rating has inspired the House to work even harder in passing legislative measures that will benefit the people.

"It's an honor to be part of this 18th Congress. The highest ever trust and approval ratings inspire us to be more productive," he said.

Cayetano's high ratings came after the country's successful hosting of the 30th Southeast Asian Games where he served as chairman of the Philippine SEA Games Organizing Committee.

Looking forward, House leaders are confident that the chamber will continue to perform well in 2020 and maintain its very high public satisfaction

"2020 represents perfect vision... What we can do is focus on things that matter education, health, peace and order, defense and sports," Villafuerte stressed.

Albay Rep. Joey Salceda, chairman of the ways and means committee, vowed to sustain the House's commitment to funding the President's key infrastructure and human development priorities.


"As chair of the committee on ways and means, I have three goals that we need to achieve by 2022: A-level credit rating, eight percent GDP growth, widespread prosperity. We will work tirelessly to achieve these," he said in a statement last Monday.

Salceda said they would prioritize measures involving taxation on Philippine offshore gaming operations, Motor Vehicle Road Users' Tax, Mining Fiscal Regime and taxation on single-use plastics in 2020, which could raise at least P42 billion for the government.

The committee also seeks to improve tax administration by studying structural reforms in the Bureau of Internal Revenue and the Bureau of Customs. We will likewise try to raise taxpayer morale by studying digital transformation of the revenue collection
