V. Terms of Payment

- Payment shall be made after the last day of the event, subject to submission of billing statement and other supporting documents by the Service Provider and subject to the issuance of DENR Certificate of Acceptance for the rendered/deliveries/services.
- VI. Implementation and termination of Catering Services
 - The Service Provider hereby warrants that the goods subject of the Contract are free from latent defects and spoilage. The Service provider shall ensure that the quality of food, either raw, processed or cooked complies with established sanitation standards.
 - DENR reserves the right to suspend/cancel delivery of the items covered by herein order in the event of strikes, accidents or other contingencies beyond control.
 - The Service Provider agrees and obligates to finally and unconditionally abide by the decisions of DENR on the interpretation or construction of any term, condition or stipulation contained in the contract.
 - 4. Service provider's failure to deliver specified goods when due will authorize the DENR impose penalty equivalent to the maximum liquidated damages of 10% of the contract which shall be deductible from any money which may become due to Contract which shall be deductible from any money which may become due to Service Provider, or to recover from service Provider's performance bond filed under this contract, if there is any.
 - 5. In case of breach of violation by the Service Provider of any provision for this Agreement, the Service Provider shall pay DENR, by way of liquidated damages the sum equivalent to 10% of the total Contract Price. It is understood that the damages herein provided are fixed, agreed and liquidated damages, and that to be entitled to such damages, the DENR shall not be required to prove that it is has incurred actual damages.

- 9. Liquidated Damages (LD) equivalent to one tenth of one percent (0.1%) of the value of contract not delivered within the prescribed period shall be imposed per day of delay. The DENR may rescind the Contract once the cumulative amount of LD reaches 10% of the amount of the Contract, without prejudice to other courses of action and remedies open to it.
