- DENR serves the right to suspend/cancel delivery of the items covered by herein order in the event of strikes, accidents or other contingencies beyond control
- The Service Provider aggresses and obligates to finally and unconditionally abide by the decisions of the DENR on the interpretation or construction of any item, condition or stipulation contained in the Contract.
- 4. Service Provider's failure to deliver specific goods when due will authorize DENR to impose penalty equivalent to the maximum liquidated damages of 10% of the Contract which shall be deductible from any money which may
