To modify the requirement to add the line - or a Registered Private Company to the qualifications of the bidders "The bidder must have at least (3) three completed or ongoing contracts on Cloud services (credits or hosting subscriptions) projects from any recognized Government agency in the Philippines."	Request denied. We respectfully do not concur with the request and will retain the original requirement. The justification for retaining the original requirements is as follows: 1. Consistency and Reliability: Bidders with experience serving recognized Government agencies understand the complexities and standards required, ensuring reliable service delivery. 2. Minimizing Risk: Experienced providers are more likely to have established risk management practices, ensuring smooth project execution. 3. Expertise in Government Projects: Bidders familiar with government projects can effectively navigate unique challenges and ensure timely delivery. 4. Alignment with Strategic Goals: Bidders with government experience understand long-term strategic goals, ensuring continuity and success. Given the above points, retaining the original qualification requirements ensures that the bidders have the necessary experience, reliability, and expertise to successfully deliver the project. This approach mitigates risks, ensures compliance with government standards, and fosters a higher probability of project success.

The flexibility provided by Azure credits will allow us to allocate resources dynamically based on evolving project needs.
