We would like to respectfully inform the President that due to the ongoing and the forecasted rainfall today, August 28, 2024 which will bring occasional rains with possible flashfloods over Metro Manila caused by the Southwest Monsoon, the NDRRMC recommends the suspension of classes and work within the National Capital Region (NCR) **effective 7:00 AM, August 28, 2024 (Wednesday).**

Likewise, the same course of action for private companies, offices and schools is left to the discretion of their respective heads. This excludes frontline agencies engaged in emergency services.


The recommended suspension will prevent any untoward incidents and will ensure the safety of the general public.
