Subscription of Digital Secure Socket Layer (SSL) Certificates for various Websites and Information Systems of the Department of Environment and Natural Resources (DENR)

I. Rationale

With the onslaught of website and web application hacking, data theft and defacement nowadays, it is imperative that organizations protect themselves by adding additional layers of protection aside from traditional cybersecurity protection. The DENR-CO deemed it necessary to affect the enhancement of its website and information system data protection and stakeholder protection through the procurement of a Wildcard SSL Certificate.

II. Approve Budget of the Contract

The total ABC for the project is Php 300,000.00 inclusive of all applicable government taxes and service charges

III. Scope of Work

Supply and delivery of Wildcard Digital SSL Certificates for the *.denr.gov.ph domain with the following key features:

- Valid for a minimum of one (1) year.
- · Shall encrypt website traffic and private information to ensure secured transactions
- Capable of full business authentication verifies business identity and domain ownership.
- Shall have at least 256-bit encryption.
- Shall secure both *.denr.gov.ph and its subdomain (unlimited subdomains).
- Shall be universally compatible with all web browsers and devices.
- Must have unlimited reissuance of certificate.
- 8x5 Technical Support (phone, email and remote) valid for the duration/validity of the certificate.

IV Qualification of Service Provider

Service providers must have at least three (3) years' experience in providing similar (supply and delivery of Digital SSL Certificates) and should provide proof accompanied by correspondence from referees indicating that such project was executed as well as their contactable references.

V. Delivery Period and Place of Delivery

The winning service provider shall supply and deliver the digital certificate in the form of a paper subscription certificate at the DENR Central Office, through Property and Supply

VI. Duration and other Terms of Contract

- 1. The Digital SSL Certificates shall be valid for at least one (1) year upon enrollment.
- The service provider shall provide a web portal for the easy reissuance and downloading of digital SSL certificates by using a certificate signing request (CSR). A knowledge transfer training for the web portal must be provided to a DENR designated ICT personnel by the winning service provider.
- 3. The paper subscription certificate shall include the following:
 - Letterhead of the service provider.
 - In favor of the DENR.
 - Name of Project or Procurement.
 - The validity period shall indicate a start and end period and should be at least one
 (1) year. The start period should start exactly or after the date of receipt of contract (see Section VII timeline column).

Note: Start period earlier or before the date of subscription is acceptable only if advantageous to the DENR such as the validity period is at least one (1) year from date of subscription.

- 8x5 technical support with the same validity period of the Digital SSL certificate.
- Signed by a service provider representative and approval to be signed by DENR end-user or his/her representative.
- The Enrollment of Digital SSL Certificates, Domain Validation, Training and delivery of paper subscription certificate, shall be within fifteen (15) calendar days from receipt of Contract.
