**Approved Budget for the Contract: PhP 2,500,000.00**

1. The **Department of Environment and Natural Resources (DENR)** intend to apply the sum of PESOS: Two Million Five Hundred Thousand (PhP2,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for **PROCUREMENT OF CONSULTING SERVICES FOR THE EX-POST EVALUATION STUDY ON LAND ADMINISTRATION AND MANAGEMENT PROJECT (LAMP) PHASE I AND II**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.

2. The DENR now calls for the submission of Expression of Interest and Eligibility Documents for the **PROCUREMENT OF CONSULTING SERVICES FOR THE EX-POST EVALUATION STUDY ON LAND ADMINISTRATION AND MANAGEMENT PROJECT (LAMP) PHASE I AND II**. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. Bidding is restricted to entities or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Prospective bidders must have completed within the last five (5) years a contract of similar nature.

*“Similar nature” shall mean “Impact Evaluation / Assessment Studies” (Application of results-based monitoring and evaluation (RbMe) strategy or NEPF used to demonstrate the impact of projects’ interventions in the field of ENR, agriculture or rural development).*

6. A complete set of Bidding Documents may be acquired by Shortlisted Bidder/s during office hours (9:00AM - 4:00PM) but not later than the Submission of Technical and Financial Documents. The Bidding Documents shall be received personally by the Shortlisted Bidder/s or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge for the PhilGEPS and DENR websites, PROVIDED that Shortlisted Bidder/s shall pay the applicable fee for the Bidding Documents not later than the Submission of Technical and Financial Documents. For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the bid submissions.

7. Interested bidders may obtain further information from the BAC Secretariat Office, 2<sup>nd</sup> Floor, Two-Storey Warehouse, DENR Compound, Visayas Ave., Diliman, Quezon City from 9:00 AM to 4:00 PM only, Mondays to Fridays starting **10 October 2024** at Tel. No. (02) 8926-2675. However, any queries relative to the content of the bid documents and the project requirements can only be made not later than ten (10) calendar days prior to the Submission of Technical and Financial Bids.
8. The BAC shall draw up the short list of consultants from those who have submitted eligibility documents/Expression of Interest and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of **maximum of three (3)** prospective consultants who will be entitled to submit bids. **Minimum Eligibility Score** to be considered for short listing is **48 points** (60% of the total number of points). Details of rating scheme for short listing shall be as follows:

2. Current Workload Relative to Capacity	20 points	20%
3. Qualification of the Key Personnel	30 points	30%

9. A Notice of Eligibility and Short Listing shall be issued to short listed bidders indicating therein the schedule for the submission of Technical and Financial Documents.
10. Proposals shall be evaluated using the **Quality-Cost Based Evaluation (QCBE)** at a ratio of **60% for the Technical Proposal** and **40% for the Financial Proposal**. The Technical Criteria for the evaluation shall be as follows:

2. Approach and Methodology	150 points	30%
3. Qualification of Key Personnel	200 points	40%

11. Only the Consultant with a total technical score of **240 points** (60% of the total number of points) shall be qualified for the evaluation of financial proposals.
12. The contract shall be completed within **two hundred ten (210) calendar days** from receipt of Notice to Proceed.
13. The **DENR** reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
